School Counselor Wonders

On September 15, 22, and 29 the PTO is sponsoring a parenting seminar. The seminar is called Developing Capable People. It is based on the book. Raising Self-Reliant Children in a Self-Indulgent World by H. Stephen Glenn. The first seminar on September 15 is "Barriers and Builders to Our Relationships With Our Children." On September 22 the discussion will be "Developing Responsible Kids" and on September 29 we will hear, "What You Have to Do to Develop Self-Esteem." The seminar will be conducted by Theresa Gilbert, a parent and school board member from De Leon. The meetings will be from 7-8 p.m. in the high school library and is for anyone interested in parenting. You are encouraged to come to one or all of them. Please feel free to dress casually so that you will be comfortable.

I'm excited about having the chance to hear this presentation again. Most of all, I'm pleased to be able to share this with my students' parents. It occurred to me, how could I possibly motivate and encourage parents to come to a seminar when it was all I could do to stay up in the evening myself? I wonder if it will make a difference if I tell them statistics like:

- Almost half of the USA's teen drug abusers got involved before age

- 65% used drugs a year before parents suspected.

- 70% were introduced to drugs by

- 1 out of every 200 children is severely depressed.

- Suicide is the 3rd leading cause of death for ages 15-19 - about 5,000

per year. - About 1/3 of all high school students exhibit signs of depression.

- Texas ranks number one in the nation in teenage pregnancies among girls 15 and older.

- 1.5 million Americans may have already been exposed to AIDS.

I wonder if it will make a difference if I tell them that I am a concerned parent, too. I wonder what I can do to make a difference when my 9th grader comes home and I excitedly ask him, "What happened at school today?" and he says, "Nothing." Football is the most exciting thing in his life. I wonder if his energy and motivation for sports will make him care in the classroom. I want him to have fun and friends. I wonder if he'll make all the right choices when he's with them. wonder if it will make a difference if I tell parents that I wish that I had heard this seminar when my son was 5 instead of 15. Please join me and other parents on September 15 at 7 p.m. in the high school library. Babysitting will be provided in the Home

Additional \$755 Million For Disaster Assistance Available

LUBBOCK - President George Bush announced an additional \$755 million in emergency funds for crop losses incurred in 1990, 1991, and 1992.

This is in addition to the \$955 million disaster assistance for 1990-91 crops announced by Jerry D. Harris, Chairman of the Texas State ASC Committee, January 2.

The application period for disaster claims on fall-seeded program crops planted in 1991 and harvested in 1992 will begin September 8 and end October 2, Harris said.

The application period for producers with losses on other 1992 crops, and for producers with losses from 1990 or 1991 crops who did not previously receive disaster payments for those losses, will begin on October 13 and end February 12, 1993.

"Disaster assistance is available on a per-farm basis for any two years of 1990, 1991, or 1992," Harris said. "The original program provided \$955 million for either 1990 or 1991. Now, relief will also be provided for fallseeded program crops planted in 1991 for harvest in 1992.

"Producers will be eligible to apply for assistance on 1990, 1991 or 1992 crop losses; however, if producers received assistance for any of those years they may not receive further assistance for that crop year. Producers who receive payments for fallseeded program crops will only be eligible for assistance for 1992 crop losses."

Producers with qualifying gross revenues of less than \$2 million per year may file claims for losses of participating and nonparticipating program and nonprogram crops. "Producers with crop insurance must have had losses greater than 35 percent," Harris said. "Producers without crop insurance must have had losses greater than 40 percent. Producers with 1992 crop losses are required, under certain conditions, to purchase crop insurance for 1993."

Harris said producers intending to file for assistance should begin to assemble their records now, so they will be ready when the official application period opens and they should contact their county Agricultural Stabilization and Conservation Service office for additional information.



NOTICE OF COMPARABLE TAX RATES AND REVENUES

The legislature has enacted a statute on school funding to comply with a court mandate enforcing the state constitution. Under prior statutes (SB 1) the tax rate for last year provides \$4,683 per student in state and local revenues. Under this statute (SB 351) that same rate now provides \$5,045 per student in state and local revenues.

State law only requires a minimum tax rate of \$0.9398 for county education districts. State law does not require a school district to adopt additional taxes. Neither does state law require a school district to adopt a tax rate that maximizes the receipt of state funds.

The board of trustees of the Cross Plains Independent School District hereby gives notice that it is considering the adoption of a tax rate of \$0.1422 that will provide \$5,261 per student in state and local revenues.

MICROWAVE COOKING

Microwaves cook food by vibrating water molecules. Moisture near the outside of the food evaporates, leaving the surface cooler than the interior. 

We have fire ants in our back yard. I didn't worry much about them but now we have a baby. What should I do? I've heard that boiling water works.

Boiling water is one way to rid your yard of fire ants if you have only a few mounds. Be sure to use the water when the mounds are active. It usually takes several gallons of water to reach and kill the queen, the key to fire ant control. Be aware that the boiling water will kill or at least scorch the grass that it touches. If you have more than a few mounds, you should try a bait formula such as Amdro or a bait product containing the insect growth regulator fenoxycarb. Follow the label directions carefully and be patient. It may take up to a few weeks to completely rid your yard of fire ants. These products - while relatively low in toxicity - are not non-toxic. You shouldn't let your baby play in the treated area for several days. Some people have had success placing the bait in a plastic milk jug with holes near the bottom. The ants can reach the product and you can move the bait from mound to mound without leaving a residue.

What should I do with old books and magazines?


