# Pipe Bomb Found Locally

On Thursday, February 17, a rancher in the Spring Gap area found an object which he thought might be some type of bomb. The rancher brought the object into Cross Plains and turned it over to Don Griffith of the Cross Plains Police Department.

Griffith called the Abilene Police Department Bomb Squad to dipose of the bomb. The bomb squad transported the bomb to Abilene where it was dismantled.

The bomb was constructed of 14 inches of one inch PVC pipe, wrapped with black electrical tape, filled with powder and equipped with a homemade fuse. Several clues as to the identity of the persons connected with construction of the bomb were found and turned over to the Callahan County Sheriff's Department for investigation.

Bomb experts stated that if anyone had tried to use the pipe bomb they would almost certainly have been killed or se-

Several pipe bombs have been found in the Big Country area lately. Some of them are set as traps and can be detonated

by being moved. If anyone finds anything which looks suspicious, DO NOT TOUCH IT, and call the police department or sheriff's office at once.

It is not the intent of the Historical Commission to restore Zion Hill to an active cemetery. The intent is to restore it from a state of being almost unfindable and impenetrable to being more accessible, consistent with the honor and respect due those buried there. The gravestone dates range from about 1878 to 1915. These include two Civil War Veterans.

The Historical Commission would like to locate more living descendants of the people buried in Zion Hill. If you know of any, please notify Chairman Felix Manion, Baird, Texas 79504. The Commission plans to prepare a list of both gravestones and known descendants in the near future.

heard someone comment once on the oddity of some terms or words used - like what do you call the vehicle that is summoned after a wreck - a wrecker? You don't need a wrecker — the wreck has already happened! What is needed is a tow truck, or a lift of some kind. I've even seen some who were summoned to tow the car just add to the wreck by picking the vehicle up improperly or pulling it incorrectly. Then others handle even a wrecked car like it was a priceless antique, not wanting to add to the damage, rather get it somewhere for repairs.



The Cross Plains press and fast break stimied Zephyr, but the Lady Buffs never gained a lead.

" Zephyr came out smoking the first half," Coach John Starcher commented. " We matched them almost bucket-forbucket the first quarter, but they just kept putting them in." Shana Bagley led Cross Plains with 15 points and 6 assists. Amanda Sowell added 14 points, while Heather Montgomery put in 10 points and 7 rebounds. Tonya Stover scored 9 points, Jennny Potter had 4, and Amy Strength put up 2 to round out the Cross Plains scoring.

On February 18, Cross Plains challenged the 12th ranked Brock Lady Eagles in a Bi-District playoff game. Cross Plains jumped out to an early lead but the playoff experience of Brock paid off in an 86-61 victory. The Lady Eagles canned 11 three-point shots, but were unable to score inside ( except for rebounds) as the Lady Buffs closed any inside penetration. Cross Plains hit at

40% from the field and shot 57% from the free throw line. The key to the loss came from Cross Plains inability to hit the close-range shots. "I'll give Brock credit...they can shoot the ball! " Coach Starcher said in reviewing the game. " I felt we did all the things needed for the game, we just were not able to get the shots to drop. Brock has a tough press, but we broke it all night long. They live off their press, but it was'nt effective against us. We just shot our own foot

The three Cross Plains seniors led the Lady Buffs in the contest. Montgomery tallied 13 points and 9 rebonds, Bagley scored 12 points with 8 rebounds and Sowell put in 12 points along with 2 steals. Potter hit for 8 points and 8 rebounds, Stover scored 8 and 4 rebounds, Rachelle Bishop canned two 3's for six points and Strength put in 2 points.

The Lady Buffs finish the year with several accomplishments under their belts. They captured the Championship of the Rough Creek Classic in Novice, won consolation at the Panther Creek Tournament and played well against bigger schools in the Bluekatt Classic in Coleman. Several players received honors in these tournaments. More importantly, the varsity finished with a season record of 22-11 which breaks all

previous winning records over the past four years (maybe even longer!). The team finished District 26-A competition with a 5-1 record and represented the district as Co-Champions in the state playoffs.



# **VETERANS NEWS**

NOT SO GOOD NEWS----America's military Veterans often must wait years for decisions on injury or illness compensation, the government and Veteran's groups say. The claims backlog is now soaring toward ONE MILLION.

The Department of Veterans Affairs acknowledges that it is now losing the battle of coping with the tens of thousands of new claims for compensation and pensions coming in every year.

Four years ago the backlog of pending claims was 377,000. By the end of fiscal year 1995, the DVA estimates the number could hit 870,000.

On average, it takes more than 200 days to get an initial compensation claim processed. A Veteran can expect to wait more than two years to get a decision from the Board of Veterans

Veterans groups are outraged.

"We believe that a crisis situation, approaching a state of emergency, currently exists in DVA's Compensation and Pension Service", Joseph Violante of Disabled American Veterans testified before Congress. Appeals board delays, he said, "have become unconscionable and intolerable."

John Hanson of the American Legion said other issues "must not be allowed to overshadow the true crisis" in the claims process.

"Overall, the system stinks," said Sam Ledwith, 73, a Marine Veteran who fought in World War II and in the Korean War. Veteran Ledwith of Valley Stream, NY recently learned that after four years of appeals and an even longer period of hospital visits that the DVA was restoring a 40 percent disability payment for hearing loss that it had cut in half in the 1980s.

One of our local Veterans has been waiting for a decision on Agent Orange related cancer since last April, some ten months. Others are receiving letters that their claim has been received and that it will be quite some time before a decision is made on the claim.

Gary Hickman, director of the DVA

Compensation and Pension Service, said military reductions have meant a 50 percent jump in new claims, to about 150,000 last year, and that Veterans now tend to file multiple, and often complicated, claims.

There have been about 30,000 claims from the Persian Gulf War, including thousands who say they are suffering from the mysterious Persian Gulf syndrome.

"If you don't have Part B of Medicare and you want it, you have from now until the end of March to sign up." That reminder comes from Glyn Hammons, Social Security manager in Abilene.

Every year, the government offers a 3 month enrollment period - from January 1 to March 31 - during which people who turned down or previously dropped the Part B coverage can sign up for it. "If you enroll during this period, your coverage will begin July 1, 1994," Hammons said, 'and you'll probably pay a slightly higher monthly premium." The current cost for Part B coverage is \$41.10 per month, but most delayed enrollees pay a 10 percent surcharge for each year they could have been enrolled but weren't.

Part B coverage, also called "medical insurance," helps pay for doctors care, outpatient hospital visits, and other medical services. People are offered the option of signing up for Part B at the same time they are automatically enrolled in Medicare's Part A program. Part A helps pay for inpatient hospital care and certain other services.
