The tornado in Saragosa killed 30 on May 22 and those at Palestine and Jacksonville on November 15-16 resulted in 11 deaths.

Randy Montgomery will be seeking re-election as school board trustee for a three year tenure. Montgomery ran for the two year unexpired term of John D. Montgomery in 1986. Montgomery is employed by 3M in Brownwood and is a farmer and stockman.

Donnie Dillard will also be seeking re-election to the School Board. He filled the unexpired term created by the resignation of Scot Edington in 1984. Dillard ran for trustee in 1985, and is currently serving as secretary for the board. He is the manager of Dillard Drilling. Incumbent, Mayor Frank Robertson, will be seeking re-election for a two year term. Robertson has served as mayor for two years and councilman for six years. He is owner of Robertson's Tires.

Ray Purvis filed for re-election for City Councilman for a two year term. He has served on the council for nine years. Purvis is the owner and operator of Ray's Barber Shop.

Many will remember the devastation in 1979 in Wichita Falls which claimed 42 lives or the 1982 Paris tornado where 12 residents were killed, not to mention the millions of dollars of damage.

April through June are the months for unstable weather conditions and the usual period for tornadoes, but they can occur any time of the year. The TIAA provided the following

recommendations concerning tornadoes:

**Before Trouble Heads Your Way** - Keep emergency supplies on hand, including a portable radio and flashlight with fresh batteries.

- If you live in a mobile home, know the location of the closest shelter.

- Find the designated shelter areas in public facilities, such as schools and shopping malls.

- Make an inventory of all household furnishings and possessions, supplemented by photographs of each room. Include a description of the item, date of purchase or age, purchase price and estimated replacement cost today. (For a free household inventory form or tornado safety brochure, write to: Insurance Information Institute, 800 Brazos St., Suite 4220, Austin, TX 78701.)

- Make a detailed list of all damaged or destroyed personal property for the adjuster, keeping a copy for your records. Gather canceled checks, invoices or receipts that could help in placing a proper value on them. Get repair estimates for those pieces which can be economically repaired.

- In a major catastrophe, hundreds of claims will be processed and emergency cases must be handled first. Being available when the adjuster calls can speed your settlement. If you must leave the property, put a note on the door saying how you can be reached.

#### During the Storm

- Know the differences between a "watch" and a "warning." A tornado watch means that conditions are ripe for formation; a tornado warning means one has been spotted and danger is imminent.

- During a tornado warning, take cover immediately in a basement, bathroom, closet or under a heavy piece of furniture away from windows. Do not go outdoors. The only exception is if you are in a mobile home or car, in which case you will be safer taking cover in the nearest ditch

7. One year extensions were given to the building principals and athletic director. Their contracts will now extend through the 1989-90 school year. 8. The meeting was adjourned.

is so severe that you will be living elsewhere until repairs are made.

- If debris (such as a tree falling on the insured property) prevents you from using your home or if such debris could increase the damage, advise insurance officials of this when you report the loss.

- Your policy requires that you make temporary repairs as necessary to prevent further damage. This includes boarding up broken windows and covering holes in the roof with temporary materials. Your insurance will pay for the cost of these repairs, so record expenditures and keep receipts. DO NOT MAKE PERMA-NENT REPAIRS unless the adjuster has reviewed the claim and given you permission.

- Take steps to protect property from theft or vandalism, and do what you can to salvage damaged property.

## Getting Tough on Nursing Home Violations

Advocates of nursing home reform have reason to hope for more effective monitoring of the industry, thanks to laws that go into effect September 1.

Last year my Planning and Research division held seven public hearings around the state to consult health care consumers for needed changes in the laws regulating nursing homes. Consumers' ideas for improvement and reforms that had previously failed to pass were sorted out to form the basis for the amendments I requested. We have Senator Chet Edwards (D-Duncanville) to thank for a superb job of guiding the reforms through the legislative process.

#### ADMINISTRATIVE FINES

Perhaps the most important amendment provides for administrative fines instead of costly lawsuits whenever a nursing home violates Health Department standards. Under the new regulations, the Health Dept. may assess penalties of up to \$10,000 for each day of a continuing violation.

#### **TOUGHER INSPECTIONS**

One of the major concerns expressed during the public hearings we held was the need for after-hours inspection of nursing homes. The new law specifies that some of the unannounced inspections must be made at random between the hours of 5 pm and 8 am.

When an unannounced inspection is planned, my Office can now be notified and may accompany the inspector. The inspector will now have the authority to take photographs and to photocopy all relevant evidence of conditions that threaten the health and safety of a patient.

The Health Dept. will now be required to summarize each inspection report and must assure that copies of the summaries are made available to consumers, patients and their relatives.

#### TRUST FUND SET UP

Occasionally due to serious violations of the law, a trustee is appointed by the court to operate a nursing home. But in some cases funds are not available to meet the basic needs of residents. To solve this problem, the new law establishes a trust fund to assist the court-appointed trustee in meeting the patients' basic needs. The fund is to be created by assessing a fee of \$1 for each licensed bed in the state, and any facility that receives funds from the trust must repay within a year.

#### WHEN A HOME CLOSES

If a nursing home voluntarily closes, the residents and their families must now be notified *in writing* within five days of the decision to close. But if a home is closed involuntarily, notification does not have to be in writing and must be made within a "reasonable time."

#### POSTING INFORMATION

Each nursing home will now be required to post the following items in a public area of the facility that is readily accessible to residents, employees and visitors:

• the license to operate • a sign that explains the procedures for filing a complaint against the nursing home


• a notice that inspection reports and related reports are available at the nusing home for public inspection

• a notice of the Health Dept.'s toll free number to be used to obtain infornation about the facility

• a concise summary of the most ecent inspection report on that nursng home.



#### ENFORCING THE LAW

With over 100,000 licensed nursing home beds in the state, policing the industry can only be accomplished with help from the general public. Anyone who witnesses abuse or neglect in a nursing home should call the toll free hotline and report it to the Health Dept. The toll free number is 1-800-252-9106. They will investigate any complaint filed and will not reveal the identity of the person making the complaint if you request that it not be revealed. And the new law also prohibits retaliation against anyoneincluding an employee-who reports violations.




## Hidden Drawbacks For Reimbursing Employers

Dear Commissioner Nabers: I am president of a small 501 (c) (3) nonprofit organization with six employees. I know that under the unemployment law I can either pay taxes on my employees or pay reimbursements in lieu of taxes. I am leaning toward reimbursing. Can you clarify the advantages and disadvantages of reimbursing status?

> - M.P. Galveston, Texas

Dear M.P.: A reimbursing employer pays no taxes. Instead, the reimburser pays back dollar for dollar any benefits which are paid out to its former employees. If no benefits are paid, no money is owed. That is the obvious advantage.

The not-so-obvious disadvantage is that reimbursers have much less control over benefit payments than regular, taxed employers. The only time a reimbursing employer may protest the payment of benefits or appeal a decision to pay benefits is when it is the last employer for whom the claimant worked prior to filing the claim. Because liability on claims may be incurred up to 18

months after an individual has left employment, the reimbursing employer is frequently stuck with a bill for benefits drawn as a result of other work separations separations in which it had no part and over which it had no control.

Finally, it is impossible for the reimbursing employer to budget for unemployment costs. An unexpected bill for \$5000 may cause a real hardship. The next letter illustrates yet another disadvantage of reimbursing status.


Dear Commissioner Nabers: Our school district has elected to be reimbursing under the Texas Unemployment Compensation Act. We fired a teacher for what we considered misconduct; she

filed a claim for unemployment benefits and the first decision was in her favor. We appealed it and finally got the decision reversed. By then she had drawn almost all the benefits. Now the TEC tells me we still have to pay the amount she drew. Surely this is not correct!

not be done if large plants are thinned or cut back.

Consider growing flowers in containers to put color where you want it this summer. Potted plants need more water and fertilizer since they aren't able to sink their roots into the earth, but with this extra attention they will bloom for months, bringing life and color to areas where there are no flowerbeds.

You can fill a large container with all one kind or mix several plants to provide contrast in color and texture. If you decide on a mix, be sure to choose plants that share the same requirements for water and light. You must allow adequate space for growth. It's easy to over-plant when you're starting out with small plants..

Also, be aware whether the plants will grow upright or trail over the sides of the container. A combination of these types makes a pleasing display.

A planter containing several different herbs is both useful and attractive. In addition to its culinary uses, each herb contributes its own look to the planter. Regular pinching of the herbs is the key to keeping the planter tidy.




## **1988 Texas Breast Screening Project**

The 1988 Texas Breast Screening Project will be aired by KTXS-TV Channel 12 March 7-11.

The project is a joint effort by hospitals, breast screening centers and the American Cancer Society to offer low-cost mammograms to all symptom-free (without a single, abnormal breast lump) women. Insurance companies in the state have been mandated by Texas law to begin coverage of screening mammograms as of this year. Women should check with their insurance carrier to see when this coverage will take effect.

All women over the age of 35 should routinely have a screening mammograpic examination. Mammography, which has an accuracy rate of about 90 percent with breast selfexamination and a physician's exam



## **Referendum And Election Of** T.P.P.B. Approaching

#### **By MARY WEBB Executive Director Texas Peanut Producers Board**

The Texas Peanut Producers Board will hold its biennial election on April 30, 1988. The current terms of three board members will expire at that time. Any person living within the following counties who is engaged in the business of producing, or causing to be produced, peanuts for commercial purposes, is eligible to vote in his district, including owners of farms and their tenants and share croppers, if such person is subject to paying the assessment that is collected on peanuts within the following counties:

DISTRICT II: Includes the northwestern counties of the State. The southernmost boundary of this district includes the following counties: Loving, Wheeler, Ector, Midland, Glasscock, Sterling, Coke, Nolan, Taylor, Callahan, Eastland, Palo Pinto, Parker, Wise, Denton, Grayson, Fannin, and Lamar. Peanut producers north of this line are in District 2.

DISTRICT III: The westernmost boundary of this district includes the following counties: Red River, Delta, Hunt, Collin, Dallas, Tarrant, Hood, Erath, Bosque, McLennan, Bell, Milam, Lee, Bastrop, Fayette, Colorado, Wharton, and Matagorda. Producers east of this line are in District No. 3

DISTRICT IV: The northernmost counties of this district include the following counties: Maverick, Zavala, Medina, Bexar, Guadalupe, Gonzales, Lavaca, and Jackson. Producers south of this line are in District No. 4.

Any person qualifying to vote in the election may place his name in nomination for membership on the Texas Peanut Producers Board for a six year term from that district by application to the above organization, signed by himself and at least ten other



gets 23 per cent and Pct. 4 (Cross Plains) gets 25 per cent.

Here's another interesting fact. According to the county treasurer's report of Jan. 11, 1988, Pct. 1 had \$3,362.35 in its money market account, while Pt. 2 had \$192,032,99; Pct. 3 had \$355,707.81 and Pct. 4 had \$199.213.26.

Also, LaFoy said he doesn't have exact figures, but he understands there are more miles of road in Pct. 1 than each of the other precincts.

And, when you tack on the fact that more people mean more road traffic and thus more maintenance, it's hard to understand the present set-up.

If you want to see how screwy it is, just look at a precinct map of the county some day. I don't know what commissioners' court was thinking about in their last redistricting when they stuck a small jut of land around Belle Plain in Pct. 1 with the Baird precinct on the north and the Cross Plains precinct on the south.

It must be maddening to the folks in that area to see another precinct's maintainer turn around within eye-shot of their house while they wait for a maintainer to get there from Clyde.

Also, it's a bit unfair to require those folks to come all the way over to Clyde to vote, or force them to come to Baird to vote absentee.

As well as I can remember, the last redistricting of the precincts was done about 12 years ago. Also, it seems like it is required by law that redistricting be done every so often, maybe every 10 years.

Anyway, it's time to look at it again.

### To the Voters of Callahan County:



The following is an outline of what I will acomplish when I am elected:


