Cottonwood Historial Association To Purchase Oldest Building

At the general meeting on May 1 of the Cottonwood Historical Association it was voted to purchase the Methodist Church located in Cottonwood. The building is approximately 104 years old, the oldest building in the community. It stands just as it did during its last use. The pews, piano, podium and bell tower are still in place.

The present owner's plans were to demolish the church. The purchase

price for the church is \$3,500. It is felt that this amount can be raised by private donations, plus the funds needed for immediate care and maintenance, as the building has had no care for more than twenty years. Some cash and pledges were obtained during the general meeting.

One more attraction was the traditional Longhorn cattle. A small herd was corraled, and they were interesting to watch and compare. There were so many different shapes of horns and lengths. Each animal had its own distinct personality.

Then we met Cotton, the most famous of the Hardin-Simmons Six White Horses. The kids were allowed to sit on him for a while. They were really impressed.

The highlight of the day was seeing the world famous Clydesdale horses. To our disappointment we found that Sunday was their day off and we wouldn't be able to see them except in their stalls.

Still, the size and beauty of the eight animals was amazing. They were well-groomed and calm in temperment. It is just difficult to imagine a horse that size.

My parents, Darwin and Wanda Anderson, were fortunate enough to see the horses harnessed and prepared for exhibition the day before. They



Dr. Henry B. Hardt of Fort Worth, widower of Leo Marion Tyson Hardt, died recently in a Fort Worth hospital. Funeral services were held May 5 at Greenwood Funeral Home and burial was in Greenwood Memorial Park.

Dr. Hardt was a brother-in-law of Lindsey Tyson of Cross Plains, and had visited in Cross Plains many times. Mrs. Hardt, a former resident of Cross Plains, was the daughter of the late Dr. and Mrs. John Tyson. She died in March of 1982.

Dr. Hardt was formerly head of the chemistry department at Texas Christian University. He was also known as "founding dean" of the Texas College of Osteopathic Medicine.

He received B.A. and M.A. degrees from Southwestern University in Georgetown, and his Ph.D. degree from Columbia University in New York. He taught in Columbia University and various other universities.

He was a member of the National Collegiate Athletic Association of which in 1961-62 he was president. He had also served as chairman of the Board of Examiners in the Basic Sciences for the State of Texas.

Dr. Hardt was a member of the First United Methodist Church in Fort Worth, where he had taught a Sunday School class.

He had numerous books and articles published in both the field of chemistry and in athletics.

Dr. Hardt is survived by one son, Dr. David Hardt of Waco; one daughter, Janet Dominey of Arlington; two grandsons; and two granddaughters.

Parvovirus Prevalent

There has been an alarming number of parvovirus infections diagnosed in this area since the beginning of the spring. Canine parvovirus is a viral disease of dogs which is capable of causing two different sets of clinical problems. The first to be recognized, and the most common, is the "intestinal form" which is manifested by bloody diarrhea, vomiting, loss of appetite, depression, and often death. the second to be recognized is the "cardiac form", which occurs in very young pups and is manifested by an acute inflammation of the heart muscle.

Any age, breed or sex of dog can be affected by parvovirus. Several factors such as age, environment, stress, parasites, and general health status of each individual dog infected could affect the severity of illness. It is important to begin vaccination at an early age and repeat every 2-3 weeks until the puppy is at least 14-16 weeks old. Adult dogs should receive two doses of vaccine given 3-4 weeks apart for maximum protection. All dogs should receive an annual booster vaccination to assure an enduring immunity. Comparing the dog population in this area to the number of parvovirus infections that have been diagnosed, Callahan County has an infection percentage comparable to any other area in the state.

Savings Bond Semiannual Rate Set At 6.90 Percent

The semiannual market-based interest rate for United States Savings Bonds, in effect from May through October 1988, has been set at 6.90 percent, the Treasury Department announced today. The rate is 85 percent of the average market yield on fiveyear Treasury marketable securities during the preceding six months, 8.12 percent.

Bonds must be held five years or longer to receive market-based rates. Series E Bonds, Savings Notes, and Series EE Bonds issued through October 30, 1983, are now receiving market-based yields retroactive to issue date or their first interest accrual date on or after November 1, 1982, whichever is later. The yield on Bonds held since the beginning of the marketbased interest program is 8.50 percent.

Yields at redemption are the average of semiannual market-based rates during the time held rounded to the nearest quarter percent and compounded semiannually, or a minimum rate — whichever is greater. The current minimum rate is six percent. EE Bonds held less than five years earn interest on a fixed, graduated scale.

Jerrold B. Speers, Executive Director of the U.S. Savings Bonds Division, called the new rate "a reflection of current market conditions. We expect sales to continue the strong growth we have experienced since last summer, as more and more Americans starts a new Bonds-by-phone service. Anyone may call, toll-free, 1-800-US BONDS to get current rate and other information, and they will be able to order Savings Bonds using their VISA or Mastercard. We expect this new 24-hour-a-day service to be a hit with the public."

Savings Bonds semiannual rates are changed each May 1 and November 1 to reflect market activity during the preceding six months. The last semiannual rate, in effect from November 1987 through April 1988, was 7.17 percent.

One-third of all American households own at least one Savings Bond, with the total value of outstanding Bonds now exceeding \$104 billion.




Select Committee on Tax Equity Examining Texas Property Taxes

The property tax is one of the oldest taxes in Texas. It is also among the most controversial.

The Select Committee on Tax Equity will be focusing on property taxes at a May 18 and 19 meeting in Austin.

The Select Committee is a 13member panel created by the Legislature last year to take an exhaustive look at the Texas tax system. It expects to make recommendations to the Governor and Legislature prior to the next regular legislative session in January, 1989.

Since the 1850s, property taxes have been an important source of revenue for local governments in Texas and especially for paying for public schools. In 1986, the property tax accounted for 41 percent of school district funding statewide.

In general, Texas local governments rely more heavily on property taxes than do local governments nationally. In 1986, property taxes were 35 percent of local government revenue in Texas compared to only 28 percent nationwide.

Recent public opinion polls reveal that property taxes are the least popular of all Texas state and local taxes. Many of the people attending public hearings conducted this year by the Select Committee have appeared to speak out on property taxes.

The last major overhaul of Texas property taxes was in 1979 with the so-called "Peveto bill," after one of the bill's sponsors. Although controversial, the legislation went a long way to improve the equity of Texas property taxes by providing for a single appraisal to be used by all taxing jurisdictions. Prior to that time, a property owner often received several different values for the same piece of property.

Given the importance of these taxes as a local source of revenue, further changes that could make property taxes more fair and equitable could have a significant impact on Texas taxpayers.

As part of the work leading up to the May meeting, the Select Committee conducted a survey of property tax professionals in an effort to identify problems with the current system and alternatives to it. Preliminary results indicate that other methods of funding local government should be considered and that the increase in special taxing jurisdictions, such as water districts and municipal utility districts, is of concern.

The Select Committee will also examine the various exemptions and other property tax relief measures which have helped ease the burden of property taxes on homeowners and the elderly.

Additional tax relief measures are often recommended as ways for government to promote economic development. However, new exemptions are a concern to local governments who consequently must look elsewhere for revenue or cut services.

These and other issues are among the questions that will begin to take shape when the Select Committee looks at the property tax this month.
