### Invasion Of Night-Crawlers

After sundown, especially on weekends, Clyde and the surrounding area is invaded by night-crawlers.

They damage and destroy tombstones at the cemetery.

They mess up streets and buildings with cans of spray paint.

They smash mailboxes along the roads.

It's an adventure to go through town on Sunday morning and see what cute little misdemeanor they've connived.

Their latest little game seems to be to drive along the roads and see how many mailboxes they can dispatch. They are getting pretty good at it as the mail carriers come in and say, "well, they got (so many more) today."

In an article in the *Journal* several weeks ago, Postmaster Charlie Steph virtually pleaded with the vandals to stop, pointing out that many of the boxes they had destroyed belonged to elderly people on fixed incomes who could ill afford to replace them.

But that just seemed to encourage the night-crawlers, making them feel they were really doing some "good" with their meanness.

And, here's the frustrating part. Authorities apparently know who at least two of them are and nothing has been done about it.

Clyde Police Chief Ron Young said Tuesday his office had investigated the box vandalism, had talked to witnesses and had gotten the names, and addresses, of two 19-year-old Clyde men who are prime suspects.

Young said that about three weeks ago he turned this information over to Sheriff Bill Skinner because the vandalism occurred outside the city limits and outside Young's jurisdiction.

Young said he inquired this week why nothing had been done about the case and Skinner told him "he was going to take care of it." I called Skinner's office Tuesday but he was out of town at a conference and I couldn't reach him.

Steph said Skinner told him he was going to make the vandals repair the boxes at their expense.

### Waggoner Re-elected To BGCT Executive Board

AUSTIN — A Cross Plains resident was elected to a major position on one of the Texas Baptist Boards during the annual meeting of the 2.4-million-member Baptist General Convention of Texas (BGCT) in Austin, October 25-26.

Knox Waggoner, Pastor of Cottonwood Baptist Church, was reelected to the 193-member BGCT Executive Board.

The Executive Board, composed of pastors, church staff members and laypersons, conducts the business of the BGCT between annual sessions.

Institutions of the BGCT include eight universities, one academy, seven hospitals, four children's homes and four homes for the aging.

The work is supported by the more than 5,000 Texas Baptist churches and missions which will give about \$58 million this year through the Cooperative Program for mission work at home and abroad.

Besides the institutions, the Convention helps support worldwide missions causes including 7,500 missionaries in the United States and more than 110 foreign nations.

Cody Odom, Jody Brown, Robby Wheeler, and Chris Brown all scored in the Buffaloes' 28-point first quarter, with Jody Brown's coming on a 50-yard run.

Odom and Chris and Jody Brown then added to the total in the second half, with Chris Brown running 50 yards this time and Jody Brown returning an interception 30 yards.

Bill Johnson's 40-yard touchdown run set the second-half tone as Cross Plains got 333 yards rushing for the game while holding the visitors to 19 rushing yards on almost twice as many carries.

The Hornets escaped a shutout by scoring with 11 seconds remaining.

Cross Plains now is 6-2, while Lometa is 0-8.

Eleven Seniors will be playing in the final Class A District action against Rising Star Friday night at 7:30 p.m. on the Wildcats' turf.

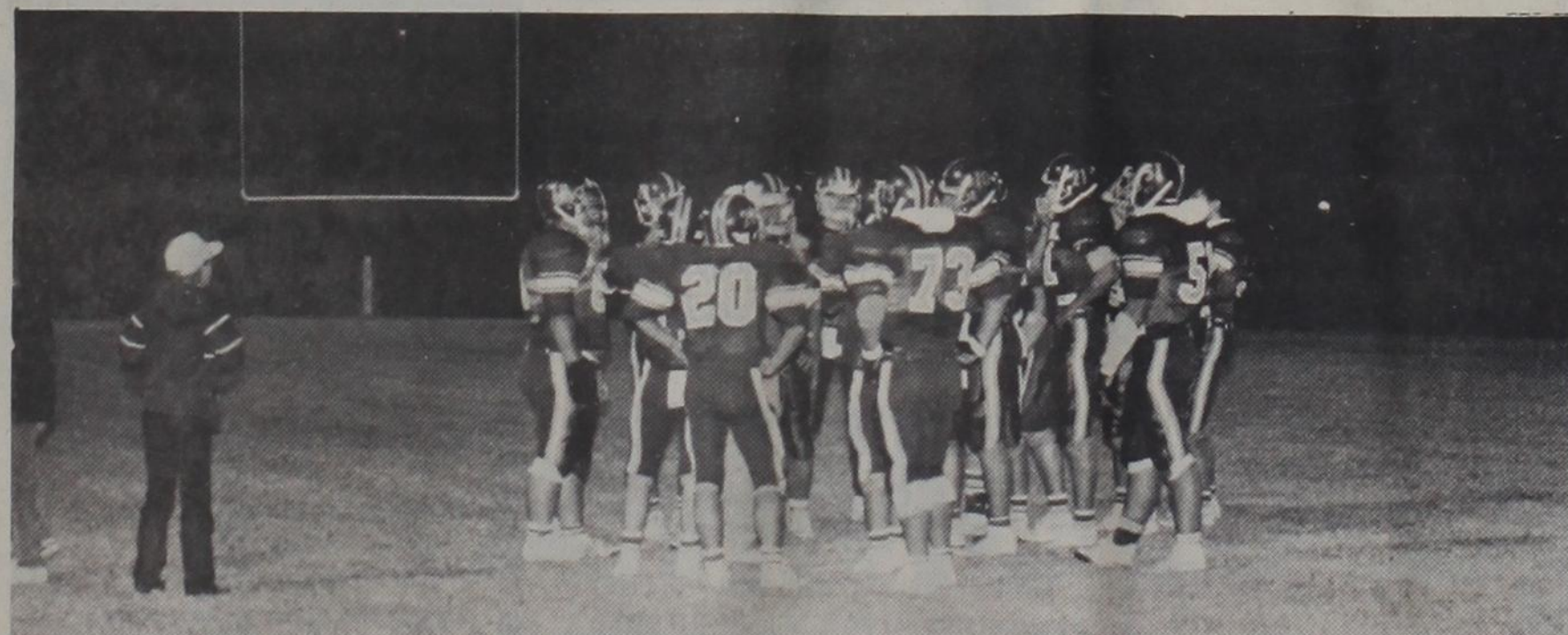

Morgan stated that the independent insurance agency provides coverage for businesses, autos, homes, health, life, bonds, and hail insurance on crops.

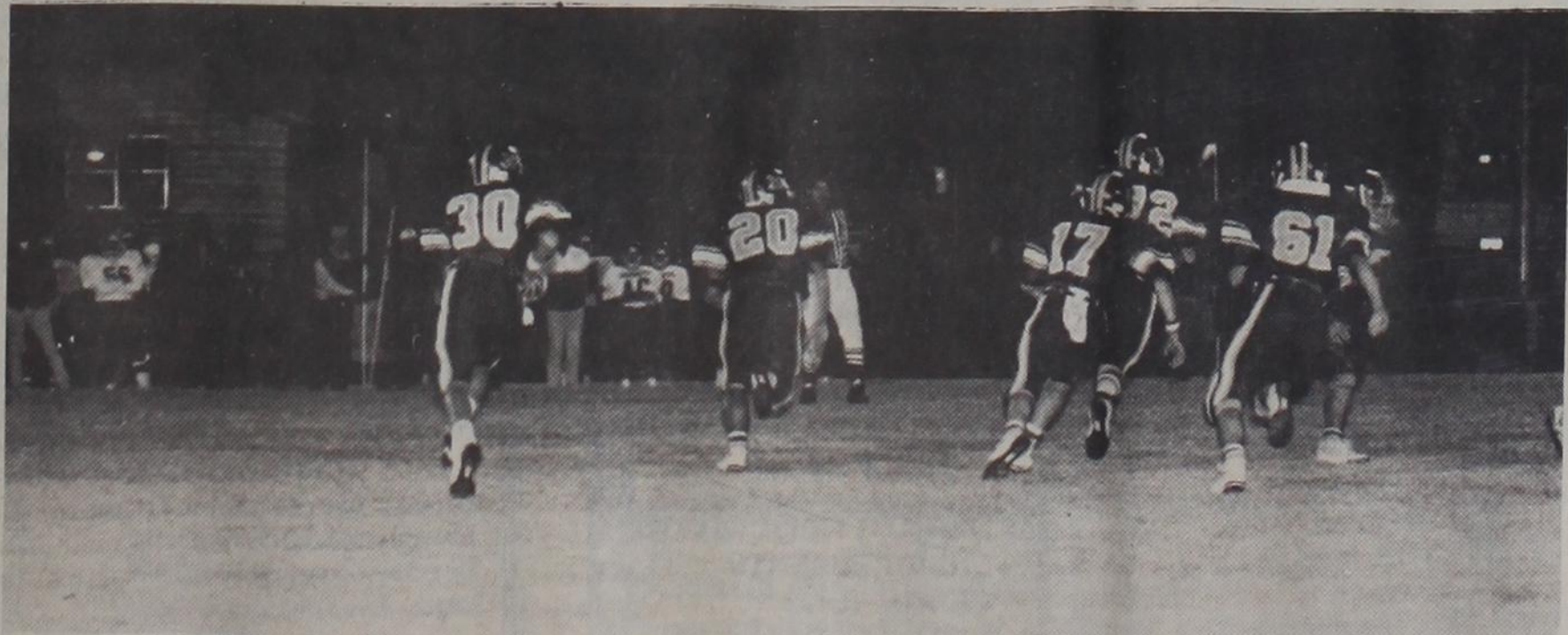
The office is open from 8 a.m. until

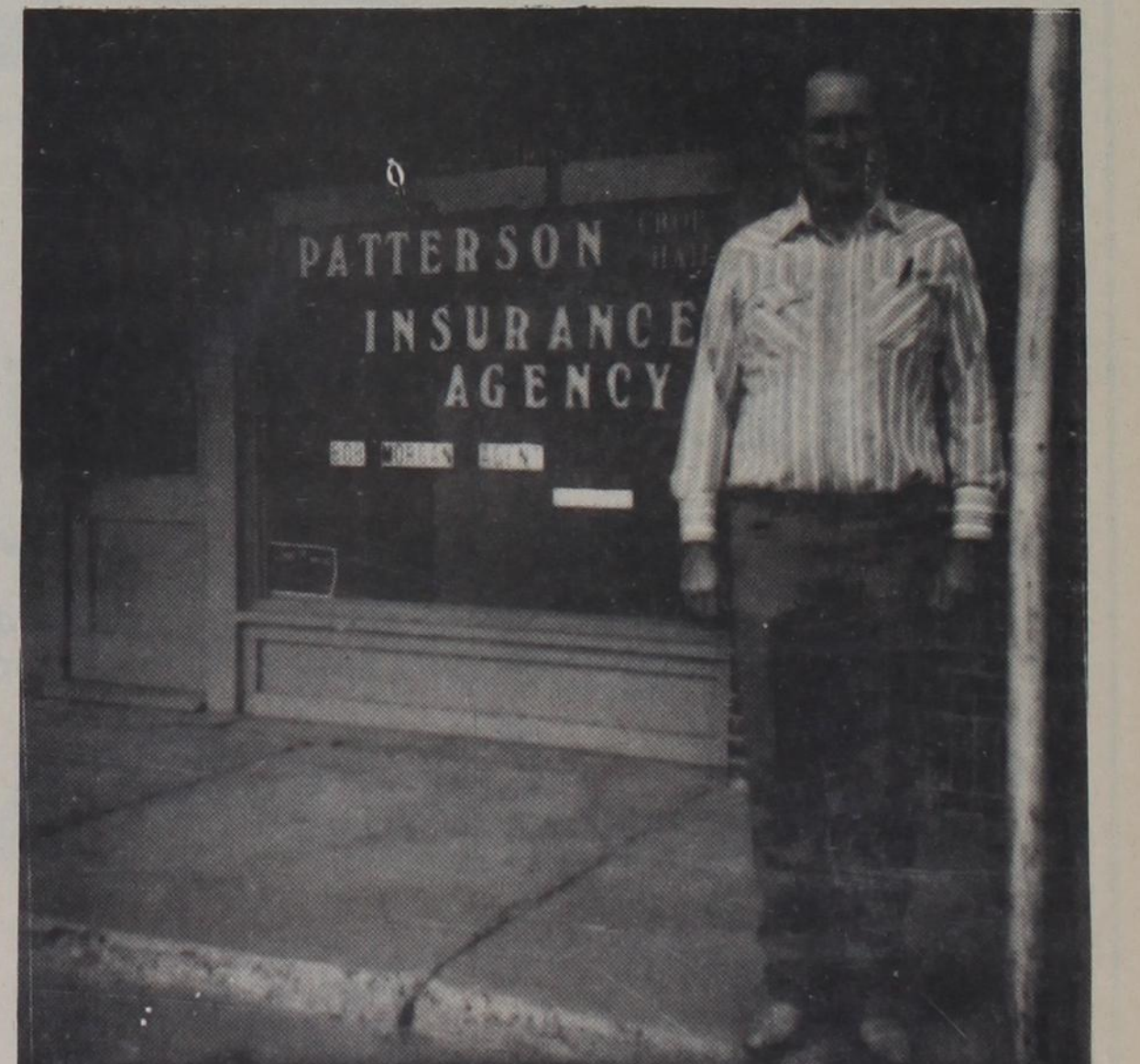


**THE BUFFALO HERD** — Players gather round Coach Permenter for the final details for the game.

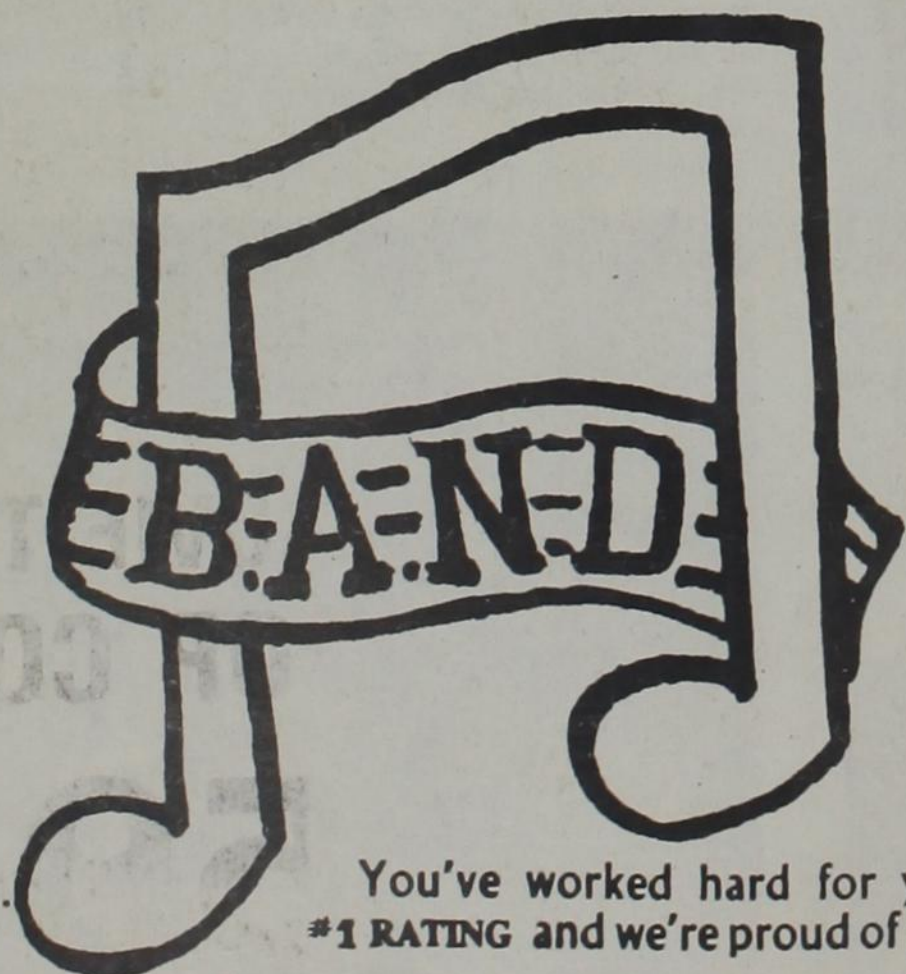

A great big thanks to the Pioneer ladies for a wonderful Halloween feast last Tuesday night. Twenty-seven members came to enjoy the good food and fellowship.

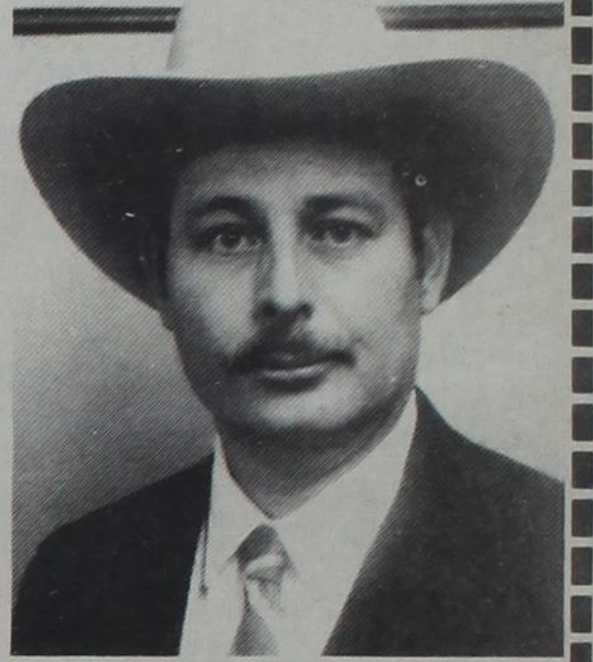
It was decided not to have a dinner in November, since it will be close to Thanksgiving and our Christmas Dinner Party will be December 17 at 7 p.m.

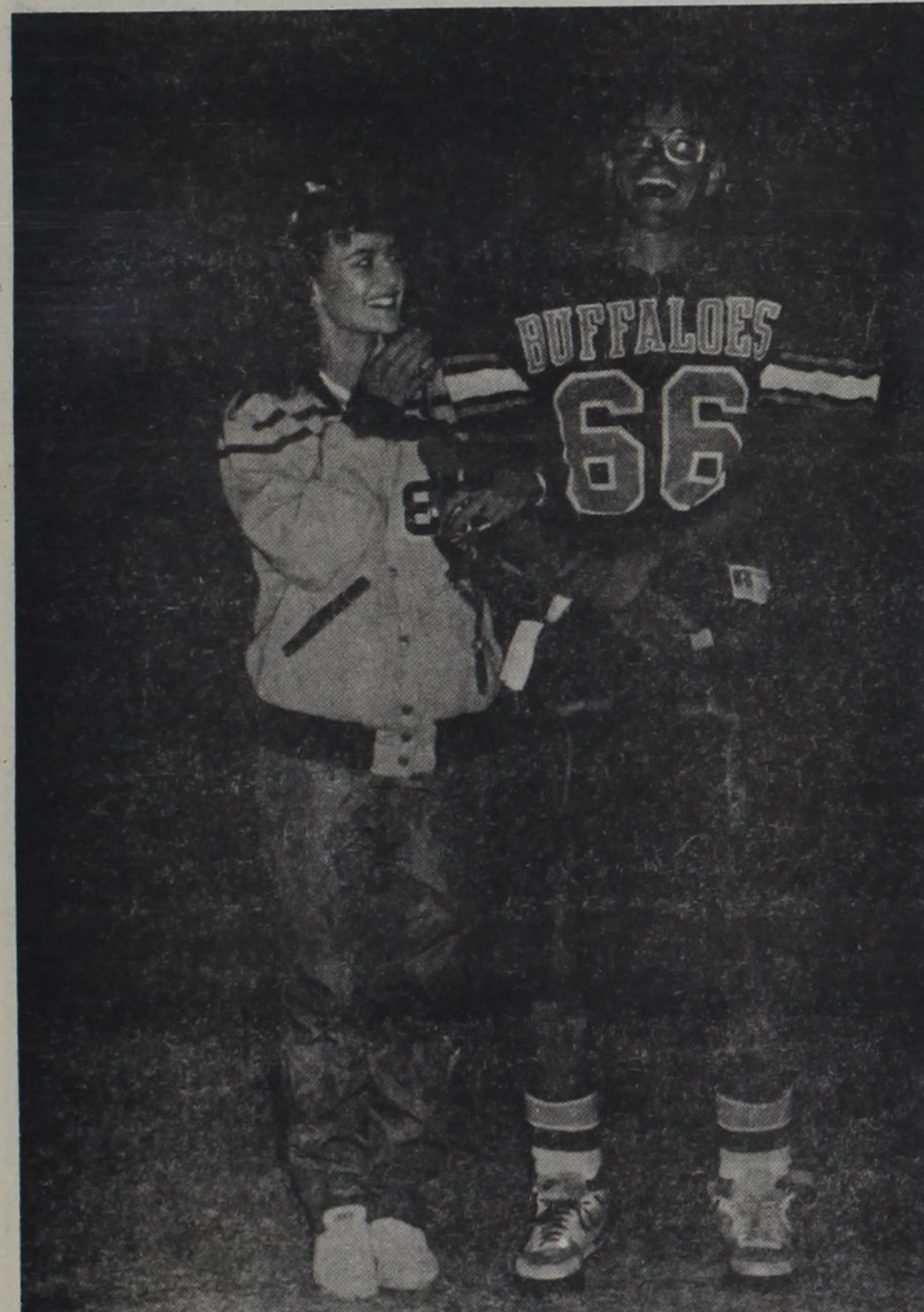

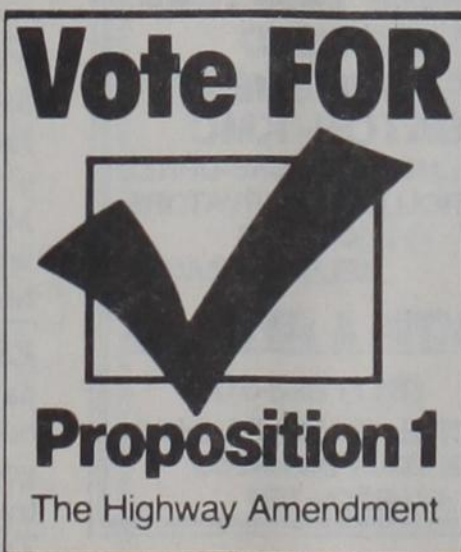

## UNDERSTANDING SOCIAL SECURITY AND MEDICARE

### CHOOSING WHEN TO RETIRE

When choosing a time to retire, remember that the age at which you retire has a major effect on the Social Security benefits you will receive. Average earnings and the number of years you have spent in the work force also affect benefits.

**When May You Retire**

Workers drawing Social Security benefits based on their own earnings records and spouses of retired or disabled workers may retire at age 62. Widows or widowers of a worker eligible for Social Security may receive benefits as early as age 60 (50 if disabled). But early retirement means smaller benefits.

**Early Retirement Reduction**

There is no early retirement reduction in benefits for disabled workers or adult disabled children receiving benefits on the earnings record of a retired or deceased parent. Everyone else who retires early—including disabled widowers—receives reduced benefits if they begin receiving checks before they reach age 65.

Each month a retiree is closer to age 65 before benefits begin means a smaller reduction from the full benefits which would be payable at age 65. At age 60, or younger if disabled, widow(er) benefits are 71.5 percent of the benefits which would be paid at age 65. Workers retiring at age 62 receive 80 percent of the amount they would receive if they waited until age 65. Spouses retiring at age 62 receive 75 percent of the spouse benefits which would be payable at age 65.

**Delayed Retirement Credit**

Just as retiring early means reduced benefits, retiring later means increased benefits. Under current law, benefits are increased three percent for each year after age 65 and before age 70 that a worker delays receiving benefits. If a worker waits until age 67 to retire, for example, benefits would be 106 percent of age 65 benefits; until age 70, 115 percent.

**Years of Earning Counted**

Workers who have spent less than a full worklife in the paid work force may find that delaying retirement will result in greatly increased benefits. This is particularly important for women who may have spent years as homemakers or caregivers, but whose own worker benefits will equal or exceed their spouse benefits.

Monthly Social Security benefits are based on lifetime average earnings. For a worker reaching age 62 in 1988, Social Security will average lifetime earnings over 32 years. One additional year will be added each year until all workers reaching age 62 in 1991 or later will have their monthly Social Security retirement benefits based on 35 years of earnings. Workers with less than the required number of years of earnings will have to include zero earnings years in averaging lifetime earnings. Thus a worker with less than the required number of years of earnings will benefit twice by delaying retirement. The early retirement reduction will be less and each additional year of earnings will replace a year with zero earnings.

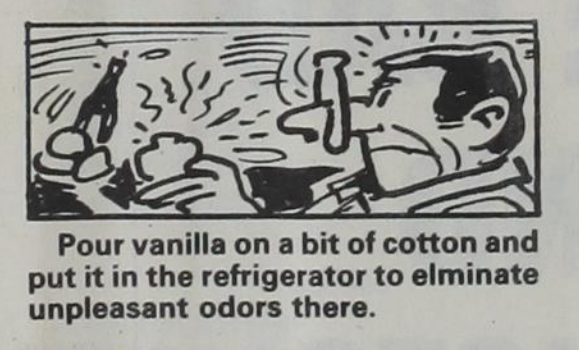

# Callahan County Absentee Voting Starts

Callahan County voters are now able to vote absentee by personal appearance for the general election planned Nov. 8th in the office of the County Clerk during regular office hours, 8:00 a.m. to 5:00 p.m., Monday through Friday. Absentee voting by personal appearance began at 8:30 a.m., Wednesday, Oct. 19, and will continue until 5 p.m., Friday, Nov. 4.

The county clerk's office, which is located in the Callahan County Courthouse, will also be open during the noon hour Monday through Friday of the absentee voting period for anyone who would like to vote during that time, according to Darlene Walker, county clerk.

Any qualified voter of the county is eligible to vote absentee in person, Walker said, regardless of age or whether he or she will be absent from the county on the day of the election. She said this is true only for persons voting by personal appearance, as long as the person is a qualified, registered voter of Callahan County.

She stressed that there are still certain restrictions concerning absentee voting by mail, call the county clerk's office during regular hours or go by and pick up an application for a ballot by mail. For more information about mail applications, contact Walker or one of the deputy county clerks at 854-1217.

Several local races are being contested, thanks to a write-in effort by some candidates.

The big race involved Callahan County Commissioner, Precinct #1 (Clyde). Democratic party candidate Roy H. LaFoy Jr. is being opposed by write-in candidate Eugene Kitchens. Kitchens, the incumbent commissioner, was defeated in an April 12 Democratic run-off election by LaFoy.

One countywide contested race involves incumbent sheriff and Democratic party nominee Bill Skinner facing write-in candidate Dahyl Bradshaw. Skinner defeated Bradshaw in the March 8 Democratic Primary Election 2,060 votes to 808 votes.

Other candidates filing as write-in candidates in Callahan County, but not facing a Democratic nominee, include: Eddie Glen Curtis for Constable, Precinct #1, Baird; and A.F. Pruet for Constable, Precinct, #8, Putnam. Pruet is the incumbent constable at Putnam, while Curtis is the son of incumbent constable, Glen Curtis, at Baird.

The names of the write-in candidates will not be on the official ballot in the general election November 8. Their names will be posted in each voting booth at the polling place. To have the vote counted for the write-in candidate, the voter must write the candidate's name in the appropriate place on the official ballot.

Two area contested races include:  
—State Senator, District 30 with Republican party candidate Bobby Albert facing incumbent Democratic party candidate Steve Carriker.

—District Judge, 42nd Judicial District with Republican party candidate Richard C. Mabry against incumbent Democratic party candidate Don Lane.

Candidates unopposed for local offices include:

County Attorney: Democratic party candidate Brad Harris.

County Tax Assessor/Collector: Democratic party candidate Wauneta Estes.

County Commissioner, Precinct #3, Baird: Democratic party candidate Tommy Holland.

Constable, Precinct #5, Clyde: Democratic party candidate Roy McAdams.

County voters will also have the chance to cast ballots for Bud Arnot, unopposed Democratic candidate for Justice, 11th Court of Appeals District, unexpired term; Austin McCloud, unopposed Democratic candidate for Chief Justice, 11th Court of Appeals District; Rick Perry, unopposed Democratic candidate for State Representative, District 64; and Charles W. Stenholm, unopposed Democratic candidate for United States Representative, District 17.

## 'She's Put Her Stamp On Occupation For 45 Years'

EDITOR'S NOTE: The following article appeared in the *Abilene Reporter-News* and was written by Larry Zelisko, Regional Editor.

PUTNAM — LaVerne Rutherford was surprised when I dropped by one recent afternoon to visit with her about her 45 years working in the Putnam Post Office.

I wanted to call to let her know I was coming. But the post office has no telephone. In fact, the post office hasn't had a phone for 10 or 15 years, she says.

Rutherford, though, probably doesn't need a telephone — she talks to practically everyone in town every day.

With its two employees, Rutherford and clerk Meta Isenhower, the Putnam Post Office handles mail for about 100 people. Putnam has neither home delivery nor rural routes, so residents must come by the post office to get their mail.

And when they do drop by, they chat about relatives and friends, the weather, or whatever else is going on in Putnam.

"We worry about people who don't show up and don't tell us that they are going out of town," she said.

Rutherford does a little extra to help postal customers because of her fondness for people and her job. For example, one elderly customer came by while we were talking and asked Rutherford to add up the numbers and figure the tax on a mail order form.

The postmaster gladly obliged. "One reason I've worked so long is that I know everybody," she said. "I haven't really wanted to retire, I just enjoy working."

When she applied to be clerk at the post office 45 years ago, she had no idea she would work here so long, she said. She began working at the post office on Oct. 20, 1943. She was appointed postmaster 26 years ago. The certificate naming her postmaster was signed by President John Kennedy.

Rutherford, 63, was reared in Putnam, and lived here until moving to Baird in 1977. She is a first cousin to Putnam's most famous former resident — Larry L. King, author of *The Best Little Whorehouse in Texas*.

When she's not selling stamps, she's collecting them. She's been doing that for about 35 years. When she started working at the post office, stamps cost two or three cents — she's not sure which. She does remember there were different rates depending on whether envelopes were sealed or not.

She has no plans to retire, so five years from now I can write a story on her 50th anniversary with the post office. However, I should be able to call first — she was filling out a request for a telephone when I stopped in this time.

## FmHA Activates Farms Loans For Socially Disadvantaged Persons

The Farmers Home Administration (FmHA) is preparing to activate a loan program designed to help members of socially disadvantaged groups, including minorities, acquire land for farming, J. Lynn Futch, FmHA State Director, said today.

Under the new program, FmHA will try to find persons in those categories who are interested in farming and can qualify for an FmHA farm ownership loan. The agency would also be prepared to sell or lease to them a farm held in its inventory if any are available in that county, Futch said.

FmHA can also provide other loan and technical assistance, if needed, to help the borrower get started.

The new program was included in the agricultural credit act signed earlier this year, Futch said, and funds have been reserved for farm purchases based on the population of socially disadvantaged persons.

The population of such persons range from as low as 1 percent in some New England and midwestern states to highs of 68 percent in Hawaii, 57 percent in New Mexico, and somewhat lower percentages in southeastern states. Population groups involved are Hispanics, Native Americans, Blacks, Asians, and Pacific Islanders.

Persons who think they might be eligible and who are farming or who would like to become farmers are urged to contact the Farmers Home Administration office serving their area, Futch said.

Now all your questions about cancer can be answered by calling a toll-free number.

This service will be staffed by trained American Cancer Society volunteers with access to a comprehensive database of information.

The toll-free number is 1-800-ACS-2345 and can be called from anywhere in Texas. Hours of operation are 8:30 a.m. — 4:00 p.m. (CST).

People often have a lot of questions about cancer when they find out a loved one has the disease or when they suspect they have a warning sign of cancer or when they have read an article that leaves them with a question. Now anyone in Texas can have their questions answered with just a phone call — and it's free.

Callers may ask technical questions about the disease, about cancer detection and warning signs and about treatments. But the unique aspect of the new phone line is that callers can find out about services available to cancer patients and their families in their own city or area.

ACS loans equipment to cancer patients and offers free classes and information to cancer patients and their families. Information about these local services, as well as education for public groups, can be obtained by calling this toll-free number.



## Advisory Group Recommends Work For Disabled

The recent report of the Disability Advisory Council should prove helpful to people who have been promoting work incentive programs for the disabled. The report strongly urged that Social Security disability programs need to be "restructured to give a higher priority to encouraging beneficiaries to work than to declaring them unable to work." Many people on disability can work with the proper support services, and they should be encouraged to do so, the council suggested.

The advisory council was appointed by Health and Human Services, Secretary Otis R. Bowen, to study the disability program. It is composed of representatives of employers and employees, public and private vocational rehabilitation services, disability, advocacy groups, medical experts, and the general public.

Of the more than 50 recommendations the council made, one of the most remarkable is that, the work incentives provisions of the law should be strengthened and marketed as an important part of the disability program, not just as technical details. Most of the incentives were added to the law since 1980, although, some date back to the beginning of the Social Security disability program in 1955.

In general, the work incentives provisions are designed to extend cash benefits, and medical coverage to disabled people who attempt to work until they have proven they can work on a regular basis. They include:

— A trial work period of up to 9 months (not necessarily consecutive) during which a person can keep all earnings and still receive monthly benefits, and Medicare.

— An extended 36-month period of entitlement, following the trial work period, during which a disabled beneficiary can receive benefits for any month during which he or she does not earn over \$300 a month.

— Medicare may continue for up to 39 months after the trial work period.

— Certain work expenses related to the disability may be deducted in figuring earnings that count towards substantial gainful activity.

— If a person in an approved vocational rehabilitation program medically recovers, benefits may continue until the program is completed.

There are other similar provisions that apply strictly to SSI recipients. People who want more information on these, or the SSI provisions, should call the nearest Social Security office.

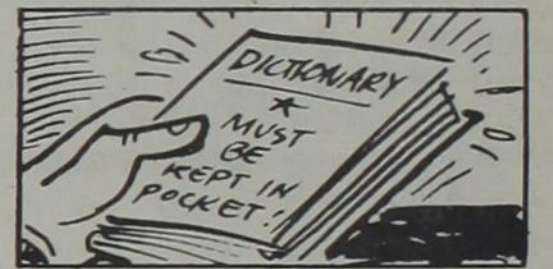

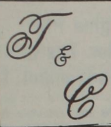
Lastly, the freedoms for good men to voluntarily work together toward their desired goals are proven morally and economically superior to every other form of government. Ask Nicaragua.
