Let's Stand Together

You are all aware of President Reagan's recommendation of a 50 percent pay increase for members of Congress, judges, and other top federal officials, plus a 56 percent hike in his pension. How does this grab you?

A Cabinet secretary's annual salary would increase from a mere \$99,500 to \$155,000. Former Presidents Jimmy Carter, Gerald R. Ford and Richard M. Nixon would receive pension increases as well.

These dramatic increases seem ridiculous considering the nation's deficit. Besides, how many people have you ever known to receive as much as a 50 percent salary increase?

It puts the financial creditability of the United States in a curious light. Don't you know other countries got a good laugh out of this one!

Seems no one can even recall the last time minimum wage was increased. It would be quite a sight to watch some of the government officials exist on \$7,176 gross per year, as many working people do. That should be a real challenge.

These salary increases will be effective automatically, under special legislation, unless voted down by both houses of Congress by February 9. The recommendation will be submitted to Congress with the budget.

The only thing that might sway their decision is a flood of letters to state and federal officials. It has been reported that this is already happening, but it wouldn't hurt to pitch in and

I have never written this type of letter before, but there is always the first time. It may be that we all have to stop being passive about the direction of the nation and do something about it. It is the same theory as voting, actually. You may assume that your meager vote will make no difference, but if everyone takes the same attitude, look what happens.

Low self-esteem must be the country's number one stigma, as most citizens feel their opinion doesn't count. If we don't speak out on some of these important issues then there is no possibility of change.

If you agree that these salary increases are unnecessary, please voice your opinion to an elected official. Charles Stenholm has stated that he personally did not agree with the raises. He might be one person to contact. Let's bombard them with letters and see if there is any progress.



Long Time Resident Passed Away Friday

Arnett Langevin Bennett, age 58, died peacefully Friday afternoon, January 13, 1989 at his home in Cross Plains, Texas. He resided there with his son, Phillip, and family. He went to meet God after a courageous, 21/2-year battle with cancer. He was well-loved and will be missed by all who knew him.

Services were held at 3 p.m. Sunday at Cross Plains Church of Christ. Burial was in the Old Cottonwood Cemetery, directed by Higginbotham Funeral Home.

Arnett was born in Rising Star on September 25, 1930 and was raised in Cottonwood. He became deaf as an infant after a bout with infantile paralysis. He began attending the Texas School for the Deaf in Austin in 1937 at the age of 6 and graduated in 1951. It was there that he entered the wonderful world of sign language.

He raised his 3 sons in Cottonwood with his parents, Bryan and Lee Bennett. He was an employee of Pioneer Farmers Coop for 2 full years and 2 peanut seasons and an employee of Johnston Truck & Supply for over 15

Bennett of Bryan, Wallace J. Bennett of Arlington, and John F. Texas Education Agency recently notified M. Lee Thompson, Superintendent of the Cross Plains Independent School District, of citations for improved student performance in the Board's academic recognition program. The school was selected on the basis of results of the 1987-1988 Texas Educational Assessment of Minimum Skills (TEAMS) scores.

Exceptional achievement if 90 percent or more students mastered all TEAMS tests taken in 1987-1988 or Exceptional Gain if at least 30 percent more students mastered the tests than in the previous year. Cross Plains topped the list with the highest percentage of 80.6 percent students passing.

It was noted that student performance is related to effective leadership both in the district and within individual campuses.

Mr. Ray Womack, Elementary Principal, received a letter honoring Cross Plains Elementary School in the academic recognition program to promote improved student mastery of basic skills. A Certificate of Achievement from the State Board of Education was also enclosed. The certificate noted Cross Plains Elementary for exceptional achievement on all sections of the Texas Educational Assessment of Minimum Skills 1987-88.

The Annual Performance Report 1987-88 Academic Year has been returned and submitted for publication. The goals for public education in

The school system has viewed the measures of educational achievement within the district covering a three year comparison and has made the following observations. The district administered TEAMS and the California Achievement Test in Reading, Mathematics and Language Arts. The mean percentiles are listed in this report under Measures of Educational Achievement. The results were:

CAT — The results indicated that students in Reading, Language Arts, and Mathematics scored above the National 50th percentile in all grades.

TEAMS — The results of these tests indicated that grades 1, 3, 5, 7, 9, and 11 scored at or above the Region and State levels in all three areas of Math, Reading, and Writing except grade 9 Writing. Students are to be commended for their 100% Mastery in grade 5 Math, and grade 7 Reading and Writing. Twelve (12) of the seventeen (17) areas tested reflected a 90% or above Mastery with four (4) areas indicating 83-89% Mastery

Approximately seventy (70) elementary students, thirty-five (35) junior high, and a large number of high school students participated in the UIL academic competition. Elementary placed:

Five (5) students received the Lone Star Farmer Award.

The district had twenty-five (25) seniors and over 75% of the students had post secondary plans, and 50% of them received some type of scholar-

The forms are for reporting inventory, equipment, and other assets the business owned as of January 1, 1989 according to Jane Ringhoffer, Deputy Chief Appraiser for the district.

The State Property Tax Code requires all business owners to render their property each year for taxation. Businesses that fail to do so will have their valuation estimated by the District appraisers. The law, also provides criminal penalities for filing false or misleading reports.

The forms are due back in the Appraisal District office no later than April 1. Assistance in completing the forms may be obtained by contacting Mrs. Ringhoffer at (915) 854-1165 or stopping by the district office on the first floor of the courthouse in Baird.

When it came my turn to hide, I already knew that I was going to climb up the windmill and hide on the platform - he would never be able to find me there...

Twelfth graders not passing the May 1988 exam was 0 in the District and 2,481 in the state (1.3 percent).

Cross Plains I.S.D. can be proud of one of the lowest tax rates at \$.62 per \$100 within the District compared to \$.83 in the state. Local taxes only provide 23.5 percent of the school's finances needed.

Enrollment by special program includes Vocational Education reflecting a 31.2 percentile in the District and 17.4 percent in the State.

Disciplinary actions include only one action in the Elementary Campus, resulting in 1-3 days suspension and no expells. Secondary reported 10 actions with 5 removed to a supervised alternative education program for 1 to 4 days. Five out of school suspensions for 1 to 3 days resulted and no expells.

All this speaks well for Cross Plains I.S.D., and the community should be filled with pride for all the administrators, teachers, board members, parents, and students of the District for their outstanding accomplishments.

Classes For Job

Work-related educational expenses may be deductible. However, miscellaneous deductions are deductible only to the extent the total exceeds two percent of adjusted gross income. directions. I was screaming my head off, but Arnett couldn't hear me! He could not even hear the wind. But then, he looked up as though asking for help from above, and he saw me on the platform scrambling to stay away from that speeding fan. In the blink of an eye, he was at the brake trying to shut off that contraption, but all of his effort was to no avail. The wheel was moving too fast, and he just did not have enough muscle and weight to stop that wheel of potential death for

Oh God! I have never been so frightened in my life, before or since. When Arnett saw that he would never be able to stop that spinning wheel with no more strength than he had to give, he reached out and grabbed a rope off of the back porch. As quick as a cat can climb a tree, he tied one end of that rope onto the brake for the fan, and then he brought the rope down under the lower framework of the windmill, and quickly tied the other end onto an old car that was setting on a slight incline. He got into the car and stood on the clutch. In less than another second or two, he had that wheel shut down and tied off.

I was frozen onto that platform, and he came up the ladder coaxing me to come down, but I refused to move. Then, he gave me a great-old-big grin and his A-O.K. sign and a heck of a lot of signs for encouragement and assurances that I did not know, but I understood, nevertheless. District Conservationist Leaving For Sherman SCS Office

Clyde resident and Soil Conservation Service's district conservationist Steve Uselton has resigned his position at Baird to accept a similar position in Sherman.

Uselton has been the district's conservations in the SCS office at the courthouse in Baird for the past five years. He will be leaving Friday to accept the district conserationist job in Sherman.

The Nocona native stated that he has some regrets leaving Clyde and Callahan County. "If it wasn't for the job advancement, Clyde is the type of town I'd like to stay in and raise my family," said Uselton.

Uselton has been associated with the Soil Conservation Service for 10 years. The SCS is a branch of the United States Department of Agriculture. He was previously a conservation planner in Canyon before coming to Callahan County five years ago. He has a agricultural education degree from East Texas State University.

Uselton said the new position is a promotion. As the top SCS man at Sherman, Uselton will have six employees under him. In the Baird SCS office, he had only one employee.

Range conservationist Tony Baeza, will assume the duty as acting district conservationist in the Baird office until a permanent replacement can be made Uselton said. He added that another conservationist will probably be named in May. Uselton said that the new district conservationist will be named by the area conservationist in Stephenville. Uselton said that Baeza is expected to apply for the head job here.

Uselton said that along the the job promotion he will only be 70 miles from his hometown of Nocona. He said his father still lives there and that factor had some bearing on his accepting the job in Sherman.

The SCS conservationist said that during his five year tenure in Baird, his biggest accomplishment was getting a countywide soil conservation district for Callahan County. The county had

previously been in two SCS districts in Shackelford and Coleman counties. The new SCS district for Callahan County is the Callahan Divide. He also said that during his stay here, his office has doubled the number of conservation contracts with county farmers and rancher. Callahan County began the Conservation Reserve Program under Uselton's guidance. The CRP program pays landowners lease on their highly erodible land to plant grass.

During his community involvement in Clyde, Uselton has served five years with the Clyde Jaycees organization and has held the offices of president, vicepresident, director and chairman of the board.

His wife, Dawna, teaches high school goverment at Clyde and is the annual staff sponsor. She has taught in the Clyde school system for four years.


The couple has two sons, Peter, age seven, a first grader at Clyde Elementary and Matt, age two.

Veterans Given First Chance To Bid On 332 Forfeited Land Tracts

AUSTIN - Texas veterans can now submit bids on 332 tracts of forfeited land being marketed by the Texas Veterans Land Board (VLB), Texas Land Commissioner Garry Mauro announced today. These tracts are set aside exclusively for bids from eligible Texas veterans and can be bought with no down payment.

The tracts, located in 117 Texas counties, range in size from five to 80 acres. Detailed information on the tracts and their location is available by calling toll-free 1-800-252-VETS.

The VLB will finance the entire loan amount of all winning bids. There is no limit on the amount loaned or on the number of tracts that an individual can bid on. However, eligible Texas veterans are limited to one land purchase in the sale.

"I want to encourage all eligible Texas veterans who have been looking for quality land to take advantage of this sale," said Mauro, who serves as chairman of the VLB. "Since these tracts have never been offered for sale by the board, this sale gives Texas veterans an excellent opportunity to buy good land with 100 percent financing.

Mauro noted that these tracts of land are offered exclusively to Texas veterans because the VLB has always given Texas veterans the first chance to buy forfeited tracts. If any of the tracts do not sell, they will be offered to the general public in the next sale through a marketing arrangement that allows Texas real estate agents exclusive rights to market the properties.

Eligible Texas veterans will receive an 8.75 percent interest rate with a 30-year assumable fixed-rate loan. A \$25 non-refundable bid fee for each bid submitted is required.

The sale will be by sealed bid only, with the minimum bid set by the VLB. All bids must be received by February 22, at 1 p.m. Any and all bids received after that time will be rejected.

Details of the sale and a brochure describing each tract and its location can be obtained by calling the VLB toll-free at 1-800-252-VETS.

A public reading of the bids submitted to the board will be held on February 22 at 1 p.m. in Room 831 of the Stephen F. Austin Building at 1700 N. Congress in Austin.
