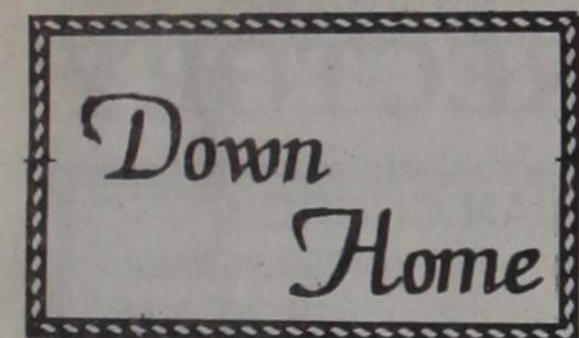

## Old Soldier Recalls Big War Memories

The guns have long since gone silent along the Western Front of World War I and so too have all but a few of the men who struggled in that great global conflict. One of the last survivors of that bloody carnage is a gnarled old, Cross Plains veteran who was in the forward trenches when the last shots were fired.

Like the rest of the nation this area sent the cream of its young manhood to that war. It was a war that saw America, England, and France pitted against Germany and the Central Powers. Today, Guss Simons, 94-year-old man, who lives alone at his little home on 9th Street, one block west of the city water tower, recalls his experiences in that war, one that people said was "to save the world for democracy".

Like most recruits of that day Guss was taught to shoot and salute and sent straight overseas. Germany's war machine was at first unstoppable. France and England were reeling near defeat when America entered the fight. Hundreds of boys from Callahan and adjoining counties were among the first replacements moved in to fill vacant files and blunt Kaiser Bill's forward thrust.

Simons, a youngster who had grown up in the Dressy area, four miles west of town, entered military service at Dallas. He was sent to Camp Travis at San Antonio. Shortly thereafter he marched up the gangplank for shipment overseas.

Guss remembers well the voyage across the submarine-infested Atlantic Ocean. His ship moved in a convoy

and was able to avoid the "German Wolfpack," as the sea raiders of the Central Powers were commonly called.

"We were a happy bunch to set our feet on solid ground at Brest, France," he recalls.

Being from Texas and having an understanding of horses and mules he became a wagoner, who hauled ammunition and supplies from forward depots to front line troops. Teamsters were required to stay off roads and move through woods and pastures to avoid barrages of German artillery. Often, though, the freighters fell prey to enemy gunnery. Casualties were commonplace. Once when his wagon train was hit by overhead shelling, Guss leaped out of his seat to hold his teams which were bolting amok with fear. One of his animals fell dead at his feet and the carcass of the beast became a breastwork. Guss was able to get under the dead horse and escape shrapnel which was falling like hail.

"I don't think I'll live long enough to forget how scared I was at that time," the old soldier declares.

In 94 years of living Guss believes he has never seen as much happiness as that shown by soldiers at the front on November 11, 1918. That was the day the war ended. It meant German surrender, end of fighting and that everyone would be going home. When night came flares, tracers, and every type of pyrotechnic the army possessed were fired into the sky. It may have been the biggest fireworks display human eyes ever beheld. Some said prayers of thanksgiving. Others hooped, hollered, or were spellbound with delight.

## New Proposal For Handling Trash Announced

The special meeting called by the City of Cross Plains last Friday evening was well attended, with approximately 75 to 100 present.

Brad Halbert, representing West Central Texas Council of Governments, began the program by explaining current demands by the Environmental Protection Agency. He noted that the entire country is facing the problem of safe waste disposal.

He has been working closely with the Council and commended them for being on target concerning the changes regulated by the E.P.A.

The City of Cross Plains has been challenged by a choice of three proposals in regard to trash disposal. The first choice is to continue the landfill, second, to haul its own trash to a privately owned landfill, or thirdly, contract for hauling trash with a privately owned company.

The expense of updating the present landfill to meet regulations was estimated at \$442,650 — just to get started. Halbert read in the Texas Municipal League Handbook that a city of less than 50,000 could not maintain their own landfill.

Should the City haul its own trash, the cost of a truck, insurance, employee, etc., which was determined by a study, would be a greater cost to the customer than contracting.

If privately contracted, the cost of this service would be approximately \$10 to \$12 per month to each meter. The Council determined that the

best solution to the problem at this time would be to contract for one year to a privately owned company. At the end of that period an evaluation will be made to see if the solution remains feasible.

The City of Cross Plains has already notified the Health Department that the landfill would be closed effective August 31 to the public.

Bids for the trash contract will be posted shortly.

Council is aware of the economic impact this will have on the community and will try to provide a service suitable for all residents within the city limits and hopefully those outside.

More information will be available concerning details after a contract is signed.

Roy Stambaugh recommended writing Bylaws for the Cross Cut Cemetery Association since the Bylaws which were supposedly written when the Association was organized in 1976 cannot be located.

The speaker for the afternoon was Bransford Eubank who gave an interesting account of the activities concerning what was to later become the Cross Cut Community. His reminiscing began about 1840 with the establishing of the army forts in this area. Fort Chadbourne near San Angelo; Fort Phantom Hill near Abilene; Fort Belknap near Graham; and Camp Colorado all played a part in the development of the area due to the travel between the forts. He related several stories which had been told to him by early day settlers. After 1900 his facts were from personal experiences; the first school house, the first post office, (including how Cross Cut was named); and his first church meetings when everyone slept in wagons and camped out. Mr. Eubank has contributed information, both published and unpublished, toward the preservation of the history of Cross Cut.

insurance costs do not go entirely to the roof when new rates are set in October and prepare to meet again in a second special session in November.

When the excessive verbiage of the last few days is examined, the obstructionism of the lawyer-labor bloc in the Senate becomes clear.

Their target is Rep. Richard Smith of Bryan, co-chairman of last year's Joint Select Committee that studied workers' comp reform and author of the House reform bill. Smith's great crime, in Senate-lawyer eyes, is that he wants to reduce the cost and enhance the equity and efficiency of the system by setting fair standards of compensation and by resolving disputes through administrative law rather than continuing the crap-shoot approach by which employers' costs and workers' benefits are both in the hands of personal injury lawyers and their counterparts in the insurance industry.

Smith and the House negotiators have offered compromises on the thorniest issues, including adjudication, but they have not surrendered to the lawyer lobby. For their efforts, they are the target of outrageous calumny.

### Velma Jackson

COMANCHE — Velma Jackson, 82, died Thursday at an Abilene hospital.

Services were at 10:30 a.m. Saturday at the Sidney Baptist Church with the Rev. Raymond Jones officiating. Burial was in Stag Creek Cemetery near Comanche, directed by Comanche Funeral Home.

Born in Cross Plains, she was a longtime resident of the Sipe Springs community.

She was a homemaker and a member of the Sidney Baptist Church.

Survivors include her husband, Whaley Jackson of Sipe Springs; a son, David R. Jackson of Austin; two daughters, Janis Lain of Hamlin and Frances Valentine of San Antonio; two sisters, Ruth Clark of Pecos and Jean White of Odessa; 11 grandchildren; and 11 great-grandchildren.

Sen. Ted Lyon of Rockwall became a big player in the comp battle when the Senate and Lt. Gov. Bill Hobby rejected their own co-chairman of the select committee, Sen. Bob Glasgow of Stephenville, and instead let the trial lawyer lobby dictate a Senate bill. Lyon complains that Smith is not a lawyer and therefore cannot grasp the comp issues.

That is patently ridiculous, especially in view of the widespread support Smith enjoys among lawyer colleagues in the House. Smith has spent the better part of the last five years (counting an earlier study group) concentrating on the nuances of workers' compensation systems in Texas and other states. He wants comp payments to go to workers rather than to lawyers. He understands the threat that the present litigious system poses to a healthy business climate in Texas.

Passing the bar exam does not confer either wisdom or candor on an individual, and Lyon is living proof.

Sen. Carl Parker of Port Arthur joins Lyon in his vitriolic campaign against Smith. The only hope is that cooler heads, such as Sen. John Montford of Lubbock, will eventually prevail and lead to an agreement.

All Texans must hope so. While the Battle of Austin is fought between self-serving lawyers and business-oriented reformers, the old chaotic comp system lives — and the state, its workers and its hopes for economic recovery all suffer.

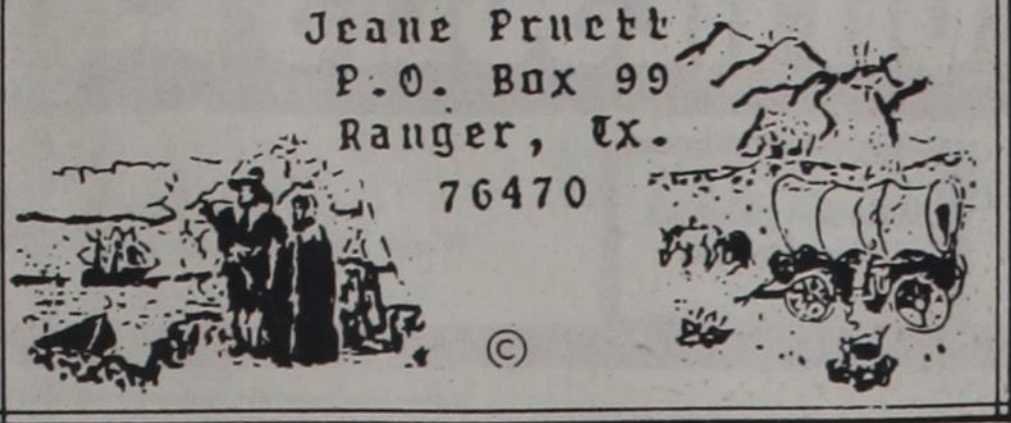

### Governor Announces New Energy-Saving Design Standards

AUSTIN — Governor Bill Clements today announced updated design standards for new state office buildings that could cut energy consumption by as much as 25 percent per year. The new design requirements apply to all building construction projects now undertaken by the state.

"These new design standards will translate into significant savings, not only for the agencies but for Texas taxpayers," the governor said.

"Texans demand and deserve a state government that is as cost-effective as possible. Energy efficiency must be a part of that goal."

The Texas Energy Conservation Design Standard is based on a model developed by the American Society of Heating, Refrigerating and Air-Conditioning Engineers, and was adapted to Texas climate conditions to optimize energy savings.

The new designs include higher insulation levels; more efficient heating and air-conditioning equipment; and improved lighting techniques, such as better use of natural light. The standard will be administered by the Governor's Energy Management Center. It replaces one in existence since 1977.

The state's utility bill is typically more than \$200 million a year.
