AmWest Savings Closing In Callahan County

AmWest Savings will be closing 12 banking branches in Texas, including all in Callahan County

AmWest Savings officials, headquartered in Bryan, said Monday, August 13, that the AmWest Savings branches (formerly Olney Savings) in Clyde and Cross Plains will be consolidating with branches in Abilene and Cisco.

The Clyde AmWest Savings branch is the largest of the 12 branches that plans to close. The Clyde AmWest branch lists assets of \$8.5 million, while the Cross Plains branch has \$7 million in assets.

According to AmWest official Glen Carter, the Clyde savings branch will be consolidated with the Abilene AmWest office, located at 1150 North Fourth Street. He said that the 1,100 accounts in the Clyde office will be moved to Abilene soon. The Cross Plains AmWest office will consolidate with the Cisco AmWest Savings branch, Carter added. Clyde and Cross Plains are the only two communities in Callahan County with AmWest Savings branches.

He added that customers using AmWest Savings can use any savings branch throughout the state, but only one location will have signature cards for the accounts.

Carter said that the closing of the 12 branch offices is "economics." He said that of the 1,100 accounts in the Clyde branch, 600 accounts have deposits of \$250 or less. He said that for a savings and loan to survive, each account needs \$800. He added that for AmWest to be profitable here, \$15 million to \$20 million in assets is

Carter said that the accounts in the 12 branches will all be consolidated with AmWest offices in nearby towns.

The AmWest officials said that because of several business accounts in Clyde, company officials will be looking into operating an office every business day morning in Clyde. Officials are now looking into opening a small office here.

The AmWest building in Clyde, located in the Callahan Plaza on the south access road of Interstate 20, will be sold Carter said.

AmWest officials said that all employees, in the 12 branches that consolidate, will be relocated to other branches. Carter said that the three AmWest employees in the Clyde office have been offered positions in
