A sunrise breakfast at Fort Concho in San Angelo started out a full day of activities surrounding the Fiesta del Concho, which is held annually. Pancakes were served to approximately 6,000 people on the parade grounds of the fort by the Lions Club. Everyone was extremely friendly, as strangers shared tables for the delicious meal.

A flag ceremony performed by the calvary, complete with original uniforms or reproductions of the ones worn during that time era, brought everyone to their feet.

A sheep shearing contest was in progress as part of the Fiesta del Concho Frontier Day 1990. If you have never seen one, it is amazing how the shearers remove the wool in one large piece, which is closely examined by the judge to determine the winner. The sheep didn't put up much of a battle and very little bleating was heard.

Next, there were the sheep dog trials. Trainers and their dogs, complete with whistles and staffs, carefully herded a half dozen sheep into the designated pen. The one with the best time won the competition.

the rock barracks and officer's quarters, which have been refurbished. You could watch butter being churned, lye soap processing, wool being spun into yarn, and one lady was sewing on a peddle sewing machine. A blacksmith was actually making horseshoes, and corn was being milled with a machine dating to the 1800's.

The infirmary at Fort Concho had been restored with iron bedsteads and mosquito nets. Medical equipment, including an iron lung were on display. Looking at the antiques really makes you appreciate modern technology.

The fact that they had no airconditioning was another inconvenience. The ladies wore long dresses with a pinafore or apron over them with all the can cans, plus high-top, lace-up shoes. The soldiers' suits were made of wool. How did they tolerate the heat? We decided they didn't know anything else and they were more accustomed to it.

A quilt exhibition was beautiful, as they garnished walls of the San Angelo Museum of Fine Arts. Every pattern was represented and the colors and skill spoke for itself.

These were just some of the highlights of the morning activities. Then we drove to the downtown section and browsed through several antique stores. The stores are actually old buildings which have been restored. The fronts look like something you would see in a movie, while the interior was filled with glassware and articles from the past. Miss Hattie's was the most memorable, as it was once a saloon and the lady of the evenings' rooms upstairs can still be toured by groups with reservations.

During the afternoon we walked the river walk beside Concho River and visited the booths set up in the park. There were all types of food, drink, arts and crafts, and children's games available for everyone's entertainment. Boat rides were available on the river and armadillo races were being held.

After a refreshing swim in the pool, we rested briefly and headed back to the river walk for the parade at 8 p.m. People brought their lawn chairs and quilts and sat on both sides of the road awaiting the start of the procession.


First Baptist Church **Presents Special Film Production**

City Council Minutes

This was a regular meeting of the Cross Plains City Council. Members present were Mayor Ross Gerking, Ted McKeehan. Donald Beeler, Betty Lewis, Edwin Weiss, and Leon Nixon. Also present were Gene Dillard and Delilah Goble, Billy Jacobs and Dayton Robertson.

The meeting was called to order at 6:30 p.m. The minutes of the last meeting were approved as read.

First on the agenda was Dayton Robertson. Dayton informed the council of the developments on the new city hall. He informed the council of the findings of the contamination on the city hall property and that all testing had been completed and all necessary papers had been sent to the state. Billy informed the council that hopefully when the new sewer treatment plant was built we would be able to use the contaminated dirt as fill dirt. Billy also informed the council that they were working on the sewer treatment plant and that bids would probably be let in July or August. Billy asked the council to consider getting a discharge permit from the state to have just in case we may need it if something should happen and we need to discharge into Turkey Creek during the rainy season. He also told the council that we need to sign an agreement between the city and Bobby Dillard that he is willing to use the water off of the sewer farm according to state standards. Billy will draw up this agreement as soon as possible and as simple as possible. Ted McKeehan moved to pursue the discharge permit. Donald Beeler seconded and motion carried.

Discussion was held on the water cooler at the community center. The cooler has had a leak for several months and the coils have a leak located in the cooling unit. Ted McKeehan made the motion to take the water cooler out of the community center. Betty Lewis seconded and motion carried.

Delilah Goble met with the council to discuss getting some caliche hauled on the lane past her home leading to Reba Lane's. The secretary informed her that this street was on the list of streets that were to be hauled and that in the near future this would be done.

The Arbor Day Foundation is a nonprofit education organization dedicated to tree planting and conservation. The Foundation has more than the Foundation graphically describes the adverse consequences of irresponsible topping versus the positive results that come from competent pruning.

The Bulletin describes how correct pruning techniques can be utilized to reduce the height of a large tree without topping. It also shows how utility companies can carry out line clearance pruning in a way that avoids topping and maintains the natural form of the tree at decreased costs.

The Bulletin also describes how to properly remove tree branches to maintain trees' health, appearance and safety.







American families are being asked to offer hospitality to ten Hungarian high school exchange students who are scheduled to arrive in the United States in late August. The exchange program with Hungary is administered by OPEN DOOR Student Exchange and supported by the United States Information Agency and Hungarian Government. In addition, the Soros Foundation in our country has agreed to provide scholarship money to increase from 10 to 20 the number of Hungarian high school students arriving annually to the United States by way of OPEN DOOR. **OPEN DOOR's 5-month reciprocal** exchange involves a total of 20 Hungarian students arriving during the 1990-91 school year (10 students in August 1990 and 10 in January 1991) and spending a semester in the United States while attending an American high school and living with an American family. This August 10 American students will also travel to Hungary to live with host families and attend their local high schools. After their arrival to the United States, the Hungarian students will spend four days of orientation in New York along with secondary school students from over 20 countries before leaving for the cities of their host families. OPEN DOOR, a 25-year-old notfor-profit international high school exchange organization based in Hempstead, New York has active programs with 33 countries throughout the world and is one of the first to establish a long-term academic exchange with Hungary. Along with newly established programs in Eastern Europe and the Soviet Union, OPEN DOOR offers programs with such diverse countries such as Japan and Thailand, Israel and Egypt, Germany and Spain, and most countries in Latin America. 
Wes Parker plays Larry Sanders whose marriage is on the brink' of disaster because of his unfaithfulness and his wife's unwillingness to forgive.
