# 'The Rest Of The Story'

For the past four years I have written many stories about the local Emergency Medical Service in an effort to promote their heroic actions in times of need. During those interviews it was always from an outsider's viewpoint, as I am not a member of the EMS volunteers.

The last time I photographed the EMS vehicle I was impressed by its updated interior and medical capabilities. I made the comment to Rolan Jones that I hoped I would never have to experience the use of the equipment personally, but felt that it was very efficient.

I barely got the words out of my mouth before I had a personal experience. Recently, I was rushed to Hendrick Medical Center with symptoms of high blood pressure, difficulty in breathing, and drawing and tingling of extremities and face.

Knowing both the volunt Evans and Rolan Jones, was a comfort to me, but I am sure that being acquainted with the patients makes the duty much more stressful for them.

The professionalism and speed with which they delivered me to the emergency room was impressive. I feel that the oxygen that was used on the trip was responsible for the lowering of my blood pressure 20 points, due to its calming effect and ability to improve breathing.

I also applied a relaxation technique which I learned many years ago at a twirling school. It consists of telling your body to physically relax beginning at your toes to the top of your head. Then you think only of calming and pleasant past events that remove consciousness from the present circumstances. This process has come in handy on several occasions, so maybe you can benefit from the simple procedure in a stressful situation.

However, I have to tell you that I did a lot of praying on the journey. I kept thinking I just wanted to live to raise my children, Blandye, Leah and Kye. At one point, I suddenly recalled the verse concerning two or three gathering together in the name of the Lord. I requested Guy to pray with me and he graciously did so, and understood completely. There have been so many times in my life that individual praying and prayer groups have made the difference for my family. I want to give God the glory for every blessing.

After blood tests, etc., the physician determined that I had an allergic reaction caused by combining aspirin and a prescription medication I take regularly. In some cases these can be fatal, but I feel that the quick thinking of the EMS volunteers and with help from

above, I was very fortunate. I have learned that the Cross Plains EMS is one of the most dedicated and well trained in the area since the incident, and we are so lucky to have them in our community. The time they spend on call alone is very demanding and expresses their feelings toward their fellow men.

I have never made the trip to Abilene in such a short time, and probably never so bumpy, but I was just thankful to be alive. The personal attention I received will always be remembered, as I am appreciative of their kindness.

Keeping the EMS strong and active is of utmost importance to the residents of Cross Plains. Thanks for being there for me.

The Cross Plains Public Library is just that - A PUBLIC LIBRARY. It does not belong to the city. It does not belong to the county. It does not belong to the Library Board. It belongs to YOU. An emergency exists at your library today. The roof has finally given up after having been pat-ched each year and the time has come to have it replaced. Both estimates for this job come close to \$4,000. Because the library budget is not sufficient to handle this extraordinary expense, Callahan County and the City of Cross Plains have pledged to donate \$1,000 each for this purpose.

The Library Board assumes that the Cross Plains community wants a library. The circulation of books, the use of the facilities, and the remarks of praise and appreciation confirm that assumption. But words will not pay for the problems that the library faces at this time. Although the financial report has been published, we believe that individuals simply do not realize that there is not a group or organization somewhere totally funding the library. THERE IS NOT. It depends on you.

We believe that pledges are one answer - from people who will pledge support each year, whatever it may be. The library is yours. It does not belong to either the city or the county. It is a non-profit organization with only one paid employee. Volunteers make up the Board and try to find enough money each year to keep the facility going. We hope you will think seriously about pledging annual support and help the library stay a valuable part of a "Caring Communi-



#### Secretary Of State George Bayoud Says Primary Runoff Turnout Hightest Since 1972

AUSTIN — Texas recorded its highest primary runoff election turnout since 1972 on Tuesday when more than 1.2 million people cast ballots in the Democratic and Republican party runoffs, Secretary of State George Bayoud said.

The runoff turnout is the highest since 1972 when more than 2 million Texans went to the polls to nominate candidates for governor and other of-

On Tuesday, Texas voters at the statewide level nominated Democratic Party candidates for governor, treasurer, the Texas Supreme Court and Texas Court of Criminal Appeals and Republican Party candidates for land commissioner and agriculture commissioner.

The runoff turnout represents 15.2 percent of the state's 8.3 million registered voters. In the March 13 primary, 28 percent of the state's registered voters cast ballots. The March 13 turnout was the highest primary election turnout ever in a non-presidential election year and the second highest total for any primary election in Texas history.

"The runoff turnout exceeded our expectations," said Bayoud, the state's chief elections officer. "I am particularly pleased that we have reversed a historical trend in which runoff turnouts drop substantially from primary turnouts."

Historically, the drop in turnout from the primary to the runoff is at least 50 percent, election records indicate.

Bayoud encouraged all Texans who are eligible to vote to do so in the November 6 General Election. The deadline to register to vote in that election is October 7.

"If you are not registered, you have plenty of time to do so between now and the registration deadline," Bayoud said. "It's imperative that as many Texans as possible participate in the democratic process by registering and voting."



#### Disabled Children Local Student Attends

The Social Security program pays benefits to the children of retired or disabled people receiving Social Security benefits. Benefits can also be paid to children of workers who died. Any child under 18 may be eligible for benefits. And a child over 18 may get benefits if he or she is disabled and the disability began in childhood - before

The disabled child need not have started getting benefits before age 18. Benefits can start at any age since entitlement to benefits depends on the parent's death, disability, or retirement. For example, suppose John Smith, who has a 40-year-old developmentally disabled daughter living with him, is planning to retire. Chances are his daughter would be able to collect benefits when he retires. She probably could also get

The SSI program is somewhat different from Social Security. It pays monthly benefits to disabled people with limited income and resources. The age at which the disability started has no bearing. Disabled people of any age who qualify - young or old - can

A disabled child under 18, who lives with his or her parents, can qualify for SSI payments only if the income and resources of his or her parents are limited. However, once a child turns 18, the parent's income and resources no longer count. If the child has little income and few resources, he or she

Sometimes disabled children who live in institutions might be able to leave and live outside the institution if they had an income. In many cases, that needed income could come in the

If you have a disabled child who may be eligible for either Social Security or SSI benefits, call, write or visit any Social Security office. The people there will be glad to give you more information and assist you in completing an application.

# Cold War Really Over?

He has now managed to gather to himself more personal power inside the USSR than any one man has ever had before, even Stalin. And at the same time, with the help of some of our politicians and news media, he gives the appearance of doing just the opposite, even losing

The governments of the Captive Nations seem to be changing, too. But if you look closely you will see that the dreaded secret police and the army are still controlled by the dictators who can slap the lid on again any time. What looks like "freedom" is mighty shaky. In his article, "Is The Cold War Over?", John F. McManus of the John Birch Society points out that "you can bet your bottom dollar that the arch criminals who have climbed over the corpses of tens of millions to establish Communist-led tyrannies in nation after nation are not going to walk meekly away from their seats of power. Nor are they going to permit real political and economic freedom to challenge their control."

Gorbachev has repeatedly stated that the goal of his perestroika program is to strengthen socialism, world socialism. Socialism is what they have had for years that has resulted in so much misery and horrible bloodshed. (We used to call it "communism" but that is not the style anymore.)

The alarming thing is that our President Bush says that he will "support perestroika". And last year he told the graduating class at Texas A & M University that his objective is to welcome the Soviet Union back into the world order.

I don't believe that the American people want a new world order run by the Soviet Union. Of course not. We don't even want a new world order that collaborates with the Soviet Union. If we stop long enough to think things out, we don't even want a new world order. We want to be free and keep our independence. The John Birch Society slogan: "Not World Government! Keep US Independent!"

# War On Drugs Does Not Get Community Support

And then, there are those of you, who believe in your hearts, that IT doesn't affect you.

IT, of course, is drugs.

On March 17, our community had the opportunity to support the fight on drugs in our area. About 35 entertainers and volunteers donated not only their fine talents, but their own travel expenses, to raise funds for the West Central Texas Interlocal Crime Task Force. Food and soft drinks were donated to help sustain performers through two performances. Printing of programs were donated; advertising was provided as a community service; volunteers worked for days, weeks and months to put on shows that were outstanding. It was 31/2 hours of country music, barbershop singing, bluegrass, comedy and gospel. Proceeds were to provide the desperately needed funds to be able to continue the work of the Task Force to fight the war on drugs.

But, there was a shocking lack of support from our community for the cause, for the efforts, and for the need. Tickets were only \$5, the price of a movie ticket, a few games of bowling, a quick meal - and every dollar went directly to the Crime Task Force. Out of a 14 county community, consisting of almost 300,000 people, only 200

came to support the event.

Maybe this entertainment is not everyone's favorite. Maybe everyone was busy Saturday afternoon and Saturday evening. Maybe no one in the community has had a son, daughter, mom or dad affected by drugs or drug dealers. Maybe no one in the community has ever been robbed, burglarized, mugged, defrauded, lied to or cheated out of anything because of drugs. Maybe taxes don't go up annually so more people can be hired to deal with the problem. Maybe there is a Utopia. But, chances are you do know someone who has, and taxes do go up every year because of it. There is no Utopia.

Locally, our Crime Task Force must raise 14 of their own funds to keep operating and keep the struggle with drugs going. The President's declaration of War on Drugs is only % of what we need — we in our community are responsible for the rest. In general terms, it translates into only one dollar from each person in our area.

We didn't have an entertainment star or Hollywood name in our corner to raise big dollars and convince everyone this is a good cause - but, we shouldn't have to. We should have been able to carry this off with just keeping the "Main Thing" the "Main Thing" - and that is getting drugs out of our communities.

After all, everyone is talking about what a problem this is and about how "those" people need to do something. Unfortunately, I've discovered that "those" people who are fighting it are getting beat, frustrated and worn out. They're fighting a battle they didn't create for people who seem to not care, under conditions that, at best, are bad enough for the rest of us to avoid working under.

For those of you who do help fight — GOD BLESS YOU!

For those of you who support those who fight it - THANK YOU!

For those of you who are apathetic and tired of hearing about it - I PITY Your world is not real and when

reality hits, it'll be hard and heartless.



#### Bright Future For Glass Containers

Glass container shipments were up 1.3 percent in 1989, according to a recent U.S. Department of Commerce report. And the same report predicts glass growth at about 1% per year through 1994.

The report, U.S. Industrial Outlook 1990, claims that environmental issues will have a great effect on the growth of the glass container industry, particularly with the increasing legislative and regulatory bias against plastic.

Retailers such as Wal-Mart and successful food store chains are not only responding to consumers' new found environmental consciousness, in many cases they are leading the movement. Consumer education programs and recycling opportunities are surfacing all across America's heartland in an

increasingly "green" marketplace. And in every case, 100% recyclable glass is featured as a preferred container that can be purchased with confidence. Ederer noted that, "On an average, every glass container on the market today contains about 30% recycled content. The glass industry is confident that these factors, together with microwaveability and the premium image glass containers enjoy all add to a very bright future for

glass." The MidAmerica Glass Recycling Program is an eight-state promotional and educational effort of the Washington, D.C.-based Glass Packaging Institute. The MidAmerica program is headquartered in Bella Vista, Arkansas.
