

Dr. Fowler is a native Texan, having graduated from Killeen High School before attending Southwestern University. Entering the Missionary field in 1957, he held a number of appointments in schools and churches in the South Pacific area; primarily in Malaysia. He returned to SMU between appointments and attended Perkins School of Theology. In 1976, he attained a Doctorate of Ministry Degree in Evangelism.

This led Dr. Fowler back to the South East to become a faculty member of the South East Asia Graduate School of Theology for the Burma-Malaysia-Singapore-Thailand ar ea. He has also served on the General Board of Global Ministries and just last year was a delegate to the Global Consultation on World Evangelization in Singapore.

## **Jody Brown Captures Gorman Track Award**



These funds come primarily from public contributions.

The Bike-A-Thon program this year is dedicated to Ellen Marie Haynes. Five-year-old Ellen Marie, from Rossville, Georgia, developed a malignant tumor in her abdomen in June, 1986. After treatment at St. Jude Children's Research Hospital, which consisted of surgery, radiation, and chemotherapy, Ellen Marie was taken off all therapy in January, 1987. Although she isn't cured of her cancer yet, her prognosis is good.





We let this be our omen that "slowly but surely" the note at the bank will be paid and with careful planning and perseverance the museum will be a reality. Until the house is free of debt, the purpose of preserving it and making it functional for use is the goal of Project Pride.

In order to preserve, elbow grease and energy are required; spending on-

ly as the money is available. If this property can be kept intact and presentable until "our ship comes in," then at that time, we can find the ways and means to turn the house into the ultimate museum of which our organization and community will be proud.

## **1990** Decennial **Census:** Delivery **Began March 23**

The Postal Service began delivery of the 95 million census questionnaires on Friday, March 23. All delivery was to be completed by Tuesday, March 27.

The Bureau of Census is encouraging recipients to complete the questionnaire and return it in the postagepaid envelope as soon as possible. They hope to have all of them back in the mail by the first of April. The Postal Service will deliver a reminder note to all addresses on Friday, March 30.

The return envelope has been especially designed to facilitate handling by the Postal Service. A unique ZIP Code plus the four digit add-ons and a corresponding bar code will enable the Postal Service to sort the mail by means of high speed automated equipment to Census district offices and processing centers.

The add-on ZIP Codes and barcodes will also allow sorting by long or short form, and single-family or multifamily address.

The Bureau of Census will reimburse the Postal Service for the operational and mailing costs amounting to approximately \$70 million.

The Postal Service adds its encouragement for everyone to participate in this extremely important event.





and a half-dozen of the other whether I bought it on time or through leasepurchase. I was never more wrong.

Here's what I mean about a lease being a good deal for the automaker. Not only is a sizeable amount of interest figured in the monthly payments, but the lessee (that's me) also has to pay all the taxes and license fees.

Also, the automaker makes you shell out several hundred bucks for an extended warranty policy over the term of the lease and, of course, you have to pay for the insurance on the vehicle.

But, here's the kicker. If you want to buy the car at the end of the lease term, you have to shell out the market value of the car at the time, which is several thousand bucks.

So, what it all boils down to is, you pay for a car over four years and then have to buy it after that. Now, if that's not a good deal for the automakers, I don't know what is.

Oh, yeah, I almost forgot. In a lease, there is a limit to the number of miles you can drive. If you exceed the limit, you have to pay extra.

The carmakers argue that by leasing, you can always be driving a relatively new car. You can always have car payments and never own a car, too.

They also argue that there are tax advantages to leasing. But it has never been explained to me just what those advantages are, and I can guarantee you that whatever they are, they don't nearly stack up to the extra money you'll be spending.

I know you're going to say I should have read the contract before I signed the lease. You're right, I should have. But I didn't, so now you can profit from my mistake.

While on the subject of car financing, I read a story the other day that when you buy a car on a five-year pay-out, you do not have any equity in it until the 24th payment is made. In other words, for the first two years, you're paying interest. That's ridiculous.


