## Candidate Filings Still Underway For Democratic Primary Elections

Only one candidate filing was reported during the past week of filing for the Democratic Primary Election, Democratic Party Chairman Jon Hardwick said.

David Blalock, the incumbent County Constable from Precinct #1 (Clyde), filed for re-election Monday, December 11. Blalock, 49, has resided in the state and in the county all his life. He lists his occupation as a farmer/constable. Blalock resides at 9069 FM 604 South in Clyde.

Blalock and the two incumbent commissioners are the only candidates to file for the upcoming Democratic Primary Election, Hardwick said as of December 11.

Harold Hicks, Precinct #1 commissioner from Clyde, and Tommy Holland, Precinct #3 commissioner from Baird, both filed for the Democratic Primary Election on December 4.

Those county public offices which will be up for election in 1996 include: County Attorney, County Commissioner Precinct #1, County Commissioner Precinct #3, County Sheriff, County Tax Assessor-Collector and all three County Constable places in Clyde, Baird and Cross Plains.

Candidate filing for the Democratic Primary Election began December 3 at the offices of the Hardwick Company on West Highway 80 in Baird. Democratic Party County Chairman Jon Hardwick

can be reached at (915) 854-1256.

Hardwick said besides being a resident of the county, a registered voter and over the age of 18, candidates are required to pay a filing fee to be placed on the primary election ballot. The filing fee for the office of County Attorney is \$1,000. The filing fee for County Sheriff, County Tax Assessor-Collector and County Commissioner is \$600. A filing fee of \$300 is charged for a candidate running for the office of County Constable.

Filing for a place on the Democratic primary ballot will continue until 6:00 p.m. on January 2, 1996, Hardwick said.

The Democratic Primary Election Day will be March 12, 1996 in Callahan County. Early voting for the primary election will take place from February 21, 1996 through March 8, 1996.

All individuals wishing to file for a county office position in the upcoming Democratic Primary Election are required to file a campaign treasurer form with the county clerk, according to the Texas Election Code. The campaign treasurer form may be obtained from the office of County Clerk Darlene Walker at the Callahan County Courthouse in Baird.

Individuals must file the campaign treasurer form with the county clerk before filing with the Democratic Party county chairman, Hardwick noted.

**Annual Windbreak Tree Sale Underway**

"The annual windbreak tree sale offered by Callahan Divide Soil & Water Conservation District is now under way", says Clint Rollins, District Conservationist for the Natural Resources Conservation Service in Baird. Orders will be taken until February 13th and will be sold to the general public on a first come, first serve basis.

This years selection of Evergreens includes the Afghanistan Pine, Arizona Cypress, Austrian Pine, Pinyon Pine and Eastern redcedar. These evergreen seedlings are being offered for \$2.50 each or 30 for \$65.00.

In addition to the evergreens, several varieties of bare-rooted hardwoods are being offered this year. These varieties include Russian Olive, Catalpa, Green Ash, Hackberry, Shumard Oak, Chinkapin Oak and Nanking Cherry. The bare-rooted hardwood seedlings are sold in bundles of 100 for \$35.00 or 25 for \$10.00.

Tree orders will be taken until 4:30 p.m. on February 13th or until supplies run out, whichever comes first. The expected date of delivery will be February 14th. All orders are pre-paid with a check or money order and delivery is guaranteed. These trees are delivered fresh from the Texas Forest Service Nursery located in Lubbock. The pick-up location for the trees will be at the Natural Resources Conservation Service Office in Baird.

**EPA Agrees To Streamline Section 18 Process For Texas Cotton Producers**

ABILENE—Administrators with the Environmental Protection Agency have agreed to streamline the Section 18 process to give Texas cotton producers quicker access to chemicals necessary to combat such devastating cotton pests as the beet armyworm, tobacco budworm and aphid.

This agreement came during a meeting between Texas Boll Weevil Eradication Foundation Inc. officials and the EPA in Washington, D. C. last week. The meeting was set up by Congressman Charles Stenholm at the Foundation's request.

Craig Shook, vice chairman of the Foundation's board of directors, Frank Myers, Foundation executive director, and representatives from the offices of Congressman Stenholm and congressman Kika De La Garza, met with the EPA administrators to voice their concerns about the lack of timely availability of certain chemicals such as Confirm, Pirate and Furadan to Texas cotton producers during the 1995 season.

The losses cotton producers experienced in 1995 could have been minimized had the mechanisms been in place to quickly deploy the proper chemicals," said Shook, who also represents the South Texas/Winter Garden Zone which is scheduled to begin its boll weevil eradication program in the fall of 1996. "Under normal circumstance, it takes up to 50 days for EPA to grant an exemption for use of a Section 18

chemical such as Pirate and that's simply too long when the beet armyworm can completely devour a cotton crop in four days."

"Streamlining the Section 18 process is essential if we are going to give our cotton producers the tools they need to combat the cotton pests that can devastate a healthy crop in days," Stenholm said. "I believe the meeting between the Texas Boll Weevil Eradication Foundation and EPA officials was both important and educational for both sides, and I am hopeful we will see very positive results in the months ahead."

Under the Foundation's agreement with the EPA, the Texas Department of Agriculture will develop the paperwork necessary for the usage of these chemicals by sometime in January.

"This requirement is critical," said Myers, "because growers begin planting cotton in the Valley in February, as early as March in the Coastal Bend, and the paperwork needs to be in before then."

The documents will contain provisions for EPA issuance of Section 18 exemptions based on predetermined thresholds. These thresholds have not yet been worked out, but Steve Johnson, EPA's director of the chemical registration division, will meet with officials from the Foundation, TDA and the Extension Service to work out the details.

"That meeting should take place within the next month or so," Shook said.

**CALLAHAN COUNTY CLARENDON NOW ON MICROFILM**

The Callahan County Historical Commission has microfilmed the 1879-1885 issues of the weekly *Callahan County Clarendon*, the first Callahan County newspaper. This was announced Tuesday, December 5, by Chairman Russell Chatham at the Commission's December dinner meeting at the West Side Story Restaurant in Cross Plains.

The *Clarendon* was first published in Belle Plain and then moved to Baird. A print of the roll of film has been presented to Sonia Walker, librarian of the Callahan County Library at Baird, where it will be available to the public. Ms. Walker had made the original suggestion that the *Clarendon* be filmed.

History instructor Lee Abernathy, Commission Member of Abilene, Texas, has reviewed the film of over 600 frames and reports that the old newspapers were in good condition and the quality of the film is excellent, and much of the story content is of great local interest. The number of missing weekly issues, itemized by Abernathy, totaled about the equivalent of one year for the period 1879-1885.

Of the several editors and co-editors of the *Clarendon*, William R. Lotz was the principal owner, and the collection of old issues was handed down through his descendants. The collection now is in the Special Collections Division of the Library of UT-Arlington. The microfilming was done through their

cooperation, and paid for by the Callahan County Historical Commission.

Mr. Abernathy and the Commission would like to obtain more historical information about William R. Lotz. It is known that he was a native of Dortmund, Germany, and at the age of 30, married Ada M. Rust at Belle Plain in Callahan County in 1880. Her father, Albert D. Rust, was also in the printing and publishing business, and co-editor of the *Clarendon* for a while.

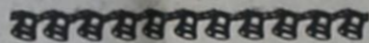

We hear a lot about self-esteem -- and it is an important ingredient of our lives. Someone has said: "We spend our young lives trying to build up a head of e'steem; when we boast, we're letting off e'steem; and we quit when we run out of e'steem." Well, a little play on words there but it makes the point very well -- the importance of self-esteem.

A simple definition of self-esteem (or self-concept) is simply "What a person thinks of himself/herself". Self-esteem is healthy when we have a good feeling about ourselves, based upon a realistic and honest appraisal of ourselves. People who feel good about themselves feel better, are happier, and are better adjusted than those without a good sense of self-worth. (That's another good, simple definition of self-esteem -- "self-worth".) The wise man Solomon, writing for our Maker, said, "As a man thinks in his heart, so is he." Proverbs 23:7. One who suffers from a feeling of inferiority and low self-esteem will not be able to confront life from a joyful, confident position; one who does feel good about himself/herself will!

Most self-esteem is developed during childhood -- for better or for worse. # TEXAS COURTS STYMIE EFFORTS TO PROSECUTE DWI CASES

Drunk driving is a serious problem in Texas. Between 1987 and 1990 about 301,400 drivers caused more than 352,000 DWI events. Texas law enforcement officers have few tools with which to fight drunk driving in Texas, yet Texas courts have worked against sober Texans in a number of important decisions.

ATAC believes it is important the public is aware of these adverse rulings.

In a recent example, the Austin Court of Appeals reversed a DWI conviction on the grounds it is not an officer's job to render aid to a motorist.

The facts are these: An Austin police officer saw a Lincoln Continental traveling at an unusually slow speed on the frontage road to Interstate 35. The lights on the car were switching between high and low beam. The man driving the car

had his head down close to the steering wheel. Worried the driver was falling asleep or experiencing some medical problem, the officer stopped the vehicle. The policeman then discovered the driver was intoxicated, so he placed him under arrest.

The local court convicted the driver of DWI, but the case was appealed on the grounds the policeman had no reason to stop the vehicle. That is, concern for public safety was not a valid reason for pulling over a motorist. The State argued that part of a police officer's job is a "community caretaking function," a function which most Texans who work outside a courtroom can appreciate and understand.

The State is now asking the Texas Court of Criminal Appeals to review the Austin Court's decision. The case,

*Rheinlander v. State*, was argued on October 11 and a decision is pending. The State is asking the highest criminal court to consider the overwhelming number of cases which support a "caretaking" role for police and reverse the appeals court. (Ironically, the Austin Court of Appeals cited a Texas Court of Criminal Appeals' precedent in deciding that an officer can stop a driver for criminal conduct only.)

If the Criminal Appeals Court rules otherwise, Texas could be the only state in the union where an officer has no "community caretaking" role.

The *Rheinlander* case is also important because the Texas Court of Criminal Appeals has a history of stretching logic to overturn DWI convictions. One such example, is *Erdman v. State*. Here, the court reversed the DWI conviction of a driver who was found weaving from lane to lane on a Harris County Highway on the grounds he was "coerced" into taking a breathing test.

In March 1989, a deputy sheriff stopped the defendant and watched as he stumbled out of his Mercedes smelling of alcohol. The trooper believed the defendant was "highly intoxicated" and radioed for a DPS trooper to take him to jail.

The defendant refused to take a breath test when he arrived at the jail, but later asked the trooper about the consequences of refusal. The trooper explained that no charges would be pressed if the defendant passed the test, but that he would be charged with DWI if he failed. He told the defendant that if he refused to take the test his license would be suspended for 90 days and the refusal could be used against him in court (the required legal warning). The trooper also explained that a refusal would result in a DWI charge and that the defendant would spend the night in jail.

In the trooper's experience, this was the normal course of events.

The Texas Court of Criminal Appeals was offended by the trooper's straightforward response, finding the explanation "coercive." According to the high court, breath tests are voluntary, and the trooper's prediction of upcoming events (no matter how accurate) somehow violated this "right to refuse" a breath test.

The Court of Criminal Appeals made this decision despite a landmark precedent in their own court (*Forte v. State*) which explains that why a DWI suspect has no legal right to refuse a breath test. In Texas, simply operating a motor vehicle upon a public highway implies such consent.

WASHINGTON, D.C.—Congressman Stenholm is now accepting applications from college students and educators interested in participating in the 1996 Washington, D.C. Internship Program.

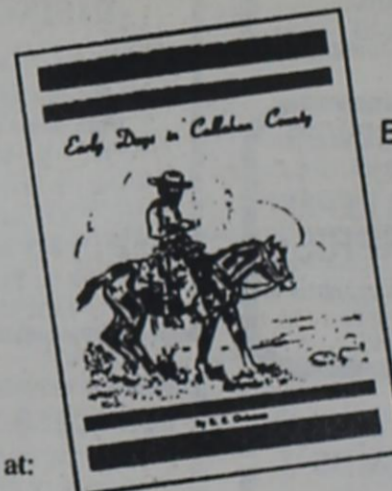

## NEWS FOR VETERANS

1994 MEDICAL REIMBURSEMENT—Word has come from the Texas Veterans Commission to the effect that 1994 Medical Expenses must be received by VA before December 31, 1995. It is stated that no reimbursements will be made for expenses turned in after December 31, 1995.

Veterans and dependents are also reminded that 1995 expenses may be turned in after January 1, 1996.

FORFEITED LAND SALES—A new catalog of forfeited land tracts has been received from the Texas Veterans Land Board. Sales are through the TEXTRAC II program and purchases must be made through a broker or real estate agent. It is vital that all Veterans stay in touch with our Washington representatives to insure that issues concerning Veterans are given proper consideration.

## Rabies Packets Dropped Locally

The Texas Department of Health (TDH) will conduct an upcoming rabies control project in which packets of rabies vaccine enclosed in small cubes of flavored dog food will be airdropped over a 55-county area to immunize gray foxes against the disease.

Scheduled to begin in late January, the massive project is an attempt to control a gray fox rabies epizootic in West-Central Texas. Some 738 cases of rabies have been reported in 45 area counties since 1988, including 219 cases in 1995.

Counties in TDH's Public Health Region 2/3 included in the drop zone include: Comanche, Erath, Eastland,

Callahan, Shackelford, Taylor, Jones, Nolan, Fisher, Scurry, Mitchell, Borden and Howard.

The project will be conducted in cooperation with the U.S. Department of Agriculture's Texas Animal Damage Control Branch, headquartered in San Antonio.

The airdrop technique was initiated in Texas last February when some 850,000 vaccine-containing baits were dropped in a 40-mile deep band across the state south of San Antonio to stem the spread of a South Texas epizootic of canine rabies in coyotes.


