The good news come this morning of the U. S. senate committee doing one good thing in making a big cut in the rivers and harbor bill. It is said the cut is "horizontal" and deep, and that the portion falling to the Trinity river steal is 25 per cent on the cash appropriation and 33 per cent on the contract. Much as is abused the ship subsidy bill, the river and harbor bill is about on a par with it in infamy. Both are concerted steals for the benefit of the few, one for shippers and the other for the landlords. To make lands on the Trinity and lots in Dallas high and hard to get, the owners would ask the people to put up the cash. The man who upholds the one of the appropriations has no reason to censure the other.

It seems our state legislature is determined to disfranchise the portion of our citizenship that depend solely on their physical labor for support, by requiring a poll tax receipt as a prerequisite to the ballot. The prime reason for doing so is, of course not to limit the privilege of voting, oh no; but to force the payment of the tax. Why not prohibit, in the same way, the man's privilege of marrying—not to restrict marriage, of course not—but to make him pay his taxes? Of the two, this prohibition would have double advantage of the poll tax receipt—it would go deeper, and stop the breed of the cuss. The prohibition of any privilege would be more justifiable, and a deal more in accord with the spirit of free government, than a restriction of the ballot. Nothing would be more menacing to us, however common the class may be. It is already too hard to get men to the polls, without offering any subsidy to further discourage them. What we rather need is a badge of honor for every sovereign vote that can be got. Our danger is not in extending the ballot but in restricting it. The next move presumably, will be an educational test, next a property qualification—to especially enthrone plutocracy and dethrone the republic.

Tom L. Johnson is to deliver the principal address at a public meeting under the auspices of the Massachusetts Single Tax league in Fremont Temple, Boston, in the afternoon of Washington's birthday.

While Farmer Shaw and Gov. Hoogg are incubating subtifuges, wouldn't it be well for the legislature to get down to business and hatch out the real thing on the line of Senator Bucklin's bill before the Colorado legislature, and the Tax Reform association of New York? Put the power to tax, as well as to be taxed, into the hands of the people, and the "maximums" of prosperity would be assured—as well as the minimum of imposition by the railroads, or any other corporation.

### THE ONLY WAY TO BETTER THE TIMES.

The Saint Louis Globe-Democrat published a letter, signed "A Miserable Widower," asking how best she could make a living? The editor invited a symposium of answers, and some dozen or more appeared in a following issue. The gist of the answers given as indicated in the following article:

No. 9, called Tuzzy Muzzy,—meaning a back number—said "growing track, driving sharp bargains, working and waiting, and you cannot fail." To encourage opinions the chairman said that was "good."

No. 10 said: "Good books and read and study;" but failed to say that books on political economy—recently defined as being "the science of how to get a living"—were the good books needed—and all were yet in the dark.

No. 11 would "secure a small tract of land and get help to work it." Response: "Get help!"

And so the deliberations continued, until even old man Credulous, sitting in the amen corner, was brought to his feet, and declared, "All them suggestions is old receipts that was tried in all ages and found wanting," and that for himself he "knew of no remedy, and didn't believe anybody else did," and would move that a committee be appointed and sent to God to find out what to do. The motion was carried with a bound. But who should the committee consist of? Of the "best to do," of course, as others couldn't spare the time nor afford the clothes for so important a trip. So the committee was formed and started on their heavenly mission.

Arriving in sight of the pearly gates, the angels described them coming, and wondered whom they were, whence and for what.

One of the angels thought they must be disembodied

souls. "No," replied another, "disembodied souls do not come with stovepipe hats."

Old Peter was called to the gate, ready to receive the strange visitors. Asked if he was God, he told them no, but that he would act. "No," they replied, "we are commissioned to see God only."

God appeared, and they began: "Good Lord, we are from earth, in trouble there too deep to be settled by any but yourself."

Spokesman. Verily, Lord, there is. Our people are poor; can't get work or the wherewithal to buy the necessaries of life; the majority of our people are unable to support their families, and the widows—even in Missouri—are begging leave to toil. Lord what shall we do?

S. Yes, Lord, the seasons come and go as ever?

S. Nothing of the kind, dear Lord.

G. Are my people able and willing to work on the land I have given to all of them?

Mince Meat. Take 4 pounds of tender beef, 3 pounds of suet, 8 pounds of chopped apples, 3 pounds of currants, 3 pounds of raisins, 6 pounds of white or brown sugar, 2 pounds of citron cut thin, the grating, juice and pulp of two oranges, the juice and grated rinds of four lemons, one ounce of cinnamon, a quarter ounce each of cloves, mace and allspice, four grated nutmegs, one quart of wine, one pint of brandy, a cupful of strawberry or raspberry jam; chop beef and suet very fine, mix it with salt to remove fresh taste: to this add the apples, sugar, fruit and other ingredients a little sweet cider or molasses (cider may be used in place of brandy and wine). This is to be cooked—only the meat and the suet should be cooked.

For breaking a cow from sucking herself tie the cow's head to a post or tree and pull her tongue out and split it about two inches. This is a positive cure. It seems a little cruel, but it does not hurt the cow for a few days. It will be well in a week, so you could not tell that her tongue had been split unless you should see her forked tongue.—Subscriber in Globe-Democrat.

Our Washington letter says: "The editor of a Michigan Republican paper said to his Washington correspondent who had sent him some favorable comment on the attempt to pass the ship subsidy bill. "We don't want any more such gush we are not running an administration paper but a Republican paper from an honorable standpoint.
