Seed Rangeland To Boost Forage

Ranchers with rangeland in poor condition may want to consider a seeding program during the next few weeks.

Seeding forage-deficient ranges with desirable forage plants can make them productive again. Also, seeding is usually necessary following root-plowing for brush control.

Range seeding is usually done in late winter or early spring. Since seeding is expensive and the risk of failure is always present, careful attention must be given to a number of factors.

To begin, evaluate the quantity and distribution of desirable plants currently present. If desirable plants make up less than 10 to 15 percent of the vegetation, seeding is probably necessary. Ranges can be improved by grazing management and brush and weed control if desirable plants are uniformly distributed and make up more than 10 to 15 percent of the vegetation.

Seeding is usually necessary following a brush control method such as a root-plowing that destroys existing turf. Also, seeding is usually the most effective way to establish desirable vegetation on abandoned cropland.

Seed only better sites to insure reasonable chances of success. Steep, potentially erosive sites should not be disturbed. Seeding range sites that receive runoff water usually provides good results.

Species and varieties of plants selected for seeding must be adapted to the area's soil, climate and topography. Also, plants selected should be easily established, palatable to animals, relatively productive, able to withstand invasion by undesirable plants, able to withstand moderate grazing and able to prevent erosion under moderate grazing.

Check with the county Extension office or local Soil Conservation Service office for information on plants adapted to a specific area. A publication on seeding rangeland is available at the county Extension office.

As far as the seeding operation is concerned, plant into a well prepared seedbed. An ideal seedbed is firm below seeding depth and free from live plant competition. It has moderate amounts of mulch or plant residue on the soil surface.

Less expense is involved in preparing a seedbed on abandoned cropland. On rangeland, however, the ideal seedbed is a goal seldom attained because of expense and expected return. So, prepare the best seedbed that available resources will allow. For example, rootplowing followed by roller chopping or chaining is an acceptable method of seedbed preparation on brush infested rangeland.

The two most common methods of seeding rangeland are broadcast and drill. Broadcasting places seed on the soil surface while drilling puts seed into the soil. Drilling is the superior method of seeding where a drill can be used. However, broadcast seeding by aerial or ground application is often used because most drills are not sturdy enough for rough rangeland.

When to seed is important. Start seeding at the beginning of a period that will provide the best growing conditions for the slowly developing seedlings.

Warm-season plants grow in the summer and will make the best and most vigorous growth if seeded in late winter or early spring. A late summer or fall seeding date for cool-season plants may be best because young seedlings may not be able to tolerate hot, dry summers.

A newly seeded area will need protection from grazing until seedlings are established. With exceptionally good growing conditions, deferment through one growing season may be sufficient. During periods of harsh growing conditions, two or three years of deferment may be necessary to allow seedlings to establish.

Weed control measures such as mowing, shredding or use of herbicides may be necessary during the first growing season to allow seeded species to become established.

Seeding can rejuvenate poor ranges, but careful attention must be given to proper planning, use of correct plant material, seeding methods and good management.

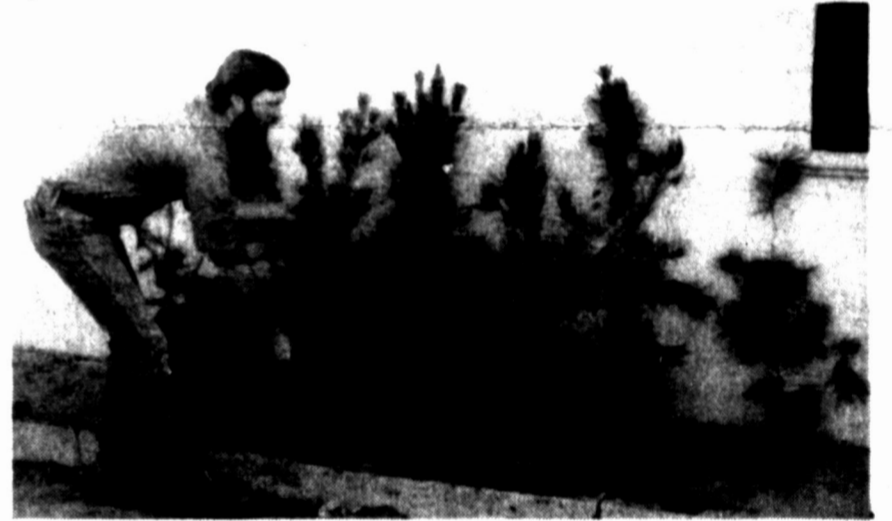
Since the Don't Mess with Texas and Adopt-A-Highway programs were launched in 1986, the state has seen a 72 percent decrease in roadside litter.

Contest Announced

Young people in Clarendon will have a chance to put their stamp on the world by participating in an environmental postage stamp design contest announced February 28, 1994, by the U.S. Postal Service and McDonald's family restaurants.

Local postmaster Lonnie Davis is looking forward to helping kids get involved in the contest.

"I hope this effort opens a new world to our youth," said Postmaster Lonnie Davis. "Combining kids' interests in the environment and stamp collecting promises to be fun for everyone. I hope that many of our local youth participate in the contest, and who knows, maybe someone from Clarendon will be the winner!"

pregnant by a man who picked her up on her school parking lot.

My question is: "What has to happen to get adequate supervision for our children at school?" Will we have to wait for one of our children to be picked up by a stranger at school and be killed, before we, as parents, take action to protect our children? How many of our young girls must become pregnant at school lunch or how many young men will try drugs or alcohol during lunch? Do we as parents send our children to school to get pregnant or to be come addicted? Is this what our staff at the school wants? No! I do not think these are the reasons that we send our children to school, nor are these things our school staff wishes to see happen.

I speak for myself--as one parent. I know there are others who feel the same as I do. I send my children to school to learn, to get a good education. I had hoped my children would go to college then be productive citizens. Now instead, my daughter will have a baby. The chances of her finishing school are slim, of going to college even less. I did recognize my child's immaturity and did not allow her to go out, but because of that one hour during the school day that she was not supervised she will now become a mother to a child while she is still a child.

"What do we do?", you may be asking yourself. I intend to meet with the school board April 14, 1994 at 7:00 p.m. to give my ideas as to this matter. No, we cannot completely stop teenage pregnancy or teenage drinking and drug abuse, but we can slow it down. How? The way I see it we have two options to chose from.

One choice is to have a closed campus, where none of our students could leave campus, at lunch. And to have teacher out on the grounds to ensure there are no strangers in the parking lot to pick up our children and talk them into doing things they might not do otherwise.

The second option is at the very least to only allow the young people who's parents feel secure in letting them go out unsupervised to go. Others, who feel their children may not be responsible enough to be unsupervised, these students would not be allowed to leave

school grounds. There should be teachers on the school grounds to supervise children at lunch. There should be someone to keep strangers off our school campus. The school should give a pass to the children whom do have permission to leave school, these passes could be checked as the students enter of exit school. Then those who do not wish their children unsupervised would not be.

I ask that if you have an opinion please come, on April 14 at 7:00 p.m., to the school board meeting and express your opinion. I want things to change. I know that to close our school campus might cost a few extra tax dollars, but to put a few extra dollars into our school system now, will save tax dollars in the welfare system later. I know at least one teenager who is going to be a mother, who would not have been at this time had we had a closed or at least supervised campus at lunch.

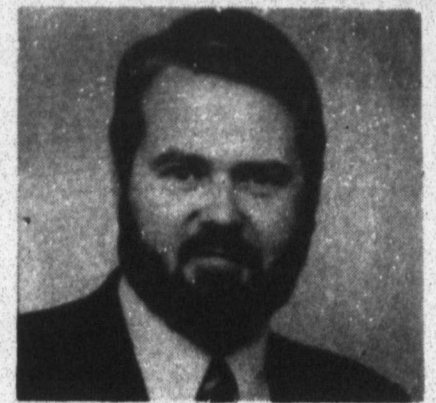
An Attitude Adjustment

In the last six years, I have worked with hundreds of troubled businesses. Some owners are able to weather the adversity and return to profitability, while others fail. One key difference I've observed is their attitudes. When the attitude is positive, there is hope. However, when the owner's attitude becomes negative, the end is near. Without an attitude adjustment, the business will fail.

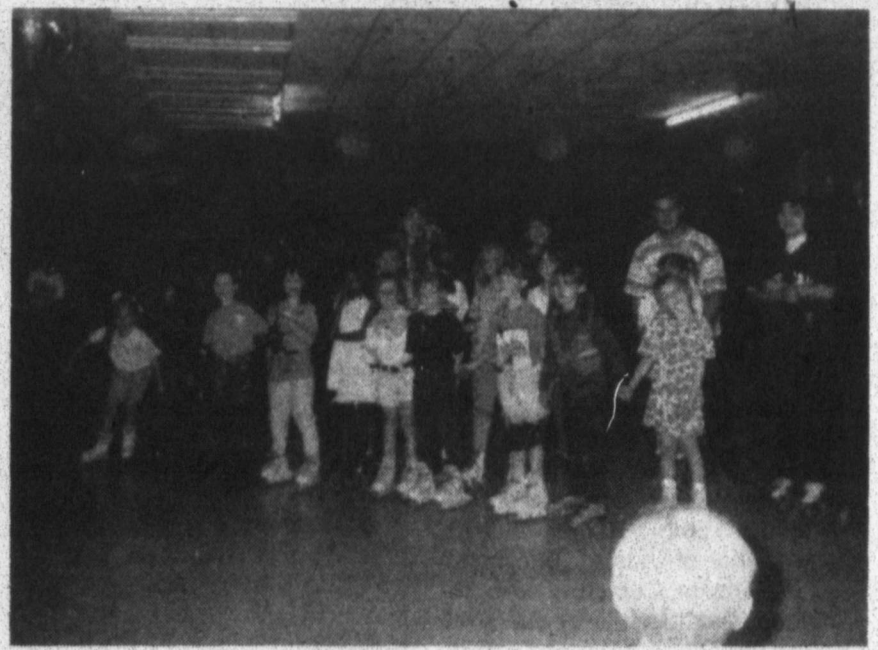

A variety of homestead exemptions could lower your property taxes!

A homestead exemption lowers the property taxes on your home by lowering its taxable value. If your home is valued at \$50,000 and you receive a \$5,000 homestead exemption, your home will be taxed as if it were worth \$45,000.

Who qualifies for an exemption?

Anyone who owned a home on January 1st (and used it as their primary residence on that date) is entitled to a \$5,000 homestead exemption to lower their school taxes this year... and it doesn't matter if your home is a house, condominium or mobile home. (Counties, cities and special taxing districts may also offer homestead exemptions.)

Are other exemptions available?

If you're disabled—or if you're 65 years old or older—you are entitled to an additional \$10,000 school tax exemption on your home. And if you qualify for the over-65 exemption, you're also entitled to a permanent, locked-in "ceiling" on the school property taxes on your home. (The ceiling does not apply to county or city property taxes, and those entities may offer other exemptions.)

Do I have to apply each year?

No. If you had a homestead exemption on your home in 1993, you won't need to reapply for 1994 unless your chief appraiser requires it. However, if you haven't received an exemption on your present home—or if you've moved to a new home—you'll need to file for an exemption for 1994. And if you turned 65 or became disabled during 1993, you need to file for the additional exemptions.

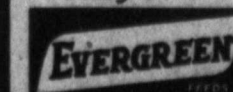
