This weeks featured business is the Bar H Working Dude Ranch. The Bar H Ranch is five miles Northwest of Clarendon off Highway 287 and FM Road 3257. Frank and Terri Hommel, owners and operators, have lived in Clarendon all of their life and have been in business since July of 1991. Frank and Terri have four girls, all in which work for them. Christiana, age 18, is a graduate from Clarendon High School. April, age 16, will be a junior. Laura, age 15, will be a sophomore, and Alice, age 8, will be entering the third grade. They also employ Corey Wood, Zack and Felicia Robinson, Brad Williams, and Sharon Cannon.

The Bar H Ranch started cooking meals in July of 1991, and by October they had their first bunk house for overnight guests. 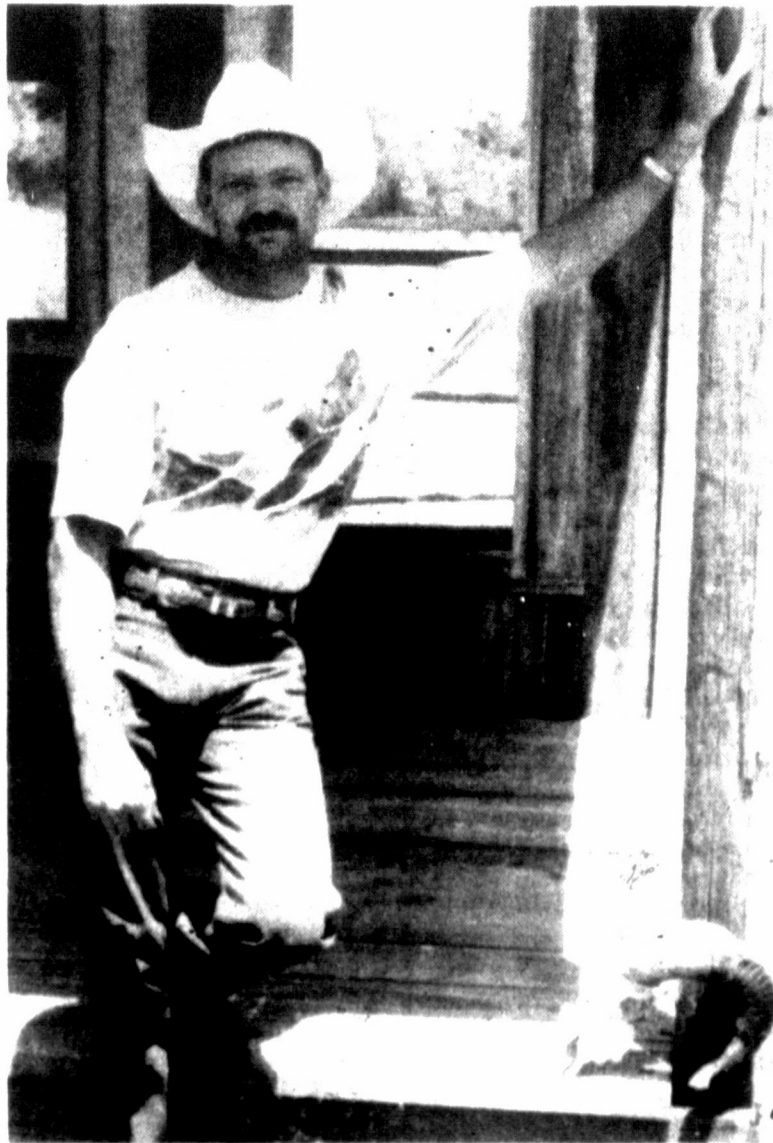

Livestock Pest

Livestock pest such as the horn fly, bot fly, horse fly, and heel fly can cause considerable economic losses. Livestock pests reduce milk production, weight gain, feed efficiency and hide value.

There are several self treatment devices that may be used to control flies. Cable type back rubbers covered with an absorbent material treated with an insecticide oil solution, or fabric dust bags filled with an approved pesticide dust, have been successful. Place these devices near water, feed or mineral sources are in gaps in gateways to enhance use. At 2 to 3 week adjustment period may be necessary before cattle begin to use self treatment devices regularly.

Reception Planned

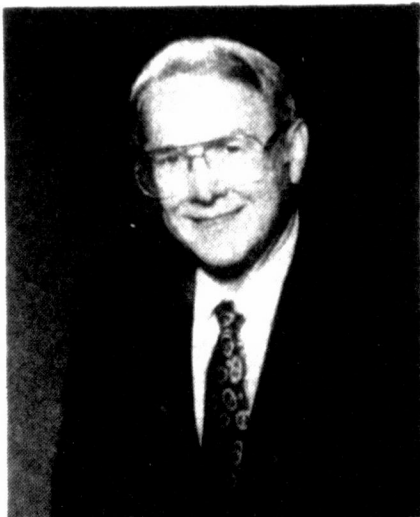

Forced use of these self treatment applying devices results in more rapid and effective control of flies. Sprays, dips and pour-ons also provide excellent control of livestock pest but are also more labor intensive. Insecticidal impregnated ear tags provide excellent control of flies for periods of 2 1/2 to 5 months if properly attached to the ear and if pyrethroid resistance is not a problem.

Both vehicles were traveling westbound on 287, the front vehicle driven by a Hedley man was turning left into the Automotive Shop, when a pickup truck hit him from behind. There were three people injured, two were transported to Hall County Hospital and the other was transported to the Donley County Rural Health Clinic in Clarendon.

His first book for parent and teachers, *Dare To Discipline*, has now sold over two million copies and was selected as one of 50 books to be rebound and placed in the White House Library. It has now been revised and updated, and is entitled, *The New Dare To Discipline*. His subsequent eleven books for the family are also best-sellers: *Hide or Seek, What Wives Wish Their Husbands Knew About Women, The Strong-Willed Child, Preparing For Adolescence, Straight Talk To Men And Their Wives, Emotions: Can You Trust Them? Dr. Dobson Answers Your Questions, Love Must Be Tough, Parenting Isn't For Cowards, Love For A Lifetime, Children At Risk, and When God Doesn't Make Sense*.

His first film series, "Focus on the Family" has now been seen by over 70 million people. His second film series, "Turn Your Heart Toward Home" was

released in January, 1986, and continues in circulation international.

Dr. Dobson has been heavily involved in governmental activities related to the family. He served on the task force which summarized the White House Conference on the Family and received a special commendation from President Jimmy Carter in 1980. He was appointed by President Ronald Reagan to the National Advisory Commission to the office of Juvenile Justice and Delinquency Prevention, 1982-94. From 1984-87 he was regularly invited to the White House to consult with President Reagan and his staff on family matters. He served as co-chairman of the Citizens Advisory Panel for Tax Reform, in consultation with President Reagan, and served as a member of the United States Army's Family Initiative, 1986-88.

He was appointed to Attorney General Edwin Meese's Commission on Pornography, 1985-86. Dr. Dobson was also appointed in the spring of 1987 to Attorney General's Advisory Board on Missing and Exploited Children, and to Secretary Otis Bowen's Panel on Teen Pregnancy Prevention, within the Department of Health and Human Services. In October, 1987, he received the Marian Pfister Anschutz Award in recognition of his contribution to the American family. A videotaped message of congratulations was sent by President Reagan. He also consulted with President George Bush on family related matters.

Dr. Dobson is married, the father of two grown children, and resides in Colorado.

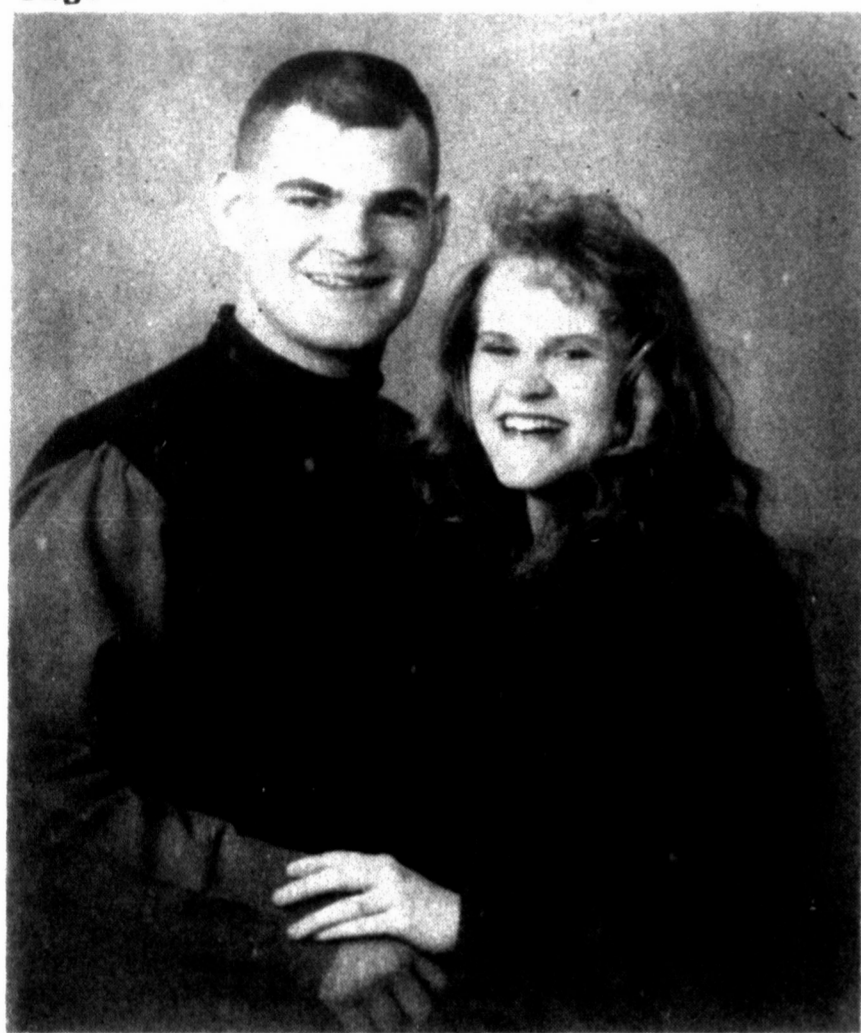

Mom gave me a little quotation book for Christmas and one of them said "Treat everyone you care about as if it were the last time you'll see them."

Granddad, you and Grandmom have always been there for me and loved me unconditionally. For that, I will always be grateful. You were always there for me growing up and made me feel safe whenever I was scared or felt lonely. I'm so glad I had a "second daddy." I'm so thankful our family, through a lot of hard work, love and patience, is better than it's ever been before. I know my children will reap the benefits of all the time and effort we have put into this family.

I have so many wonderful memories of you as I was growing up. Here are a few... I loved hearing all of your "scary" stories. I especially loved "dig here!" I'm sure I've heard it a hundred times

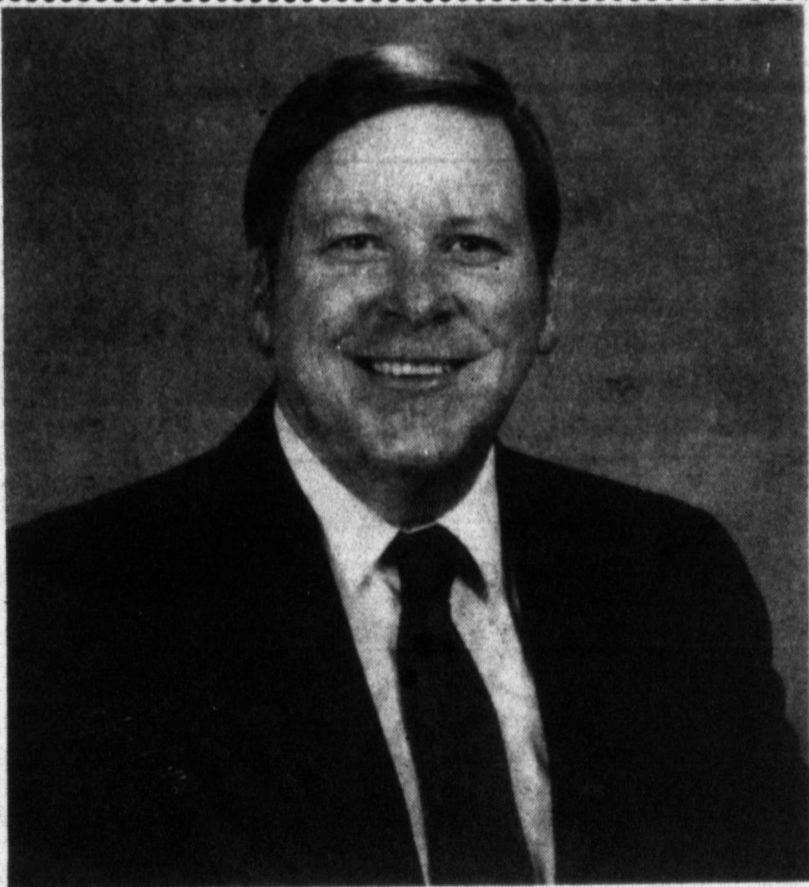
