## Sheriff Makes Pot Bust

The Donley County Sheriff's Department seized a marijuana patch and arrested its guard, Thursday afternoon about 5:00 p.m. More arrests are expected in the case.

The atmosphere was tense at times as the law officers first inspected the site. Drug dealers are often armed--sometimes with automatic weapons--and the brush site could easily have concealed an ambush.

Deputy Joe Shadle, Sheriff Jimmy Thompson, Deputy Jake Longan, and Deputy Charles Blackburn, assisted in the case, along with Kelly Rushing, investigator for the Texas and Southwestern Cattle Raiser's Association, Warden Gary Hunt and EMT Mutt Graham.

Officers arrested Dayna Jo Brown, 30, a white female, who was watching the pot patch from a camouflaged tent concealed under a tree. She and suspected accomplices had watered, fertilized and tended twenty or more marijuana plants in a remote location up Carroll Creek from Greenbelt Lake. They had carefully hidden some of their equipment and blocked the trails with dead brush. Some of the tools and cans had been spray-painted olive or flat black to make it less visible.

The law officers confiscated several pounds of green marijuana with an estimated street value of several thousand dollars.

The arrest followed several weeks of surveillance, after the Sheriff's department was alerted by a confidential informant.

Bondsmen contacted the Sheriff's Office soon after the arrest to secure the release of the suspect.

**Deputies Have Busy Months**

Donley County Sheriff's Deputies had their hands full in August. Six people were arrested for Public Intoxication. There were five cases of probation revocation. One charge of assault was filed. Two had charges filed against them for criminal mischief.

There were four arrests for Driving While Intoxicated, one suspect being arrested twice ten days apart.

One person was charged with Aggravated Sexual Assault and another with Sexual Assault.

Two people were charged with the unauthorized use of a motor vehicle. One was brought up for parole violation.

One charge of assault was filed.

There were 29 arrests. Prisoners spend 126 days in jail and ate 378 meals. Officers investigated five accidents and served four warrants. There were four fire calls, 40 ambulance calls, and seven traffic tickets.

July was similar.

Two were charged with Possession of Marijuana and three with Possession of a Controlled Substance. Ten people were charged

with Driving While Intoxicated, while four more were charged with Public Intoxication.

There was one charge of Simple Assault, one of Assault and one of Assault on a Police Officer. There were also single counts of Disorderly Conduct, Theft Under \$20, and Criminal Trespass, Contempt of Court and Burglary of a Habitation.

There were two counts of Criminal Mischief, two of Theft Over \$200 and Under 750, two charges of Parole Violation and two of Trespassing.

July saw three traffic offenses ticketed.

There were 60 arrests in July. Inmates spent 152 days in jail and ate 456 meals. Officers made out six accident reports. Two papers were served. There were 9 fire calls and 41 ambulance calls.

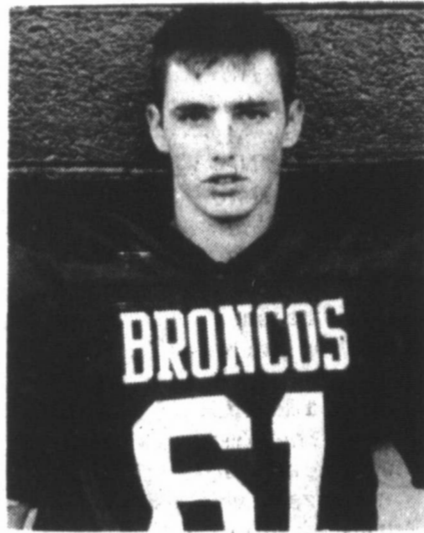

**Check It Out**

Why go to the library, other than to check out a book? One good reason is to view the rare articles that are encased by the south wall in the Burton Memorial Library. If you have not yet discovered these treasures, you are, truly, in for a delightful treat.

The glass case in which these articles are displayed, and which is very much appreciated, is on loan to the library by Mac and Bill Stavenhagen in memory of Ira Stavenhagen.

One of the things one might notice are possessions of Pioneer Doctor, Jerome D. Stocking, which date back to 1885. Birth forceps, a tongue depressor, and eye cup are three interesting items included in Dr. Stocking's collection.

A picture of Clarendon jeweler, Dr. Spiller, and druggist, Dr. Addison M. King, may also be viewed. The *New England Primer*; *Great Gavelston Disaster*; and *Oliver Wendell Holmes' Autocrat of a Breakfast Table* are books which have been donated to the rare collection.

For you who really like to take trips down memory lane, a copy of a 1915 Clarendon College annual, *The Wester*, awaits you. A few of the many names that Clarendon citizens will recognize are Burkhead, Moore, Chism, Burton, Slover, and Powell who were three of the staff members; and Carpenter, Slay, Baird, and Hedrick who are members of the Honor Council.

Current college students might find it interesting to compare their 1992 organizations to the 1915 debater's Club, Ministerial Association, Lawyer's Club, Literary Society, and others. There was even a Big Mouth Club whose motto was, "When I open my mouth, let no dog bark", which can be found on page 107 in *The Wester*.

Various articles such as "Cost of War" by Hubert L. Stone, which gives facts concerning the United States and other countries, are also in this annual. Readers might be interested in the type of jokes that were going around in 1915. These can be found, beginning on page 126.

Baseball, Tennis and Football are three sports that were prominent at Clarendon College during this period of time. I feel this brief review of the Clarendon Wester would not be complete without a quick rundown of their football schedule. Clarendon won most of their game that year. The opening game on September 14, 1914, with Shamrock YMCA resulted in Clarendon's victory of 15-0. The team went to play Goodnight, Seth Ward, and NMMI. They won their sixth game against Amarillo Military Institute 30-0.

When Seth Ward, Clarendon's opposing team in the seventh game, was interviewed concerning their thoughts about Clarendon College, they were quoted as commenting, "They are a big fat bunch of babies, and everyone is as yellow as they make 'em". According to page 83 in *The Wester*, Seth Ward went as far as to present CC with a nice fresh bottle of milk. Needless to say, this gesture made Clarendon more determined than ever, and they triumphed over Seth Ward 13-0 that evening.

Are there other interesting items at Burton Memorial Library besides books? Why not check it out?

**Lithium For Various Mental Disorders**

Lithium has been used successfully for more than a decade in the United States for the management of certain mental problems including mania, depression, and mood disorders. According to a number of recent articles in psychiatric journals, lithium probably is the most effective agent being used in the prevention of manic depression.

Most persons who take lithium experience a lag time from when they start the medicine until the time it reaches its maximum effectiveness in preventing manic or depressive behavior. The lag time may range from a few days to two weeks. The *American Hospital Formulary Service* indicates that lithium is more effective in preventing mania and hyperactivity than in preventing depression.

Lithium is one of a few medicines that have a narrow therapeutic index. This means that the range from an effective therapeutic blood level to a toxic level is not very wide. Therefore, blood levels of lithium must be monitored carefully during therapy. Mild toxicity may include nausea and vomiting, while severe toxicity may result in muscle rigidity, seizures, and irregular heart beat. Lithium may interact with several medicines including certain diuretics, nonsteroidal anti-inflammatory drugs, and certain antidepressants. If you take lithium, discuss its use with your physician and pharmacist.

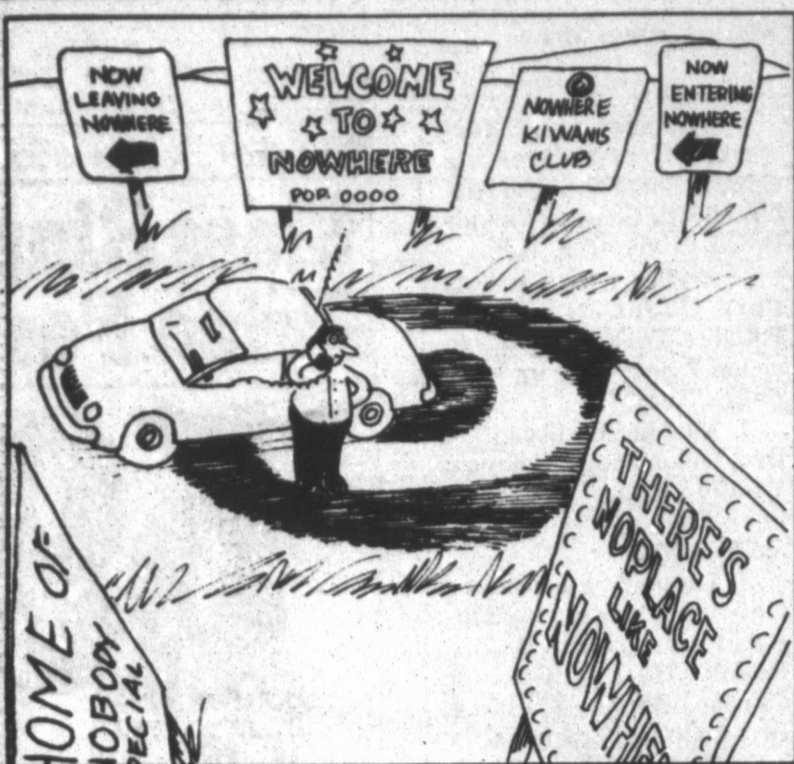

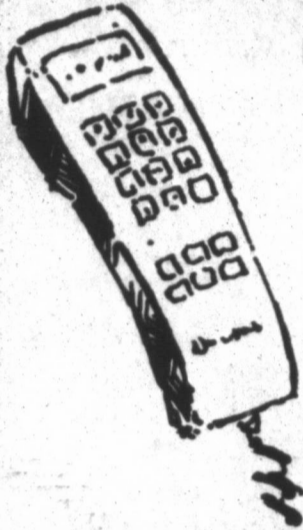

## Task Force Formed

A task force to promote tourism and recreation is being started in the panhandle. In a meeting held at Canadian last Wednesday the directors of the North Rolling Plains Resource Conservation and Development (RC&D) Council voted to organize the task force.

The main thrust of the task force will be to develop a plan to "market" recreation and tourism in

the area, organizing a "Marketing Council" will be one of the main goals of the task force. The Marketing Council will promote recreation and tourism in an effort to bring dollars back into rural communities of the panhandle.

"Rural communities are hunting economically. Tourism is one way we can help those struggling communities," says John Crowell, coordinator for the RC&D Council.

"This task force will help communities to develop, organize, and coordinate events. By working together we can attract more tourists and keep them in the area longer.

According to Crowell, "Interstate 40 and Highway 287 bring millions of people through the panhandle each year. Many are looking for something to see and do. They need to know the Texas Panhandle is more than just a stretch of highway connecting the lakes of Oklahoma with the mountains of New Mexico. We have a unique history and culture that still live and must not be forgotten. The trail of the Red River Wars is just an example of our history that needs to be preserved for our children and developed for tourism. This task force will look for potential, historical, recreation, and tourist developments as well as promote the ones we already have."

In other business the North Rolling Plains RC&D Council voted to provide help for several community projects around the area. These include constructing a "Creative Learning Playground" at Memphis, starting with a new fire department at Hoover, upgrading the Wheeler T.V. Translator system, building an open air pavilion at Canadian, finding a permanent home for the Silverton Caprock Jamboree, and sponsoring a fund raising/grant writing seminar. The RD&D Council will help find possible sources of funding and prepare grant proposals. Some projects may be partially funded with RD&D funds from the Department of Agriculture Soil Conservation Service. The RC&D

office will also help in organizing, planning, and promoting local projects where needed.

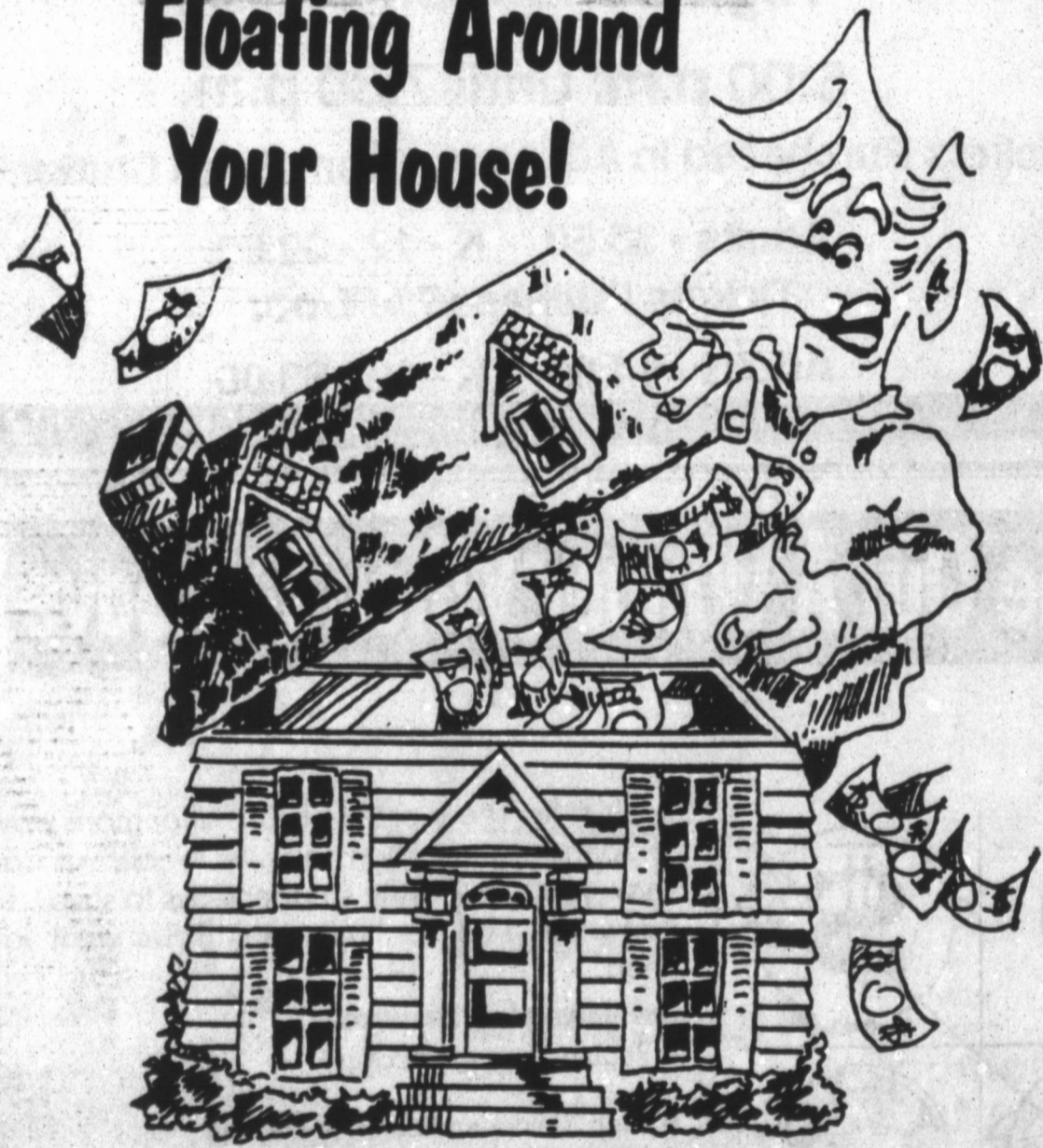

## Public Notice

Southwestern Bell Telephone Company has asked the Public Utility Commission of Texas (PUC) for approval to offer new optional call management services called Caller Identification Service (Caller ID) and Anonymous Call Rejection (ACR).

Caller ID is a new optional phone service which allows subscribers to see the phone number and/or name of most local calls before they answer the phone. Caller ID also allows the recording of the date, time, name and/or phone number of calls. Currently, Caller ID would work only on most local calls, not long distance calls. It would also require that a separate display unit be connected to the telephone. These units that attach to the telephone will be available from various retail vendors, including Southwestern Bell, at a cost starting at approximately \$50.

Southwestern Bell is also proposing that all customers be able to "block," or stop their name/number from being transmitted and displayed on a Caller ID device, free of charge. You would have this option of "blocking" your name/number on each call free of charge. There would be no need to subscribe to this service. All customers would have this capability when Caller ID is introduced in their area.

If you want to block your name or number, you need only press \*67 on your touch-tone pad (or dial 1167 from a rotary phone) before dialing the telephone number. The person you're calling would see displayed a message such as "private" or "anonymous" on their Caller ID display unit.

Southwestern Bell also proposes that qualified domestic violence and law enforcement groups have the option of free per-line blocking, or free per-call blocking.

Anonymous Call Rejection (ACR or "block the blocker") allows subscribers to automatically reject all calls that have been marked anonymous, or "blocked" by the person calling. It is not necessary to subscribe to Caller ID Name/Number to subscribe to ACR. With ACR, your telephone will not ring if the person calling you has "blocked" his/her name or number. The person calling whose identification is blocked will receive a message to hang up and call back with caller identification unblocked. Following are the proposed monthly rates for Caller ID and ACR.

\* These rates are in addition to the initial installation charges and monthly basic service rate. For residence customers, installation charges are \$2.70 per feature, with a maximum charge of \$5.40. For business customers, the charges are \$5.40 per feature, with a maximum charge of \$10.75.

\*\* Anonymous Call Rejection is \$3 per month if purchased without Caller ID and is \$1 per month when purchased with Caller ID Name or Number.

This proceeding has been designated Docket No. 11362, and a hearing on the merits has been scheduled for November 16, 1992. The PUC has jurisdiction to consider this matter pursuant to Sections 16, 18, 37 and 38 of the Public Utility Regulatory Act (PURA). This application was filed pursuant to the provisions of the PUC's Substantive Rule 23.24. Among the issues that will be addressed in this proceeding is the legality of the Caller ID device and service under Texas wiretap laws.

Persons who wish to intervene or otherwise participate in these proceedings should notify the PUC as soon as possible. The deadline to intervene is October 26, 1992. A request to intervene, participate, or for further information should be mailed to the Public Utility Commission of Texas, 7800 Shoal Creek Boulevard, Suite 400N, Austin, Texas 78757. 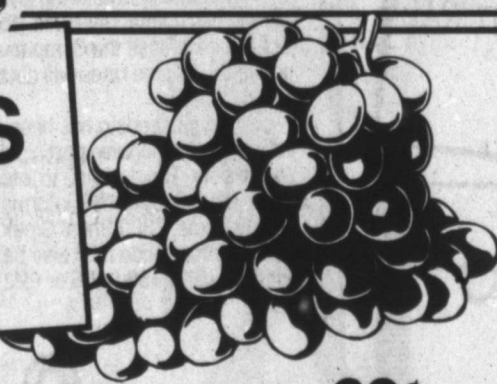

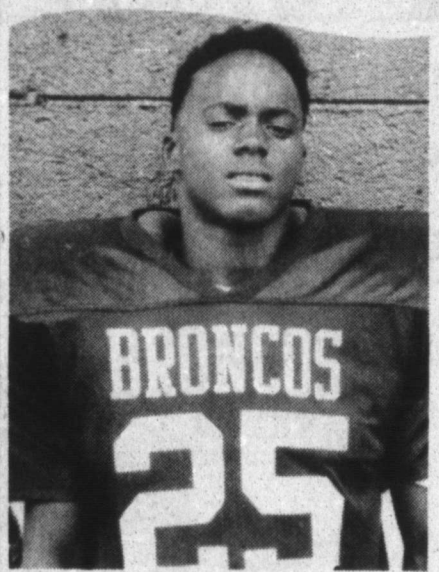

## Public Notice

Southwestern Bell Telephone Company, in accordance with the rules of the Public Utility Commission of Texas (PUC), hereby gives notice of the Company's intent to implement a new schedule of telephone rates in Texas for optional Custom Calling Services and Touch-tone service, effective March 15, 1993, unless otherwise determined by the PUC.

These proposed rates will not increase or decrease the Company's overall revenues; the net effect will be neutral to the Company's annual revenues.

The Company proposes to decrease the rates for Touch-tone service for residential customers from \$1.00 to 68 cents, and also to reduce the Touch-tone rates for business customers from \$1.75 to \$1.70. In addition, the Touch-tone rates for business PBX trunks will be reduced from \$3.15 to \$2.18.

This proposal to decrease the rates for Touch-tone service does not change the commitment that the Company made in the Docket No. 8585 Stipulation to reduce the rates for Touch-tone service in 1993.

The Custom Calling Services affected by the Company's application are optional telephone service arrangements that provide the following features: Call Waiting, Call Forwarding, Three Way Calling, Speed Calling-8 and Speed Calling-30. Following are the feature combinations and their current and proposed rates.

Most of the Company's residence and business customers who subscribe to Custom Calling Features and Touch-tone service will be affected by the proposed rate restructuring.

It is expected that the restructuring of Custom Calling Features will result in a rate increase for approximately 2.9 million residence customers and 280,000 business customers. The reduction in rates for certain Custom Calling Services and Touch-tone Service will affect approximately 4.3 million residence customers and 1.7 million business customers.

This rate restructuring is expected to have a "revenue-neutral" effect on the Company's annual revenues. The proposed rate restructuring of Custom Calling Services will increase the Company's annual revenues by \$19.8 million; while the reduction in Touch-tone rates will decrease the Company's annual revenues by \$19.8 million.

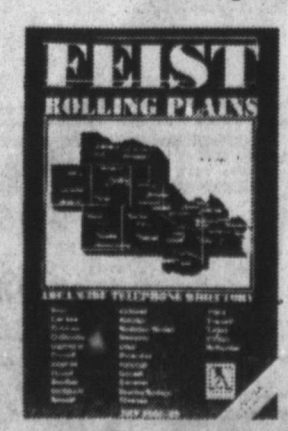

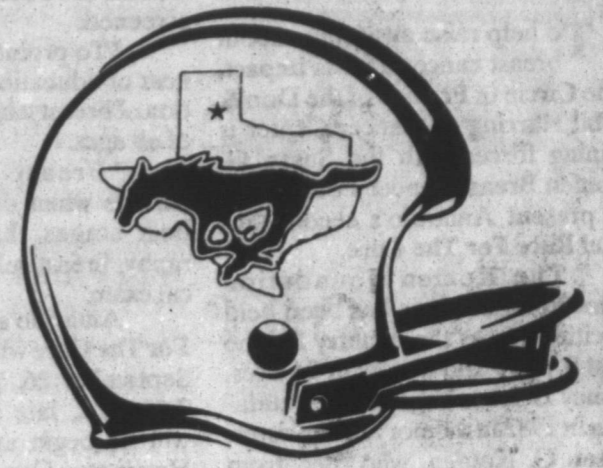

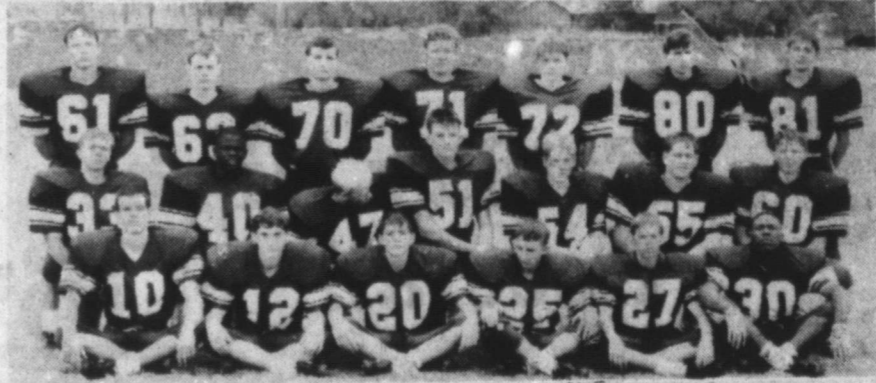

\*Breast Cancer is 90% curable when detected in its earliest stages through mammography, breast self-exam and physical exam.

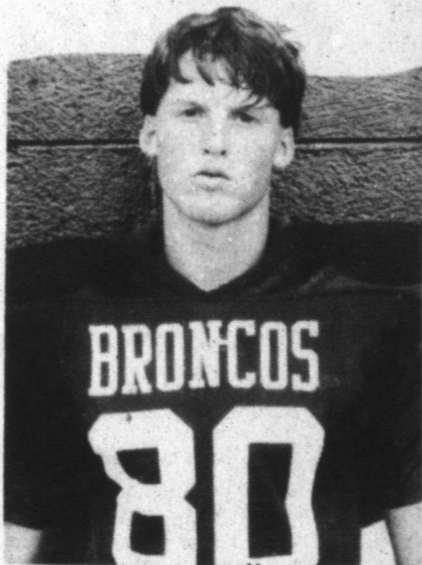

# Ag Dept. Provides Farm Program Facts For Loan And LDP Eligibility

The United States Department of Agriculture, Agricultural Stabilization and Conservation Service has issued its Farm Program Fact Sheet. A breakdown is given for those affected, regarding beneficial interest requirements for loans and loan deficiency payments (LDP), excluding sugar and tobacco.

**LOAN AND LDP ELIGIBILITY:** For a commodity to be eligible for a loan or a loan deficiency payment (LDP), the producer must have beneficial interest in the commodity in addition to other eligibility requirements.

**BENEFICIAL INTEREST:** A producer retains beneficial interest in the commodity if all of the following remain with the producer: a) control of the commodity; b) risk of loss; c) title to the commodity.

For LDP's, the producer must retain beneficial interest in the commodity from the time of harvest through the date the LDP is requested.

For loans, the producer must retain beneficial interest in the commodity from the time of harvest through the date the loan is redeemed or Commodity Credit Corporation (CCC) takes title to the commodity.

Once beneficial interest in the commodity is lost, the commodity remains ineligible for a loan or an LDP even if the producer regains control, risk of loss, and title.

**CONTROL:** A producer is considered to have control of the commodity if the producer retains the ability to make all decisions affecting the commodity, including movement, sale, and the request for a loan or an LDP.

**RISK OF LOSS:** A producer is considered to have the risk of loss in the commodity if the producer has sold or delivered the commodity

to the buyer or delivered warehouse receipts to the buyer. Title may be considered to be transferred before the producer receives payment for the commodity.

**SELLING EQUITY:** If a producer receives any payment that would give the buyer any share of the equity in the commodity, such commodity is immediately ineligible for a loan and an LDP. If a producer sells any equity in the commodity after it has been pledged as collateral for a loan, repayment of the loan principal and charges plus interest, is required.

**OPTION TO MAINTAIN BENEFICIAL INTEREST:** An option to purchase is an agreement allowing the buyer, at the buyer's option, to enter into a contract at a later date to buy the commodity. The option does not give the buyer any interest in the commodity and expires at a specified time.

**PAYMENTS:** If a producer has entered into an option to purchase, the producer may receive a payment and retain beneficial interest if such option to purchase contains a provision written as follows:

"Notwithstanding any other provision of this option to purchase, title; risk of loss; and beneficial interest in the commodity, as specified in the applicable code of Federal Regulation: 7CFR Part 1421 (for wheat, feed grains, oilseeds, rice, and farm-stored peanuts) and 7CFR Part 1427 (for cotton), shall remain with the producer until the buyer exercises this option to purchase the commodity. This option to purchase shall expire, notwithstanding any action or inaction by either the producer or the buyer, at the earlier of (1) the maturity of any Commodity Credit Corporation price support loan which is secured by such commodity; (2) the date the

Commodity Credit Corporation claims title to such commodity; or (3) such other date as provided in this option.

Insertion of this language into a sales contract does not mean that the producer retains beneficial interest when a payment is made under such a contract.

**SALES CONTRACTS AND LOSS OF BENEFICIAL INTEREST:** A sales contract, including advance sales contracts, contracts to sell, price later contracts and contracts for future delivery, gives the buyer an interest in the commodity at a time set forth in the contract or at a time implied by law.

If a producer has or will receive a payment in return for the sales contract, beneficial interest is lost when the payment is made.

A producer will lose beneficial interest upon signing any contract which contains clauses restricting the producer's decision to obtain price support from CCC, such as:

a) the buyer may require the producer to obtain a loan or an LDP;

b) the producer may obtain a loan or an LDP, only with prior approval obtained from the buyer.

An addendum to a contract to remove any restrictive clause must be agreed upon by all parties in order for CCC to consider the addendum valid. Such addendum must be before ginning in the case of cotton; or harvest for commodities, except cotton and honey; extraction in the case of honey.

**SUBJECT TO CCC DETERMINATION:** All loans or LDP's requested shall be subject to a determination by CCC of such producer's eligibility to receive a loan or an LDP, based on a review of any option to purchase or sales contract involving the commodity.

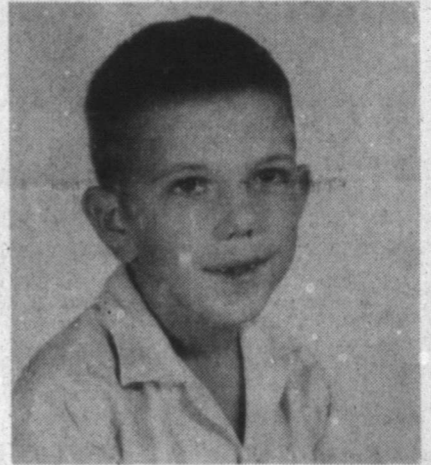
