Miss Ruth Richerson reports that the three home economics classes in the county will have displays and premium money will be \$25.00 for first place and ten dollars for the remaining two places.

The nine departments in the fall fair will include: horse show, races, community agriculture displays, home economics exhibits, flower show, merchants displays, poultry show, dairy show and the boys swine show.
