





Whereas, the Board of Aldermen of the City of Clarendon opposes specific provisions of Tax Reform Bill H.R. 3838 which was passed by the House of Representatives and became effective January 1, 1986.

Whereas, if passed by the Senate, the tax bill will place overly restrictive restrains on the use of tax-free bonds by states, cities, and other governmental subdivisions, and

Whereas, complaince with the new rules will result in additional costs to states, cities, and other governmental subdivisions, and will require continued monitoring of investments and expenditures, and will require the services of accountants and lawyers to determine the amount of and to prepare the documents for the required payments to the United States Treasury. Furthermore, noncompliance would result in the

interest on the bonds being included in the gross income of the owners of the bonds retroactively to the date of delivery of the bonds, and

Whereas, some of the provisions of H.R. 3838 are:

1. Five percent of the proceeds of a bond issue, net of issuance costs, must be spent within 30 days after the date on which the bonds are delivered and all of the proceeds of a bond issue must be spent within 3 years after bonds are delivered.

2. All earnings on investments acquired with the proceeds of any tax-exempt bond issue must be paid to the United States Treasury to the extens that the investments yield a higher interest rate than the interest rate on the bond issue. For example, if bonds are issued at a 9 percent yield and the proceeds are invested in excess of 9 percent (i.e., 1 percent) must be paid to the United States Treasury.

3. In addition to the requirement that excess earnings be paid to the United States Treasury, H.R. 3838 limits the period during which bond proceeds can be invested at a yield higher than the yield of the bonds. Bond proceeds used to acquire tangible property can only be invested without arbitrage yield restrictions for a 30 day period beginning on the date of delivery of the bonds. Bond proceeds used for construction expenditurees can only' be invested without arbitrage yield restrictions until the earlier of

(a) the date construction is 90 percent completed or is abandoned, (b) three years after the date of delivery of bonds or.

4. Municipal bonds will not be tax-exempt obligations where the lesser of 10 percent of the proceeds or \$10 million of the proceeds are used (directly or indirectly) in any trade or business carried on by a person other than a governmental unit.

5. All tax tax-exempt bonds are subject to information reporting requirements. Information regarding the bonds, the issuer, the property financed and the principal users of such property must be filed with the Internal Revenue Service.
