According to what we consider accurate information, gamblers are making plans to establish dog race tracks in every principal city of Texas, which likely would include

Let's Not Have It dog tracks.

Browawood, in event the present legislature fails to pass a bill now pending which would outlaw parimutuel gambling at the

For some time dog racing has been permitted in Texas under doubtful legality. The doubt was removed last week when the court of civil appeals at San Antonio held that the pari-mutuel laws of Texas, designed to permit supervised gambling on horse races, also held out the same privilege to those who follow the dog races. And so, unless the supreme court should hold otherwise, gambling on dog races is legal within the state.

There are many disadvantages to dog racing, even without the gambling feature. From a humanitarian standpoint, the game is revolting. True, it appears a harmless amusement to watch sleek greyhounds pursue a mechanical rabbit around a circular track. The cruelty comes in the training period, not watched by cash customers. In this, live rabbits are strapped to the mechanical device, and the race run under conditions similar to the mechanical process seen by the spectators. The dogs are permitted to lunge on, destroy and eat the helpless rabbit, strapped on the mechanical device in place of the synthetic rabbit they chase during the money races. The dogs then are starved for a day or two, released on the track, and instead of merely engaging in harmless fun, think they are in pursuit of a real meal of rabbit.

But to the gambling feature of the race. A track can be set up for comparatively little money. It can be moved easily. Dog races are run at night, under the lights. The price of admission is low, usually twenty-five or fifty cents. Bets are placed for as low as fifty cents. The result is that dog track gambling sucks the life blood of any community in which it operates, taking small bets from working people who cannot afford, at present low wage schedules especially, to be deprived of necessary funds. No city can stand the drain of gambling on the dog races long; no small city such as Brownwood could afford it at all, and certainly communities such as this are entitled to protection from the legislature.

A bill outlawing dog track gambling has passed the senate, and now is before the house of representatives: It should not be allowed to get clogged in the last minute rush, nor should the legislators heed the strong gamblers' lobby. paint and labor, Mrs. A. E. Camp bell of Fannin county has provided storage space for the 88 varieties of canned food in her pantry by repairing an old handmade walnut cupboard belonging to her grandmother, according to Miss Minnie Eldridge, home demonstration agent Mrs. Campbell rearranged the shelves, added new doors, and painted the cupboard apple green As it was not large enough, she built other shelves on top of it. Each section is stocked with required products according to her food budget plan and saves her many trips to the smokehouse where her food was formerly stored.

Dallas-Because green feed was added to the ration for his hens, C. A. Luper of Dallas county gathered an average of five and onehalf eggs more per hen in March. 1935, than in March, 1933, according to Dale Merwin, county agricultural agent. During the winter of 1933, Luper had no green feed for his hens but fed three and one-half pounds of mash and three and one-half pounds of grain per hen. He received an average of 19.4 eggs per hen.

Luper planted alfalfa and in March, 1935, he fed his hens three and one-half pounds of grain and four and one-third pounds of mash with green alfalfa. His flock averaged 25 eggs per hen.

San Marcos-"Hays county's self liquidating terracing project is moving forward with unexpected speed, 625 acres having been terraced since January 4 when the new equipment was put into use," says Jack Williams, county agriultural agent. More than 500 acres had been terraced prior to that time with the old equipment, giving a total of 1,125 acres having been worked since the project was begun

Lines have been run on approximately 400 acres and this land will e terraced in the next few weeks.
