## It's Fair Time For Bailey County Live Entertainment, Rain Enhances Crop Prospect Contests Are Added

"One thing that's on every-body's mind right now are the rain, wet, and muddy condi-tions,' said Bailey County Exension Agent Spencer Tanksley. 'Basically, that weather has been good. We have had good, general rains across the country for the last two weeks in varying amounts."

The Extension agent conti-nued, "The benefits from the rain will surely enhance crop yields, although most producers are ready for some clear, warm weather and sunshiny days.

"For dryland, the rainfall has sure increased crop production prospects, for both cotton and grain sorghum.

'It has caused some damage in acreage, by slowing cotton fiber production," he added, "and has caused some insect especially problems, since farmers can't get into the fields and spray. Both cotton and grain sorghum are seeing increases of infestations of head worms and boll worms. Also, rain has hurt some alfalfa hay crops, if they were cut and on the ground, and some minor disease has been noted in

vegetable crops." Farming is generally at a standstill, said the county agent, and even if the weather should clear up immediately, it would still be several days before the farmers should be able to get into their fields.

## **3** Lawsuits Are Moved **To Lubbock**

At approximately 1:45 p.m. Friday, attorneys from Lubbock representing Westworld Com-munity Healthcare, Inc., lessors of West Plains Medical Center in Muleshoe, filed orders in the District Court in Bailey County removing three lawsuits from Bailey County to federal Court in Lubbock.

The three suits involved were lawsuits filed against Westworld Community Healthcare, Inc. by Dr. Homer Allgood, Dr. Jack McCarty and Dr. Enrique Muyshondt.

Reasons for removing the lawsuits from jurisdiction in Bailey County were given in the PETITION FOR REMOVAL as follows: "...in that it is a civil action wherein the matter incontroversy exceeds the sum of \$10,000.00 exclusive of interest and costs, and is between citizens of different states."

As the suits were removed to the United State District Court, for the Northern District of Texas, Lubbock Division, they will now be held before Judge

## Compulsory Attendance **Is Noted**

"The beginning of the school year seems to be an appropriate time to remind the public of the Compulsory School Attendance Law of Texas," said Bailey County Judge Gordon H. Green. He added, "The Texas Ed-

ucation Code provides that every child in the state who is as much as seven years of age, and who has not completed the academic year in which his 16th birthday occurred, shall be required to attend school unless excused as provided by law. Any parent or other guardian who fails to require their child to attend school as required by law is subject to criminal charges. Each day the child remains out of school may constitute a separate offense.

"The Juvenile Code also provides that the unexcused voluntary absence of a child on ten or more days or parts of days within a six month period or three or more days or parts of days within a four-week period from school is conduct for which the Juvenile Court may assume jurisdiction over the child," he added.

Judge Green concluded, "Unexcused absences will be reported by the school officials to the juvenile authorities and investigations will be made. All parents, guardians and school age children should understand and comply with the attendance Cont. Page 6, Col. 5 laws."

Three minutes and 10 seconds later, Michael Dunham plunged through a narrow opening into the end zone for six. He then followed through almost the same route a play later to add two extra points, and turning the game around to a 15-14 Muleshoe lead.

### **Babies** Are Too **Young To Diet**

In a misguided attempt to prevent obesity, heart disease, hypertension and other dietlinked conditions, some healthconcious parents are putting their children on restrictive diets.

According to Dr. Dymple Cooksey, a nutritionist with the Texas A&M University Agricultural Extension Service, this practice may cause stunted growth and failure to gain weight in children under two.

Nutrition researchers have found that these parents typically substitute skim milk for whole milk, feed their toddlers lean meat and complex carbohydrates and no more than three eggs per week, while also forbidding snacks between

meals

"This type of low-fat, low-cholesterol diet can be appropriate for an adult, but will result in young children getting only 63 to 94 percent of the calories they need," she says.

It's particularly important that babies drink whole milk, says Cooksey, since the fat provides essential fatty acids and calories, in addition to the calcium, vitamin D and phosphorous \_\_ found in all milk.

Research studies show that nutritious snacks provide up to 20 percent of a child's food energy. They also supply much of the vitamin C-rich foods and liquids in the form of fruits, juices and drinks.

Rather than deny young children snacks, parents should make sure the snacks are nutritious, advises Cooksey. Fruits, fruit juices, fresh vege-

tablet pieces, cheese and crackers, egg custards are all examples of nutritious snacks.

Sugary snack foods, including soda, candy, sweetened fruit drinks, cakes, pies and sugared cereals contain many calories but very few nutrients. So parents can justifiably limit these snacks, says the nutritionist.

acres hurt in the recent weather is much less, and production

will not be affected that much. The county agent also said the moisture is a 'big boost' to established wheat on drylands, and predicts that a lot of wheat will be planted within the next two weeks.

"Range conditions are in as good a condition as they have been for the past five to ten years, since the middle to late 70's," added Tanksley. "Livestock is in excellent condition, although the market is slow.'

Then, Tanksley added, "But low prices are the biggest problems facing the farmers at this time. I predict that a lot of the county crops will be going into the government loan program this year."

Vegetables are still producing good, including honey dew melons, bell peppers, carrots, green beans, watermelons, cabbage and cantaloupe. Harvest is virtually over for potatoes, onions and sweet corn, continued the county agent. "Overall," said the county agent, "we needed the rainfall. We got the rain and how we need very hot weather to help mature the crops." He also spoke very briefly about the Conservation Reserve Program, and said more than 88,600 acres have been accepted into the program from Bailey County now, for the biggest acreage in the program from the State of Texas. During the last sign-up, 50,000-plus acres were signed up at up to \$40 per acre. This will take approximately onefourth of the 360,000 acres in the county out of crop production for the next ten years.


free country. Bessire's 27 yard TD run was enhanced by Greg Young's extra point kick, and the game showed Muleshoe 22-Olton 14.

## **Fuel Tax Hike Is Not Solution**

A five cent increase in the state tax on motor fuels. as proposed recently by Highway Department Chairman Robert C. Lanier, concentrates the state's a ficit reduction burden on a B-h aguered segment of the economy and therefore is not an equitable solution, says Robert Floyd, president of the Texas Motor Transportation Association.

"In 1984, the Texas truck and bus industry stood in strong support of the increase in motor fuels taxes to 10 cents per gallon. increases in registration fees, and a one percent increase in the motor vehicle sales tax to help fund education reforms and the highway program." Floyd explains. "Another five cent increase in fuel taxes at this time would be very hard on an industry plagued by furious competition and a downturn in the economy."

Motor fuel is one of the most heavily taxed essential commodities in the nation, and since 1982, fuel taxes for Texas. users have nearly doubled. In combined state and federal fuel taxes. Texas diesel fuel users pay 25 cents per gallon. In 1986 a trucking company will pay as much as 9,200 in taxes on fuel, equipment, and licensing for a typical five-axle tractor and semi-trailer.

per gallon would aggravate conditions for the motor carriers who are vital to the state economy, Floyd says. With increased overhead from skyrocketing insurance premiums and a declining volume of freight to be hauled, many trucking companies are barely surviving. Adding this additional tax burden to an industry that is reeling because of marginal profits and an unstable marketplace would undoubtedly result in more worker layoffs and increased company failures. both of which would be detrimental to the state's conomy. "These are difficult times for the state of Texas," Floyd says. "Our industry's leaders are ready to work with the Legislature to solve the state's revenue problems.

"The current low price of fuel at the pumps is unlikely to last with the volatile nature of the Middle East. An increase in fuel taxes would not be a painless solution, but would have a severe impact on all motorists and on the financial stability of the Texas truck and bus industry," Floyd says.

Based in Austin, the Texas Motor Transportation Association reprsents the public and private sector of the truck and bus industry in Texas. The group has 750 allied and carrier members.



The truth is reporters writing these stories don't know why, and accept the view of brokers, who themselves are guessing. In recent weeks we have seen financial reporters write one week interest rates are going up and the next week write they are going down.

There are even stories contradicting one another on this and other questions from one day to the next. Aside from financial advice columns,. which analyze a question in some detail, and are signed, news reporting on the market's ups and downs is almost worth-
