



Texas, February 6- Average retail gasoline prices in Texas have risen 2.5 cents per gallon in the past week, averaging \$3.37/g yesterday. This compares with the national average that has increased 3.0 cents per gallon in the last week to \$3.43/g, according to gasoline price website TexasGasPrices.com. Including the change in gas prices in Texas during the past week, prices yesterday were 43.4 cents per gallon higher than the same day one year ago and are 17.0 cents per gallon higher than a month ago. The national average has increased 10.2 cents per gallon during the last month and stands 31.9 cents per gallon higher than this day one year ago. "The national average has continued on its upward trend as we move closer to spring and EPA-mandated cleaner burning gasoline," said GasBuddy.com Senior Petroleum Analyst Patrick DeHaan. "The smaller movements in gasoline prices as of late in areas of the country will certainly not hold much longer. Gasoline prices tend to start moving significantly higher towards the end of February and into mid-March, so motorists should be preparing for higher prices,' DeHaan said. GasBuddy operates, TexasGasPrices.com, and over 225 other local gasoline pricetracking websites that fol low prices at over 125,000 gasoline stations in the United States and Canada. # Texas Crop & Weather

The following specific livestock, crop and weather conditions were reported by Panhandle Extension directors for February 7 2012: Temperatures were above average for most of the reporting period, then dropped to near average. Part of the region received some moisture late in the week, with accumulations ranging from a trace to 1.5 inches. Soil-moisture levels varied from adequate to very short with most reporting short to very short. Winter wheat was in poor to very poor condition. Most rangeland and pastures were in poor to very poor condition. Cattle were reported as mostly in good condition, with a few herds on irrigated wheat experiencing bloating issues. Livestock producers continued supplemental feeding of livestock.

McKeown, ticked off at the race people for scheduling their event at the same time as the revival, told his supporters it was like Elijah's joust with the prophets of Baal to prove who had the real god

"I ... reminded them that Elijah's God is ours," the preacher recalled, and the group prayed hard.

The next day, when the afternoon revival service was over, McKeown found out at the railroad station the race had degenerated into arguments and even gunplay, the \$1,000 had been withdrawn and that most of the "sinners" had gone home mad.

That's the sort of story you can read in David Murrah's 2009 book, "'And are we yet alive?' A History of the Northwest Texas Conference of the United Methodist Church.'

Gruver native Murrah wrote the book to mark 2010's 100th anniversary of the conference, which covers the Texas Panhandle and stretches to the Lubbock, Abilene, Childress, Midland and Big Spring areas. The conference, reorganized in 1910, was split from a previous NWIC that covered a larger area of the state. The book is available from the NWTC office in Lubbock or from State House Press (www.tfhcc.com/press). Murrah, 70, now lives in Rockport and is a senior historian for Southwest Museum Services in Houston. A strength of his book is its melding of church history with larger events such as the coming of the railroads, World War I and campus unrest at McMurry College in the 1970s. The work covers essential history such as the first NWTC meeting in Clarendon's massive new church in 1910 and the appointment of the Rev. Max Whitfield as bishop in 2000, and Murrah doesn't sweep controversy under a rug.





# Words from Faith & Grace



by Cecil R. Biggers, Lutheran Lay Minister

In the sixth week of the Season of Epiphany, we discover that Jesus is "willing", as we study 2 Kings 5: 1-17, Psalm 30, 1 Corinthians 9: 24-27, and Mark 1: 40=45.

Naaman, the Commander of the Army of Aram, was a mighty warrior who suffered from leprosy. An Israeli slave-girl tells Naaman's wife of a prophet in Israel who could cure Naaman. After a series of events, Naaman rolls up to Elisha, the prophet, with his war-chariots and cavalry. Elisha sends a messenger to tell Naaman to dip himself into the river Jordan seven times and be cured. Naaman initially refuses until his servants implore him to comply. Naaman would have done any difficult thing, but he could not understand doing a simple one. Naaman complying with the prophets instruction was healed. We see this mighty warrior transformed in body and spirit by the word of God. Learn from this that we cannot encounter the living God, even in a simple manner, without being transformed.

The Psalmist sings a song of praise because God has ransformed his mourning into dancing. The Psalmist recalls that the Lord has delivered him from crisis; he then asks others to join him in praising God. The Psalmist recalls his ill-founded attitude of self-assurance before his crisis. He then recalls his prayer for help which God answered. When we meet the living God in prayer, we are transformed.

Paul uses the image of a runner training for his race to exemplify the Christian life. In the Greek contest, only the winner received the prize; the also-ran's received nothing. For the runner it takes discipline, perseverance and fitness to compete successfully. For the Christian it takes knowledge of our goal (eternal life with Jesus) knowledge of the worth of our goal (Jesus is everything to me), and we must master ourselves so that we are not disqualified. Living the disciple life takes practice, practice, practice. When we sin, and we do, we must not let that dissuade us from persevering through prayer and the enabling of the Holy Spirit toward our Goal in Jesus Christ.

A leper comes to Jesus, begging to be healed. The leper, by Law, should not have approached or spoken to a rabbi. Verse 42 is translated "Moved with pity ... ", it is probably more accurately translated "Moved with anger..."; yet, the anger is not with the leper but with a society which excludes the leper from any contact, any support from his community. No rabbi would have touched such an unclean person, but Jesus did. Jesus was willing to heal the leper and says, "Be made clean"; this phrase is exactly the phrase that Jesus used when commanding the demon to leave the man possessed. Immediately the leper was healed. After "snorting" at the leper (RSV "After sternly warning ... "), Jesus tells him not to say anything about being healed but to go and fulfill the law by showing himself to the priests and making the appropriate offering to God. Jesus is "willing" to transform us in body and spirit.



These mills are not sold locally, but shipped to Denver to apply toward the purchase of vintage windmills for the Association.
