HOUSTON-(Dec. 10, 1992)-Contrary to the way it usually happens, New Year's resolutions are not made to be broken.

"Resolutions can work any time of the year if you go slowly and realize you may not succeed on the first try," said Dr. Michael Cox, a psychologist at Baylor College of Medicine in Houston.

Successful New Year's resolutions begin as reasonable goals with reasonable expectations.

'Make the first step a small one, and take your time," Cox said. "Pick something at which you can be successful, and build on that suc-

Cox encourages people to ask, so they can help." "how can I take better care of myself next year?"

"It may sound self-centered, but working on personal growth makes you more able to take care of relationships," he said.

After choosing a resolution or two, write them down.

Cox says that it will not make the resolutions a reality, but it does indicate that you are serious.

Once New Year's Day arrives, it is time to review the list and to get

Whatever change you want to make, tell other people," Cox said. "Give them your sense of direction,

It may be a friend's encouragement to stick with that new walking program or a co-worker's positive comments that make the dif-

"Take credit for positive changes and accomplishments," Cox said. "As you begin to see yourself making changes, the attitude truly begins to change.

DPS requests help

Major Vernon Cawthon, Regional Commander of the Texas Department of Public Safety, said today, "Based on past holiday experience, we know that numerous persons will lose their lives and hundreds will be injured on Texas streets and highways during the 1993 New Year's holiday. The Department requests the help and support of the motoring public in reducing this needless waste of human life by observing all traffic laws, especially those regarding speed and alcohol.'

Major Cawthon said, "All available Department of Public Safety Troopers will be on patrol throughout the holiday period in an effort to reduce, both by their presence and actions, violations that could

lead to accidents. But it is only through the help and cooperation of the motoring public, by their self-compliance, that the needed reduction can be realized.

Major Cawthon stated, "Possibly the most prevalent accidents occurring this period will be the one car run-off-the-roadway type accident which is directly attributed to driver inattention and/or intoxication.

The Major suggested that adequate travel time be budgeted in holiday plans, stop frequently and rest, reduce speed for road conditions, and above all, don't mix alcohol and driving. If you drink at a party, let a sober friend drive you

Texas Railroad Commission... releases August stats

The monthly Texas oil and gas statistics for August were recently released by the Texas Railroad Commission.

According to the release, Hansford County's oil and gas wells produced 3,433,727 Mcf (thousand cubic feet) of gas and 28,612 barrels of oil in August.

Texas oil and gas wells produced 447,119,248 Mcf (thousand cubic feet) of gas in August. This is up by 1.17 percent from the 441,943,799 Mcf produced in August 1991.

The preliminary figures for the August crude oil production in Texas averaged 1,618,636 barrels daily, which was down from the 1,729,945 barrels averaged daily in August 1991.

Texas' preliminary oil production figure for August is 50, 177,686 barrels, which is also down from August 1991. In 1991 53,646,328 barrels were reported.

In October 1992, the Commission issued a total of 1,401 drilling permits, compared to 1,235 in 1991. The total included 59 to re-enter existing well bores, 886 permits to drill new oil and gas tests, 53 to deepen existing holes, 186 to plugback existing holes and 68 for other wells. 149 drilling permits were amended in October.

For the 1992 year-to-date, a total of 10,690 drilling permits have been issued. This is a nine percent decrease from the 11,697 issued in the same period of 1991.

In October, permits issued included 575 oil, 314 gas, 458 oil and gas, 39 injection, four disposal and 11 other permits.

Operators reported that in October there were 216 gas, 422 oil and 34 service completions, as compared to the 268 gas, 471 oil and 53 services competed in October 1991.

The total of well completions recorded for 1992 year-to-date is 6.553, a 21 percent decrease from the 8,252 recorded for the same time period in 1991.

For October 1992, operators reported 937 holes plugged and 60 dry holes, compared to 932 holes plugged and 291 dry holes reported in October 1991.

Miss Benton receives a \$2,000 scholarship; Miss Walker gets a \$1,500 scholarship.

K.C. Allan of Uvalde County won the Free Enterprise Speech competition and a \$4,000 scholarship. Kimmee Melton of Plainview took runner-up honors and a \$2,500 scholarship. The four finalists receiving \$1,500 scholarships were Sara Graham of Sherman County; Jana Casada of Collin County; Dawn Ohlendorf of Caldwell County; and Neil Childs of Howard County.

Along with the contests there was other business conducted at the convention.

The Rasors and the other voting delegates to the 59th annual Texas Farm Bureau (TFB) Convention called for term limitations for elected officials, but remained firmly against a state income tax here this week.

At the conclusion of the convention Wednesday, S.M. True, a Plainview cotton, grain and cattle producer, was re-elected to an 11th one-year term as president. The 916 voting delegates from 149 county Farm Bureaus also re-elected six state directors to another true weat term.

other two-year term.

Elected to their third and final two-year term are Leland White, Tahoka (Lynn County); Billie Ray Huddleston, Celina (Collin County); Harlan Huffman, McGregor (McLennan County); and Tommy Walker, Ulvalde (Uvalke County). Re-elected to a second two-year term were State Directors Bill Tullos, San Angelo (Tom Green County) and Tryne Mengers, Tynan

(Bee County).

In a board meeting following adjournment of the convention, Huddleston was re-elected secretary-treasurer, and Bob Stallman of Columbus (Colorado County) was

re-elected as TFB's vice president.
While several delegates stated a
preference to ending elected offi-

preference to ending elected officials' time in office at the ballot box, the body ultimately called for term limitations at the state and national levels. They also called for a term limit for the Speaker of the U.S. House of Representatives.

Delegates reaffirmed their strong opposition to a state income tax, overwhelmingly rejecting a "flexible" resolution that would allow Farm Bureau leaders to accept a state income tax.

Delegates expressed continued support for the North American Free Trade Agreement and urged that the Texas Department of Agriculture participate in the NAFTA debate.

On education and school finance, TFB delegates urged school systems to be more efficient. They reaffirmed their long-standing support for prayer in schools and for empowering teachers to enforce discipline in the classroom.

They said the redistribution of school taxes should also take into account the percentage of taxes collected in a district.

Delegates said they would support a high speed rail only under the following conditions:

*American technology is utilized.
All U.S. Technology must be considered.

*Capable of operation on existing right-of-ways.

*High speed rail must be selfsupporting with no federal, state or local funds required.

*The rail system must serve both rural and urban areas. If these TFB criteria are not met, TFB will oppose high speed rail.

The delegates reaffirmed their support for control of groundwater by local underground water districts.

On farm program issues, the delegates opposed a requirement that producers purchase crop insurance from a person or institution having a financial interest in the crop production.

They favored having all disaster payments being based on quality as well as quantity losses.

They said target prices should not be reduced below their 1985 levels and should not be used to determine deficiency payments.

loan rates should reflect increased cost of Environmental Protection Agency regulations and the cost of complying with conservation plans.

Among other national recommendations approved Wednesday the delegates:

*Called for careful monitoring of the implementation of the North American Free Trade Agreement to ensure that its terms are carried out on an equitable basis;

*Urged that Congress provide additional funds for research on Africanized Honey Bees;

*Said landowners should be compensated for all income and property value losses created by government imposed regulations;

*Called for an economic impact study and careful evaluation of the results before declaring that a species should be included on the Endangered Species list. Moreover, if private property is declared to be a habitat for endangered species the owner shall be adequately reimbursed for such restrictions.

*Supported increasing the Texas Agricultural Finance Authority General Obligation Bond limits from \$25 million to \$250 million;

*Self-employed taxpayers should be allowed to deduct the full cost of their health, dental and disability insurance premiums as business expenses

*Supported limits on further airport development and expansion that infringes on prime farm and ranch land and expansion of highways and roads in the airport development and expansion.

SORELY TEMPTED Matthew 6:13

Several years ago, Valentine's Day landed on a Sunday. As pastor of a small church located near a state prison, I often taught and counseled inmates. On this particular day one of those inmates was marrying a lady who regularly attended our church. The place was packed with friends, family and regular members.

The service and reception went beautifully. Everyone was blessed, except me. I still vividly remember preaching and visiting at the reception, with an almost unbearable empty feeling. I felt like a movie backdrop, all facade and no content. It was one of those times I was sorely tempted to call it quits. It seemed everybody was blessed but me.

Even though temptation is sure to come, in order to test and purify our faith, that knowledge is not enough to face and overcome it. Something else is necessary: God's eternal perspective. That can only be obtained, as one song says, "from the heights of a bended knee."

Probably the most important thing we must willfully remember in the midst of temptation is that it's not peculiar to us. Look around. Everyone else, including preachers, are tempted just like you and I. Remember that two rewards come to those who endure, and don't give in to the temptation: an escape route and a crown of life, both provided by God

Finally, and this has helped me times without number, remember Peter's reply to Jesus's question of whether he would desert Him. Peter said, "Where else can I go, Jesus. You're the only game in town", (Carter Reversed Version).

Have you found that Jesus alone has the words of life. If so, don't even consider shopping around. If not, quit your shopping and buy into Him.

It reminded me of the time that

"Twas a few nights before Christ-

I was able to spend a couple of days during Christmas with my parents in Oklahoma and the weather was first cold and blustery enough that a fire in the fireplace sounded good. So, we looked around for someone to volunteer to step

> I yelled at Betty to get the kids, guns, silver, jewelry and picture albums (not necessarily in that order) while I jerked on my britches, pulled on my boots and grabbed a jacket on the way out the door. Outside the cold front that had been forecast had come through as the temperature was about 20°F and the northwest wind was howling at 25 knots and the chill index had to be 20° below

When the flames were doused, I dashed away down to the bedroom to close the damper and cut off the air before the fire could catch up again. This had the predictable effect of filling the room with smoke as I dashed away to open the window, which faced the northwest wind.

Notice is hereby given that North Plains Electric Cooperative, Inc. (the "Utility") intends to change rates for electric utility service effective March 9, 1993, or as soon thereafter as may be permitted by law. The Utility has not had a rate increase since 1983. Based upon a test year ending December 31, 1991, the increase requested over actual test year revenues is \$369,472 or 4.67%. The changes are applicable to all areas, all custome classes, and all customers served by the Utility.

The Utility proposes to change all rates for residential, irrigation, small commercial large commercial, including demand, energy, minimum and other charges. The proposed changes are expected to affect the classes as follows: for the 2.997 customers in the general service 1-phase class, the proposed increase will be \$75,178 or a 3.50% change in revenues; for the 357 customers in the general service 3-phase class, the proposed increase will be \$15,183 or a 3.50% change in revenues; for the 70 customers in the irrigation class the proposed increase will be \$15,252 or a 4.97% change in revenues; for the 419 customers in the sprinklers and tailwater pump class, the proposed increase will be \$20,200 or a 10.00% change in revenues; for the 120 customers in the large power class, the proposed increase will be \$103,661 or a 3.50% change in revenues; for the 9 customers in the Perryton water works class, the proposed increase will be \$4,889 or a 6.18% change in revenues; for the 961 customers in the oil well pumping class, the proposed increase will be \$129,944 or a 7.71% change in revenues;

The Utility is required to give notice of the percentage increase in base revenues which is 10.53%. The percentage increase in base revenues is not an indication of how much your bill will increase. Rather, it is a measure of the increase needed by the Utility for its own operations, excluding payment of the cost of power purchased by the Utility from its wholesale power suppliers.

On or about January 8, 1993, the Utility will file with the Public Utility Commission of Texas, a Statement of Intent to Change Rates, specifying in detail each proposed change. Requests to intervene must be filed no later than 45 days after the application filing date. Thus, the Utility anticipates the deadline for intervening and objecting to the rate changes will be February 22, 1993. 


