Davis' Quilt Selected For International Show

Gruver quilter Gerry Davis has stitched up another honor as a semifinalist in the 2004 American Quilter's Society Show and Contest in Paducah, KY, April 21-24.

Davis' Piecemakers Times and Seasons 2002, was one of 425 quilts chosen for display at the international show where \$100,000 in prize money will be awarded.

The 90"x 90" quilt entered by Davis features a scene from each of the twelve months joined by Victorian crazy quilting. Velvet, satin, cotton, and silk fabrics are used in the creation which has a border of black and gold velvet.

Lavish embellishments are featured on the quilt including extensive silk-ribbon embroidery, antique buttons, antique tatting, seed beads, metallic spider webs (a mainstay for all crazy quilt designs), fabric with imprints of Davis family members, hand-dyed lace, and reproduction silk cigarette package

The quilt, on which Davis has worked for 18 months, also depicts ground zero from the 9-11 disaster.

Grand prize in the show will receive a \$20,000 cash award and a permanent space in the Museum of the American

Quilter's Society. More than 40,000 visitors attend the show each year. in the town known as "Quilt City,

USA." The individual quilt that is named the best of show will garner a grand prize of \$20,000 and earn a permanent space in the Museum of the American Quilter's Society.

The expert quilter designates each quilt for a family member to one day possess.

"The quilt I have just competed will one day go to my daughter Barbara Stavlo, and that's why I used pictures of her family on the quilt.," Davis said. "It will eventually be passed on to my granddaughter Sammy, whose picture is on the quilt twice. "

Combs Announces New Public School Nutrition Policy

Agriculture Commissioner Susan Combs has just announced the new Texas Public School Nutrition Policy for all Texas public schools participating in the federal child nutrition programs. The policy becomes effective Aug. 1, 2004 for schools participating in the National School Lunch Program, School Breakfast Program and

the After School Snack Program. "This policy is the result of months of collaboration with experts and interested individuals around the state who consider children's health and education a top priority," Combs said, "We want to ensure that foods served in our schools are nutritious and balanced,

and we are dedicated to promoting an environment that nurtures both mental and physical development." The policy limits the number of grams of fat and sugar Texas schoolchildren may have each week, and allows a phase-in period

to eliminate deep-fat frying in food preparation for meals, a la carte and snack items. In addition, portion sizes for food items such as chips, cookies,

bakery items and frozen desserts at elementary, middle and high schools are limited. The policy also limits the sale of foods that compete with a

school's operation of the breakfast, lunch or after school snack programs. A school can lose up to \$1.20 at breakfast and \$2.19 at lunch in federal reimbursements for each meal lost to a competitive food

"A majority of the state's schools will be soliciting contract bids for food and other supplies for the next school year within the next few weeks, and we wanted to release the new policy now to give them plenty of time to plan and prepare for any modifications," Combs said.

"We realize it will take time for schools and the food industry to make the necessary changes to products and recipes, so we want to use this policy to phase in better nutritional guidelines," Combs

"I appreciate all of Commissioner Combs' hard work in developing a policy that will help our children learn how to make wiser food choices during the school day," said Sen. Eddie Lucio Jr. "She was the first state official to actively support my legislative efforts of curbing obesity among our public school children through proper nutrition, and I look forward to the expertise and assistance she will provide the Joint Interim Study Committee on Nutrition and Health in Public Schools."

Dr. Eduardo Sanchez, commissioner Texas Department of Health, said, "Childhood obesity and obesity-related problems are reaching epidemic levels in Texas. If we don't act now to tackle these problems, both individual Texans and the state will be faced with a healthcare crisis of enormous proportions.

"The nutrition policy from the Texas Department of Agriculture is an important first step, and I applaud the efforts and contributions of all those who are working to ensure a healthy food environment in our schools," Sanchez said.

José Montemayor, commissioner Texas Department of Insurance, said, "Future healthcare costs for obesity and related diseases are expected to increase dramatically, having a direct impact on insurance premiums paid by individuals and Texas businesses. By addressing the problem of obesity now in our schools, we are not only promoting and encouraging a healthier lifestyle in our students, but also we are trying to keep future healthcare costs under control. I fully support the Texas Department of Agriculture and all who worked on this policy."

Risk Management Conferences To Help Beef Producers

Agriculture Commissioner Susan Combs announced that the Texas Department of Agriculture is partnering with Texas Cooperative Extension, the U.S. Department of Agriculture's Risk Management Agency and the Texas and Southwestern Cattle Raisers Association to offer conferences in April and May to help producers manage challenges and risks in the beef industry.

The first two conferences will take place at Texas A&M University Agricultural Research and Extension Center, 6500 Amarillo Blvd. West, in Amarillo on April 5 and at Ray Clymer Exhibit Hall, 1000 Fifth St. in Wichita Falls on April 7. Registration is \$20, and participants may register at the door. The events are from 8 a.m. to 5 p.m.

The conferences, called "Got Risk?" will also be held in six other major beef production areas of the state including Hallettesville on April 20, Abilene on April 28, Sulfur Springs on May 11, Waco on May 18, Palestine on May 19 and Alpine on May 26.

"These workshops are a great way to inform cattle producers the ultimate leaders in our agricultural business community," Combs said. "Our cattle industry is widely known for its quality and high levels of production, and there are a number of programs and strategies available to help cattle producers keep their operations moving forward."

The workshops will highlight various tools available to producers. Sessions will include information on prices, strategic planning, state and federal programs, country-of-origin labeling, drought management and value-added marketing, to name a few.

"Providing tools for our cattle producers is more important than ever," Combs said. "Risk management involves being proactive and prepared for shifts in the industry, severe weather, price volatility and many other situations that can be challenging.

Valor proposes the following monthly ELCS surcharges per business line: \$1.72 in Year 1, \$1.70 in Year 2, \$.06 in Year 3, \$.04 in Year 4, \$.02 in Year 5. Valor is currently billing interim ELCS surcharges approved by the Commission, including an interim ELCS surcharge of \$.65 interim ELCS surcharge of \$.65 per month per residential line and an interim ELCS surcharge of \$1.30 per month per business line.
