Texas Panhandle Sheriff's Association Meets In Spearman

In 1986, a group of Texas Panhandle Sheriffs, while attend-Annual Sheriff's Association of Texas meeting in El Paso, TX, decided that they needed a means of getting together in a regular or formal setting to discuss regional concerns. They felt that they should meet more often than the annual state meeting. Thus, the Panhandle Sheriff's Association was created.

These Sheriffs initially chose to meet every other month at a mutually agreed upon location in the Texas Panhandle for a meal and

time of information sharing. The Texas Panhandle Sheriff's

Association (consisting of the twenty-six counties of the Texas Panhandle) later decided that they should expand their meetings to include any and all law enforcement agencies, thus the Texas Panhandle Sheriffs' Association was changed to the Texas Panhandle Peace Officers Association (TPPOA). They have continued to meet, assist, discuss, Officers and fellowship with one another in an attempt to provide more effective law enforcement for the people of the Texas Panhandle.

The Texas Panhandle Peace Officers Association conducted their regular business meeting on

November 18, 1999 in Spearman, Hansford County, Texas.

The meeting was co-hosted by long-time Sheriff R.L. McFarlin, Jr. of Hansford County, Texas and former Sheriff of Hall County, Jarrett Wilde, who is currently Chief of Police with the Spearman Police Department.

The meeting was presided over by Sheriff Michael L. "Mickey" Blackmon of Hutchinson County, Texas who was elected president of the Texas Panhandle Peace Officers Association and will serve the TPPOA in that capacity for a two-year term of office (1999-

Sheriff Blackmon also serves the Texas Association of Counties on their Policy Analysis Group Committee. He serves along with Travis County Sheriff Margo Frasier as one of two Texas Sheriffs on this state-wide committee studying county governments role as it functions within the State of Texas. Sheriff Blackmon has also been appointed to chair the resolutions committee of the Sheriffs' Association of Texas and is a member of the Membership Committee of the Sheriff's Association of Texas.

Former Lipscomb County Sheriff Calvin Babitzke, who is

with the Hutchinson County Sheriff's Office, was elected vicepresident of the TPPOA. He led the group in a pre-meal prayer.

A business meeting was conducted after the meal, including discussion of old and new business. The floor was opened for an open forum style discussion.

Sheriff Carmilla Jones of Armstrong County informed the group that she had accepted a position with the Texas Association of Counties in Austin, TX and would soon be moving to Austin, but she would maintain ties with her Texas Panhandle Law Enforcement Family.

Mr. Bill Chiders, the training coordinator for the Sheriff's Association of Texas in Austin, TX was the guest speaker. He gave a brief talk about the changes in civil process as it affects law enforcement, and also law enforcement concerns relating to Y2K

Margaret E. Gibner, 90, a resident of Albuquerque, NM since 1991, died on Sunday, November 28, 1999.



Hansford Hospice Highlights

Coping with Grief **During the Holidays**

No simple guidelines exist to take away hurt, but some things can be done to help people better cope with grief during this joyful, yet painful, time of year

Listed below are a few ideas that may be helpful.

Talk about your grief, Ignoring it won't make it go away. And, alking about your grief openly may make you feel better. Surround yourself with caring friends and relatives who will lisen without judging you. And talk candidly about the person who was a special part of your life, including their name in your conersations and embracing your memories of them.

Be tolerant of your physical or psychological limits. It is natural to become fatigues by feelings of loss. And, well-meanng friends and family often try to prescribe what is good for you when you're grieving. Instead of going along with your plans, respect what your body and mind are telling you and do what is ight for you during the holidays.

Plan ahead for family gatherings. Anticipate holiday activiies and structure your time, rather than simply reaching to what nappens. Getting caught off-guard can create feelings of panic, fear and anxiety during a time when feelings of grief are already neightened. Decide ahead of time which family traditions you would like to continue and which new ones you would like to

Renew your resources for living. The combination of a holday and a loss naturally results in looking inward and assessng your individual situation. Use this time to define the positive things in life that surround you.

And finally, as you approach any holiday, birthday, or special time, remember that grief is both necessary and a privilege. It comes as a result of giving and receiving love. Don't let anyone ake your grief away or try to distract yourself by "keeping busy." This will only increase your stress. Spend some special time alone, but don't isolate yourself from others. Think of your loved

one often, and laugh, smile or cry with family and friends. Healing is a personal experience that takes time. So, be tolerant and compassionate with yourself as you continue to heal







Olin Sheets locates the Rifle Pits, and he also explains the two graves on the Buschman ranch just north of the Palo Duro Park. He gave Sid Powers, a son of Ace Powers, as the source of the stories on the graves. The earliest one was of a cowboy who worked for the 777 Ranch which was also called the Rifle Pits Ranch.

'A bull knocked his horse down and trampled him to death and killed his horse by goring him. There were half a dozen men standing around watching, but it all happened so fast, they could do nothing.

Does anyone else have an account of this? I would like to find the cowboy's name and the year this happened. A Mexican sheepherder is buried in the other grave, but it is a longer story to be saved for another column.





Superintendent's Corner

by Rodney Sumner, Spearman ISD Superintendent

A buzzword over the past ten years in education has been the term - Site-Based Management or Site-Based Decision Making (SBDM). Although many have heard of Site-Based Decision Making, there is still a great deal of confusion by parents and the community as to exactly how SBDM will make our schools bet-

I think one of the biggest problems is that the term Site-Based Management is confusing and implies something that it is not intended to be. Site-Based teams or committees were never intended to become policy makers or minischool boards at the campus level. Then what is Site-Based Decision Making?

Site-Based Decision Making is a process for decentralizing decisions to improve educational outcomes at school campuses. Site-Based Decision Making is a collaborative effort by which principals, teachers, campus staff, district staff, parents and community representatives can assess educational outcomes of all students; determine goals and strategies; and, ensure that strategies are implemented and adjusted to

improve student achievement.

How did we get here? Senate Bill I (passed in June, 1990) provided for the establishment of district and campus committees where classroom teachers and campus-based staff representatives looked at campus progress in attaining student performance objectives. House Bill 2885 (passed May 1, 1991) required 'site-based decision making" and outlined the roles of campus committees. These roles were in goal setting, curriculum, budgeting, staffing patterns, and school organization. While these roles were established in broad terms, districts throughout the state interpreted the intent of the legislation in many different ways. The last major overhaul to the Site-Based process was in the past legislative session. Senate Bill 1724 (effective September 1, 1999) mandated that campus improvement plans include goals and methods for preventing and intervening in campus violence. In addition, Senate Bill 476 (effective September 1, 1999) included provisions that campus and district plans must include comprehensive needs assessments addressing student performance desegregated by all student groups, including special education programs.

The Site-Based process includes two different teams or committees. The first is a team at the campus level. Each school must have a campus committee made up of campus-based professional staff, parents, businesses and community representatives. The primary purpose of this committee is to work with and advise the principal in efforts to improve student achievement at the campus level. The theory behind the concept SBDM is that those in the trenches have the better ability to address educational problems and come up with solutions which will impact the students they teach. By decentralizing control, we have moved from top down management as it relates to student achievement. Makes sense! The primary document produced by this committee is a Campus Improvement Plan, which attempts to evaluate data (mainly TAAS test), and devise plans to address the needs at the campus level. Again the primary focus is to improve student Campus achievement. This Improvement Plan is an on going process and must be evaluated and reevaluated regularly to determine growth and refocus efforts. The commitment is great at this level and much time and energy is expended in determining what works and what direction we need

The other committee established the District Educational Improvement Committee (DEIC) which advises the superintendent in evaluating the district's instructional programs and setting educational goals and objectives. The composition of this committee is the same as that of the campus level. This committee is also charged with developing and evaluating the District Improvement

You may be asking yourself what does all this have to do with improving our schools. A valid question, since the Site-Based process has been around since the early 1990's. These teams are ongoing, enduring groups with a task. They are teams of people (from a diverse representation of the school district) given responsibility to work collaboratively on important goals. The results being improved student achievement.

Recently, parents of students attending Spearman ISD were mailed a "Parent Self-Nomination Form" soliciting names of parents to be considered for the District Educational Improvement Committee. The main focus of this week's article is to draw attention to the Site-Based process and to provide some understanding as to the roles and responsibilities of

Improving student performance is no easy task, and I applaud those involved in the process to explore options to make a difference in the way we do business at school. However, everyone has the opportunity to make a difference. Broadbased input is the main mechanism for the committees to operate effectively. I will try to periodically post minutes of both campus district Site-Based Committees and encourage you to route any questions or comments to the appropriate committee or

Site-Based does not usurp the authority of the Board of Trustees who have the final decision in approving the campus and district improvement plans. However, the goal of SBDM is to provide the administration and Board of Trustees with more input which should and will improve our educational programs. SBDM is a grass roots effort to get more people involved. An effort for each one of us to accept responsibilities for the success of our school system. An effort to make a difference! The old adage that it takes a village to raise a child is best exemplified in the Site-Based process. If you have any questions or concerns related to SBDM, please feel free to contact me or

pals. Remember, together we can

make a difference!
