Texas, September 19- Average retail gasoline prices in Texas have fallen 5.2 cents per gallon in the past week, averag-ing \$3.39/g yesterday. This compares with the national average that has fallen 4.2 cents per gallon in the last week to \$3.61/g, according to gasoline price website TexasGasPrices.com.

Including the change in gas prices in Texas during the past week, prices yesterday were 85.0 cents per gallon higher than the same day one year ago and are 7.4 cents per gallon lower than a month ago. The national average has increased 2.4 cents per gallon during the last month and stands 88.0 cents per gallon higher than this day one year ago.

"It took the end of summer for a drop in retail gasoline prices, but I'm sure motorists won't complain that we're finally seeing some drops in prices," said Patrick DeHaan, GasBuddy.com Senior Petroleum Analyst. "We've seen wholesale prices continue to be somewhat volatile, but I believe as we enter October we'll see markets slowly quiet down with retail gasoline prices falling to \$3.35-\$3.55 on average by Thanksgiving, with the exception being typical hotspots on the West Coast," DeHaan adds.

GasBuddy operates, TexasGasPrices.com, and over 225 other local gasoline pricetracking websites that fol-low prices at over 125,000 gasoline stations in the United States and Canada. GasBuddy also uses Facebook (facebook.com/gasbuddy) Twitter (twitter.com/gasbuddy), and phone apps to keep motorists ahead of changing gasoline prices.



Texas Crop & Weather

The following specific livestock, crop and weather conditions were reported by Panhandle Extension directors: The region received from a trace to 2 inches of rain and cooler temperatures. However, more rain was needed to have a substantial effect on soilmoisture levels. Along with the rain, Deaf Smith County had a 1.5-mile-wide band of hail that traveled 4 to 5 miles, destroying crops in its wake. Some cotton producers were still irrigating. Winter wheat was being planted. Rangeland and pasture continued to be rated very poor. Livestock producers further reduced herds and were weaning calves early.



Meanwhile, on Sept. 15, Texas Commission on Environmental Quality Chairman Bryan Shaw, in a congressional hearing on CSAPR, said, "Under average conditions, the potential generation loss in Texas caused by this rule will have real impacts to real people. Should Texas face another sweltering summer like this past one, there is every reason to worry about loss of life."





In the fifteenth week of Pentecost, we study Ezekiel 18: 1-4,25-32, Psalm 25: 1-9, Philippians 2: 1-13, and Matthew 21: 23-32. We learn something of our responsibility for sin, for others, and for God.

Ezekiel speaking to the people refutes the idea that children suffer for the sins of their parents. Now we recognize that a child may be disadvantaged and suffer consequences from the mistakes of its parents, but Ezekiel is taking away the form exiles excuses for their troubles. Each believer bears the responsibility of his/her actions. We must each accept responsibility for our own sin. God is willing to forgive each of us, if we turn away from our evil ways in repentance. God has no pleasure in the death of anyone.

The Psalmist sings a song of thanksgiving to God. The Psalmist surrenders his being to God requesting that he not be put to shame, that God teach him and lead him in God's ways, and that God forgive him and not remember the sins of his youth or his adult transgressions. A song that we all can sing.

Paul exhorts the Philippians to allow the same mind to be in them that was in Christ Jesus. The greatest enemy of the young church is disunity. If the faithful put away selfish ambition and conceit and with humility regard others as being better than themselves, it is possible for them to live the mind of Christ together. The believer is to work out his own salvation through God who is at work in them. I cannot truly believe in my Lord, Jesus Christ, or accept God's grace without the work of the Holy Spirit within me. Therefore I cannot boast of my own righteousness, but boast only of Christ crucified.

The chief priests and the Sanhedrin seek to trap Jesus into 'blasphemy'. They ask Jesus by what authority he performs his miracles and by what authority he teaches. Jesus turns the trap back on them by asking, "Did the baptism of John come from heaven, or was it of human origin?" The elders are stumped. If they admit that John was sent by God they will have to admit that Jesus is The Messiah, if they deny that John was sent by God the people will rise up against them. So they answered, "We do not know." Allowing Jesus to say, "Neither will I tell you by what authority I am doing these things. Jesus then tells another parable of two sons. A man asks one of his two sons to work in his vineyard. The son says, "I will not" and later does the work. When the father asks the other son, he says "I will", but he does nothing. Jesus asks, "Which the two did the will of his father?" The elders answer, "The first." Note that both sons are not initially obedient; they both lack something. Jesus uses this to show that those 'sinners' who heard John believed him and God accepts them. The elders although claiming special religious knowledge did not believe John and God will hold them responsible.
