**H.C.H.D. Physical Therapy Department to hold an Open House**

Hansford County is observing National Physical Therapy Month during October, following a proclamation by Spearman Mayor Burl Buchanan.

The public is invited to an open house Tuesday, October 24, from 4:00 p.m. to 6:00 p.m. This is an opportunity to meet the Physical Therapy staff and to see Hansford Hospital's new up-to-date Physical Therapy facility. The entrance to the Physical Therapy Department is located on the south side of the hospital on 8th Street.

Carol Dunnihoo, P.T., and her staff of two licensed physical therapy assistants, Mitzl Mires and Hector DeSantiago, provide many services in a variety of settings, depending on the needs of the individual patient. They may visit patients in their homes through Hansford Home Care; work with patients during their acute hospital stay; provide services to nursing home residents; or patients may come to the Physical Therapy Department as outpatients. Hansford Hospital's Physical Therapy Department also provides services on a contract basis to the Perryton Special Educa-

tion Co-op and Region 16 Education Service Center, both of which serve children in the upper Panhandle.

National Physical Therapy Month is designed to focus on the important role physical therapy plays in today's healthcare system. Examples of ways the physical therapist contributes to an individual's total health care are through treatment of musculoskeletal and neurological conditions to obtain a maximum level of functional ability. Methods such as therapeutic exercise, massage, heat, ice, electricity, sound waves, and water are used in various ways to achieve the most beneficial results.

Hansford Hospital is proud of its homegrown Physical Therapy staff. Carol Dunnihoo is a long-time resident of the county; she and her husband, Johnny, are local farmers. Mitzl Mires and her husband, Allen, are Spearman natives. Hector DeSantiago and his wife, Elda, are Gruver natives.

"We look forward to showing our excellent facility to the public and introducing our staff. We want

people to know they can get quality physical therapy services right here at home," says Hospital District Administrator, Anne Snow.

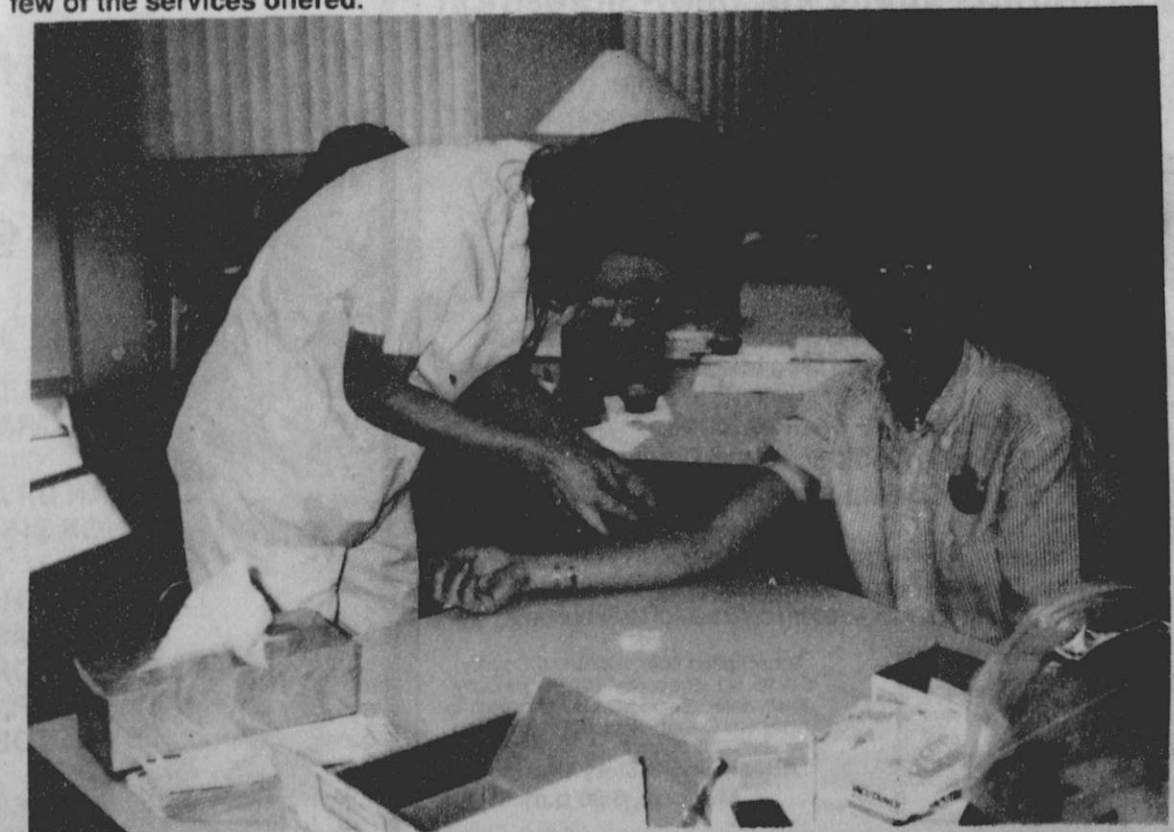
Reyes Hernandez, 46, was arrested for local warrants on the 200 block of James.

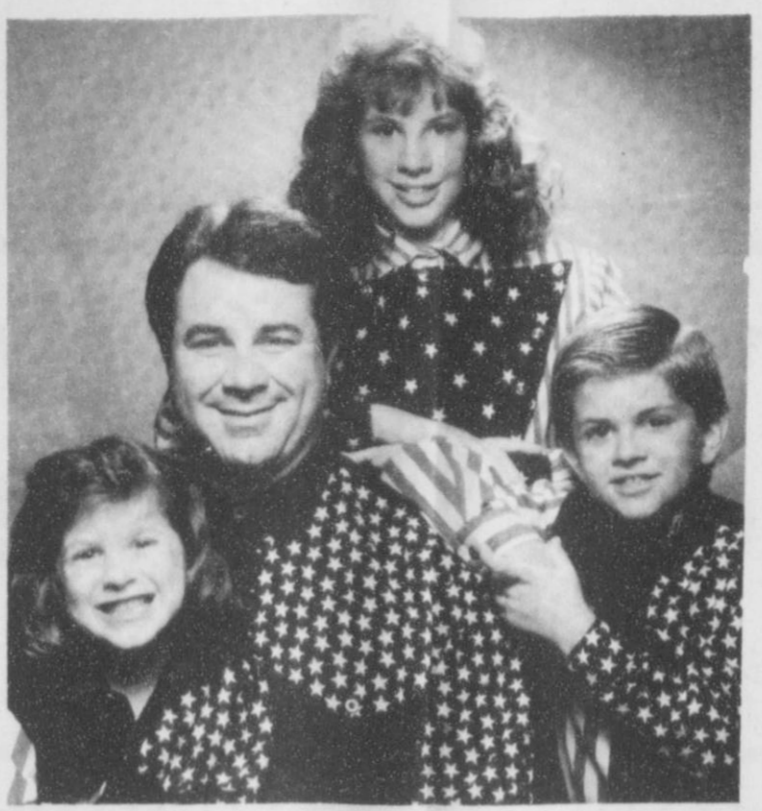

**Dear Editor:**  
 Rural Texans have long felt that their concerns were not being heard in state government. HARK! State government has heard our rural plea to develop financing for diversification of agriculture, at last! The legislature established the needed funding for a market-based finance program that helps Texas agriculture and Texas workers, without creating any new taxes or bonding authority. 90% of everything raised in Texas goes out-of-state to be processed; one of the worst rates in the nation. To bring Texas up to the national average of 20%, in-state production would add 22 billion dollars to our Texas economy.

from the existing bonding authority of the Farm and Ranch Finance Program, an underutilized program, to expand the TAFE program. TAFE has already been able to add \$400 million to the state economy, effectively and efficiently, on a limited amount of funding. Imagine the economic impact TAFE could have on rural Texas with the funds and opportunity to multiply the benefits. With the passage of Proposition 3, more bond money will be accessible for expansion, development, production, and marketing of Texas agricultural products, which means jobs for rural Texans and economic growth for rural Texas.

On the November ballot, find Proposition 3 and vote YES! Proposition 3 will shift resources from an underutilized program to a program that will benefit rural Texans. The program is the Texas Agricultural Finance Authority (TAFE), and the amount is \$200 million. This money can be shifted

## Library Book Notes

Hansford County Library has, because of concerns over the safety of children as well as legal liabilities, had to adopt a policy on unaccompanied children in our library. Public libraries across the nation have noticed an increasing problem with children being dropped off by parents for extended periods of time in lieu of daycare. Our rules are not meant to discourage children from using the library, but to encourage parents to come with their children rather than sending them in alone. Our new policy also addresses the need for children to be picked up on time at the library's closing. The policy is as follows:

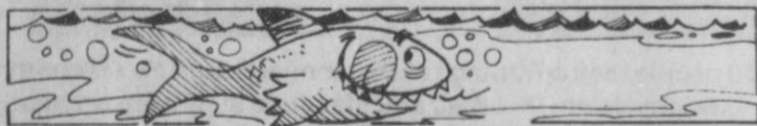
Hansford County Library welcomes and encourages children to use its facilities and services. Responsibility for children using our library rests with the parent or guardian, not the with library personnel.

Children, ages six and under, should not be left alone in the facility; they must be accompanied by an adult.

Disruptive children will not be allowed to interfere with library service to others. Such behavior will include any behavior on library premises which infringes on the rights of others using the library. Parties who become disruptive may be asked to leave the facility and parents or authorities contacted.

Our library closes promptly at 6:00 p.m. on weekdays during the school year, 5:00 p.m. on weekdays during the summer months, and 1:00 p.m. on Saturdays. Because of safety concerns for unattended children after hours, authorities will be contacted.

Children who don't as yet know how to read have a very difficult time selecting materials for us in a library setting. A love of reading and books is such an important part of a child's development, that our library board and staff hope that all parents will take the time to bring their children to the library rather than just sending them in alone.

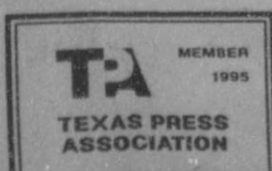

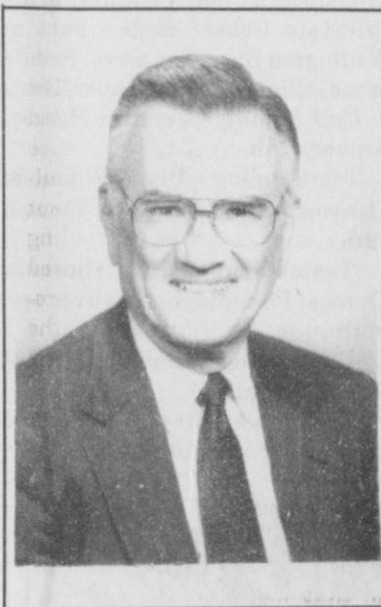

## Turner completes Army ROTC training

Army ROTC senior cadet Chris Turner has recently completed Army ROTC Advanced Summer Training at Ft. Lewis, Washington. This training consisted of 6 weeks of instruction and leadership evaluation on the fundamental skills required of newly commissioned Army officers.

Turner, a senior Business Management major at Sam Houston State University located in Huntsville, TX., has been involved in many activities in his 4 year cadet career. Some of these activities include participation in the Ranger challenge competition, 4 years active involvement in Ranger Company (which he now commands), and graduation from Army Airborne school at Ft. Benning, GA. This summer, after graduating from Advanced summer Training, Turner spent three weeks of Cadet Troop Leadership Training with the 3rd Armored Cavalry Regiment located at Ft. Bliss, TX. He was assigned as acting platoon leader in a strict armor company, where he became familiar with the officer side of an armor (M1A1 Abrams main battle tank) platoon.

In addition to Cadet Turner's activities, he has received many awards. He has been named 2 time

Ranger of the Semester, received the Battalion Commander's Award for Outstanding Cadet of the Semester and the SHSU Outstanding Cadet Award. Turner has also been designated as Distinguished Military Student and recommended for a Regular Army type commission. He commands SHSU's Ranger company, the largest company in the SHSU's Raven Battalion. # City Lites

More than fifty Texas cities, including the city of Spearman, have joined together to write a model GTE Franchise Ordinance. The coalition has hired Austin attorney Jim Boyle, who specializes in public utility law. Boyle will draft a proposed GTE franchise ordinance that is equitable for cities and for ratepayers.

Why is this ordinance necessary? The Texas Legislature required telephone companies to have franchise agreements and pay cities for the use of City property that benefits the telephone utility. For example, GTE puts its telephone poles, wires and other equipment within public rights-of-way, including streets and alleys, underground conduits owned by the city; and city buildings and facilities. The coalition of cities believes that most cities have not been paid the right amount of franchise fees by GTE.

GTE is asking that cities pass a new franchise ordinance, and this request provides an opportunity to correct some problems in the current franchise agreements. The city of Spearman's franchise agreement expired several years ago; we have been waiting to see what the Legislature was going to do with the telecommunications industry

before entering a new franchise agreement.

The franchise proposed by GTE has some problems for the cities. Some of the problems include: GTE's ordinance fails to tie franchise payments to revenue received by GTE from local telephone services; The company asks cities to give up all claims of underpayment of franchise fees without having any idea of the size of the claims. Some experts estimate the underpayments to be from 30% to 50%. For Spearman, this could be between \$1,295 and \$2,158 per year. If this goes back to the breakup of AT&T in 1984, the total bill could be between \$13,000 and \$21,000.; GTE's ordinance does not give cities the right to audit the books and records of GTE. In fact, it does not require GTE to provide any records to cities when we ask for it; and GTE's ordinance provides that any legal action taken against GTE can be filed only in Dallas County.

The City of Spearman will stay actively involved in negotiating a new telephone franchise agreement with GTE. Ultimately, we hope to have a franchise ordinance that is fair to Spearman ratepayers and at the same time provides the City of Spearman with proper franchise fees.

## Panhandle Crisis Center Report

We're off to a running start with our new officers on board. Because of the efficiency and continuing interest of the "old" officers, the transition has been smooth. Another contribution to this smoothness is the efficiency of the staff. Did you see the picture in the PERRYTON HERALD of our Executive Director, with the "Workhorse of the year" horse collar draped around her head and neck? We're pretty proud of her. And of our Office Manager. And of our shelter supervisor. And of all the other staff members, plus the rest of us who serve on the Board or volunteer in other ways, and attend to those tedious chores in which we all of us float - like flotsam and jetsam don't do in running water.

Some more good news: We've received a generous grant from the Department of Human Services for funding our rape program. Until now, we've had little need for this funding, but our outreach has been so enlarged, and faith in our aid has so increased that when we applied for the funding, it was granted on the first try.

Along with the announcement of having received the grant came some statistics on the history of rape and/or incest, as documented from the courts. (We all of us know that only a tiny bit of this exploitation has surfaced - these waters run very deep.) Anyway, this history states that violence against women was not recognized until about a hundred years ago: With courtesy toward states rights, though Congress enacted the ruling, it was up to each state to set its own limits. When it came to Statutory Rape (which, no doubt, you know is sex with the consent of the female, who has been cajoled into the sex act "of her own free will," but was really too young to know what was going

on) at first most states listed the age at which this was "illegal" as 12 years and younger. Some set it as low as 10 years and younger. One (whose name I shall not name) set it down to 7 years and younger.

Fancy that! If the child was 7 years old, it was all right to have sex with her if she agreed to it! During my dating years, the age in Texas was 15 years. Now, thank goodness, it's 18 years.

Be that as it may, violation of girls and women, even by a family member, still goes on. So you can well imagine the need for this sexual assault ministry. Even for women whose incest experiences were back in their childhood, and possibly it wasn't even unpleasant, their maturing realization of their violation is difficult to deal with. Even without this realization, their self-respect has been severely damaged. We have yet to make the drawing for the CD player that we raffled off last month. We appreciate all those of you who bought raffle tickets. Since this money was raised for the enrichment of the local United Way fund, let me tell you of the baseball with the signatures of all the Cleveland Indians players - and our own Mike Hargrove - the United Way itself is raffling off 2 as its own contribution to its funds. How about that! Tickets are at the United Way at the courthouse.

Remember, the Panhandle Crisis center offers services free of charge to men or women who are victims of domestic violence, whether physical or "merely" verbal. We give counseling, support, and information to these victims, plus a shelter to those who feel themselves to be in danger at home. We are available for help 24 hours a day, at 435-5008. ## Gruver Greyhounds remain undefeated winning district game

The Gruver Greyhounds overcame a lackluster performance this past Friday night, October 13, at Greyhound Stadium, to down the visiting Boys Ranch Roughriders, 20-8.

Yes, the Hounds racked up some good and interesting stats. Tye Womble had three key interceptions, and played an outstanding defensive football game. Daniel Bort racked up 152 yards on 24 carries, and Travis Ferguson racked up 115 yards on 19 carries, but

after the game, one had to wonder where all the yards came from. Gruver fumbled seven times on Friday the 13th, losing five fumbles, and they did get a break or two. Without one of the breaks, Boys Ranch may have had an opportunity to win this ball game.

The game started out to be a disaster. Gruver had a nice drive going on the first possession of the game, but fumbled on the 46 yard line, and it was Boys Ranch ball.

Boys Ranch, surprisingly, was then able to move the ball well, as it

seemed the Hounds were just making a token appearance in this game. The Ranch gained two first downs, and moved to the Hounds 31 yard line. That despite two penalties which hurt the Ranch. On a 4th and 16 play, they punted, but Daniel Bort couldn't handle the punt and fumbled, and what a break for the Hounds deep near their own goal line. There was an inadvertent whistle prior to the fumble as Bort was going down, and the Hounds were able to make the Ranch punt the ball again. Whew!

On the second punt attempt, Travis Ferguson steamrolled in and blocked it, and it was the Hounds ball on the 45 yard line. But the Hounds netted only 3 yards on the series, and James Sursa had to punt. Sursa, filling in for the injured Wylee Maupin, did an outstanding job.

Boys Ranch took over in their own territory at the 10 yard line, but on their second play of the series, they fumbled on the 18 yard line. What an opportunity for the Hounds!

Gruver moved with a steady charge to the 2 yard line, where Bort carried it over for the touchdown with 1:57 left in the first quarter. But the Hounds self-destructed. A critical 15-yard holding penalty was assessed, and the Hounds ultimately failed on 4th and goal from the 20 yard line.

One had the sense that this was indeed Friday the 13th.

After Boys Ranch failed to move at the start of the second quarter, the Hounds finally got things rolling. It was a seven play, 54-yard drive, with a great highlight catch by Sursa of a 18 yard pass from Bailey Barkley. Sursa looked like Jay Novacek catching a pass from Troy Aikman in a Super Bowl. What an outstanding, leaping catch! Ferguson did the honors from 7 yards out, and with 8:57 left in half, the Hounds were struggling, but ahead,

7-0.

Boys Ranch couldn't move, as it was three and out, but on the punt, the Hounds fumbled, and the Ranch maintained possession. They moved all the way to the Hounds 11 yard line, aided by a personal foul penalty on the Hounds which was a cheap call by the referee, one made more by the Boys Ranch bench than the official. But the 39 yard drive ended with a fumble, as the Hounds took over and dodged a bullet.

The Hounds took over, couldn't move, and punted. Boys Ranch took over at the 45 yard line, but Womble intercepted his first on the first play of the series, and it was Hounds ball on the 10 yard line, deep in their own territory.

But the Hounds put together a nice drive, with Bort carrying 3 times for 27 yards, and Maupin coming off the bench to make a key 35 yard reception from Barkley. The Hounds had a first and ten on the Ranch 28 yard line, but failed to gain a yard on four consecutive attempts, three of them passes, and the Roughriders took over.

The half ended, and the Hounds led 7-0, but they were not playing well at all.

After the second half kickoff by Juan Arreola of the Hounds, the Ranch was unable to move, and punted. From the 40 yard line, the

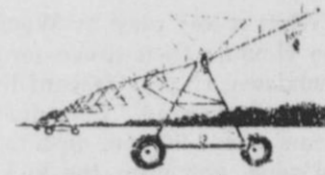

# Spearman Lynx lose first district game of the season to Stratford

A play know as the Oklahoma Swinging Gate was started back in the 1950's by Oklahoma Sooners football coach, Bud Wilkinson. It was mainly designed to trick or catch the opposing team off guard for an easy score, as no one would be covering the man who would receive the ball. What does this gate have to do with Spearman football? A lot. Some could say it was the deciding factor in last Friday's Lynx loss to the Stratford Elks in Spearman's district opening game. Yet, others could say that the Lynx had ample opportunities and time to make up the points scored, and win the game. However it is looked at, the Lynx were handed their first loss of the season by the Elks in a heartbreaker, 22-20.

This district opener for both teams started much the same way as every game the Lynx had played all year, sluggish. However, there was a very bright spot in the game that started at the first and continued through the last minute of the game. The spot was also one of the main reasons why the Lynx were so close to Elks. That spot was freshman Michael Lusby. Lusby came into last Friday night's game with the calm and coolness of a veteran varsity player. In the first half alone, Lusby was near or right at the same amount of yards as all Lynx ball carriers. He did his fair share of running in the 1st drive for Spearman, with 3 carries for 14 yards, and those yards, like all he earned all night, were hard earned. Phillip Sanders, Michael Witten, and Brent Collins also racked up several yards a piece on this drive, but with 6:03 left in the quarter, the Lynx were forced to punt.

After the punt, the Elks quickly took control. Senior Fabian Cruz took the helm, and mounted several yards. One of those carries for Cruz was a 51 yard touchdown with 3:24 left in the quarter. This is when the "Gate" came into play. To explain, this version of the gate is somewhat different, but it most definitely works. Stratford's place kicker and quarterback, TD Baskin, was over in the far right side of the field pretending to tie his shoe, when all of a sudden the ball was snapped to holder Chris Haynes, who immediately threw the ball to Baskin for the 2-point conversion. This put the Elks up early, and it also put a huge question mark into Lynx players and coaches alike, 8-0.

After a great run back by Jake Howard, the Lynx were looking at fair field position on their 40. On this drive, it was the awesome Lusby who came through for the Lynx again. He took the first play of the drive and turned a short yardage play into a 10 yard gain and a first down for the Lynx. Then, Witten helped out with a nice gain of 5, as Lusby brought in another 7 yards, but flags held the team back, and the Lynx were looking at a 3rd and 15 situation. Of course, they tried a pass play, but it failed, so the

Lynx decided to let Collins have his shot a 4th down play, which ended after he was brought down 5 yards from the line of scrimmage.

The Elks then took over with 1:08 left in the quarter, and ran two plays, which let the clock expire, and a very confused and dismayed Lynx team came off the field to get reorganized, 8-0.

Stratford started off maintaining possession of the ball in the second stanza of play. After a good read by the Lynx defensive line on a draw play, the Elks were forced into a punting situation with 11:10 still left in the half.

Spearman was then starting to get out of the dazzle phase on their next drive, as they started on the Elks' 31. Sanders and Witten combined their talented selves to help set up the first score of the night. For the score, senior quarterback, Coyt Tigrett struck a fantastic pass to Martin Sanders, who quickly ran in for the 22 yard touchdown with 8:57 left in the half. Now, no one likes to hear how the refs win or lose a ballgame, but on the 2-point conversion try a loose ball was recovered by the quick Cody McLeod in the end zone, but the refs said it was no good, and the Lynx were within 2, 8-6.

However, the Elks would soon strike back. Baskin had a fabulous night of passing, and this drive really started showing this early. All with the exception of one play, which was a draw, Baskin went 4-4 on passing on this drive to set up the Elks second tally of the night. This was another one of those weird plays when Stratford scored. Receiver, JB Presley took a short pass from Baskin, and fumbled the ball on the way to being tackled, but everyone, with the exception of Cruz, thought the play was dead. Cruz, realizing the easy opportunity, scooped up the ball and headed 18 yards for the score. Even if the Lynx would have realized the play was dead, it would have been almost impossible for the to catch the speedy Cruz. Baskin went on to kick the extra point, and the Lynx were behind in front of the home crowd, 15-6.

Spearman started their next drive on their own 32. A few plays to Lusby, and a pass to Sanders, and it was already punting time for the Lynx again with 2:57 left in the half.

However, it would not be long before the Lynx would come back. On the second play of Stratford's next drive, a loose fumbled was quickly pounced on by McLeod and the Lynx were in really good field position with time to score. The very first play of Spearman's drive was started off with a quick reverse to Lusby, who gained about 11 out of the play and gave the Lynx a first down on the 5. It was then fairly easy for the powerful Witten to blast up the middle for the 5 yard touchdown score. This time Elliott was sent in to kick the extra point, and the Lynx were trailing by those 2 "magical gate" points.

The Elks, who were realizing how close the Lynx were approaching, then mounted a huge drive of 12 plays for yet another Stratford score. It was a hard earned touchdown for them though, and one in which the Elks would again pick on the Lynx secondary. With only 35 ticks on the clock until half, Baskin found a lone Dusty Stewart in the end zone, who made a really terrific catch. The extra point was again good, and the Lynx were behind again by 9, 22-13. This play knocked a huge hole in the side of the Lynx, as well as ended the quarter.

The third quarter started off for the Lynx much like the first part of this ball game. Sure the Lynx came out pumped up and ready for action, but silly mistakes plagued them once again. They started the first few minutes really great, as they held the Elks to a punting situation with 9:49 left in the quarter. Unfortunately, trouble struck soon after, as, on the punt, the ball hit a Lynx blocker, and the Elks quickly recovered.

Fortune did come their way though, and they held the Elks to another punting situation. Spearman couldn't move the ball as well, and they kicked it away again with 5:45 left in the stanza, but Stratford kicked the ball right back to them with 4:40 still left.

Spearman then moved the ball 25 plus yards, they couldn't score before the third quarter buzzer ended, and they still trailed, 22-13.

After their little third quarter breather, it was time for the Lynx to go to work and in a hurry. After getting a 1st down on a very important 4th and 3 play, and other big yardage plays, it looked as though the Lynx were going to score again, as they were on the Elk's 25 yard line. However, Spearman "shot themselves in the foot", and fumbled the ball on the snap, and the Elks recovered with 10:07 still left in the game.

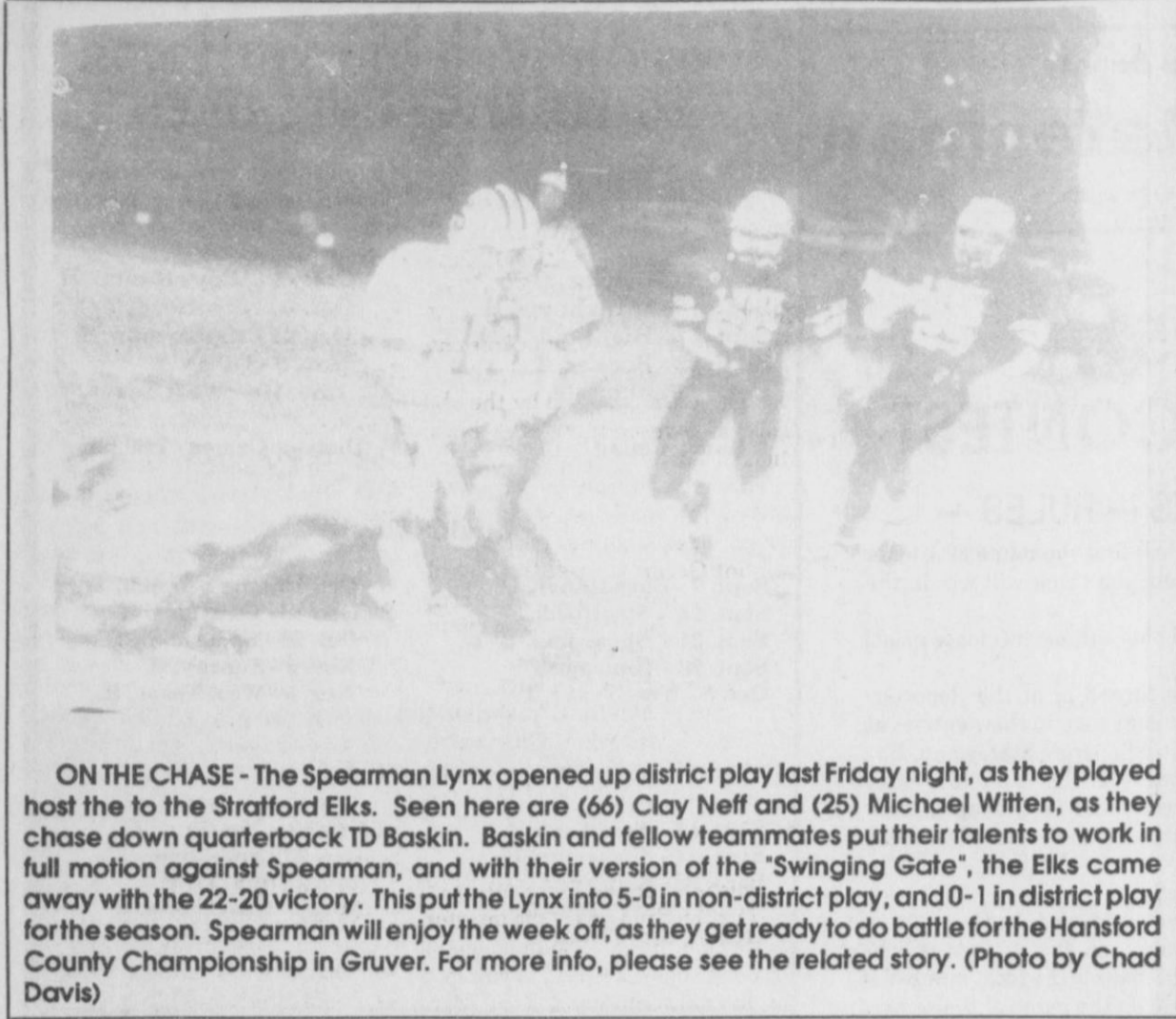
Thanks to an awesome display of defensive aggression, the Lynx held the Elks to an incredible 4th and 19 play, and Stratford was forced to punt with 9:00 still left in the game.

The Lynx then took over on their 44 yard line. For this drive, Collins, Witten, and Lusby all put their efforts to work to bring the Lynx again with in scoring range. However, for the second time in a row, Spearman fumbled the ball and the Elks recovered again.

Once again, the defense would not allow the Elks to score, and they punted the ball away with 3:48 left in the stanza.

The Lynx were halfway there, as they started their next drive on the 50. Collins, Lusby, Witten, Jeremy Blain, Dillon Miller, and Tigrett all pitched in for this huge drive. One of the biggest helps for the Lynx squad was a 3rd and 8 play in which Tigrett dished out a pass to Miller, who sprinted 25

Hounds moved all the way to the 33 yard line, but hurt by a critical holding penalty, failed on a 4th and 7 yards to go.

Boys Ranch then broke off a big play - a 30-yard run by a back who has been injured most of the year. They moved to the Hounds' 29 yard line, but failed on a 4th and 2, and fumbled at the same time, giving the ball to the Hounds at the 36 yard line.

Gruver moved 24 yards on the ground on two plays, but fumbled on the third play, and the Ranch took over. They couldn't move.

Gruver moved 22 yards on the ground on three plays, but fumbled on the fourth, and the Ranch took over. Yes, it was Friday the 13th.

Womble made his second interception on the next drive of the Ranch, on the third play, and the Hounds took over at their own 44 yard line.

What a key play by Womble! The Hounds then drove for the touchdown, a 5-play, 56 yard drive, all on the ground. Bort did the honors with a 30-yard dash to the end zone, and after the kick by Renteria split the uprights again, and with 10:25 left in the game, the Hounds led 14-0.

But on this strange day, disaster struck in a weird way. Boys Ranch was unable to move the ball, but on the punt, the ball struck a Hound right smack on the top of the head as it was coming down, and the Ranch covered the "fumble".

Of course, the Lynx JV were up to their task, but came out on the downside of this one, 46-30. This game was marked by the absence of awesome running back Michael Lusby.

The first quarter of the game started off really slow for both teams. Spearman did strike first, as Clint Goodman took the 1 yard blast for a touchdown. The extra point failed, but the Lynx were on top, 6-0.

Stratford did strike back, however, when #22 for the Elks sprinted in for a 30 yard run. Their extra point failed, but the game was tied up, as the Lynx headed into the second quarter.

This is when the Elks really put the hurt on the Lynx. The quarter started out fine, as Goodman again used his superior speed to run in a 13 yard touchdown, and "Mr. Hands" Kevin Baker caught a brilliant pass from Aaron Witten, to give the Lynx the go-ahead points, 14-6. However, Stratford came back, and they came back hard. Four consecutive touchdowns by the Elks were scored, with #22 making 3 of them. The first TD was a 48 yard pass to #83, with a 2-point conversion pass play reception by #27. Then #22 struck on a 2-yard TD run, with a failed extra point. The next was a huge run of 81 yards by #22, with a 2-point conversion by #11. #22 was there again on the next score, as he blasted in for a 1-yard run, with a failed extra point. The quarter and the half then ended, but the damage was done, and the Lynx were trailing, 34-14.

The second half began with another Lynx score, as the very talented quarterback for the Lynx, Josh Bynum, blasted in for a 1-yard

touchdown. Bynum took the honor of the points after, as well, and things didn't look as bad 34-22.

However, the Elks would not stand for such a close score, and #27 for Stratford caught two consecutive passes for touchdowns, one for 3 yards and the other for 10. Both extra point attempts failed, and the Elks were blowing this one away. This not only widened the scoring gap, but it also ended the third quarter.

Spearman did score the lone tally in the fourth, as the talented Goodman took in a 21 yard run, and put in the 2-point conversion. However, his lone efforts were not enough to bring the Lynx out of this one, and the game ended, Elks 46 Lynx 30.

Offensively, Bynum carried the ball 6 times for 22 yards for an average of 3.7 yards per carry, with 1 touchdown, 1 completion, and a throwing percentage of 100%. Goodman blew away everybody with 23 carries for an amazing 217 yards for an incredible 9.4 yards per carry, with 3 touchdowns. Another awesome ball carrier, Aaron Witten, ran the ball 11 times for 58 yards and an average of 5.3 yards per carry, and 2 pass completions. The team totals for the offensive was very impressive. The Lynx had 40 carries for 297 yards, for an average of 7.4 yards per carry, with 4 touchdowns.

On the defensive side, Bynum also managed to grab one interception.

The Lynx will be out of district play, as this was to be their off week, and they scheduled a game against the Sunray Bobcats at Lynx Stadium. This should be a good game for the Lynx to have good practice, and give them encouragement to enter back into district play, as they will be playing the Gruver Greyhounds.

yards to put the Lynx in great field position. After two or three more great plays like that one, Collins leaped over the top for the 2 yard touchdown with 52 seconds left in the game. Elliott split the uprights, and the Lynx were behind again by that 2 point "gate", 22-20.

With only a few seconds left the Lynx tried what was to be expected, and kicked the on-side kick. Several of the players had a chance to pounce on the ball, but Stratford somehow ended up with it. The Elks then let the clock tick out, and the Lynx were given their first loss of the season, which was a shame because it was also the first game of district, 22-20.

As they headed into the locker room, the Lynx brought in some stats that were not as impressive as in past games. Lusby led all rushers with 10 carries for 56 yards, for an average of 5.6 yards per carry. Witten was close behind, with 10 carries for 53 yards, for an average of 5.3 yards per carry, with 1 touchdown. Sanders came in next with 9 carries for 44 yards, for an average of 4.9 yards per carry, and 2 catches

for 24 yards. Finishing up, Collins carried the ball 12 times for 41 yards and an average of 3.4 yards per carry with 1 touchdown, while Tigrett had 8 carries for 22 yards and an average of 2.8 yards per carry, with 5-10 pass completions, 1 touchdown on a pass, 1 interception, and 65 total yards passing. Martin Sanders also had 1 completion for 22 yards, as did Miller for 25 yards.

The offensive squad for the Lynx racked up 49 carries for 216 yards for 4.4 yards per carry, with 2 running touchdowns, 5-11 completions, with 1 throwing touchdown. From time to time, a major part of the offense is left out. The Lynx varsity line is something to be dealt with and they definitely deserve credit. In fact, a main part of that offense, Matt Gafford, graded 88% on the strict grade by the coaches on the Elks film. For his superior blocking, Gafford will receive Lynx offensive player of the week.

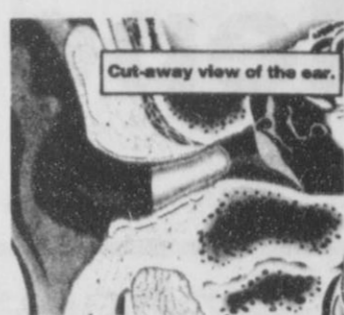
On the defensive side, the Lynx brought in 16 unassisted tackles, 50 assisted tackles, 1 fumble recovery, and 4 forced fumbles. One of

those forced fumbles and 5 assisted tackles were by Blan, and for this great effort, he has earned the Lynx defensive player of the week. Blan will share the honor with Clay Neff, who racked in 1 unassisted tackle, 5 assisted tackles, and 1 fumble recovery.

For the special teams, Witten had 1 punt return, 1 kick-off return for 14 yards, for a total of 2 returns for 14 yards. Howard had 1 punt return for 2 yards, 3 kick-off 75 yards, and a total of 4 returns for 77 yards. Collins had 4 punts for 155 yards, for another great average of 38.8 yards per punt. Elliott kicked the ball 4 times 143 yards for an average of 35.8 yards per kick.

This was the first loss for the Lynx, but it was tragic that it was also their first district game of the season. Don't count the Lynx out yet. They still have a very good chance to make it into the playoffs this year, and chances are, they probably will. Spearman will be off this week to get ready to battle it out for the Hansford County Championship in Gruver. It is probably a safe bet that most Lynx players will

go to the Hounds vs. Elks game in Stratford this Friday night to see how the district is quickly shaping up.

## Out at the Lake

The Oklahoma Panhandle Sam's Club had five R.V.s at the Park this weekend. Two other R.V.s were also visitors.

Randy Hendrickson's Walleye contest couldn't award a prize because no one caught one of these hard to catch fish. Lynn and Bob Cook did catch 16 pounds of catfish. Two of these weighed 4 and 1/2 pounds each. People were out enjoying the Park, but the fishing was slow.

Bob cluck gave me a follow up on

the beaver stories. His office is just off Farwell Draw on the highway from Gruver to Morse. Some years ago he set out a lot of cottonwood trees and put a little dam with an overflow pipe on the Draw. Later a family of beavers migrated in and set up housekeeping at the dam. They stopped up the overflow pipe with bottles, old hose, sticks, and any loose items they could scavenge. When they moved in on his trees, Bob drew the line. I don't think we have beavers just south of Gruver any more.

Around this same time a lone beaver appeared at a tail water pit

in lake on land 8 miles northeast of Gruver that is owned by J.C. Harris and farmed by Les Barkley. When a mated pair of beavers have their first set of kits, they allow them to stay in the family group after they have the second set. When the female is going to have the third set of kits, the first ones (two year olds) are driven off to establish another colony. I wonder if this lone beaver was driven off when the Draw was in flood stage. It could have followed the Draw fairly close to this tailwater pit. J.C. said the beaver died without ever finding a mate.

Serving as chaplain at the Hansford Manor this week I thought I would write to "GOD'S" people. The scripture text is found in Matthew five and thirteenth verse. "You are the salt of the earth, but if the salt loses its saltiness, how can it be made salty again? It is no longer good for anything, except to be thrown out and trampled by men."

Jesus was not directing these words to a group of person in a theological school who had dedicated themselves to the full-time ministry of the church as clerics or pastors. Among those who heard Jesus that day doubtless many did devote their lives afterward wholly to spreading good news of Christ, his life and teachings, his death and resurrection, and his living presence among his followers. But most of those to whom he addressed himself continued to be fishermen, tax collectors, soldiers, carpenters, or shepherds. And they as well as Peter and Andrew, James and John, added daily to the church "such as should be saved" (Acts 2:47).

The function of the church to be the salt of the earth could only be fulfilled then and now by the laity. And lay men and women must be "laity" in the biblical sense--"the people of God in the world."

In common speech a layman in any walk of life is one who is an unauthorized amateur. In the church he stands over against the clergy, the "professional, full-time Christians." He or she is only "laity" a lay-person--a part-time Christian even though he or she may spend a good deal of time and money doing "church work."

This concept of the laity is a far cry from the biblical meaning of the word (laos) which in the Old and New Testament is a key word meaning "the people" all the people of God as distinguished from the peoples of other loyalties among whom they lived.

The church, the laity, the people of God is failing to accomplish its

primary task of penetrating and transforming the world. "YOU ARE THE SALT OF THE EARTH" not a small segment of it. "GOD SO LOVED THE WORLD"--not just a part of it. The first covenant about which the bible speaks is not the covenant with Abraham and Israel or the church but the covenant with Noah and the whole living creation. The last promise we have from God is not the promise of a renewed church but of a new heaven and a new earth. Yet so often has the people of God neglected their responsibility for the world.

The church does not exist for itself (yet some do) but for those outside it. The church owes a service to those who do not belong to it--a service which nothing can replace and which it alone can render.

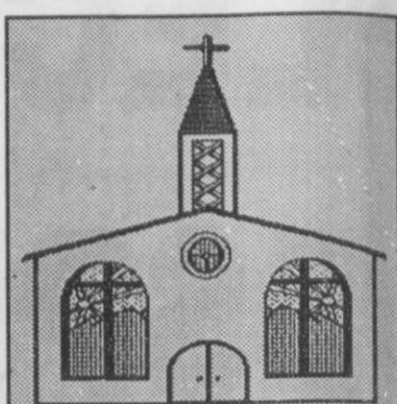
Do the people of God know that God not only dwells in the high and lofty place, yet also in the heart of one with a humble and contrite heart and he can be with any of the people of God this hour in a living presence. God can be like the sun which, though it is far away, is still giving us its warmth and light. People of God, He can free us from our doubts and disheartenments. Yes, we do have a lot of mysteries. But don't let mystery frighten or dismay you. God can give you confidence when you don't know the explanation, there is one. God can drive out our fearful doubts and bring within each of us a fresh faith. And as people of God we need to rejoice in the truth ("the word") we can see and live by that we do know.

If today you say with great pride "I know who I am!" Well who are you? Are you the person your friends think you are? The person the world thinks you are? The person you thing yourself to be? Or the person God knows you to be?

As people of God we delight ourselves in the Lord and He gives us the desires of our heart. We commit our ways unto the Lord; we trust Him; and God brings it to pass.

Let us replenish the seed of faith through...
