College Tuition Assistance

Many scholarships pay the entire tuition; others can be applied towards tuition, living expenses, and/or other fees. Most scholarships can be used at junior colleges, career and vocational schools, 4 year colleges, graduate schools, medical and law schools. TAAS Test

The TAAS retest will be administered beginning with the writing test on July 15, followed by the math test on July 16, and the reading test on July 17 at 9:00 a.m. in room 108 at the high school. Individual Subject Test For Acceleration Without Prior Instruction. Students wishing to take tests in order to attempt gain credit without instruction must come by the business office and register before July 10, 1997. There is no charge for the test. However, students must score 90 or better to receive credit. The test will be administered on August 5, 6, & 7 in room 108 at high school. Individual Subject Test To Regain Credit With Prior Instruction. Students wishing to take individual subject tests in order to regain lost credit must come by the business office and register before July 10, 1997 The cost is \$28 per test. In order to be eligible to take the test a student must have attained a grade of at least 60 in the course. In addition, the student must score at least 70 on the test in order to receive credit. The test will be administered on August 5, 6, & 7 in room 108 at the high school.

Babysitting Clinic

Babysitting should be a rewarding experience for the sitter, a treasured time for the child cared for, and a worry-free time for the parents. Youth age 4th grade and older will have an opportunity to learn or improve their babysitting skills in a Babysitting Clinic. The clinic will be held Thursday, July 10, 1997 from 1-4 p.m. at the Fellowship Hall of the United Methodist Church in Gruver. Subjects for the clinic cover the responsibilities and requirements of the sitter including first aid procedures, what to do at meal, bed or bath time, and how to keep a child safe and happy. Educational programs of the Texas Agricultural Extension Service are open to all citizens without regard to race, color, sex, disability, religion, age, or national origin.

Final Rules For EQIP Announced

Representatives Charles W. Stenholm (D), Larry Combest (R), Chet Edwards (D), and Henry Bonilla (R), announced publication of the final rules for the Environmental Quality Incentives Program (EQIP) in Texas. In a joint release, the four representatives initiated formal roll out of the U.S. Department of Agriculture's (USDA's) newest natural resource conservation program in Texas.

Representative Stenholm, who serves as the Ranking Member of the house Agriculture Committee, said, "The final rules for EQIP were printed in the Federal Register for public review on May 22, 1997. This means that we have the latest information on EQIP. Agency personnel from the Natural Resources Conservation Service (NRCS), Farm Service Agency (FSA), local soil and water conservation districts, and others will begin implementing the program at the county level."

EQIP is part of the 1996 Farm Bill and takes the place of previous USDA programs, including both the Agricultural Conservation Program (ACP) and the Great Plains Conservation Program (GPCP). Applications for assistance will be accepted from agricultural producers throughout the year. There are basically two parts to the program. One part addresses statewide concerns related to natural resource conservation and the other part directs assistance to state priority

Representative Combest, Vice Chairman of the House Agriculture Committee said, "One section of EQIP will address statewide concerns such as-livestock production, cropland, wellhead protection areas, and forest land. Producers will compete for funding as related to

the statewide concerns. The most significant resource or environmental need will receive highest priority. Applications offering the most environmental benefit at the least cost will rank highest in the process."

The other section of the program will address resource concerns in specific geographic priority areas. In Texas, 12 areas have been identified to receive initial fund allocation. The 12 priority areas are: Southern High Plains-A (including Hansford County); Southern High Plains-B; Southern High Plains-C; Central Texas; Blackland; Northeast Texas; Edwards; Middle Concho; Pecos River; Upper Rio Grande River; Gulf Coast; and Rio

Representative Edwards, Member of the House appropriations Committee said, "Texas is expected to receive about \$13 million for EQIP, but obligation of that money depends on producers making application, receiving approval, and developing contracts. Many agencies, groups, and individuals are working together to ensure that everyone has the opportunity to apply for the program. The cooperative approach to program delivery is an important part of the process."

The NRCS, FSA, Texas Cooperative Extension Service, Texas State Soil and Water Conservation Board, local soil and water conservation districts, Farm Bureau and other commodity organizations and groups will assist in providing information, outreach, and education to all potential participants.

Under EQIP, each application will be ranked according to total cost and the environmental benefits derived from the installation of the practices. Producers within a priority area will compete for funding against other applicants within the area. Producers, outside the priority areas, will compete statewide for

Representative Bonilla, the only Texan on the House Appropriations Subcommittee on Agriculture explained, "This program is a good way to provide producers with incentives for conservation. Moreover, this program provides producers with valuable help to develop and implement the best conservation program for them. I know that many producers in my congressional district are eager to participate."

To receive funding from EQIP, producers are required to enter into long-term contracts. Contracts must be at least five years long and cannot be longer than ten

Producers can receive up to \$10,000 of EQIP funding per year not to exceed \$50,000 for the life of

75 percent of the cost of installing some conservation practices. EQIP will also provide incentive payments for some practices.

A producer will be required to develop a local conservation plan, but USDA personnel will assist every step of the way. USDA continues to use the "team" concept in administering its programs and this has made the job easier for everyone including the customer.

EQIP offers a good opportunity for producers throughout Texas to participate in a natural resource conservation cost-share program. Participants will need to inquire with their local USDA office to determine eligibility for the program. Producers must be accepted and contracts signed prior to September 30, 1997. Landowners and producers can obtain additional information by contacting the USDA Natural Resources Conservation Service, at 909 West 9th, or the Farm Service Agency at 711 West 7th in Spearman.

Deadline To Report Spring Crops


July 15, 1997 is the final day to report planted acres of corn, grain sorghum, soybeans or any spring seeded crop to the Hansford County FSA Office located at 711 West 7th in Spearman. Native pasture should also be reported by this date in order to maintain eligibility for the Noninsured Assistance Program. A timely filed acreage report is required to establish eligibility for several programs administered by the Farm Service Agency. Accurate and timely reporting can also prevent loss of both program benefits and price support

benefits.

Acreage reports are required for program benefits for NAP (grazing losses) applications, commodity loans, CRP payments, CAT insurance through this office or any future benefits that may become available due to natural disasters or other circumstances. Fruit and vegetable acreages must also be reported.

Please call for an appointment (659-3036) before July 15, 1997.

For all producers who have Catastrophic insurance through the Hansford County FSA, please remember that fees for your insurance for spring seeded crops are due by July 15, 1997, also.





Focus On The Family

QUESTION: Nothing bothers me as much as the fighting and bickering that occurs from morning until night between my two boys. Do all parents struggle with sibling conflict, or does it result from our failure?

DR. DOBSON: If mothers were asked to indicate the most irritating feature of child rearing, I'm convinced sibling rivalry would receive their unanimous vote. Little children (and older ones, too) are not content just to dislike each other in private. They attack one another like miniature warriors, mobilizing their troops and probing for a weakness in the defensive line.

Children argue, hit, kick, scream, grab toys, taunt, tattle and sabotage the opposing forces. I knew one child who deeply resented being sick with a cold while his older sibling was healthy, so he secretly blew his nose on the mouthpiece of his brother's musical instrument!

The big loser from such combat, of course, is the harassed mother, who must listen to the noise of the battlefield and then patch up the wounded. If she requires peace and tranquility (and most women do), she may suffer under the barrage of cannon fire.

Columnist Ann Landers once asked her readers to respond to the question, "If you had known then what you know now, would you have had children?" Of the 10,000 women who answered, 70 percent said "No"! A subsequent survey by Good Housekeeping magazine posed the same question, and 95 percent of the respondents answered "Yes."

It's impossible to explain the contradictory results from these two surveys, although the accompanying comments were enlightening. One woman wrote, Would I have children again? A thousand times no! My children have completely destroyed my life, my marriage and my identity as a person. There are no joys. Prayers don't help--nothing stops a screaming kid."

It's my contention that something will stop a screaming child, or even a dozen of them. It is not necessary--or healthy-to allow children to destroy each other and make life miserable for the adults around them. Sibling rivalry is difficult to "cure," but it can certainly be treated by a parent who wants to make a difference.
