Much needed new ambulance received by Spearman EMS

On Saturday, May 27, the Spearman division of the Emergency Medical Service received a new ambulance.

This new ambulance is a major improvement over the old vehicle. It has major technical and mechanical advantages that the previous ambulance did not have.

The medical systems in the new emergency vehicle are part of an advanced electrical system, and they operate on a separate source of energy from the engine. This not only makes the ambulance systems more fail proof, but it makes the

ambulance more energy efficient as a whole.

In addition to the advanced electrical system, the new ambulance also has a turbo charged engine. This allows for faster pick-up of speed and more power.

Some may wonder if the new ambulance was really necessary. Keep in mind that 60 percent of the runs that the Spearman EMS makes must be transferred to other hospitals.


"We didn't need the ambulance, but our patients did," said EMS crew member Monty Blackman.

The previous ambulance is failing mechanically, and it has lots of miles on it. Additionally, it is an inefficient source of transporting patients. It's engine can no longer gain the needed speed on hills or produce the needed power to quickly move a vehicle of its size.

New features and added power of the ambulance will increase the quality of EMS service. However, it will also greatly help the people it serves by encouraging the EMS team. The entire EMS crew is excited by the addition of the new ambulance.

Recycling Words

You are saving, rinsing, squashing and hauling all that valuable material to the recycling center. You believe you are doing your part to save the world from our throw away society. But are you really doing all you could?

I'm not talking about clipping the sticky part off the post-it-notes to make them recyclable or even about picking up cans from the street (Though that would be nice). I'm asking you to close the loop.

Closing the loop means buying a product made from a recycled material. Often you do that without even realizing it. Glass containers are, on average, 30% post consumer content. All steel manufacturing processes require at least a 25% recycled content and about 40% of every aluminum can you buy is recycled. Cereal boxes are 35% recycled paper and 10% of this newspaper is recycled. (The paper-not the news.)

What more can a person do? You can buy recycled office supplies as varied as adding machine rolls, computer paper, scissors and rulers. There is plastic lumber from milk jugs, tile from windshields, and insulation made from old newspaper to be had.

Dust pans, lawn furniture, and trash bags use up the plastic we

recycle. Tissue, paper towels, and greeting cards consume paper. Pillows, sleeping bags, and mittens are stuffed with old soda bottles. There is just one catch-finding it.

Recently I purchased a recycled paint roller tray at Coast to Coast and a soaker hose made from old tiers at Alco but there is so much more out there. Your job is to ask for it. If you ask for it, it will come. Tell the store manager that you want and will buy products made from the materials you recycle. Buy recycled products for you office. Tell office supply stores it is what you want.

If there is no demand for products made from recycled materials there will be no demand for recycled materials. Then it's all garbage!

Don't let a good thing go to waste... BUY RECYCLED! (This last catchy message is from the Texas General Land Office.)

Recycling Notes: Spearman has leased hanger #15 at the airport to store recyclable corrugated cardboard. Please breakdown and recycle your cardboard at the hanger. Shredded paper can be stored there as well. Gruver residents can recycle corrugated cardboard at the recycling center.

Out at the Lake

There were many people enjoying the fishing and the Park over the Memorial Day weekend. While Jim Derrington, Darrel Harvey and a man from Tyrone, Oklahoma were visiting after a shower Saturday afternoon, they were treated to an unusual double rainbow.

The upper rainbow (called the secondary) was fainter, but the inner one, known as the primary, had the northern leg hanging over the Buschman place.

The man from Tyrone told them that he learned in school to remember "Roy G. Biv" to know the order of the rainbow colors. Starting on top the colors are red, orange, yellow, green, blue, and violet. The World Book adds that this is true of the primary bow, but the colors are reversed in the upper. In some countries, a rainbow is known as the "Girdle of God."

For some reason, hummingbirds have been on my mind this week, and I wondered if anyone in Hansford County had them in their yards. I have found Skeet Ellison and the Gene Fletchers have been successful in luring them to their feeders some years, but so far this year they haven't seen them.

Skeet has both day lilies and trumpet vines in addition to the feeder. She said they seem to prefer the lilies to the trumpet vines. Gene said they had just started the vines and lilies. Their birds usually left when the weather got hot other years.

Gene mixes his own nectar--1 cup of sugar to 4 cups of water. He thinks the red food coloring is harmful to the birds, but you need red on your feeder.

The Children's Miracle Network Telethon will feature eight month old Lori Dawn Watson, Hansford County's Miracle Baby. She is the daughter of Jill (Stedje) and Sam Watson of Gruver, and granddaughter of Jan and Lynn Stedje. Her great-grandparents are Ada Joyce and James Stedje, and her great-great-grandmother is Mrs. Jessie Spivey, all lifetime residents of the area.

A detailed account of the miraculous birth of Lori Dawn has been printed in other papers. It is difficult to select the most unusual highlights of the articles. One reports that Jill's case is due to go into medical text books.

Jill was born with abnormal anatomy and underwent surgery at age 15 and was repeatedly told by medical experts that she could never expect to carry a full term baby.

There were seven doctors in on that surgery and they all said it could not be successful. After six hours, her surgeon told her that the

result was a miracle which he could not believe.

During the next few years, Jill underwent four more surgeries. Three of the specialists' opinions were that her chances of carrying a baby was zero. However, a baby was eventually on his way.

During the months before the birth, she had sonograms every two weeks which the doctors checked with great interest. No doctor was willing to say if she had a good chance of having a healthy, normal baby. The doctors followed many procedures and finally ordered a complete bed rest. As complications developed, they were inn touch with Dallas and Denver doctors. After many crises, one of which went so far as Jill being asked about funeral arrangements for the baby, she was moved to Ronald McDonald House in Amarillo.

On September 22, 1994, the Children's Miracle Network came to the hospital to film Jill. That day, Lori Dawn arrived weighing three pounds, 10 ounces and 16 inches long. She spent three and a half weeks in the Neonatal Intensive Care Unit before going home. She had been seven weeks early.

The accompanying picture shows how strong and healthy Lori Dawn is. Jill and Sam feel, "She is a true gift from God and the culmination of six years of prayer."

Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

- the value placed on your property
- any exemptions that may apply to you
- the cancellation of an agricultural appraisal
- the taxable status of your property
- the local governments which should be taxing your property
- any action taken by the appraisal district that adversely affected you.

Informal Review
The first option a taxpayer may use to protest a value is to visit with the chief appraiser or a staff member. Records on individual properties are available for review by every taxpayer. This informal review is to the benefit of the taxpayer, as many protests are resolved at this level.

Review by the Appraisal Review Board
If you can't resolve your problem informally with the appraisal district staff, you may have your case heard by the appraisal review board (ARB).

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the appraisal district to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. The hearing will be informal. You and the appraisal district representative will be asked to present evidence about your case. The ARB will make its decision based on the evidence presented. You can get a copy of a protest form from the appraisal district office at 709 W. 7th Street; Spearman, Texas.

Note: You shouldn't try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they haven't talked about your case before the ARB hears it.

Review by the District Court
After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal to district court. If you choose to go to court, you must start the process by filing a petition within 45 days of the date you

receive the ARB's order. If the appraisal district has appraised your property at \$1,000,000 or more, you must file a notice of appeal with the chief appraiser within 15 days of the date you receive the ARB's order.

More Information
You can get more information by contacting your appraisal district at 709 W 7th Street; Spearman, Texas, 659-5575 and 733-5139. You can also get a pamphlet describing how to prepare a protest from the appraisal district or from the State Comptroller's Property Tax Division at 4301 Westbank Drive, Building B, Suite 100, Austin, Texas 78746-6565.

Deadline for Filing Protests with the ARB*

Usual Deadline
On or before May 31 (or 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medical emergency. The ARB decides whether you have good cause.

Late protests are due the day before the appraisal review board approves records for the year. Contact you appraisal district for more information.

Special Deadlines
For change of use (the appraisal district informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is before the 30th day after the notice of the determination was mailed to you.
For ARB changes (the ARB has informed you of a change that increases your tax liability and the change didn't result from a protest you filed), the deadline is before the 30th day after the notice of determination was mailed to you.

If you believe the appraisal district or ARB should have sent you a notice and did not, you may file a protest until the day before taxes become delinquent (usually February 1). The ARB decides whether it will hear your case based on evidence about whether a required notice was mailed to you.

*The deadline is postponed to the next business day if it falls on a weekend.

TRIVIA ANSWER FROM TWO WEEKS AGO: Last week's column was not printed due to lack of space, so here is the answer to the trivia question from two weeks ago. The 1979-80 Gruver Greyhounds, known affectionately as the "Super Hounds", were the best ever boys basketball team by record in GHS history. They started out the season unbeaten in their first 21 games, a perfect 21-0, before being finally upset by Stratford in a late season game at Stratford in overtime 72-70. During the regular season they had upset a fine AAA team, Tulia, at the Friona Tournament, and had also beaten River Road. In a warm-

up game for the playoffs, they defeated a fine AA team, Childress, the number four AA team in the state of Texas, 85-79, to go 24-1 on the season.

Then in one of the bitterest, toughest to take-ever, defeats in Hounds' history, Gruver was defeated in their bi-district game to the Memphis Cyclones at the WTSU Fieldhouse, 54-43, as Gruver was the favorite and expected to go on and win the state championship, but their season was then shockingly over very suddenly. It was a great, great disappointment to a very fine year.

The roster included Bruce Ammons, Randy Karlin, Darin Winger, Juan Garcia, Chris Dorman, Darrell Messer, Gary Gilbreath, Mike McKee, Clifton Peddy, Barry Barkley, Phillip Fry, and Russell Tiner; and the coach was Donnie Prater, a former GHS graduate. Their final record was 24-2, .923, the best ever for a Hounds' team over a single season. The 1965-66 state championship team had finished the season 29-4, and the 1988-89 regional finalist team had finished 30-4.



The ceremony was at the chapel at old Fort Concho with family members and friends present.



Use discretion for exercise safety

Selecting the wrong athletic shoe can be the first step to injury during a workout. "Each individual needs different types of support depending on the workout routing and physical makeup," said Dr. John Kozak, a sports medicine expert at Baylor College of Medicine in Houston.

The most important consideration when picking shoes is the type and amount of support the heel of the shoe provides. This area absorbs most of the shock during exercise.

Kozak suggest grasping a shoe with both hands at the front and the back, and then twisting the shoe. The less movement detected in the heel area means more support for the foot.

He says when trying on the shoe, pick one that feels firm in the heel and allows your toes to wiggle slightly.

Shin splints, a common leg injury among joggers and other weekend athletes, can be prevented with proper stretching and cross training.

Shin splints are caused when muscle along the long bone in the leg does not expand enough to absorb the shock of a workout. "The shin bone absorbs that shock," said Dr. Donald Baxter an orthopedic surgeon at Baylor College of Medicine in Houston.

Cross training-varying the type of workout activity-works different muscle groups and may help prevent shin splints.

Baxter suggests stretching the shin muscles by leaning against a wall with the palms of the hand flat, the arms at full extension. Then slowly fall forward so the chest moves to the wall. Hold and repeat this 10 to 20 times before running.

Whenever you feel pain during a workout, that activity should be stopped, Baxter said.

A sore shoulder in athletes may signal more than just tired muscles. It could be a rotator cuff injury.

The rotator cuff is a tendon that forms a circular joint where four muscles support and move the arm bone. If the cuff is damaged or torn, the top of the arm bone may press into the shoulder.

"People in their 50's and beyond are susceptible to this because of a lifetime of wear and tear on the shoulder," said Dr. Gerard Gabel an orthopedic surgeon at Baylor College of Medicine.

Physical therapy can usually correct the problem, but sometimes surgery may be required to rebuild the cuff.

Charlie West, 706 Lee Drive, Spearman, Texas 79081 has applied to the Texas Natural Resource Conservation Commission (Commission) for a permit (Proposed Permit No. 03784) to authorize disposal of waste and wastewater from a swine operation. The swine operation will consist of a maximum of 3840 head at Section 148 and 3840 head at Section 4. The waste treatment facilities will include two storage ponds for washdown water, flushwater and stormwater retention. Wastewater from the ponds is to be disposed of by irrigation on agricultural land. Manure and separated solids are to be applied, for beneficial use, as fertilizer on agricultural land. No discharge of pollutants into the waters of the State is authorized by this permit.

The swine operation consists of two facilities in Hansford County, Texas. Section 148 is located on the south side of an unnamed county road, approximately 1 mile west of the intersection of the county road and Farm-to-Market Road 760. This intersection is approximately 4 miles south of the intersection of Farm-to-Market Road 760 and Farm-to-Market Road 759. Section 4 is located on the east side of Farm-to-Market Road 760, approximately 5 miles south of the intersection of Farm-to-Market Road 760 and Farm-to-Market Road 759. This location is in the drainage area of Segment No. 0100, an unclassified segment draining out of the State.

The Executive Director of the Commission has prepared a draft permit based on the application submitted by the applicant and other information presently available.

A Hearings Examiner of the Commission will conduct a public hearing at 9:00 a.m., Thursday, July 6, 1995, Hansford County Courthouse, District

Courtroom, 1 Northwest Court, Spearman, TX. to receive evidence on the conditions, if any, under which the permit may be issued, and determine whether State Certification in accordance with Section 401 of the Federal Clean Water Act may be issued. This hearing will be held under the authority of Sections 26.021 of the Texas Water Code and the Rules of the Texas Natural Resource Conservation Commission.

The record of this proceeding will include evidence and testimony taken at the public hearing. The hearing may be continued from time to time and place to place, if necessary, to develop all relevant evidence bearing on the subject of the hearing. The Commission reserves the right to schedule or reschedule hearings as it deems necessary. Persons desiring to protest the granting of this application, who have not previously requested a hearing in writing, should file written protests with the Commission prior to the hearing date and serve copies of the written protest on the applicant and all designated parties, if any. The written protest shall: show the name and address of the protestant; identify the pending application by TNRCC docket number; state the basis of the

protestant's interest and any relevant facts and conclusions; describe the location of the protestant's property relative to the application; and propose any amendment or adjustment to the application which, if made, would result in withdrawals of the protest. Persons desiring to present information relating to the application must appear at the public hearing either in person or by representative and present such information, subject to all applicable rules of evidence. Information offered in written form without the writer's presence will be noted by the Commission but will not be considered as evidence since the right to cross-examine is absent. No person will be admitted as a party to the proceeding unless the person complies with Commission Rules which require a justiciable interest and attendance at the hearing either in person or by qualified representative with settlement authority. Additionally, any representative who has been retained for this proceeding will be expected to attend the hearing and to participate in settlement negotiations and other matters. The original of any document filed prior to the hearing must be filed with the Office of the Chief Clerk, Mail Code 105, P.O. Box 13087, Austin, Texas 78711-3087. If you want the hearings examiner to consider a document, you must show that the original of that document has been filed with the TNRCC Chief Clerk.
