The theme of this year's program was "Stars Shining Forth in the Panhandle". The banquet was planned and conducted by County Extension Agents, volunteer leaders, and 4-

H'ers on the District Recognition Committee. Committee members this year are from Deaf Smith, Briscoe, Gray, Donley, and Lipscomb counties.



Focus On The Family

QUESTION: I understand how the "love must be tough" philosophy can reconstruct a bad marriage. How would it function in a good relationship?

DR. DOBSON: The best way of keeping a marriage healthy is to maintain a system of mutual accountability, within the context of love. Speaking personally, the secret of my beautiful relationship with my wife, Shirley, for the past 32 years has involved a careful protection of the "line of respect"

Suppose I work in my office two hours longer than usual on a particular night, knowing Shirley is preparing a special candlelight dinner. The phone sits on my desk, but I lack the concern to make a brief call to explain. As the evening wears on, Shirley wraps the cold food in foil and puts it in the

Then suppose when I finally get home, I do not apologize. Instead, I sit down with a newspaper and abruptly tell Shirley to get my dinner ready. You can bet there'll be a few minutes of fireworks in the Dobson household. Shirley will rightfully interpret my behavior as insulting and will move to defend the "line of respect" between us.

Let's put the shoe on the other foot. Suppose Shirley knows I need the car at 2 p.m. for some important purpose, but she deliberately keeps me waiting. Perhaps she sits in a restaurant with a lady friend, drinking coffee and talking. Meanwhile, I'm pacing the floor at home wondering where she is. It is very likely that my lovely wife will hear about my dissatisfaction when she gets home. The "line of respect" has been violated, even though the offense was minor.

This is what I mean by mutual accountability. Such minor conflict in a marriage plays a positive role in establishing what is and is not acceptable behavior. Some instances of disrespect are petty, but when they are permitted to pass unnoticed, two things happen. First, the offender is unaware that he has stepped over the line and is likely to repeat the indiscretion later. Second, the person who felt insulted then internalizes the small irritation rather than spilling it out. As the disrespect grows, the stage is set for an eventual explosion.

A workable system of checks and balances of this nature helps a couple keep their marriage on course for a marathon rather than a sprint. And I can assure you, Shirley and I are going the distance!



Out At The Lake

Jim reports very little activity last week. With warmer weather forecast for this one, surely more people will use the Lake and

Kenneth Seyffert, birdman of Amarillo, saw an osprey at the Lake last April, so I have hopes of seeing this rare bird for our country this winter. These raptors enjoy a diet of fish, as do bald eagles.

These birds are similar in size and look enough alike to be confused with the largest of the hawks--the Ferruginous Hawk. Both are white underneath. The

osprey is longer than the big hawk, but their wing span is much the same. The osprey, also called fish hawk, is nearly always found near water, whereas the Ferruginous Hawk's favorite spot is a prairie dog

Once in awhile the osprey misjudges the size of its dinner, and is drowned because it can not unlock its claws after it strikes the fish. The fish will die, too, from its internal injuries. Sometimes fishermen find both bodies, still locked, washed up on the shore of a lake.

I read somewhere that sometimes ospreys harass bald eagles and steal their fish. Another article said that bald eagles "pirate" fish from the smaller ospreys. It is something to watch for. Usually the two species get along without aggressive behavior.

Senate Bill 9, passed by the 74th legislature, clearly defined the role of the Teacher Retirement System of Texas as follows:

"Purpose of the Retirement System: The purpose of the Retirement System is to invest and protect funds of the retirement system and to deliver the benefits provided by statute, not to advocate or influence legislative action or inaction or to advocate higher benefits."

TRTA is now taking on a more active leadership as an advocate for TRS members. These responsibilities include developing legislative measures concerning annuity increases and other program improvements, such as researching the possibilities of (1) legal consultation; (2) discount dental, vision, and prescription services; (3) cellular phone discounts; (4) investment planning; and (5) discounts on travel, golf, hotel/motel, car rentals, etc.



February 12, 1884: Wind N.E. cold, still snowing a little, very cold. Temp. 2 degrees below zero. Cattle drifting - Baldwin came from Rifle Pitts and camped below - A lot of teams camped above. (Mail did not get in.) Wrote to Min and sent paper home and to Edie - E. Simmers down with some letters.

April 28, 1884: Monday - Fine. Windy & cloudy - Bob came down and we made out the mail reports. Hy Bugbee came up the creek and stayed - Pat Oneil was up. Johnson started work - no Mail. It hailed very hard down about "777 Ranch - Rifle Pitts."

April 30, 1884: Wednesday -Fine - Cloudy Cool - Wind W. and Strong. Sheplock's team passed with Tyler's freight. Tyler's cousin came here and went on

with teams - Steve Arnold came with John Leverton and Ike Meek going to Beaver Roundup - Rode up creek with gun, did not see any antelope - rode down, the heifer had not calved - They got Tyler's and their rooms about all fixed up. No Mail. As team came down, he left 4 balls of rope.

It's hard to imagine how an English gentleman came to the Texas Panhandle when there was almost nothing here, hunted buffalo, and stayed for the rest of

News From ACCORD

ACCORD Agriculture, Inc., a non-profit organization with members from Hansford, Lipscomb, and Ochiltree Counties, met Thursday, November 6, 1997, at the Expo Center in Perryton. Fifty nine members and guests attended.

Those present heard a report from the Seward County, Kansas county option vote which denied Seaboard Corporation a hog operation in Seward County. The speaker was Kathy Bloom from Liberal. Kathy is a citizen of Seward County who was involved in the opposition to the proposed hog operation.

When Seaboard approached Seward County Commissioners' Court in early summer to bring a confined hog operation into the county, the commissioners voted to allow this operation. Citizens petitioned for a county option vote. This vote was held in late September, and Seaboard's request failed by 75% to 25%. Since then, the commissioners have been approached by Seaboard to allow them entry anyway since the Kansas Attorney General issued an opinion that the vote might not be absolutely binding. So far, the court has not decided to disregard the vote of such a large majority of Seward county voters. Other Kansas counties have exercised their rights to the county option votes. Of the twenty who have conducted county option votes, eighteen have voted to deny corporate confined hog operations in their counties. Mead County, Kansas, will have a county option vote this week on whether to allow

Seaboard to enter their county. Other reports heard by the

Hansford, Lipscomb, and Ochiltree County Farm Bureau meetings held in each of the counties during October. All three county Farm Bureaus voted to send resolutions to the Texas State Farm Bureau meeting. The resolutions state opposition to tax abatements and tax exemptions for corporate confined pork facilities. Hansford County voted the following recommendations in addition to these resolutions: 1. That state directors review the Subchapter K rules concerning the nearness of these operations to rural residences. 2. Prohibit tax exemptions for these operations. 3. Prohibit the availability of state, federal, and local grants for these operations. 4. Corporate farms should have to bear cost of . expansion of schools because of increased school operations. Ochiltree and Lipscomb Farm Bureau votes urged stricter permitting regulations to prevent abuse or depletion of water, land, and air. All of these resolutions will be considered at the Texas State Farm Bureau meeting in

In addition, Doug and Kathy Ricketts from Lipscomb County and Donnie Dendy from Ochiltree County reported on a meeting in Oklahoma City, November 1, which was attended by more than 250 persons from nine states. Experts from universities, citizens from areas which have worked to improve conditions relating to swine operations, and leaders of citizens groups from the nine states viewed the area wide problems facing residents as confined hog operations continue to come to the heartlands of the United States. Featured speakers included Iim Hightower of Texas

and Joel Dyer of Colorado. group included reports from University and independent experts on swine operations led small group sessions. In the work session concluding the meeting, area group leaders were told that the best possible way to prevent major contamination and pollution problems in this nine state area would be to establish a national moratorium on large confined hog operations until solutions to the problems can be addressed. U.S. representatives and senators are aware of the problems, especially since North Carolina has declared a two year moratorium after major contamination of land, creeks, and rivers in that state. Letters relating to this problem can be sent to our legislators.

> The current state of permit applications in Ochiltree County were reported. #03960 was denied until Texas Farm Inc. meets technical merit requirements. The corporation had thirty days to meet these requirements, and then ask for a rehearing. The other two applications, #03961 and #03962 are still pending. The first report may be coming in November, after the executive director reviews the application and the protests and the state TNRCC review committee meets. It was noted that Texas Farm Inc. has applied for an air permit to build a mill 2 1/2 miles east of Farnsworth on Highway 15.

Doug Ricketts reported that Murphy Farms has begun construction of a nursery location three miles west of Follett in Lipscomb County. No permit application has been filed.

The next meeting of ACCORD Ag, Inc. will be held in January, 1998. A date will be announced. Members and guests are welcome to attend the meetings.
