Photo Contest Held

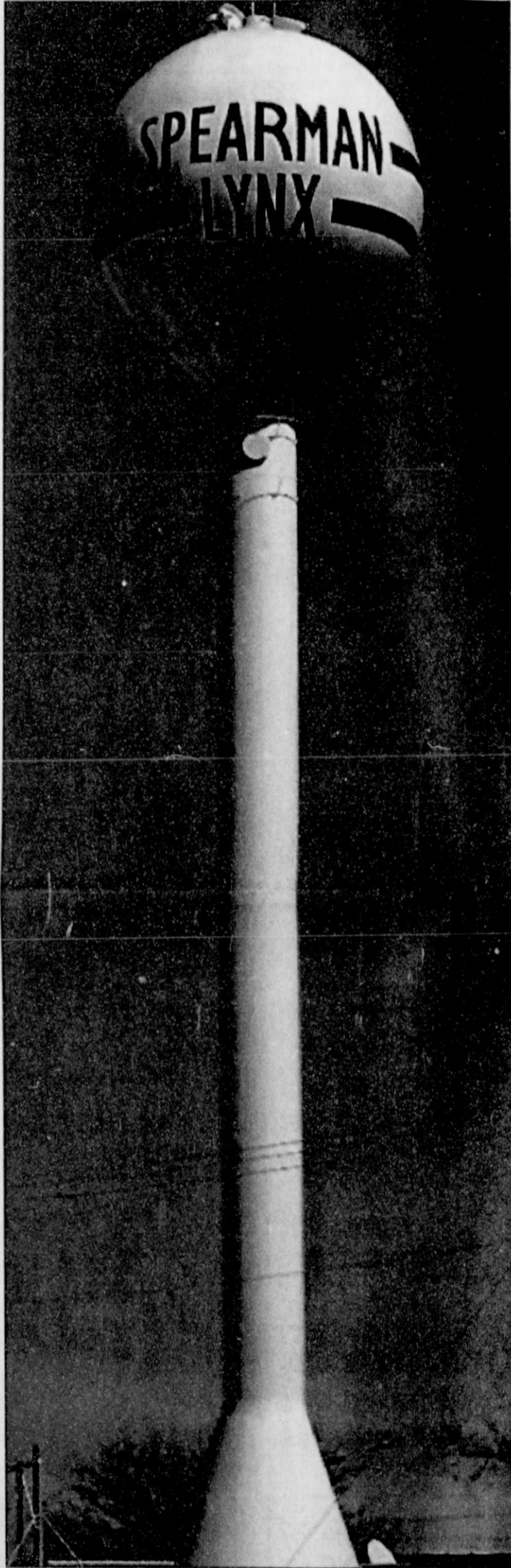
The staff of Hansford Manor would like to invite you to participate with them in an exciting endeavor which they feel will bring joy and beauty to the residents' lives.

They are currently raising funds to purchase an Oak Creek Aviary. This aviary is handcrafted, made of beautiful oak and break-resistant glass. It will be populated with finches, canaries and doves. Residents will be able to observe the birds building nests, playing, raising families and going about their "daily chores."

The residents have thoroughly enjoyed birdwatching in the current aviary. However, there have been several problems with it due to the netting/PVC pipe construction. The netting on the sides makes it hard for residents with any visual challenges to see the birds very well. Keeping the aviary and the area around it clean has been a continuous problem due to the open construction. Also, several times small finches have actually lost their lives when trapped between the netting and the side panels.

The dimensions of the new Oak Creek aviary will be approximately 8'x34'x6'6" and will cost approximately \$6,000 to purchase. (This includes setup/delivery, birds, bedding, ground cover, etc.) The Employees of Hansford County Hospital District have made the first step toward purchase with a donation of \$1,000. We invite you to join with us in making this dream of our residents a reality.

Carthel gained first-place honors with her spot photo of Holly Hart

as GHS student of the month. The picture featured Hart in a casual pose atop a brick entry to GHS. With the picture taken only of Hart and not the brick entry on which she was seated, her picture give the illusion of being super-imposed on the background.

Living in the Gruver community is comfortable. And comfort, as Martha Stewart would say, "is a good thing." Or is it?

My reason to question the fact comes from an interview I did last year with a newcomer to our county.

During the interview, I tossed in a "pat on the back" (tell me how great we are) question, "What have you found different from your expectations in Hansford County?"

I expected a compliment, an observation of a special uniqueness about us that might have impressed this newcomer. What I got back was an eye opener.

"I thought I'd have more friends," was the quick, nearly knee jerk answer. Followed by, "Oh, don't put that in. I shouldn't have said that."

But the ugly truth had already leaked out, leaving a stain in the Garden of Eden.

Living in the midst of some of the kindest, most compassionate, caring people in the world, I was mystified why this lovely, vivacious person had not found those qualities in us. How could such an outgoing, enthusiastic person be lonely here?

After more than a year of pondering, I have come to the conclusion that we may be a little too comfortable in our cocoons.

It's so easy to sit in the same pew each week at church, to chat on the phone with an old friend, to eat out with those who share our same interests, whose children are the same age as our own, who have similar careers, and on and on. It's just too comfortable to stay in our familiar routine and groups. After all, we've already have friends and routines we enjoy, why should we venture out of our comfort zone?

In the past ten years, the population of Gruver has decreased slightly, however, the school enrollment has shown a greater decrease. Just this past year, our high school decreased by over 25 students. With farming fast becoming a non-profit occupation, our agricultural community is not seeing our sons and daughters return to the land to replenish our numbers they once did. We cannot no longer depend on our own offsprings to "keep us going" as a community.

But from time to time, we do have newcomers to come our way, and a few have even come to stake their life's fortune on us, and open

a new business. While they are not native Gruverites, they have paid us the ultimate compliment in choosing to be one of us.

Someone once told me "Wear out a pair of shoes in Gruver, and you'll never want to leave." Sounds great, but it just doesn't work that way. No soul is going to wear out their soles in a place unless they feel welcome.

While its hard to venture out of a cozy cocoon, it might be worth a try. Introduce yourself to a stranger or just someone whose name you don't know, never let a new person sit by themselves at a church or school function, give that new business a try and then another. Don't let our great life in Gruver be a secret.

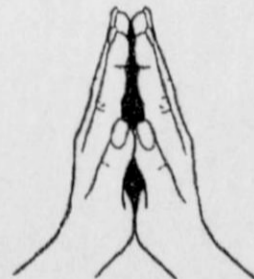

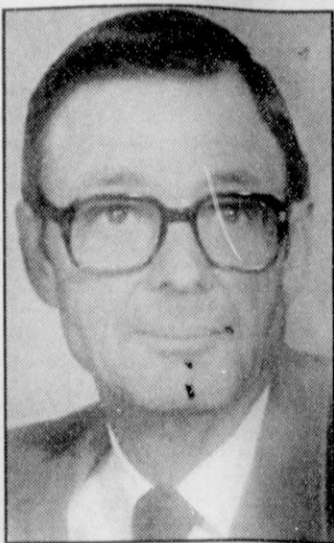

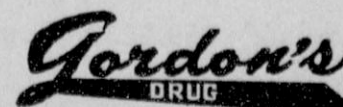

The students were successful in finding all the products on their lists at the grocery store. However, it is to be determined this next week which family stayed within their budget. If they were unable to stay within their weekly budget, the student must determine what their family will do without on the grocery list for the week.

Before leaving, Lowe's treated each student with a Jell-O Easter egg mold and a sack of goodies. A big thank you to Kathy, Raul, and all the employees at Lowe's for their special assistance in helping the students become "smart" shoppers!

The next business we visited was the local Pizza Hut for lunch. The students dined on the buffet and talked about their morning visits to the businesses. While at Pizza Hut, they were unable to ask questions, but just by observation they were to determine the answers to many of their questions about goods and services as well as advertising. Thank you to Pizza Hut for being so attentive to our needs.

Berry's Cleaners was the first stop after lunch. Here the students saw all kinds of clothing that was clean, wrinkled, starched, pressed, and bagged. They were able to watch the ladies there press the garments.

The students were also able to feel the different degrees of starching in the jeans. Some of the jeans were heavily starched and very stiff to touch. The ladies at Berry's were very kind and courteous in answering all of the student questions related to their business.

The students were treated to touching the alligators and given a real alligator-foot back scratcher. This was a very exciting stop on the field trip for the students. 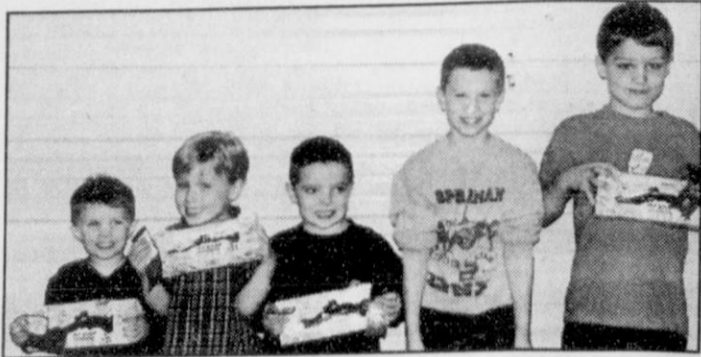

GHS Takes Second In Academic Contest

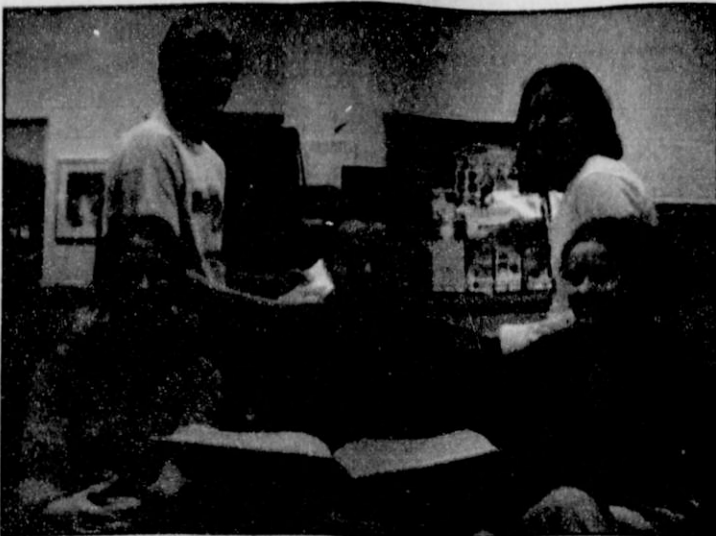
Gruver High School placed second overall in district UIL academic competition at Amarillo College, with four Gruver High School students who medaled in five events advancing to regional competition.
