Saving \$1.3 million in interest . . .

PDRA board refinances bonds

by JoAnn Morton Editor

The Palo Duro River Authority board of directors saved \$1.3 million in interest by refinancing bonds, said PDRA General Manager Johnnie Lee.

Lee explained that the board withdrey bond issues of 1987 and 1988 and reissued them to bring the interest rate on the bonds down. from 7.6 percent to 6.59 percent. The interest rate reduction will result in a savings of \$1,336,218.46,

Gruver, who replaces J.C. Harris. Three board members were re-appointed, including J.W. Buchanan of Dumas, Tommy J. Bergin of Gruver and Orval Allen of Dumas.

After the new board members were sworn in, the board was reorganized and officers elected. Officers include Robert Novak of Spearman, president; J.W. Buchanan, vice president; and Kenneth E. Evans of Spearman, secretary\treasurer.

The board approved the payment of \$1,400 to the agricultural research testing lab in Moore County Jan. 16 meeting, Hansford County for water quality testing. Approval was given to a tax abatement in administered the oath of office to Moore County for Diamond Shamrock, and to an easement for a twoinch pipeline for Harkin Exploration Company.

Board members discussed con-

struction of boat docks on the south side of Palo Duro Lake, along with paving the parking lot and paving roads which lead to the main caliche road. Lee said a contract for that con ruction should be let around Feb. 11.

The board discussed the construction of restrooms and drilling public water wells in the lake area, and also talked about construction of the laboratory and administration building. Lee noted that a contract for building construction will probably be let about two months

He added that construction is in progress for a new highway at the dam, saying that the project will take about a year to complete. Lee said that the water level in Palo Duro Lake is at 23 feet, 3 inches.

Conservation plans required

The Conservation Compliance provision of the 1985 Food Security Act required farmers receiving USDA benefits to develop a conservation plan for their land by Jan. 1,

Morris re-elected to AAM office

V.B. Morris, a grain farmer from Gruver, was re-elected as National Vice President of the American Agriculture Movement at the AAM's 13th national convention, in Monroe, La.

Morris and other AAM members said they want this year's political debate to include the condition of the nation's farm economy and how it relates to the national economy

"The condition of this nation's agricultural and rural economies is vital to the nation's economy as a whole," said Johnny Porch, AAM's national president. "It is up to us to demand those running for office to understand and address this fact of economic reality." Porch, a cotton farmer from Brownsville, Tenn., was re-elected to serve his second term as leader of the farmers and ranchers who make up the

organization. Morris expanded Porch's comments by remarking, "President Bush's failed attempt to 'jumpstart' the economy is only a temporary approach. Any farmer knows a 'jump-start' is only delaying the overhaul of the system. It is time to analyze the problem and correct

what is wrong with the system. "President Bush's campaign promises to create new jobs may be happening - but only in those foreign countries where American companies have relocated over the past decade," he continued. "The real jobs for Americans can only be created when those producers of this nation's raw materials are allowed to receive a fair price for the fruits of their labor. The agriculture sector is the greatest consumer in this nation's economy. Until farmers and ranchers have the money to replace their worn out equipment and increase demand for consumer goods from the ground up, there can be no real recovery for our nation's economy."

AAM's national director, David Senter, reported the need for substantial reform in the administration of farm programs.

The convention adopted several resolutions concerning the protection of private property rights. One resolution stated that if wetlands or other natural resources must be preserved on private property, AAM opposes any confiscation, through regulation or actual taking, of private property without due compensation. Another resolution passed which stated that AAM would work for the passage of the Forest and Families Protection Act and the Federal Lands and Families Protection Act, and that AAM would support the passage of legislation that provides for environmental and wildlife protection while also providing economic stability for rural workers and their families. Additionally, the group passed a resolution in support of amending the Endangered Species Act to require the recognition of private property rights.

The Crop Sharing Hunger Relief Act was also discussed at length at the convention. The convention also voted as top priorities for the coming year the defeat of the agreement at the General Agreement on Tariffs and Trade (GATT), the reinstatement of income tax averaging and investment tax credit, the ongoing lawsuit against the Chicago Board of Trade and to oppose the Mexico Free Trade Agreement.

In addition to the re-election of Porch and Morris, the group also re-elected Joyce Jobgen, a rancher from South Dakota, as national treasurer, and Jim Rice, a grain farmer from Kansas, as national secretary.

The American Agriculture Movement, founded in 1977 to work through the legislative process to further the interests of farmers and ranchers, is composed of family farmers and ranchers from 35 states and Canada.

As one of two Republicans on the budget-writing Senate Finance Committee, Bivins led the fight to cut \$3.5 billion from the state's budget deficit. He said there are many opportunities to further reduce

state government.

"In the next session, I plan to push for more cuts in the state bureaucracy," Bivins said. "For example, Texas has more than 16 paid holidays for state workers. Each holiday costs taxpayers \$40 million. These can be reduced."

Bivins said he planned to continue a pilot project he created designed to protect severance tax revenue from dramatic fluctuations in oil prices. He also stressed the need to reduce welfare fraud through the

use of modern technology. "I passed a resolution in the Sen-

Bivins seeking re-election to Senate ate directing the state to utilize electronic benefits transfer. Under this ECT system, food stamp recipients use a card, similar to an automatic teller-machine card, to purchase groceries, therefore preventing the buying, selling and theft of food stamps. The state needs to expand the use of EBT to further reduce costs," he said.

> Bivins said the state's economic climate should be a priority for the next Legislature. He pledged to continue the lead in the Senate to improve the state's product liability laws, which now encourage frivo-

lous lawsuits and hurt the Texas economy. Additionally, Bivins said he would continue to make worker's compensation coverage affordable for businesses and working people. The senator helped reduce worker's comp costs by authoring an amendment that required insurance carriers to offer policies with deduct-

ible provisions. Citing other priorities, Bivins said the Legislature should limit terms for its members. "The redistricting process proved that the in-

It was a surprise when I was told that the Sheriff had called while I was out. He wanted to know if I had any information about a young man named Don. It seems that he had recently escaped from jail in Oklahoma and stolen a car. The authorities were investigating all leads and talking to anyone who knew Don.

I first met Don two years ago. he came to church on Sunday morning and we talked for a few minutes after the service. Over the next few weeks Don and I became friends. In some ways he became like a member of our family.

The most notable feature about Don is that he does not fit. If you were to cross his path in the Walmart you would not give him a second glance because he looks like ever, Don probably does not fit in your world. He raised himself so he is ignorant of all but the most basic manners and morals. The most outstanding feature about Don is that in his 22 years of life he has probably never been loved.

Instead of learning how to read and compute math, Don had learned how to survive. He was more interested in filling his stomach and having a good time, than building for the future. He is the kind of person who feels unwelcome in many churches because he is differ-

Don is probably the kind of person who would have caught Jesus' eye. Jesus was magnetically drawn to those who did not fit the society of His day. Back then they were

called prostitutes, crippled, poor, irreligious and thieves. Today we call them prostitutes, crippled, poor, irreligious and thieves. How times have changed!

I think the reason I liked Don was because I could understand him. The name calling strategy of children relies upon the phrase, "It takes one to know one." I have lived my life with a very noticeable physical handicap. It means that I do not always fit. It allows me to be judged without ever being known. I know what it feels like to be a misfit.

That is why Jesus was born in a manger instead of mansion. His birth was attended by shepherds rather than sisters of a holy order. He was a carpenter by trade, not a commodity broker on Wall Street. Like my friend Don, he had no place to call home and usually no place to lay His head at night.

If Jesus would have met Don an ordinary 22 year old man. How- they would have become fast friends. jesus knew from experience what it felt like not to fit. he knew the suspicious glares of society's finest as He entered a room. he knew what it was like not to be trusted and how it felt to be re-

"It takes one to know one." That is why Jesus became a man. He became like me so He could understand me. Because he understands me then I know He can help me.

I would like to see Don again some day. If I do I hope there are no prison bars between us. I want to thank him for helping me understand more about my Savior.

He had the locker boxes opened. All but two were full of money. He turned it over to the Philippine military to be returned to the national Treasury in Manila. (We hope it got there.)





In a study conducted last summer by the Panhandle Regional Planning Commission, Spearman had the lowest cost per ton of landfills which receive between 2500 tons per year and 6000 tons per year. (of municipal solid waste). The survey showed the weighted average cost for landfills similar to ours was \$22.50 per ton. The City of Spearman's cost was \$15.66 per ton.

Modifying recipes for diabetics

Modifying recipes for sugar and fiber is important, especially for those who are diabetic.

Sugar comes in many forms including white sugar, honey, corn syrup, molasses, and maple syrup. The general function of sugar in a recipe is that it:

- · Acts as a preservative in jams, jellies and pickles

Fiber is found in whole grain breads and cereals; dry beans and peas; nuts and seeds; and fruits and vegetables, especially those with edible skins or seeds.

identifying the add vegetables to quiche fillings, ingredient(s) in the recipe you want casseroles, and salads. to modify, you can:

- · Eliminate it completely
- Reduce the amount
- · Substitute a more nutritionally acceptable ingredient

To choose the best approach, it's helpful to have a general idea of the function of the ingredient and what will happen if you modify it.

To decrease sugar:

· Try reducing sugar by onequarter to one-third in baked goods and desserts. This works best with quick breads, cookies, pie fillings, custards, puddings and fruit crisps. It may be less desirable for some cakes. Do not decrease the small amount of sugar in plain yeast breads because it provides food for the yeast and promotes rising.

· Decrease or eliminate sugar when canning or freezing fruits or buy unsweetened frozen fruit and fruit canned in its own juice or

· Increase the amount of cinnamon or vanilla in a recipe to enhance the impression of sweetness.

Non-sugar sweeteners can be used in moderation, but their use is not necessary to decrease sugar in the diet. Aspartame (Equal®) or NutraSweet®) will not work in products that are cooked or baked. Saccharin or acetasulfame-K can be used in hot and cold foods but may leave a bitter aftertaste. Neither product can provide the volume or structure that sugar does, so rather than substituting, it's best to choose recipes especially tested for use with non-sugar sweeteners.




Gruver had another 12-0 run at the close of the third quarter, and into the fourth quarter. That built their lead to 68-24, 44 points, and their largest lead of the night.





DigiLine Service may be furnished in other serving offices in any of the above exchanges in combination with foreign serving office charges. In addition, DigiLine Service may be available in other exchanges upon a customer's bona fide request. A bona fide request is a written request for service. Upon receipt of the bona fide request, Southwestern Bell will conduct an economic analysis to determine the financial viability of offering the requested service.

Southwestern Bell expects DigiLine Service to generate first-year revenues of approximately \$236,000.


Instructor for the course is James Cunningham of Spearman. Cost of the class is \$8 per person. The course is sponsored by American Association of Retired Persons.




