

Murphy Nominated for Director of the Year

Marsha Murphy, special educa-tion director for the Perryton Shared Service Arrangement, represented Region 16 for the Texas Council of Administrators of Education (TCASE) Special Special Education Director of the

. The award, which went to Gay Brown of Odessa, was presented at the TCASE mid-winter conference in Austin

The award recognizes a special education director who has demonstrated outstanding leadership in providing services to students with disabilities, and whose work reflects the highest professional and ethical standards

Murphy's nomination was initiated and endorsed by the five school districts she serves in the Perryton SSA, which include Perryton, Booker, Darrouzett, Follett and Spearman.

Murphy was lauded for her innovative efforts in letters from Jerri Director of Special Education Services, Region 16 vice Center Eastern Director, Panhandle SSA; Marita Carroll, Perryton Kinder principal; Paige Burgin, Spearman community

member; and many others. She has served as the director for the Perryton SSA for nine years. She was instrumental in the creation of the transition support group, which provides special ed

students with quality transition services and support, and in the implementation of a multi-disciplinary autism team. She also helped develop one of the foremost programs in assistive technology for the state of Texas.

Prior to becoming the Perryton SSA director, she was director of the Early Childhood Learning Center (now Perryton Kinder), where she implemented the first Head Start ESL/bilingual class for Perryton ISD.

Marsha earned her bachelor of science degree in special education and speech and language therapy in 1971, and her master of educa tion degree in 1974. She received her master of education in administration in 1989.

Region 16 serves the 64 school districts with 220 campuses in a 26,000 square mile area, in the Texas Panhandle. Amarillo is the economic and geographic center of the Panhandle. Region 16 school districts have an average daily attendance of about 78,000 stuwith individual ranging from fewer than 30 to more than 29,000 students and the total regional school staff number-

ing more than 11,400. Marsha and her husband, Larry, Assistant Superintendent at Spearman I.S.D., have one daughter, Kathryn, a junior at Texas Christian University in Fort Worth. The Murphy's are members of the

First Christian Church, and are very active in the community.

Marsha has served on the Hansford County Library Board for 24 years. She was a founding board member of the Golden Spread Senior Citizen Center, which has now merged with the O'Loughlin Center. She initiated and continues to serve the local "Meals on Wheels" program, and was instrumental in reviving a non-profit childcare center in Spearman by obtaining donations and serving on the advisory board.



Last Friday Ramon Cantu visited with a group of birders from the state meeting in Amarillo that were up trying to see some rare birds. Jim didn't find out what they saw, but the weather was bad enough to make most birds hide out.

Jim reported seeing a flock of mountain bluebirds in the snow, scrub jays, cedar waxwings, and Mandy saw the roadrunner. Their big surprise was seeing 19 mule deer in front of their house Sunday afternoon. With the exception of a little yearling with tiny little spikes, Jim didn't see any bucks. Now is the time to look for sheds.

From time to time I get a letter asking me about biographies 1 have written for the Hansford County Rootsweb page on the Internet. Almost a year ago, I had one from Mindy Cator-Mead, a great-granddaughter of Bob and Jennie Ludlow Cator. She mentioned she was especially interested in the background of Jennie, as she was a nurse and midwife in Portland, Oregon after she and Bob left Texas. We have so little information on Bob and Jennie Cator that hearing from a descendant delighted me.

In a later letter she wrote, "The family story that I have heard is that Jennie took the four children

and left on a train while Bob was on a cattle drive. My understanding was that he left everything behind to follow her. I know that she did not live on the family ranch in Corvallis. She visited but lived in Portland, My Great-Aunt Mabel apparently was expected to take care of the family at the ranch. She didn't much like it.'

This is Mindy's version of Bob Cator's death. "I have been to see my Aunt Nell who is Arthur John Locke (Bob) Cator's granddaughter. She is 87 and lives in Medford. She had some additional information. In some of the stuff I had sent her from you, it mentions Charlie Cator, who left Texas to seek his fortunes. He was a nephew of Bob and Jenny but I would have to go back and look up the exact rela-

tionship. "He came to visit at the ranch in the Corvallis, Oregon area and was quite the hit with my grandfather, Osbaldeston, who was probably around 10 or so. They were playing around one day and Charlie gave his supposedly unloaded gun to Os to hold. But it went off, hitting Bob in the foot.

"The gunshot wound became infected and Bob died of gangrene. Charlie ended up staying in the area and died in the 1970's. Aunt Nell did not know anything about Charlie's family.





Bivins Seeks Better Compliance With Mandatory Auto Insurance Law

Legislation filed Monday, February 10th by State Senator Teel Bivins responds to a longstanding problem in Texas: A high level of non-compliance with the state's mandatory auto insurance

"Whenever I visit with constituents at town hall meetings, or go through my mail at the office, a common complaint I receive is that too many people are not obeying the law requiring all Texas motorists to carry auto liability insurance," said Senator Bivins. "Historically, accident reports have shown about 20 percent of people involved in wrecks in Texas are either uninsured or haven't othestablished financial responsibility. When it comes to non-compliance with auto insurance laws, Texas is a national

leader. I'm hoping my bill will eliminate that dubious distinction."

Senate Bill 422 would create a Texas auto insurance verification program similar to one in use in Illinois. Since Illinois implemented its program in January 1990, the non-compliance rate in that state has dropped from approximately 17 percent to about five percent.

In the verification program proposed in Senator Bivins' bill, the Department Transportation would send letters to randomly selected owners of registered vehicles requiring them to provide proof of auto insurance or an alternate form of financial responsibility. If the vehicle owner has not responded with proof of insurance within 30 days, a warning notice would be sent. Failure to reply within 45 days after the

warning notice was sent, would result in the suspension of the owner's vehicle registration. To reestablish registration, the vehicle owner would have to pay a \$100 reinstatement fee and submit proof of insurance. For subsequent violations, the reinstatement fee would be \$200. The legislation also establishes a fine of no less than \$1,000 or no more than \$2,000 if the vehicle owner operates the vehicle while its registration is suspended for lack of insurance.

"It's obvious the current system of verification is highly vulnerable to avoidance. I believe my bill offers a way to dramatically reduce the success rate presently enjoyed by scofflaws who are imposing an undue burden on law-abiding citizens," said Bivins.



Fraudulent Cashier's Checks

With new computer technology, crooks find it easy to produce almost perfect copies of checks from banks and other financial institutions.

Law enforcement agencies advise that you never accept a cashier's check from a stranger unless you call the bank that issued the check and verify not only the check number, but also to whom the check was issued. Even though the number on the cashier's check could be a copy of a real number, you want to make sure that the number is on

a check that has been made to you. Many crooks will try to give out fake cashier's checks for purchases on the weekend when banks are closed and you can't verify the check. Bogus cashier's checks are becoming a major scam for many people who choose to sell their cars directly to buyers through classified ads. A potential buyer may approach you on the weekend with a check that may bear an official-looking logo in the name of a local bank and have the term 'cashier's check" printed across the top of the check. The seller will assume this is a very safe check.

Fly Fast... And Fly Free

It couldn't have been a more exciting morning. After an initial delay, the space shuttle Columbia was set to make history with its launch on April 12, 1981. Not having a VCR, I placed a tape recorder next to the television, so I could record every word and every sound of this unprecedented event. The countdown crept to zero; Columbia flew from the launch pad like a rock from a slingshot; and I was hooked.

From that moment, watching Columbia race into space, I could see my future path right before my eyes. From that moment, I was determined to be an astronaut. I followed the two-day mission from start to finish, gathering news clippings and watching every news report I could find. I knew the biographies of John Young and Robert Crippen by heart. I couldn't wait to fly into space, and my life from that moment forward was

directed toward that goal. America's space program is a shining example of ingenuity, creativity, and teamwork. We have accomplished so much, and, in such a visible arena, we have led the world. Yet, with all its successes, it is the tragedies that snap us

back to reality. I was not yet born when the first tragedy struck. On January 27, 1967, during a preflight test in an Apollo space capsule, a fire broke out and quickly spread through the oxygen rich confines. All three astronauts, Gus Grissom, Ed White, and Roger Chaffee were killed. America and the space program responded to this tragedy, and in only a year and a half from the time of the Apollo 1 fire, America became the first and only

country to walk on the moon. The next tragedy hit closer to home. On my way to my next class

in my senior year of high school on January 28, 1986, my heart sank as I heard that the space shuttle Challenger had "blown up." How could that happen? Space travel was "routine," wasn't it? After all, a civilian teacher was on that mis-

The fallout from that accident was widespread, and the space program ground to a halt for nearly three years. We lost seven daring individuals -- people who were the best of the best. They had their sights on the stars and the drive and determination to get there. The thoughts and prayers of all Americans were with them.

Following the Challenger investigation, there is no doubt that fixes were made, lessons were learned, and the space program emerged safer and refocused. After almost three years without a flight, the space shuttle Discovery put America back on track as it lifted off on September 29, 1988.

My own inspiration and drive not affected by the Challenger accident, and I pursued my dream by majoring in aerospace engineering as an undergraduate. By enrolling in the workstudy program, I was able to work the space program while enrolled in school. I just couldn't believe it -- at only nineteen years old, I was working in the space program! I was fortunate enough to be on a work tour when America returned to space in September 1988, and I was filled with pride watching the shuttle lift off and head into earth orbit. America was back, and so was the space pro-

During one of my work tours in Houston, a co-worker asked me what I wanted to be when I grew up. "An astronaut," I answered without hesitation She looked me right in the eye and said that I bet-

ter be prepared for many more years of school if being an astronaut was really what I wanted to do. I took her advice to heart, and shortly after getting my degree from Texas A&M, I enrolled at Rice University for graduate

In a classic example of not picking your career, but rather your career picking you, I realized at the end of graduate school that my calling was to another endeavor. I learned first hand the difference between doing what you want to do and doing what you were meant

I have conducted tests for astronauts in the targe underwater training pool, and I have floated weightless along side them in the KC-135. However, my head tells me that my destiny does not lie in being an astronaut, although my heart will always look to the stars with a sense of awe and adventure. To be an astronaut is to be an explorer in the greatest sense. They are heroes, and they are role mod-

My heart goes out to the loved ones of the fallen astronauts, and it goes out to the entire space family. For the seven astronauts who perished on February 1, 2003, I know there are many prayers being sent There are many yo'ur way. Americans asking God to bless you and to let your souls rest in peace. I, for one, will not utter such words because I know the type of people you were. Instead, I will simply say: Goodbye. Fly fast... and fly free.

On January 16th, 2003 at 10:39 EST the Space Shuttle Columbia and its crew of seven launched on a 16-day mission. This mission's primary focus was on what happens to the human body when it is deprived of gravity.

This mission was very important in many ways. It carried approximately 90 experiments from around the world that covered all aspects of Life Sciences from how a soybean plant grows in microgravity to studying affects to human lungs as well as three experiments related to fire and controlling fire.

For me this mission held a very special meaning and memory. After 17 years of working at NASA Johnson Space Center (JSC) I got to see my very first launch live at the Kennedy Space Center (KSC). I had many opportunities before but due to delays and other issues I did not get to see the other launches.

You could not have asked for a more beautiful day to see a launch. The sky was clear and the view from in front of the Launch Control Center at KSC was incredible. It is hard to describe the feeling of seeing the launch in person. It is incredible to see this 4.5 million pound, 184 foot tall vehicle slowly take off into space. You first see the ignition and vehicle going up into the sky and then you begin to hear and feel the rumble of the rockets. The first sensation I felt was through my feet and then deep inside as this incredible vehicle rockets towards space. At the same time of feeling pure excitement for what we were seeing there is this deep uncertainty and hope that nothing goes wrong during liftoff.

I can remember exactly where I was and what I was doing during the Challenger explosion on January 28, 1986. That event was very traumatic, especially since I had only been working at NASA for less than a year. Working together to recover from that incident was a long and hard road to travel but NASA did survive and came out better than before.

On February 1, 2003 I received a call from my father and one from my daughter telling me that the Space Shuttle Columbia had exploded upon re-entry. I could not respond and sat stunned for several seconds. I immediately hung up the phone and started watching the news. My thoughts were going from what happened, how did it happen, what about the crew on the International Space Station and why. I never expected to see something like this during reentry. Even though I did not directly know any of the astronauts onboard, they are all still like family. Working at NASA is a passion that stems deep from the heart of everyone that is here. We are a very close-knit family with one dream in common. We all have a dream and passion about mankind exploring space. I know that with the passion and dedication of all the team we will work through this and that NASA will be even better.

We all appreciate the outpouring of sympathy and support from everyone.


A Statement from the Families of Space Shuttle Columbia

Although we grieve deeply, as do the families of Apollo I and Challenger before us, the bold exploration of space must go on. Once the root cause of this tragedy is found and corrected, the legacy of Columbia must carry on --- for the benefit of our children and yours.



Commander Rick Husband

Commander Rick Husband, 45, Air Force colonel from Amarillo, Texas. The former test pilot was selected as an astronaut in 1994 on his fourth try. He made up his mind as a child that that was what he was going to do with his life.

"It's been pretty much a lifelong dream and just a thrill to be able to get to actually live it out," he said in an interview before Columbia's launch, his second space flight.

Pilot William McCool

Pilot William McCool, 41, Navy commander from Lubbock, Texas, and father of three sons. He graduated second in his 1983 class at the Naval Academy, went on to test pilot school and became an astronaut in 1996. This was his first space flight.

Payload Commander Michael Anderson

Payload commander Michael Anderson, 43, the son of an Air Force man who grew up on military bases. He was flying for the Air Force when NASA chose him in 1994 as one of only a handful of black astronauts. He traveled to Russia's Mir space station in 1998. The lieutenant colonel was in charge of Columbia's dozens of science experiments. His home is in Spokane, Wash. Anderson often returned to his hometown to talk with school kids and to share his experiences in space.

Astronaut IIan Ramon

Ilan Ramon, 48, a colonel in Israel's air force and the first Israeli in space. His mother and grandmother survived Auschwitz death camp. Father fought for Israel's statehood alongside grandfather. Ramon fought in Yom Kippur War 1973 and Lebanon War

He served as a fighter pilot 1970s, 1980s and early 1990s, flew F-16s and F-4s. He was chosen as Israel's first astronaut in 1997, then moved to Houston the next year to train for shuttle flight. His wife and four children live in Tel Aviv.

Ramon was one of the pilots who bombed the Iraqi nuclear reactor in 1981, reports CBS News Correspondent Robert Berger. Since his mother was a Holocaust survivor, he became a national hero, representing the tragedy and triumph of the Jewish people.

Astronaut David Brown

David Brown, 46, a Navy captain, pilot and doctor. He joined the Navy after a medical internship, went on to fly the A-6E Intruder and F-18. He became an astronaut in 1996. Columbia's mission was his first space flight.

Astronaut Kalpana Chawla

Kalpana Chawla, 41, emigrated to United States from India in 1980s and became an astronaut in 1994. Kalpana Chawla was a real success story in India. Just a couple of weeks ago, she was on the cover of one of India's leading magazines as an emigrant who had made good.

She had been quoted many times as saying that this is what she wanted to do, and she kept in touch with people back home, and many people wrote to her, wanting to go to the States and do what she had done. She was a real inspiration.

Astronaut Laurei Clark

Laurel Clark, 41, a Navy diving medical officer aboard submarines, then flight surgeon who became an astronaut in 1996. On board Columbia to help with science experiments. She has 8-year-old son. Her home is in Racine, Wis.

"She wasn't just intelligent," her brother Dan Clark said. "She's just one of those people who made the right moves. She got along with people. She saw the path to be an astronaut was open - she went at it full throttle all the way."
