The City of Spearman recently Freceived approval from the FAA W and TNRCC to re-open the Type I T landfill at the existing site. The landfill re-opened on Tuesday, S February 10, 1998, after being C closed on October 8, 1997 due to not being in compliance with Federal M Aviation Administration and H Texas Natural Resources I Conservation Commission (regulations. (

Before re-opening the landfill to the public, the City was required to regulate the landfill in accordance with TNRCC rules by screening incoming refuse.

Following is a list of unacceptable items in the landfill pit: A) Batteries (recyclable item) or Antifreeze; B) Hazardous, Industrial, or Toxic Waste; C) Asbestos of any kind, or Treated Seed; D) Infectious or Medical Waste; E) Burning or Smoldering Materials; F) Motor Oil, Oil Filters, or Fuel Filters (recyclable items); G) Recyclable Metal Items (recyclable items); H) Appliances (recyclable items); I) Any item containing Freon (recyclable items); J) Tires (recyclable items); K) Grit Trap Waste and Septic Waste; L) Dead Animals.

Recyclable Items Accepted in Designated Areas Only: A) "Do It Yourself" Motor Oil (5 gallons or less per trip); B) "Do It Yourself" Oil Filters; C) Batteries; D) Metal items such as appliances or white goods (Any items containing freon <u>must</u> have written documentation that freon has been recycled.); E) Tires \$2.00 per passenger, \$5.00 per truck tire, an \$10.00 for large tractor tires; F) Contractor or "for profit" materials will be billed at \$6.25 per cubic yard.

Hansford County Approved To Plant YieldGuard[®] Corn

The type of genetically improved corn that is most effective in controlling harmful corn pests without the use of chemical insecticides will no longer be restricted in 10 Texas Panhandle counties.

The corn, known as YieldGuard[®] insect-protected corn, is the only genetically improved corn that provides season-long protection against the multiple generations of European and Southwestern corn Environmental Protection Agency restricts the amount of Bt corn that can be grown as a precaution to ensure that bollworms do not develop resistance to Bt.

Cotton-producing counties in Texas remain affected by the EPA restriction, but the northern Panhandle has now been removed, which means that corn growers there will have full access to the same protection as corn producers across the state line in Oklahoma and New


YieldGuard[®], developed by monsanto, is restricted in regions where cotton is grown as part of a federal plan to guard against insect resistance development in the cotton bollworm. The 10 Panhandle counties had been included in that restricted area.

However, the Texas Corn Producers Board pointed out that cotton is not grown in the northern Panhandle and that corn is the dominant crop. The TCPB, with cooperation from Commissioner Perry's office, worked to petition EPA to lift the restriction in the 10 northern counties - Carson, Dallam, Hutchinson, Lipscomb, Moore, Hansford, Hartley, Ochiltree, Roberts, and Sherman. YieldGuard®, which contains a protein from a soil organism known as Bacillus thuringiensis (Bt), is one of several Bt corn products.

Corn borers do an estimated \$1.2 billion in damage every year to the nation's corn crop. In 1997, YieldGuard[®] insect-protected corn hybrids provided an average yield advantage of 10.8 bushels per acre over the identical hybrid without the YieldGuard[®] trait, for a net return of nearly \$17 per acre throughout the Corn Belt.

"We are very happy that corn farmers in the Panhandle will be able to use YieldGuard[®] in 1998," said Jerry Don Glover, executive director of the Texas Corn Producers Board.

Bt, when present in corn in sufficient amounts, is very effective against European and Southwestern corn borers but is harmless to humans, wildlife, and beneficial insects. Bt also provides partial control of corn carworm, which is also known as the cotton bollworm. In areas where Bt cotton is grown, the US Mexico.



Glover issued a strong advisory to corn growers to implement an insect resistance management program. "It is very important for every grower who plants Bt corn to set aside a refuge where resistant corn borers can mate with susceptible insects. Bt is great technology that improves our ability to farm, and growers must be the ones who protect it for the future."

Only one variety of YieldGuard[®] was removed from the restrictions. It is available in hybrids from several leading seed companies. Another variety, sold by Novartis seeds, is available in the Panhandle but is subject to the restriction.

"We have been working on this project for many months with the cooperation of the Texas Department of Agriculture, our senators and congressmen. The TCPR would like to thank all involved for their help," said Glover.

The Texas Corn Producers Board is the research and promotion program for corn funded by a uniform corn checkoff collected from corn producers in every county of Texas.

SISD Introduces Genlynx

When the Spearman High School dropout rate doubled in the 1996-97 school year, local school officials began to seek ways to curb the rise. The program formulated to meet this need is known as Genlynx.

Although Genlynx is an alternative school (according to Webster's definition of "a school that is non-traditional, especially in its educational ideals or methods of teaching"), Genlynx should not be confused with the state-mandated Alternative Education Plan (AEP), which deals with discipline problems within the school district.


According to Jeff Rowland, Spearman High School Principal, the Genlynx program is designed for "at risk" students, or students who, for various reasons, have fallen behind in amassing the credits they will need for graduation.

The program, which was named

Genlynx by its teacher, Myrna Biggers, is held on the second floor of Hansford County Library. There are two sections of classes each day. Students may attend the 7:30 a.m. - 11:30 a.m. classes or the 1:45 p.m. - 4:45 p.m. classes.

Novanet, a computer based curriculum designed to let a student learn at his own pace, is used in the classes. Students are required to pass a minimum of one course per month which amounts to completing a minimum of ten credits per school year. Students are required to master 85% of the course, rather than the 70% required in the traditional school setting. Students are also required to take the GED test as part of the program. This enables the students who still fail to meet graduation requirements to have their GED.

This type of alternative school is similar to the "Champs" program offered by many area schools. In the Champs program, "at risk" students from several area schools are bused to a mutual location (Fritch for this area) each day for school and are taught at an individual learning rate, which can be accelerated or slowed to meet the individual's needs. Rowland measures the cost of educating the students now in Genlynx in this manner would be approximately \$60,000 per year plus busing costs. Letter To The Editor

Dear Editor,

There has been much concern voiced over the threat posed to the Ogallala Aquifer and other drinking water resources in the Great Plains by the construction of confined animal feeding operations (CAFO's) and their attendant waste water lagoons, especially those of corporate hog farms. There have been many arguments about the overall benefits and/or detriments of those farms being located in this area. This letter is not primarily concerned with the economic and cultural impact of CAFO's, but rather a layman's look at the technical aspects of lagoon design and construction, and the probability of lagoons leaking and polluting the area's drinking water. Although the following data is specific to the northern Texas Panhandle, the environmental conditions are similar to that of western Oklahoma and the Oklahoma Panhandle. My company employs personnel in both states and has corporate offices in Guymon.

In order to meet state requirements, Texas Farm, a large swine production company in Ochiltree County, Texas, retained the services of a registered professional engineer to develop design specifications for their waste water lagoons. They have developed specifications that are far more stringent, with regard to permeability, than the regulations of the Texas Natural Resources Conservation Commission require.

Construction protocol requires that before lagoon excavation begins, all involved site soils are sampled to specified depths and tested to identify their physical characteristics and permeability rates. During excavation the most impermeable soil layers are stockpiled. After the lagoons are fully excavated the stockpiled

and compacted, forming a highly impermeable liner. Following installation the liner layer is tested in place to ensure it meets permeability standards. With the above process in mind, the figures below are provided as relevant to the potential danger that waste water lagoons pose to Ochiltree County's drinking water resources, and that of the High Plains region in general. These figures assume no evaporation.

Depth to Ogallala Aquifer in Ochiltree County: 250 to 500 feet Depth to Ogallala Aquifer

around Perryton: 280 to 350 feet Rate of permeability through compacted clay liner: 1 inch per 58.8 days (705.6 days to penetrate 1 foot liner - Below which is 260 to 330 feet of soil, sand and rock above the aquifer surface)

As stated previously, these figures assume no soil or water surface evaporation, which would significantly reduce and/or completely offset infiltration rates. In the Ochiltree County area evaporation rates for open bodies of water are 62 to 64" per year. This compares to 6.2 inches of infiltration per year in a clay lined lagoon (based on I inch every 58.8 days). At such rates, it can be expected that loss to lagoon waste water through evaporation would be 10 times that of loss to infiltration. Typical for this area are estimates given at Lake Meredith for water losses due to evaporation and infiltration through the unlined lake bed. The ratio of loss there is assigned at 3.5 to 1, up to 5 to 1, respectively. Evaporation losses greatly exceed infiltration losses, even in such unlined circumstances.

Finally, if (and it really is a big if) water from lagoons reaches the Ogallala Aquifer, it will have been filtered through hundreds of

soil is placed back into the lagoon feet of caliche, sand and soil. In short, it will be purified. Sincerely,

P.S. - I, like dozens of other people in small communities across the Oklahoma Panhandle, western Oklahoma and the northern Texas Panhandle are able to be involved in local communities (e.g., Spearman, Gruver, Perryton, Booker, Follett, Stratford, Texhoma, Hardesty, Goodwell, Beaver, etc.) as taxpayers, little league coaches, Sunday school teachers, Big Brothers/Big Sisters, etc., because we are employed by my company, or others that are involved in swine production or the construction of hog facilities. If this environmentally sound industry is detrimentally affected by a moratorium or a slow-down of some sort, many of us will have to leave the communities we call home in order to find employment that will support our families. It would be difficult for us as well as for the towns we leave behind. These issues really need to be decided by those with technical expertise, not by politicians or by a few people financially wellheeled and emotionally charged, but lacking any hard factual data to support their opinions on the issue. In Oklahoma, where the governor wants to cut taxes and brags about unemployment being down, it needs to be said that corporate chicken and hog farms are a great reason for the latter, and may enable the former.

Southwestern Bell Telephone Company (Southwestern Bell) filed an application with the Public Utility Commission of Texas (PUC) to charge an additional 26 cents per month per line to recover costs for providing Expanded Local Calling service (ELC) to certain Texas Customers.

The 26 cents per month surcharge would not be billed to customers who receive ELC. However, customers who receive ELC and pay less than the maximum \$3.50 a month residential ELC charge or less than the maximum \$7 business ELC charge will have to pay the additional 26 cents per month charge

Expanded Local Calling was created in 1993 by Texas legislation that requires telephone companies to provide toll-free calling between small towns that share a community of interest such as a school or hospital district. The legislation allows telephone companies to recover costs not paid through customer charges by applying a surcharge to all other customers in the state who do not receive the ELC service or who do not pay the maximum ELC rate. The maximum monthly ELC rate allowed under state law is \$3.50 per line for residential customers and \$7 per line for business customers.

Southwestern Bell estimates that the 26 cents per month per line charge will recover the \$27 million annual cost of providing ELC service that is not recovered from ELC rates.

If approved by the PUC, the monthly statewide surcharge of 26 cents per line per month will begin with the April, 1998 billing cycles, with an agreement to refund all or part of the charge if the PUC does not approve it.
