words from Faith & Grace

by Cecil R. Biggers, Lutheran Lay Minister

As we seek the meaning of Easter, we study Acts 7:55-60, Psalm 1-5,15-16,

I Peter 2:2-10 and John 14:1-14. Luke tells us the story of Stephen who was the chief deacon of the church at Jerusalem. Stephen was strong in the Spirit and distributed money to the widows. Stephen was accused of subverting the temple, and in his defense Stephen cites the history of Abraham, Moses and Solomon and accuses the crowd "You Abraham, Moses and Solomon and accuses the crowd "You are the ones who received the law as ordained by angels, and yet have not kept it". He then describes seeing the Son of Man standing at the right hand of God. In reply, the crowd stones Stephen to death. Stephen was the first Christian martyr. Note that "martyr" comes from a Greek root which means "witness". Consider that a "terrorist" kills other people for a cause; whereas, a "martyr" dies as a sacrifice so that others may live. The Psalmist sings that God is responsive to those who call upon Him. It is God's purpose to deliver and save His people, and to hear them when they cry.

Peter tells the persecuted Christian faith community that the believer is to long for the word of God as an infant longs for milk. Our faith is "nourished" by God's word. In Isaiah, Israel is referred to as God's corner-stone; Peter tells that Christ is the stone the builder's rejected, who has now become the corner-stone. This corner-stone is the support

Christ is the stone the builder's rejected, who has now become the corner-stone. This corner-stone is the support of a "living temple" and we believers are "living stones" supported by Christ who form that temple, that "house not made by hands, eternal in the heavens". But for those who do not believe, this "corner-stone" is a stumbling block. Therefore, dear Christian, the Church is not a building, an earthly edifice; the Church is composed of "living" stones, the faith community. Peter also says that we are a "chosen" people. Chosen for privilege in that we have an intimate relationship with God. Chosen for obedience in that we are to do God's will on this earth. Chosen for service to be used for God's purpose. used for God's purpose.

John shows us Jesus reassuring his disciples just prior to his being arrested. Jesus promises that he is going to prepare a place for us, that there are many dwelling places in His Father's house. Jesus promises to return and take his disciples there. Thomas does not understand and asks "Where are you going? How will we know the way?" Jesus responds, "I am the way, the truth and the life." Note that the purpose of the Jewish religion was to ascertain the "way" of God, to live in God's "truth" and thereby to obtain "life". Jesus is the consummation of our seeking to know God.Philip asks Jesus to show them the Father.Jesus responds, "Whoever has seen me has seen the Father...Believe me that I am in the Father and the Father is in me." Jesus then promises to do whatever is asked in his name; "name" is the true essence of Jesus.

And so Ramona Quimby, Henry Huggins, Ellen Tebbits, and her other beloved characters were born.

When children ask Mrs. Cleary where she finds her ideas, she replies, "From my own experience and from the world around me." She included a passage about the DEAR program in Ramona Quimby, Age 8 (pages 40-41) after she received numerous letters from readers who

mentioned the great reading program they were doing in class. It seemed like something Ramona's class would do, too, so she put it in

Ramona came to a halt. "Howie fixed my trike for me and told me how to ride it."


"What a clever boy!" said Mrs. Quimby. "You must be very good with tools."

"And why is smoke coming out of the windows?"







cost money.


