

# Lynxettes Claim District 1-2A Cross Country Title, Lady Hounds Claim District 1-1A Cross Country Title

Spearman Varsity Lynxettes & Lynx Spearman girls, Bushland boys successful in title defenses: The two-time defending state champion Spearman Lynxettes and defending district champion Bushland won team titles Monday, October 25, 2010 in the District 1-2A Meet at Palo Duro Lake in Spearman.

Highland Park sophomore Quinlin Mc-Gregor ran 16:56 to break his own course record and repeat as individual champion, while Tylo Farrar of Spearman also defended her individual title in strong wind on a course longer than three miles.

"The times were slow," Lynxettes coach Starla Whitely said. "Tylo usually runs 12 minutes in practice. Quinlin breaking the course record in those conditions with the wind off the lake was amazing."

McGregor, who finished fourth at last year's regional as a freshman, easily defeated Tony Surace of River Road, who was second in 18:28.

Spearman scored 24 points to claim the girls title ahead of Bushland with 35 and the district's third regional qualifier, Sanford-Fritch, with 85.

Bushland, led by Jared Vogler's thirdplace finish, easily captured the boys title with 26 points over Highland Park with 51 points and River Road with 53.

Tylo Farrar led the Lynxettes, finishing

# Child Hit By Car





We learn about "Re-Forming" our lives as we study Isaiah 1: 10--18, Psalm 32: 1-7, 2 Thessalonians 1: 1 12, and Luke 19: 1-10.

Isaiah calls the people to "Re-Form" by addressing them as "you rulers of Sodom ... you people of Gomorrah". As God's messenger, Isaiah condemns the formal religion of the people--the sacrifices, the holidays, the formal prayers--because the people have held to the form of religion but have ignored their duties of social justice. Isaiah calls for "justice" for the widow, the orphan, the poor, the immigrant, the aged; all people who are marginalized by the people of Israel. The prophet gives commands from God, "wash yourselves; remove the evil of your doings; cease to do evil, seek justice, rescue the oppressed, plead for the widow. Understand that in Hebrew, "justice" is a dynamic concept (i.e. justice as a surging, rolling, cleansing river). Perhaps, dear Christian, we need to "Re-Form" ourselves so that we live to do this dynamic "justice" from God. The Psalmist sings 'happy are those whose transgressions is forgiven, whose sin is covered." Happiness is a life no longer lived in rebellion against God. The Psalmist urges his listeners to acknowledge their sin. confess to the Lord, that they might be delivered. Hear this song, dear Christian; answer in prayer and confession. The Church in Thessalonica is undergoing persecution and affliction. Paul writes using emphatic Greek verbs, thanking God that the Thessalonican church is growing in faith and in love. Paul commends them for their steadfastness in the face of adversity. Paul prays that God will make them worthy of his call and will fulfill by his power every good resolve and work of faith. All of this to the glory of our Lord, Jesus. If our predecessors in faith can remain faithful and working in the face of torture and death, can we not spare of our time and wealth to further the Lord's work? Do our priorities need to be "Re-Formed"? Luke tells the story of Jesus and Zachaeus. How many of us have sung that little Sunday school song in our youth? Reading this story as an adult shows us a man who wants to "see" Jesus. A man who wants to understand what this young rabbi is about. We hear of a man who is wealthy at a time when most people were poor. We see a man who is short in stature, and 'short' in moral-standing in his community. Jesus sees this man and invites himself to the Zachaeus' house. The people are aghast for they see Zachaeus, the chief tax collector as Zachaeus the chief sinner. Zachaeus spontaneously offers to give half of his wealth to the poor and to restore four-fold any money he has wrongfully taken from others. Jesus declares that salvation has come to Zachaeus and his house. Notice, dear Christian, that Zachaeus is not said to have repented in order to obtain forgiveness; rather, Zachaeus has embraced the dynamic justice'; Zachaeus has "Re-Formed" his life; and for this, Jesus declares his salvation. May the Holy Spirit "Re-Form" your life that you may embrace dynamic 'justice' and find salvation in God's grace through faith in Our Lord, Jesus Christ.

Nearly 24,000 Texas employers could lose their taxexempt status because they have not filed required returns in the last three years with the Internal Revenue Service, the Texas Workforce Commission said.

Oct. 15 was the deadline for small Lonprofit organizations with 501(c)(3) status to comply with the law under a one-time relief program the IRS announced in July.
