Gold Performance Acknowledgements give local schools pat on the back

Hansford County school districts Gold Performance earned Acknowledgement from the Texas Education Agency.

Gruver ISD received acknowl- Recognized. edgments for Attendance, Writing and the Recommended High School Program (RHSP). Gruver High School and Gruver Jr. High were both rated as Recognized. Gruver High School received Gold Performance Acknowledgements in Attendance and RHSP. Gruver Junior High received acknowledgements in Attendance, Writing, Science and Social Studies. Gruver Elementary received a rating of Exemplary and received acknowledgements for Attendance, Reading, Math and Writing.

Spearman ISD received acknowledgements for Attendance created the Gold Performance and the Recommended High School Program. Spearman High School and Spearman Jr. High were rated as Academically Acceptable, with Spearman High School receiving acknowledgments for Attendance and RHSP. Spearman Jr. High received acknowledgments for Attendance, Writing and Social Studies. Spearman Elementary received a rating of Recognized, and earned acknowledgements in Reading and Writing.

Pringle-Morse CISD received said, acknowledgements for Attendance, Reading and Science. Pringle-Morse Jr. High earned a rating of

About 40 percent of Texas school districts and 31 percent of campuses earned more than one Performance Gold Acknowledgment from the Texas Education Agency. Overall, approximately 69 percent of Texas school districts and 53 percent of campuses earned one or more Gold Performance Acknowledgments.

Districts were eligible for a maximum of 11 possible GPAs, which are measures of high performance created by the Texas Legislature or the commissioner of education.

"The Texas Legislature in 2001 Acknowledgment to publicly recognize districts and campuses for high performance in areas that are in addition to those used to determine state accountability ratings," Commissioner of Education Shirley J. Neeley said.

"The Gold Performance Acknowledgments give schools an extra pat on the back. We are proud of the schools and districts that are being recognized today because they represent schools with strong instructional programs that go beyond the basics," Neeley

For example, beginning this year, high school freshmen, under Texas law, must follow the rigorous Recommended High School Program, a college preparatory degree plan. But many students in recent years voluntarily followed this diploma plan and today 51.3 percent of Texas school districts received a GPA because they had more than half of their students in the Class of 2003 graduate under the Recommended plan.

The GPA also includes new indicators that were not previously used for acknowledgments: TAKS Commended Performance in reading/English language arts, writing, mathematics, science, and social studies. Twenty-one percent of the districts received an acknowledgment because of the percentage of their students who earned "commended" status on the writing component of the Texas Assessment of Knowledge and Skills. Almost 12 percent of the districts earned this recognition because of the percentage of students who achieved commended status on the TAKS reading test.

Flu - "widespread" in Texas

Health Services (DSHS) officials reported today that influenza activity in the state last week rose to the widespread classification for the first time this flu season.

Officials say it is not too late to get a flu shot and encourage those in the priority groups to get one.

Flu season officially runs from October through May. In Texas, the heavy part of flu season typically occurs in late December, January and February.

The A/Fujian and B/Shanghai forms of the flu virus have been identified in Texas. Both are covered by this season's vaccine.

The expanded priority groups for the flu shot are children 6 months

Texas Department of State facilities, children 6 months through 18 years on chronic aspirin therapy, medical care workers providing direct patient care and caregivers and household contacts of children under 6 months old and of others at high risk of severe complications from the flu.

More vaccine has been shipped to Texas providers in recent weeks. People wanting to get a flu shot should contact their doctor, call the 2-1-1 information service and call their local public health department or nearest DSHS regional office.

It takes about two weeks after getting the flu shot for the vaccine to offer maximum protection.



Weekly Report: Influenza Summary Update Week 1, ending Jan. 8, 2004

SYNOPSIS: During week 1 (January 2-8, 2005)*, influenza activity ontinued to increase mostly in the eastern United States. Five hundred en (16.8%) specimens tested by U.S. World Health Organization (WHO) and National Respiratory and Enteric Virus Surveillance System (NREVSS) collaborating laboratories were positive for influenza viruses. Over fifty percent of all influenza A isolates this season have been reported from the Mid-Atlantic and New England surveillance regions**. The proportion of patient visits to sentinel providers for influenza-like illness (ILI) is at the national baseline and the proportion of deaths attributed to pneumonia and influenza is below the epidemic threshold. The first influenza-associated pediatric death was reported during week 1. Eight states and New York City reported widespread influenza activity, 12 states reported regional influenza activity, and 10 states reported local activity. Twenty states, the District of Columbia, and Puerto Rico reported sporadic influenza activity.

INFLUENZA ACTIVITY AS ASSESSED BY STATE AND **TERRITORIAL EPIDEMIOLOGISTS*:** During week 1, 8 states Connecticut, Delaware, Kentucky, Maryland, New York, Rhode Island. Texas, and Vermont) and New York City reported widespread activity Twelve states (Colorado, Idaho, Iowa, Kansas, Maine, Massachusetts, Minnesota, Nevada, New Hampshire, New Jersey, Pennsylvania, and Wisconsin) reported regional influenza activity. Ten states (Alaska, Illinois, Louisiana, Michigan, North Carolina, North Dakota, South Dakota, Tennessee, Utah, and Virginia) reported local activity. Twenty states (Alabama, Arizona, Arkansas, California, Florida, Georgia Hawaii, Indiana, Mississippi, Missouri, Montana, Nebraska, New Mexico, Ohio, Oklahoma, Oregon, South Carolina, Washington, West Virginia, and Wyoming), District of Columbia, and Puerto Rico reported sporadic influenza activity.

THIS WEEK IN HISTORY

Monday, January 17th was Martin Luther King, Jr. Day, observed in celebration of his life and birthday. Ronald Reagan declared the third Monday in January a legal federal holiday in 1986, commemorating Dr. King's birthday. Previously, January 15th had been observed as a public holiday for many years in 27 states and Washington, DC. This is the only federal holiday commemorating an African-American.

In December of 1955, Martin Luther King, Jr. had just received his doctorate degree in theology. He had moved to Montgomery, Alabama to preach at a Baptist Church. He observed that African-Americans had to ride in the back of public buses and he knew that this law violated their rights. He organized and led a boycott of the public busses and after 382 days the Supreme Court declared that the Alabama state segregation law was unconstitutional.

In 1957, Dr. King founded the Southern Christian Leadership Conference and moved back to his hometown of Atlanta, Georgia. This was the beginning of the Civil Rights Movement. It took until 1964 to achieve the passage of the Civil Rights Act of 1964, which guaranteed equal rights in housing, public facilities, voting and public schools.

Dr. King's most famous speech, "I Have a Dream," occurred on August 28, 1963 during a march on Washington, D.C. It was attended by more than 250,000 people.

Dr .King was assassinated in 1968 after winning the Nobel Peace Prize for leading non-violent demonstrations. The world grieved the loss of this man of peace.

I hope you celebrated this day in observance of peace and love. "We will not resort to violence. We will not degrade ourselves with hatred. Love will not be returned with hate.





Neighborhood electric vehicle, motor assisted scooter information



passed an ordinance regulating the operation of motor-assisted scooters on the streets and rights of way. The 78th Texas Legislature

authorized municipalities to either prohibit or regulate the operation of motor-assisted scooters, and the City Council of the City of Gruver has determined that the regulation of use and operation of motorassisted scooters on the highways, alleys, paths and trails is necessary in the interest of safety.

The City Council has investigated and determined it would be

The City of Gruver recently best interest to the health, safety and welfare of the citizens of Gruver to prevent potential traffic hazards and safety hazards resulting from the use of motor-assisted scooters. Therefore they passed an ordinance outlining the rules and regulations they deemed necessary.

The Gruver Police Department held training programs at the ele-mentary and junior high this week, and copies of the ordinance were given to each student.

The regulations and limitations placed on the motor-assisted scooter in this ordinance do not apply to advantageous, beneficial and in the those operators of certain mobility

devices as outlined in the Texas Transportation Code 542.009 Operators of Certain Mobility Devices" which are mobility devices for persons with physical disabilities.

The City of Spearman does not currently have an ordinance specif-ically regulating the operation of these scooters.

City of Gruver Rules & Regulations for Motor Assisted Scooters, Pocket Rockets and Mini Choppers

1. You must be at least 8 years old to ride.

2. You must wear an approved helmet at all times.

3. You may not ride after dark. 4. You may not ride on any restricted street. Hwy 15, Hwy 136 also known as Main St., 4th St also known as Hwy 84, and Broadway St.

5. Only 1 person may ride at any ime

6. You must obey all yield and stop signs. 7. You do not have the right of

vay when leaving a parking lot. If you disobey any of these rules or any other rule listed in City Ordinance #304 on file at City Hall you will be escorted home by a Police Officer and a ticket will be given to your parent with a fine of not less than \$50.00.

Texas Transportation Code

The 78th Legislature addressed the issue of new transportation technology. The law now recognizes motor assisted scooters and Neighborhood Electric Vehicles for limited street usage. The law can be found in the Texas Transportation Code (TRC) as Subchapter D, Sections 551.301 and 551.302. Subchapter D became effective on September 1, 2003

In general, any traffic law which applies to bicycles also applies to motor assisted scooters. That means the operator must obey the usual traffic laws that bicycle operators must obey such as speed limit, signal turns, etc. (TRC 551.101(a)). However, TRC 551.302(d) states that some laws that apply to a motor vehicle do not apply to these scooters. This means that:

- · the scooter operator doesn't need a driver license,
- · the scooter operator doesn't need liability insurance,

· the scooter doesn't have to be registered or have a license plate,

· the scooter doesn't have to carry a low speed vehicle emblem; and, · the scooter doesn't have to be inspected.

Cities and counties may prohibit operation of these scooters on partic-ular streets or highways for safety reasons, as can the Texas Department of Transportation (TXDOT).

Along with the "motor assisted scooter," the Legislature legalized the "neighborhood electric vehicle." The "neighborhood electric vehicle" is any vehicle subject to Federal Motor Vehicle Safety Standard 500. They generally resemble a golf cart, but are larger-usually capable of carryin four passengers-with a top speed between 20 M.P.H. and 25 M.P.H. Vehicles such as the John Deere Gator and Kawasaki Mule are not neigh borhood electric vehicles because they are not subject to Federal Standard 500 in that they are designed to primarily carry cargo rather than passengers. Like the motor assisted scooter, neighborhood electric vehicles can be driven on any street or highway with a posted speed limit of 35 M.P.H. or less, and may cross streets or highways with a higher posted speed limit. However, unlike the motor assisted scooter, a neighborhood electric vehicle must be registered and have a license plate. The operator must have a driver license and the vehicle or operator must be overed with the required liability insurance or acceptable substitute. In addition, these vehicles meet the TRC Section 547.001 definition of a slow moving vehicle," and must carry a low speed vehicle emblem. Finally, as with the motor assisted scooter, a city or county may prohibit their operation on a street or highway for safety reasons, as can TXDOT




