#### **Bigs in School** Orientation

Bigs in Schools, the schoolbased mentoring program of Big Brothers Big Sisters of the Texas Panhandle, will soon begin its second year in Gus Birdwell Elementary in Spearman. The program takes the BBBS mission of placing caring adults in the lives of children to the schools.

Volunteer mentors from the community will meet once a week with children on the school campus for about 30-40 minutes. During this time the child and his/her Big Brother or Sister will talk, play games, read or do crafts and projects. "The important thing is building a relationship," explained Kimberley Lopez, local BBBS case manager. "The activities they do are fun and lead to good communication. This is not a tutoring program. Nationwide we're seeing remark able results from caring adults spending one-on-one time with a

child at school." In fact, a 1999 study showed that children in BBBS's schoolbased mentoring programs develop more positive attitudes toward school, achieve higher grades, improve relationships with peers and adults, express their feelings better, develop higher levels of self-confidence and trust their teachers more.

"The children who are recommended for this program do not necessarily have academic problems, or any problem at all for that matter," explained Lopez. "They are simply students who will benefit from individual support and encouragement that helps them feel more positive about themselves, their abilities and school."

Bigs in School was piloted in Spearman Elementary last year. "We matched six children with mentors. It was a great success Every teacher, parent, volunteer and child who participated is eager to be involved again," Lopez said. "We are looking forward to achieving the same positive results this year."

"We can help more students if we have more volunteers," she added. "We especially need Big Brothers."

Volunteers can range from high school students to senior citizens Each must attend an orientation, and successfully complete a background investigation and an interview. "Bigs in Schools offers people who have evening or weekend commitments, or their own children at home, a chance to be a Big Brother or Sister because the relationship is restricted to the same time one day a week during the school year only. There is no contact between the child and volunteer outside of school at all.'


An orientation session for those interested in learning more abou the Bigs in School program will be held August 29th at 6:30 pm in the First State Bank Hospitality Room.

## **Local Students Participate** in Honor Choir

Five Spearman students were members of the Texas Choral Directors Association 2002 Elementary Honor Choir. They performed at the Henry B. Gonzales Convention Center in San Antonio on August 2, 2002. More than 650 students, ages 10-13, from all across Texas auditioned last spring for selection to this elite 150-member choir.

The choir met for three days of rehearsal under the direction of Dr. Joan Gregory, founder and director of the Children's Chorus of Washington, DC, before present-ing a concert to the membership of TCDA

The highlight of the concert program was their performance of 'An American Anthem," a choral anthem by American composer Allan Naplan commissioned by TCEDA exclusively for this honor choir. In telling the choir about this work, Dr. Naplan said that was a

direct response to the events of September 11, 2001 and his interweaving of the melodies of "The Star Spangled Banner" and "America The Beautiful" was an attempt to reflect the national pride and unity that is the hallmark of all that is America in response to the terrible tragedy of that day.

At the conclusion of the concert, choir member Laura Husband, 11year-old daughter of astronaut Rick Husband who will pilot the next space shuttle mission, was given a special introduction along with her father, and the choir was informed that the recording of their performance "An American Anthem" will be used as the shuttle crew's wake-up call on the mis-

For nearly a decade, Lucy Pittman has been 'freeing' inmates of the William P. Clements, Jr. Unit of Amarillo. Pittman was recently recognition by the Texas Criminal Justice system when she was named as the 2002 Windham School District Volunteer of the

While her students are prisoners, Pittman has dedicated her work to freeing their minds and souls as an education volunteer in the prison school district known as the Windham School District, as well as her work with Kairos prison ministry.

"It has been life changing for me," Pittman said of her work each Friday as an assistant to prison educator, Lupe Diaz.

"Just seeing the light that comes on in the eyes of someone has been my reward," Pittman said. "It is wonderful to think you may have made a difference in the life of someone.

In an association with the Amarillo prison, which began when Pittman and her husband Frank became a part of a Kairos team in the fall of 1992, the couple has extended their mission to inmates with Lucy working in the educational system and Frank becoming a volunteer chaplain.

These paths have given the couple more freedom in the Clements unit.

"Frank, known as' Pappy Pittman in the red suspenders, is able to go behind lock-and-key as a volunteer chaplain - places we could not go as part of Kairos," Lucy Pittman said.

"Unlike a public school, the prison educational system has given me the freedom to also share God,"

Pittman added. Perhaps Pittman has learned as much as her students in the process, "I have come to believe that crime is

everyone's business," Pittman said. "So many of the inmates are just kids who got into trouble with drugs and alcohol and made poor deci-

sions. There are so many stories there. "One of my favorites was a young man I met through Kairos. At one time he had been on the Texas

Rangers' Most Wanted list. He was trying to change the world through terrorism and had even kidnapped a general," Pittman said. He told us he came to the Kairos weekend to cause

trouble there. His first impression of the group was fakes' and 'goody-two-shoes.' Even so, when it came his time to address the gathering he said, 'I can't deny there is a power here (at Kairos.)'

"Five years later, the condemned terrorist accepted the Lord. He knows he's' forgiven," Pittman said. "To him, a good day is now one spent in 10-12 hours of

study and prayer.'

The change in the prisoner is also apparent to others. "His face shines with the glory of God," Pittman said. The former terrorist, both an artist and silversmith, now gives those he meets handmade medallions depicting a hand holding a heart on which the words, 'I surrender all' is inscribed.

"I have one of the medallions," Pittman said. "They reflect what he once told us, 'All that I have to give in

prison is my heart," Pittman said. "They (the inmates) just want and need to hear that God has not forgotten about them and that He loves

them,"Pittman added. The stories and successes continue.

"Maybe the most touching story was of a man we had tried to minister to in Kairos. At a later time, Frank, in his work as volunteer chaplain, met the man leaning on a wall at the prison and stopped to talk to him." Pittman said.

The talk proved to be a life-saving effort.

"The man later told Frank that he had been ready to give up and had planned to return to his cell and commit suicide before the encounter," Pittman explained. Although the Pittmans have witnessed much good in their work, the fact that they minister in a volatile place where three murders were recently committed is sometimes brought to mind.

'I have never been afraid," Lucy Pittman said. "One day I watched from the window as a SWAT team, armed with rifles, went after a group of prisoners who had captured a female guard."

Incidences such as a capture often result in policy

"The rules in prison change often," Pittman said. 'Since the 'Texas Seven' broke out last year, there has been a crackdown on rules and enforcement. Except for Kairos groups (who meet in large groups), there are no more big group meetings allowed

In addition to rule changes, the Pittmans must also

contend with disappointments. While the return rate (recidivism) is only 10-15% for inmates gaining their GED and attending such meetings as Kairos (as compared to the 70-80% rate for others) there are still heart-breaking failures.

"When you see one come back that you thought had it made – it is the hardest thing," Pittman said. "If drugs or alcohol problems are not licked, it's pretty sure they'll be back."

Despite rule changes and disappointment, Pittman is

undaunted in her efforts.

"I'll continue until a door is shut (rules change) or I am physically unable," Pittman said. "I would like to continue as long as possible."

## **Hansford Appraisal District** Now on the Internet

Chief Appraiser Alice Peddy reports that the Hansford Appraisal District is now on the Internet. The address is www.ptax.org. Click on 'Other Links' then go to Tax Offices. There are three appraisal districts from our area at this site. Click on Hansford CAD and you will find information pertaining to the taxing units, tax rates, and contact information. From there you can select More Tax Info to see the history of tax rates since 1982. Then another choice to view is the Public Hearings/Meetings. You can check this link to see what is happening or going to happen at the appraisal district.

The records you can view are limited at this point in time, but our designer is hoping to improve on offering more detail in the near future," Peddy said. "Hopefully, this will become a very useful tool for the taxpayers in our area. The district receives many inquiries concerning the appraisal records and many of them can be answered through this site. This is not intended to take the place of the personal service offered by the district but rather an extension of that

service through more choices to obtain information. You are no longer limited to the regular office hours of 8 - 5 five days a week. Information is now available 24 hours, 7 days a week."

Another option being offered by the appraisal district is to pay your taxes by credit card. The appraisal district has contracted with Official Payments Corporation for this service. This company will process the payment, collect a fee from the taxpayer, and remit the tax dollars to the appraisal district. A copy of the fee schedule can be obtained from the appraisal district, or you can go directly to www.officialpayments.com and use the fee calculator for your spe-cific account. Cards accepted will be American Express, MasterCard, Visa, and Discover. Credit card payments cannot be made in the office. They have to be processed through the web site on the Internet or by calling a toll free telephone number. All information is posted on the Internet about how to use this new feature or you may call the office and visit with any staff member. If you get a message stating that Texas does not accept payments, ignore it and continue through the process. If you use the jurisdiction code 6127 instead of the zip code you will be taken directly to the screen where you will select the Hansford Appraisal

Peddy emphasizes that this is a new program being offered for the taxpayer convenience. Should you have any problems in using this convenience, she encourages you to please contact the appraisal district and allow them to help.

#### KTOT Public Radio Station To Become a Reality in Panhandle

After a long period of waiting for federal paperwork to clear the last offices in Washington D.C., the project is beginning to move much faster. Skip Mancini, Project Director from High Plains Public Radio, sent a secret to all capital campaign does not be rested the government paper. report to all capital campaign donors that stated the government paper-

work is completed and a thing of the past. "Now we can literally move ahead with the nuts and bolts of the project," she recently stated.

Several planning steps have already been done, including the completion of a pattern study, which helps orient the antenna to eliminate dead spaces in the coverage. The study and testing was done by ERI, and Indiana company that is manufacturing the tower segments and the antenna. A survey has also been completed that located the exact point of construction and guy anchor placements. A soil test was done by June 10th.

Chuck Springer, Chief Engineer for the project, reports that next steps include a tower crew visit to the site to plan preconstruction details. The anchors were shipped by June 17, and once received the anchors will be set and the concrete run. A foundation for the building was also poured. The power company built the line between June 10th and July 8th.

Delivery of the tower has been set to the site the first week of July.

When completed, KTOT-FM will provide in-depth international,




