

## Heart Association Receives Gala/Social **Event Award**

American Association Hansford Division received the Gala/Social Event Association, Texas Affiliate's of the Meeting Membership. The award was presented during the annual Awards Cablevision, Inc.; Kerry L. Dinner July 16 in Fort Worth. Henton, CPA; In Memory of Ruth Debbie Wright, Regional Director, accepted the award on behalf of the division.

The criteria used to determine the Gala/Social Event Award winner included: dollars raised per \$1,000 household income. expense ratio and percent increase over the division's best year. There are three awards given in this category, one award for divisions of less than 100,000 population, one for divisions with greater than 100,000 population, and one for major metro divisions.

The Hansford Division's "Queen of Hearts Gala" held on April 10, 1999 raised over \$18,000 and had an expense ratio of less than 21%. The Gala was a 45% increase over the previous best

The homecoming festivities were great, the homecoming crowd was out in force, it was a beautiful evening, and the Lynx put on a great show! Life doesn't get much better than this if your a Lynx football fan. Sudan came to town Friday evening with upset on their mind, and they almost got it. They just forgot one thing--the Spearman defense.

On fourth and goal from the Lynx one yard line, the Lynx defense rose to the occasion and stopped the Hornets from scoring with 8:05 left in the game. That proved to be the game winner as the Lynx won 10-6. The defense had their backs to the wall, and they showed a lot of character when they stopped Sudan at the one yard line. The defense has a reputation to uphold, and they definitely upheld it last night!

Sudan won the opening coin toss and elected to receive, so the defense was going to be tested early. Spearman kicked off, and the Hornets started from their own 25 yard line. After only one first down, the Lynx defense held, and the Hornets had to punt. The Lynx started their first possession from their own 35. The Lynx drove down to the 20 yard line. Aaron Winegarner hit Jordan (Bucko) Brock over the middle, and Bucko was brought down at the Sudan 10 yard line. Then two plays later, little brother John Brock, scampered around the right end for Spearman's only touchdown of the night. Teddie Whitefield's PAT split the uprights and with 3:45 left in the first quarter, Spearman led

The Lynx kicked off to the

Hornets, and they started on their own 20 yard line. The defense did their job once again as they held Sudan on three plays without a first down, and they had to punt. On Spearman's second possession, they started on their own 26 yard line after a holding call on the punt return. With a 3rd and 7, Dusty Barber had a nice run for a first down as time expired in the first quarter to keep the drive going. But several plays later, Sudan showed they also had a good defense by stopping the Lynx on 3rd down, and Spearman had to

Sudan started their next possession on their own 22 yard line. Several plays later, Sudan had a 3rd and 12, and they threw a screen pass that was set up very well and made a first down. On the next play, they threw another pass that was completed and that took them down to the Spearman 20 yard line. On 3rd and 6 from the 16 yard line, the Lynx got called for pass interference. The penalty moved the ball to the 8 yard line with a first and goal. Then on 4th and 5, Sudan threw to the corner of the end zone for a touchdown. The PAT kick failed and the Lynx led 7-6 with 4:30 left in the 2nd quarter. The Lynx went three and out on their next possession, and that was the end of the first half.

Spearman's first possession of the 2nd half, they went three and out and had to punt back to Sudan. After a punt of 47 yards, the Hornets started on their own 17 yard line. On 3rd and 8, Sudan's quarterback (who by the way was an exceptionally good athlete), threw a long pass down field and

yard line with 8:25 left in the third quarter. Once again the defense came up big! On 2nd and 11 from the Sudan 49, Winegarner (who by the way is an exceptionally good quarterback also), threw an outside screen pass to Bucko. Bucko rumbled down to the Sudan 35 and a first down. Several plays later, the Lynx had a 1st and goal from the 7 yard line, but a tough Sudan defense kept the Lynx out of the end zone. But thanks to the trusty toe of Teddie Whitefield, the Lynx kicked a 25 yard field goal with 3:48 left in the 3rd quarter. Spearman led 10-6.

Both teams went three and out on each of their next possessions. Sudan started their third possession of the second half on their own 47 yard line. Three plays later on 3rd and 5, Sudan picked up a crucial first down, and the Lynx got called for spearing. That took the ball down to the Lynx 28. On the next play, the Lynx got called for pass interference, and that moved the ball down to the 19. Sudan had first and ten with 10:52 left in the 4th quarter. Several plays later, Sudan moved the ball down to the one yard line and had 4th and goal. On fourth down, they tried to run up the middle and the initial hit was put on by Dusty Barber, who was the offensive player of the game and co-defensive player of the game with Jordan Brock. Then the rest of the Lynx defense swarmed the ball carrier and kept him out of the end zone. That was an awesome goal line stand!

Spearman started their next possession from their own one yard line. On 3rd and 15, Barber ran a draw up the middle for a big first down to keep the drive alive. Sudan's defense then held the Lynx on 3rd and 4. The Lynx punted to Sudan, and they took over on their own 37 yard line with 2:57 left in

the game. The Lynx defense had to once again prove what they were made of. On 3rd and 4, Sudan completed a pass out in the flat, and picked up a big first down at the 50 yard line. On 2nd and 10, Sudan went to the well once to often because Barber intercepted the pass at the Lynx 47 and returned it to the Hornet 35 with 1:44 left in the game. That sealed the victory for the Lynx, and they ran out the clock. Final score was Spearman 10 and Sudan 6.

This was a very hard fought game. Sudan has a very good football team, and we wish them well the rest of the season. Spearman also has a great team, and you guys did a terrific job. You played as a team and had your backs against the wall, and you proved that you are winners! Great game and congratulations on a job well done!

## **Biblical Direction** While On The Road

If Saturday night is the loneliest night of the week, being a traveling salesman is probably the loneliest job in the world - and a hotel room the loneliest place to

John Nicholson and Samuel Hill, two traveling salesmen. could vouch for that, and because of them those lonely times and hours in a hotel room far from home have been shortened considerably for millions today.

It was Nicholson and Hill who originated the Gideon Bible.

The idea of putting Bibles in hotel rooms had its birth, appropriately enough, in a hotel room in Wisconsin in 1898 where Nicholson and Hill met by chance.

Nicholson, an aluminumware salesman, had entered the Central Hotel in the town of Boscobel to get a room for the night. But there was a lumbermen's convention in million. progress and all the rooms were occupied.

The accommodating hotel clerk offered to introduce Nicholson to another traveling salesman named Hill who was seated in the lobby. Hill h ad a double room. Maybe he would share it with Nicholson.

This was fine with Hill. That night, before retiring, Nicholson said, "You will excuse me, MR. Hill, but before going to bed I always read out of God's word and have a little talk with him."

Hill replied, "Please read aloud. I, too, am a Christian man."

The paths of the two salesmen crossed again several times in the next year as they covered their sales territories in Wisconsin. Eventually, they decided to form a not hidden away, unread, in a hotel men's group "devoted to carrying out the Lord's work.'

They named their brotherhood the Gideons after the farmer-Testament book of Judges who was called by God to lead a small band of Israelites against their Midianite enemies. Gideon's troops prevailed although outnumbered 450 to 1.

Impressed that "a few selected men could accomplish an impossi-

ble task," these latter-day Gideons decided to take on an impossible task of their own. They would provide weary travelers - footsore, lonely and far from home - with the comfort of God's word in t heir

In the front of each Gideon Bible would be a handy reference guide to passages which would help readers with any problems facing them, whether it be loneliness, discouragement, sickness or trouble of any kind.

Since the first order for 25 Bibles was delivered to a a hotel in Iron Mountain, Montana, in 1908, the Gideons have distributed over 600 million Bibles in 172 countries. And the orders keep coming

Tomorrow there will be 100,000 more Gideon Bibles in circulation than there are today. Every 10 days the number jumps by one

Besides being in nearly every hotel room around the world, Gideon Bibles go to hospitals and prisons as well as to the armed

Do these Bibles get read? It appears they do. The Gideons check back with the hotels twice a year to replace lost, worn or stolen Bibles. (The charitable Gideons prefer to say the missing Bibles were "taken" rather than stolen. "Although we don't encourage taking Bibles, we don't complain when it happens," says one Gideon.)

In any case, the average life of a Gideon Bible is six years. This short life span pleases the Gideons. It means the Bibles are room drawer.

The Gideons also have an eye for decor. Hotels may request Bible covers in red, green or turned-warrior in the Old black Las Vegas hotels usually request gold-covered Bibles.

A member of the Gideons will be speaking at the FIrst Christian Church on Sunday, September 26, 1999 during the 10:50 a.m. worship service. Anyone interested is encouraged to attend.

## Superintendent's Corner

It seems the last couple of weeks the topic of prayer at football games has been splattered in newspapers across the state of Texas. The reason for all this hype and concern centers around the Court of Appeals for the Fifth Circuit which ruled that organized prayers at sporting events violated the Establishment Clause of the First Amendment

Along with the ruling from the Court of Appeals, came legal opinions and threats from certain groups that if prayers continued school districts risked legal consequences. Our own school district attorneys and TASB (Texas Associations of School Boards) also strongly advised that we discontinue school-sponsored prayers at football games.

I personally believe that we should have the right to pray at football games! In fact, I feel that the criterion whether of not prayer is offered should be based on local community standards! However, this is not the courts' interpreta-

Should we comply with laws that we don't agree with? I don't mind rolling up my sleeves for a good fight, but in this case what message are we sending to our students? If it is contrary to their own beliefs, it is okay not to do it. I don't think that is the lesson we are trying to teach our kids. I don' think we have to accept laws we feel are wrong, but we can work through the system to change these

To complicaate matters more, the potential legal risk to the school district for disobeying this court decision could be staggering in terms of fincial loss. Taxes raised would have to divert from benefiting children to defending the district in court. I don't think this is being a good steward of the taxpayer monies and the faith they put in us as educators to provide our children with the best educa-

Sure we need God in school. Although we may not organize

Friday I read a prepared statement school system, beautiful children before the football game with Sudan, voicing our disapproval with the law; however reminding people that they could offer an individual reflection on what is on their hearts and minds and then asked them (if they so desired) to almost over. What about those join us for a moment of silence. You could have heard a pin drop. I'm sure there were many prayers offered that evening. I prayed for the state of our country and for our leaders as they endeavor to make laws. I prayed that we would continue to rely on God as a nation and not turn our backs on him! Making the announcement was one of the hardest things that I think I have had to do. It almost felt like someone placed a dagger in my heart.


