REPORTS FROM UP AND DOWN THE LINE INDICATE GOOD ATTENDANCE AT SOUTH WEST TRAIL DISTRICT MEET

HILL WILL BE PRINCIPAL SPEAKER

The Rev. Thomsen of Amarillo Has Also Been Invited to Talk Thursday Night. Visitors to be Given Informal Luncheon on Their Arrival Thursday Evening

The delegations from points on the Canadian-Clover division of the South West Trail are scheduled to reach here next Thursday afternoon for the convention Thursday night and Friday, according to advices received from the office of the secretary, Judge W. A. Whitesides of Panhandle has appointed the following delegates from Canyon County: J. A. Lee and J. C. Jackson of White Deer; Gus Corbett and P. L. Johnson of Groom; A. A. Callahan, B. D. Gosman, W. M. Bender and J. J. Vance of Panhandle. F. P. Reid of Pampa, president of the Canadian-Clover Division, advises that a large crowd will come from Pampa. Canadian will be well represented at the convention. The revised schedule of the "South West Trail Special" is as follows: Leave Canadian 12 o'clock, leave Miami 2:30 p. m., leave Pampa 2:30 p. m., leave White Deer 3:00 p. m., leave Panhandle 4:00 p. m., leave Amarillo 5:30 p. m., arrive Hereford 7:15 p. m.

The visitors will arrive here just in time for supper and the committee in charge, E. W. Harrison, chairman, C. O. Lee and Judge W. M. Megert, have planned to give the delegates an informal luncheon at the Stockmen's Cafe at 7:30 o'clock. At 8:30 the crowd will adjourn to the district court room, where the mass meeting of the people of this community will be held. President Hill of the Canyon Normal will deliver the principal address, and it is expected that the Rev. R. Thomsen will also make a brief talk.

This meeting is intended to be educational and to inform the people of this county what the Trail really is, where it starts and ends, its possibilities as a tourist route, etc. It is hoped that everybody who possibly can will come out that night and help entertain the visiting road boosters. The Hereford Band will render music before and during the various numbers on the program.

Local Political Raees Enter the Last Lap Stage

The local political pot came to a boil Saturday afternoon, and from now on the fires will undoubtedly be kept hot and snappy. The county democratic executive committee held a meeting, with chairman Travis Dameron, presiding. Fillings for places were opened and officially O. K.'d. Places for names on the ballot were then drawn and the ballot prepared. Afterwards assessments against candidates were figured out and a sub-committee appointed to look after the printing and distribution of the ballots. This committee consists of Mr. Dameron, and Messrs. Head, Woodburn, Patton and Glenn. The committee as a whole will not meet again until the Saturday following the July primaries, when they will canvass the returns and prepare for the run-off.

The fillings brought some surprises Saturday. It showed that W. E. Dameron has entered the lists against County Judge Megert, and that Berry Orr will try conclusions with Lee Biggs for the office of county and district clerk. Of the present commissioners court only one man filed for re-election, W. J. Phillips in Precinct 4. The new candidates are T. J. Paddock and J. E. Hill in places one and two, respectively, unopposed, and J. N. Messenger and Herman Gray for place three. The official ballot to be voted on in July will read like this:

BAILEY'S PART

Fort Worth, June 17.—Before leaving on his present speaking tour, Clarence Ousley, candidate for United States Senator, made the following statement: "I have just read an article contributed by Mr. Hugh Nugent Fitzgerald to the Wichita Falls News Record and several other papers in which this sentence appears: 'It was also stated that Joseph Weidon Bailey was ready to make speeches for Clarence Ousley but

some few of the leader's thought it would be unwise.' Senator Bailey told me several weeks ago that he intended to support me, as I had confidently expected he would. I had not seen or communicated with him since then until his letter endorsing me was published, and then I called him on the telephone to thank him. He did not need to ask me whether I wished his support to be made known by public writing or public address; he knew it. I would not insult him by asking his secret support.

"We have been intimate friends for thirty odd years. We have not always agreed upon policies of method or expediency; we disagreed in some respects before; we are not entirely agreed in all matters of policy. Each of us does his own thinking and each respects the other's intelligence and sincerity.

"I have supporters who formerly favored and who formerly opposed Mr. Bailey. They will vote for me, not for Mr. Bailey, because he is not a candidate and he has no proper part in this contest except the part of a brave and patriotic citizen in expressing his opinion and using his influence for the candidate of his choice. If any man expected me to seek preferment by either open or covert repudiation of a great and worthy friend he now knows his mistake."

GARY ATTACKS THE FARM BLOC

Wall Street loses no opportunity to level its guns at the farmer, nor does it hesitate to fire when the big chiefs give the word. At present, of course, the assault is directed at the farm bloc, and it is an assault as determined and yet as subtle as it will prove fruitless. After reiterating the well worn platitudes that the law of the land should be made to apply with even justice to every man and every industry, Judge Gary, of the Steel Trust, tells us, that during the last few years, there has arisen a disposition "to pass laws which measurably exempt labor organizations and recently farmer associations, from governmental investigation, supervision and control against wrong. Not only are they exempted from certain restrictive provisions of the existing statutes, but they are affirmatively permitted to do certain things prohibited to others," he says. "To permit labor associations or farmer associations to do, as the result of combination, things that are denied to others, is to create class to favor some of them and to injure the whole body politic."

Surely this is spurious logic of the first water, but unfortunately, it is hidden in the cloak of seeming justice. The basis of American liberty is government by the majority, the plain duty of government is to guard and protect its fundamental industries and the labor upon which the life of the nation depends. Presumably it is all right in the eyes of Judge Gary to permit certain special rights to railroads, the

practical right of compensation of property and other privileges denied to individuals, for example, because the railroads are public institutions, but the farmer who is the fundamental public institution of the world, must sit back satisfied to be ignored. It would seem that Judge Gary answers himself when further in his recent address he says: "It is a trite saying that often the man who cries stop thief, in the loudest tones has the stolen goods in his pocket."

WOMAN'S VOTING LOGIC A PUZZLE

Party leaders, who for policy or other reasons, were loud in their cheers for woman suffrage are now rapidly coming to believe they have repeated history and staged a modern siege of Troy. They have taken the wooden horse within the walls of the city and now they can't get it out. What is more, the wooden horse shows signs of life and has started to kick, all the little soldiers are coming out and all kinds of ructions are expected. From every state comes word of the growing political independence of the women folk. They are all "staunchly attached" to their respective parties, of course, but they insist on voting for "the best man," even if he does belong to the other side, and no argument has yet been advanced to alter this rather general view of civil and political duty. It is up to the party leaders to obtain the best man, and there you are. What could be simpler, what more logical? Certainly the intuitive vote seems likely to cause surprises at the fall elections. It will be many years before military can be brought to vote at the crack of the whip or see the supposed wisdom of electing the poorer candidate on the better platform rather than the better man on the poorer platform, on the theory that principles rise above individuals. If the politicians are to get anything like a grip on the women folk they will have to sell them very thoroughly on platforms as against personalities, and this is quite an undertaking. It is difficult to submit the goods for examination. Platforms seem to vanish into thin air soon after the count, so what can the poor leaders do?
