

Since the big ads are coming out in Plainview papers, advertising their goods at very low prices, the merchants have reaped a great harvest. They have whittled their big profits down and are now-making prices to the buying public that cannot be equaled in Canyon City or any other railroad town. We were talking with a very prominent cow-man the other day and he said: "The merchants here have now come to their senses and I am truly glad of it. They are now selling goods at lower prices than I can buy them at any point on the railroad. I buy a great many supplies and have been sending my wagons to railroad points to get them, but the other day I picked up a copy of the Press and saw where one man was selling coffee, sugar, etc., a great deal cheaper than I can buy them on the railroad, I pick up a copy of the Herald and find where another merchant is selling dry goods and groceries as cheap as I can buy at Canyon or Hereford." He said: "I know this to be a fact, for I have bought supplies at all these places and find that I get the best bargains in Plainview, and I am really glad that they have decided to advertise, for I can now keep posted on their prices." THAT BAPTIST COLLEGE.

Messrs. J. A. Williams, A. J. Lipscomb and W. B. Beach went to Clarendon Monday as a committee representing the Baptists of Hereford in regard to the bidding for the proposed Baptist College for the Panhandle, and C. L. Stocks representing the citizens, the occasion being a preliminary meeting of the various committees to ascertain what towns were really competing and what they were willing to do to have the college located in their town. Among the towns represented were Clarendon, Canadian, Canyon City, Memphis, Lakeview and Hereford, Clarendon agreeing to give \$11,750 and 26 acres of land; Canadian, a building said to be worth \$20,000; Canyon City, building site and \$15,000 cash; Hereford, \$10,000 cash and \$10,000 worth of land; Lakeview, \$14,200 cash and one section of land for building site; Memphis, no definite proposition, but said they might and could do so and so. A perusal of the above would show that Hereford had made as good a proposition, but other towns, notably Lakeview, have stated that they will give far more at the final meeting, to be held at Clarendon, July 23.

From personal interviews with the above committee we find that all things being equal in the way of donations, Hereford seemed, in the opinion of the various delegates, to be the best place in which to locate the college, she having better natural advatages, such as a fine quality of shallow water, an excellent drainage and a country surrounding that is excelled by none as an agricultural region, so that it seems to us that all we have to do to secure the proposed college is to get a large hustle on us and raise a good substantial donation or rather make a large investment in a proposition that will bring larger dividends than a national bank, and more lasting than a gold mine.

The concensus of opinion seems to be that the location of the college lays between Memphis and Hereford, the former place working against Hereford on account of being too close to the New Mexico line, though granting that it is centrally located north and south,

while Hereford contends that Memphis is as near, if not nearer, the Oklahoma line than Hereford is the New Mexico line, besides being off the plains. It has been the supposition that the college was to be located on the plains, and if this supposition is put into effect Hereford will surely get the college, providing her investment in the enterprise is somewhere near equal to that of other towns.

It should be remembered that the educational capacities of the college will depend upon the amount of capital invested by the town securing its location, as the State Board has established the precedent of investing in the enterprise according to the investment of the local people, and it may be said to the State Board's credit that they have paid out, under their system of correlated schools, nearly half a million of dollars during the past year, so that now there is not one of their schools in debt, and each one of them is enjoying a substantial endowment.

Now if the progressive people of Hereford want established in their midst another college, which will be well financed and under the direction of competent educators, it is within their grasp—all they have to do is to get in the middle of the road and work together. Will you do it, or will you sit still and let some other town with less wealth and having far less natural advantages than Hereford secure the plum? We believe Hereford will work.

WHILE we are working for the establishment of the Baptist College, let us not forget that we already have established at this place a college which is destined to be second to no other institution in the state or country, as far as educational facilities are concerned, and do all in our power to help place it in position to receive a full complement of teachers and pupils this fall.

MEMPHIS must have something up her sleeve. That town is recognized as Hereford's only competitor for the Baptist College, yet at the meeting at Clarendon no definite proposition was made by the delegation from the Hall county town, about fifty miles off the plains.



IT'S AMUSING.

Reasons (?) Why Baptist College Should be Located at Amarillo.

In last week's issue of the Amarillo Advocate appeared an article setting forth reasons (?) why the proposed Baptist College should be located at that place, and says that other competing towns should not be considered as they are moral, which, according to the Advocate's view. means that they are stagnant and dead towns. Here is what it says in this regard:

"Memphis, Clarendon, Canyon and Hereford all put forth the claim that they are quiet, moral—and this means stagnant. Yes, it does. They are little and lonesome, and are begging the Baptist brethren to send their kids there to keep them from dying of ennui amid primeval solitude and original quietude.

Why, Hereford is so antiquated it has gone back to the pre-historic days of the western village -threw away its progressiveness by a vote of 2 to 1—that lets them out, if the Baptist locaters have any regard for modern conveniences, improved systems of city government and evoluted methods of society."

Perhaps moral towns are stagnant and it may be true that the citizens of such towns are dying from enui, but we have heard of no deaths from that disease as yet, and, anyway, we had rather die from stagnant enui than from stagnant mud and filth, which abounds in Amarillo, as will be seen from a visit to that town or a perusal of the following article, which appeared in the same issue of the Advocate as did the above clipping:

"People who have never lived on the plains believe that it never rains, and that mud and water are unknown, but such is not the case. Here in Amarillo, for the past ten days, the streets and alleys have been almost knee deep with mud and water. The drainage is very poor and this stagnant mud is likely to produce sickness."
