Candidates for public of-fice will soon be making their announcements, since this is the season for political activities. In keeping with its policy of past years the Hereford Brand will require payment in advance for all political advertising and announcements sponsored by office-seekers.

This policy has been found the most satisfactory for all concerned, and since it ap-plies to all candidates alike, is fair to everyone.

For those interested in poli-tics, Congressman Wright Pat-man has compiled the list of events which must take place in Texas in the process of nominating and electing pub-lic officials.

Beginning with the final day for payment of poll taxes and going right through the Demogoing right through the Demo-cratic party's final report on September 4 of campaign ex-penditures, the list is present-ed herewith. Clip it out and save it. The information will be invaluable to voters. January 31-Last day to

February 12-Election, judges ap-April 1-On or before this date tax collectors furnish county elecpayers and exemptions.

June 4-On or before this date, candidates for party nominations for state and district offices shall file applications for place on primary ballot.

June 16-On or before this date candidates for party nominations for offices to be filled by voters of a single county or portion thereof and candidates for county chairman shall file legal applications with the county chairman for places on ballot.

June 18 County executive committees meet at county seat to determine by lot the order of names on primary ballots, estimate the cost of printing ballots and other expenses incident to holding election, and apportion cost among candidates (except candidates for state office); name a sub-committee of five members to make up ballot; decide whether the nomination of county officers shall be by majority or plurality votes. What Panhandle Papers Say

It is worth noticing that the proposed child labor amendment to the federal constitution now has been ratified by more than half of the required number of states, to insure its adoption. When the Maine legislature approved the amendment and sent it to Governor L. J. Brann for his signature, 19 states had put their approval on it. Here is an issue which the press of more immediate considerations should not cause us to forget. The NRA codes, to be sure, pretty largely have abolished child labor; but the job is only temporary, and it is incidental to the accomplishment of other ends. By putting the amendment in the constitution, the exploitation of child labor, with all the costly abuses that accompany it, will be outlawed for good. South Plains Farmer.

Advertising prepares his market for his coming, and thus saves his time. Advertising multiplies sales opportunities, makes orders easier to get and shortens the time necessary for getting them. If there is any one man in the country who should be an advocate of advertising that man is the salesman .-Muleshoe Journal.

> The newspaper code will become law of the land some time this week and will contain a clause guaranteeing freedom of the press This part of the code precipitated a terrible argument in this country and everyone is mighty, mighty happy that it has been settled and that the code is not jeopardizing the freedom granted under the constitution. The open shop clause has been dropped and the code worked so as not to jeopardize and break small newspapers. It apparently will provide for country shops, such as The Texan, A 48-hour week or slightly less for all departments of the newspaper, including the mechanical. Basically, the 40-hour week is provided but exceptions are made for small communities and small cities. The 48-hour week will be fair for us here and we can meet its requirements without jeopardizing our institution. One striking provision in the code is that newspapers must charge the legal rate in all states providing a legal advertising rate.-Dalhart Texan.

BY A FARMER




