U.S. warships shell Druse artillery positions

BEIRUT, Lebanon (AP) -U.S. warships blasted militia artillery positions in Lebanon's Druse-controlled central mountains today and Marine spokesman said:

It was the first time American warships have fired on Lebanese targets in the year since the government asked for U.S. patrol the war-ravaged Beirut area.

Warrant Officer Charles Rowe said the Marines at Beirut international airport teamed up with the USS

militia positions to the southeast of the airport that earlier fired on the Marine compound.

The retaliation came shortly after a shell barrage struck

Beirut's airport, despite a promise by Druse militiamen to stop shooting at the multinational peacekeeping

At least three shells slammed into the runway of the closed airport about 200 yards from two American generals visiting the 1,200-man Marine contingent serving with the international peace force. The shelling occurred shortly befoe noon.

But there was no suggestion in a speech given by Gromyko here Wednesday that Moscow is prepared to change its story that the Boeing 747 was on a "special duty for the American authorities" - presumably meaning a spy mission — and that the Soviets had every

The jetliner disappeared over the Sea of Japan Sept. 1. All 269 people aboard are presumed dead.

While Shultz accused Moscow of covering up the facts, Gromyko said Wednes-day that Washington is hiding what he called the true purpose of the flight into Soviet territory and bears responsibility for the consequences.

Gromyko said the jetliner flew over some of "our most important strategic facilities" and refused to obey signals to land.

"Our fighters fulfilled the orders of their base to cut short the flight," Gromyko said in a speech to the 35-nation Conference on Security and Cooperation in Europe.

Shultz, who sat impassively in the front row of the conference hall during the speech, said afterwards he was "very disappointed" in the speech.

"Falsehoods have been continuous," he said, "and juggling of the facts is too mild a word for the way in which the Soviet Union has responded to this Korean plane shootdown."

Shultz earlier told reporters he wants to know from Gromyko, "what is their explanation, why don't they tell the truth?"

Thomas Teeter, a 21-year-old employee of University Arcade, says that his employers had him reprogram three arcade games after the Soviet Union destroyed the

Korean Air Lines 747 last week, killing 269 people.

One game, "Robotron," urges players to save the human race from the "Communist mutant from outer space, Andropov," a reference to Soviet President Yuri

In another game, "Stargate," players score points by hitting "aggressive Soviet ships. A third game Teeter programmed gives a terse

message at the start of the game: "Russia: We want answers and an apology."

Teeter said the last statement echoes his sentiments. "There is no excuse. It should have been obvious it was a

The methamphetamine possession charge is a felony punishable by two to 20 years in prison and a fine of up to

The penalty for possession of Mandrex can range from a misdemeanor with a maximum year in jail to a felony with five years to life in prison and a fine of up to \$50,000.

Ginther was freed on \$5,000 bond, Houston said.

AUSTIN (AP) - Newspaper "want ads" have moved from third to No. 1 in the past eight years as the leading source for possible jobs, according to the Advisory Council for Technical-Vocational Education in Texas.

The council said not showing up for work is the main reason people get fired.

These conclusions were drawn from a recent council survey of 5,000 Texas employers about the "qualities they like and dislike in job applicants." There were 1,143 responses.

Asked where improvement is needed in preparing people for work, employers said improvement is most needed in the "ability to write and speak effectively." This was not among the top five in the council's 1975 survey.

Now You're Cookin'

The time is ripe for an abundance of fresh fruit and vegetables—and for preserving food for the winter.

"Judas was one of us, chosen to be an apostle just as we were. He bought a field with the money he received for his treachery and falling headlong there, he burst open, spilling out his bowels. I almost always agree with your advice and was surprised when you supported such surgery because "life might be easier for Down's children if they looked more like other

Actually, the surgery would not help them because a Down's child is not aware that he is different from others. I know you would want me to express this dif-ference of opinion because you strive to do a top-notch job and would not resent being corrected.-Sincerely, Jay Arena, M.D., Chief of Pediatrics (emeritus), Duke University, Durham, N.C.

DEAR DR. ARENA: Thanks for setting me straight. I now realize that the surgery might make the parents feel better because their children would look more normal, but it wouldn't help the kids. They should be our primary concern. I wasn't wrapped real tight when I went along with that one. Mea culpa.

DEAR ANN LANDERS: Please check with your experts and help me. I am only 26 years old and have varicose veins. I know they are hereditary, but I want to get rid of them if possible. I have several spider veins in my legs and I can see some large blue ones starting.

Is surgery the answer? What kind of doctor should I see? Does jogging hurt or help? What about hanging upside down, wearing gravity boots invented by a doctor in California?

I need some no-baloney in- look up or where.

DEAR B.L.: Yes, you can get rid of those veins. See a dermatologist or a vascular surgeon. One technique is to inject medication that will collapse the veins so they will no longer be visible.



Former mayor pro-tem convicted, given life

EASTLAND, Texas (AP) - Cisco's former mayor protem has been convicted of the murder of his wife last spring and sentenced to life in prison.

The state district court jury that began hearing the case Aug. 22 deliberated only 45 minutes Tuesday before returning a guilty verdict against Loyal Lundstrom, 60, in the shooting death of his 27-year-old wife, Doris. The jury then needed only

50 minutes to assess Lundstrom the maximum sentence it could give. Jurors said their first vote each time was unanimous.

The body of Lundstrom's wife was found March 5 in the motel the couple operated in Cisco, 45 miles east of Abilene on Interstate 20. Lundstrom disappeared after his 27-yearold wife's death, but surrendered to authorities March 16 at the Dallas-Fort Worth Regional Airport.

Oft-overused diagnosis

DEAR DR. LAMB - Can you send me some information on hypoglycemia? For the past year I have been having muscle spasms around my middle rib section and have lost around 40

At first the doctor thought I had an ulcer but after running tests and X-rays he couldn't find anything other than some degeneration in the spine. He sent me to a bone specialist who sent me to a neurologist who sent me back to my original doctor for a glucose tolerance test.

They found I have hypoglycemia and said that could be causing my nerve irrita-

I have never had any reactions from eating or not eating. In fact I feel better when I don't eat too much. The doctor has put me on a diabetic diet to see if I can get my sugar level up.

I would like to know what triggers the body to produce sulin and what causes it to overproduce? Will an excessive amount of sweets cause it to produce too much too quickly

DEAR READER - Your version of your complaints does not sound like hypogly-cemia. It is often an overused diagnosis. The American Medical Association became so concerned about this that it even made an official statement on the problem. The gist of it is that you have to have both the symptoms of hypoglycemia and the low blood glucose value at the same time

to establish the diagnosis. Stated another way, a low value seen on a glucose tol-erance test without the characteristic symptoms of hypoglycemia is not an adequate basis for a diagnosis of hypoglycemia.

There are two main types of hypoglycemia: those reac-tions which occur fasting and those episodes that occur after eating. The latter are called rebound hypoglycemia or reactive hypoglycemia. In these latter cases, eating sweets or starches may trigger an

She eats only sweets, pancakes, cookies, cake, candy, etc. She doesn't take vitamins. Could you please explain to her what she's doing to her body. She's in good health but cannot sit still without shaking her leg.

She may shake her leg. though, from a simple nervous habit. You might suggest she capitalize on her sweet tooth and at least eat sweets that contain lots of milk. That can be puddings, cream pies, ice cream and milkshakes. The milk will help some but won't solve all the problem. And try to encourage her to take an allpurpose vitamin tablet each

I would prefer that she eat a well-balanced diet, but even these measures would be an improvement.

DEAR READER - I'd like to see a food diary to see what her daily consumption really is before being too specific. However, if your description is accurate she is headed for disastersville. She could develop any num-ber of nutritional deficiencies from scurvy to rickets along with loss of muscle tissue and vital organ tissues from protein deficiencies.

Poultice also cleans

DEAR POLLY - I have a soapstone top for my wood stove and it has some spots on it from my iron kettles. I also

have some grease spots on it from my fron kettles. I also have some grease spots on it from keeping some food warm. Can you tell me how to get these spots off? — ESTHER DEAR ESTHER — Stains on soapstone (and marble and alabaster) can often be removed with a poultice. This is a paste that is spread on the stain, allowed to dry, then washed

For your stains, I suggest a poultice of cornstarch mixed with a little dry laundry detergent and enough water to make a fairly stiff, somewhat dry paste. (Soapstone should not be allowed to get too wet, since it's a soft and porous material.) Spread this paste over the stains, let dry thoroughly for several hours, then gently wash off the paste with a deep cloth. Don't seak the surface with water and den't use damp cloth. Don't soak the surface with water and don't use any harsh abrasives. If the stain is lessened but not completely removed, repeat with a fresh poultice. - POLLY

DEAR POLLY - I used a clean piece of cloth soaked in vanilla to take the bad odor out of a refrigerator that had been in storage for more than a year. Since that time, I've used this same method on refrigerators in rented apartments. Works every time. - MARY

DEAR POLLY — My hint is about freshly cut flowers. Bring in a rose when it is "half blown." Cut the stem at a slant so that a good bit of it is ready to soak up the water. Add two or three drops (no more) of chlorine bleach to the water in the vase, plus a heaping teaspoon of sugar. The bleach seems to keep the flower from opening too quickly while the sugar acts as food. The same idea works well for many other flowers, but is especially nice for roses.

DEAR POLLY - For extra tasty cookies, try using onethird to one-half whole wheat flour instead of all white.

Former sheriff said he 'tried to help' prisoners

HOUSTON (AP) — A former deputy sheriff said he once hit a prisoner with a blackjack in self defense, but denied he ever tortured anyone brought in for quesioning about a crime.

"The only way I violated their rights was to try to help them," said former San Jacinto County sheriff's deputy Carl Lee. "I was trying to keep them straight." Lee, former sheriff James

C. "Humpy" Parker and former deputies Floyd Baker and John Glover are accused in federal court of violating the civil rights of prisoners who said they were shackled, beaten and water-tortured.

Lee testified Wednesday he hit James Hicks, 33, with a blackjack on the side of the face after he heard Hicks "severely cursing" Baker and after Hicks spit in Lee's face and kicked him in the

In a statement to jurors as

lawyer Ed Mallett said such treatment was reserved for serious criminals and used only to recover stolen proper-

Field said he might not have allowed Harkless to enter guilty pleas to the two offenses if he had thought "some sort of coercion was

Harkless testified Sept. 1

that lawmen handcuffed him to a chair, covered his face with a towel and doused his head with water until he "thought he was going to suf-focate to death." Four other men told of similar incidents during the prosecution phase

of the trial. Harkless testified there were three such treatments during two days while he was prisoner in the Walker County jail in September 1976. He said Parker, Glover, Walker County Sheriff Darrell White and two other deputies were present.

White testified Wednesday he authorized San Jacinto County lawmen to visit Harkless, but said he did not

accompany them.

Harkless eventually pleaded guilty to charges in San Jacinto County, receiving two years' probation on one count and a year in jail for a misdemeanor charge reduced from a felony, Field said.

Field said that at the time. Harkless faced "30 to 40 home burglary charges" in East

Because of that, Field said was his impression that Harkless "wouldn't get this kind of deal except the sheriff had taken a liking to him." Field said he had seen Harkless in the jail before, where he was performing a variety of tasks, and assumed he was a civilian employee because of his freedom.

Mallett, representing Baker, conceded water treatment was used in San Jacinto County, but told jurors his client did "only what he had to do under the law."

Tom Taylor, who is representing Parker, told the jury in his opening statement that he planned to attack the credibility of prosecution witnesses using three arguments, including allegations of perjury.

Taylor said all witnesses who testified they were tortured by Parker or his

deputies had criminal records.

"Some of the things you heard are just not true," Taylor said.

Federal authorities say at least 15 people may have undergone water torture in San Jacinto County between

Parker pleaded guilty to similar charges in March but the plea was withdrawn after a federal judge ruled the sentence agreed upon in a pleabargaining arrangement was too lenient.

Man convicted in 'bathtub murder'

HOUSTON (AP) - A Houston man convicted of strangling a woman found left in her bathtub faces either life in prison or death by lethal injection.

Edward A. Ellis, 29, was convicted Wednesday in the death of Bertie Eakens, 74. A jury in state District Judge Charles Hearn's court is scheduled to consider Ellis' punishment today.

Mrs. Eakens' body was found March 1 in her Houston

Prosecutor Eric Hagstette told the jury in final

arguments the case "was like a jigsaw puzzle. You don't need every piece in place before you know what kind of a picture it is."

Hearn imposed a gag order on the case, but at the time of Ellis' arrest, police said Ellis was wanted on an aggravated assault charge in San Antonio, where he allegedly shot and wounded two men in an argument over a card game.


