School board candidates exhibited distinct differences of opinion Thursday night during the Chamber of Commerce sponsored political forum by siding up on the issue of mastery learning and its implementation in Hereford.

About 100 persons attended the forum at the Community Center to hear candidates from eachy race responsed to questions from the Chamber legislative affairs committee. Chip Formby of KPAN, Kim Thogmartin of The Hereford Brand, and N.D. Kelso, a Hereford High teacher made up the panel. Margaret Marshall, candidate for

District 1 on the school board, said there is some great misunderstandings about what mastery learning is and how it is different from the state mandate, and added that the mastery learning system itself is not the problem but its implementation. She noted that she didn't believe most teachers had problems with the mastery learning system. Marshall said the goal of the system was to graduate literate students.

Steve Coneway, one of Marshall's

opponents, said that he has read many articles on the mastery learning and believes that the concept has been mis-communicated into Hereford.

"I think what we need in Hereford is to get back to sequential teaching," Coneway said.

He also said that mastery learning as implemented in Hereford "almost eliminates individuality" by having students memorize answers to test questions instead of learning to think for themselves.

Mary Parker, seeking the District 3 school board post, told the audience that the mastery learning system in Hereford is not a pure system, but is a dilluted form of mastery learning. Parker said that her research indicates that the system is under state mandate.

Bud Patterson, a candidate in District 3, and Sammy Gonzales, seeking a seat in District 1, were out of town on business.

A recent survey among professional school employees was also a target for taking sides. The survey, conducted by a joint committee of representatives of a parent group and board members John Fuston and

GE barred from new Pentagon work

WASHINGTON (AP) - The General Electric Co., hit with a criminal fraud indictment and asked to refund the government \$168 million in "unreasonable profits," has been barred indefinitely from obtaining any new Pentagon contracts. The suspension order against the nation's fourth largest defense contractor was announced Thursday by Air Force Secretary Verne Orr and applies to "future contracting with any agency in the Department of Defense."

Orr also disclosed he has asked GE to voluntarily refund roughly \$168 million in "unreasonable profits" that Pentagon auditors assert were earned on spare parts contracts between 1978 and 1983. Orr said, a similar request involving about \$38 million had been made of the Pratt & Whitney Division of the United Technologies Corp.

Both GE and United Technologies disputed the auditors' conclusion that they had earned excessive pro-Les. GE, in a prepared statement, also called its suspension from receiving new contracts "highly unusual.'

Citing improvements made since the 1980 incidents that gave rise to the indictment, the company added it was confident it could convince Orr to lift the suspension order "promptly, and on that basis, there should be no significant impact on the company's financial results.

GE was charged on Tuesday by a federal grand jury in Philadelphia with defrauding the government of about \$800,000 while performing work on a nuclear warhead missile system. The indictment alleges employee time cards were altered and costs shifted improperly between contracts, and that an

employee and former employee lied to the grand jury.

The company has denied any criminal wrongdoing while acknowledging that "charging errors" might have occurred. It has offered to reimburse the government for any improper charges.

According to Jim Turner, a Pentagon spokesman, GE is the largest defense contractor ever to face a suspension on all new contracts. Pentagon officials said earlier this week that GE is also believed to be the largest defense contractor ever charged in a criminal indictment.

GE received more than \$4.5 billion in military contracts in fiscal 1983, and preliminary figures indicate it did at east as much business in fiscal 1984.

Forecasters predictina economic upswing

WASHINGTON (AP) - The economic growth this year. The ingovernment's main economic dex has increased only 0.3 percent on forecasting gauge gained a healthy 0.7 percent in February, leading the Reagan administration and some private forecasters to predict an upturn in economic activity in the months ahead.

The Commerce Department said the February gain in the Index of Leading Indicators followed an even stronger January increase of 1.5 percent, the biggest rise in almost two years.

Commerce Secretary Malcolm Baldrige said the new report offered encouragement that current slower growth "will be followed by better performances in the period ahead."

Baldrige said he was "particularly encouraged" by a 48 percent rebound in orders for new plant and equipment during February. He said this was a "sign that capital spending this year will again be a driving force in the economic expansion."

Baldrige said increases in the leading index of 0.5 percent a month would be consistent with the administration's forecast of 4 percent product recorded in 1984.

average in each of the last six months.

Michael Evans, head of Evans Economics, a private forecasting firm, said the two healthy gains in the index could be indicating that the slowdown in activity that started last July may have ended in February.

"When the March numbers (measuring business activity) start coming out, I think we are going to see some major strength across the board," he said. "We won't get a runaway boom, but we are going to see renewed strength.'

The index fell 0.5 percent in December, its fourth decline since last June, when it dropped 0.9 percent, breaking a string of 21 consecutive advances as the economy recovered from the steep 1981-82 recession.

Analysts believe the economy should enjoy generally moderate growth this year, but nothing like the 6.8 percent gain in the gross national

AUSTIN (AP) - Public Utility Commissioner Peggy Rosson is do-ing a good job, Gov. Mark White says, denying that he offered any apology for criticism he allegedly directed at her.

"I would be surprised that anybody would believe that I would criticize the finest public utilities commission in the whole United States and certainly not the first usewife to serve on one," White said Thursday.

"That's just ludicrous," he said, responding to allegations from

former Texas A&M regents chairman H.R. "Bum" Bright.

Bright has indicated that White criticized Mrs. Rosson during a private meeting in which Bright had complained about White's appointment of "that bomb-throwing woman" to the utility regulating board.

Bright quoted White as replying, "Bum, don't worry about her. I've got her outvoted 2-to-1."

A newspaper Thursday reported that White "sent her a telegram

"We've got to move ahead," Michel said, adding that tough measures would prompt the U.S. Embassy in Tokyo to "start communicating that the natives are restless."

The Senate acted as the Tokyo government announced a 25 percent stepup in auto exports to the U.S. market starting Monday. Industry and labor officials said it could cost 100,000 American jobs and widen

Japan's trade surplus over the United States - \$37 billion in 1984 by perhaps \$4 billion.

Japan's announcement followed the Reagan Administration's decision not to seek an extension of the voluntary restraints on Japanese auto imports here. The five-year program expires March 31.

The Commerce Department reported Thursday a \$11.4 billion overall U.S. trade deficit last month, with Japan accounting for \$4.2 billion of the imbalance.

The Senate resolution, sponsored by Sens. John Danforth, R-Mo., and David Boren, D-Okla., followed mounting pressure for a signal that the government is worried over the ballooning trade gap. The next step comes Monday when the Japanese could open the way for the sale of perhaps \$2 billion in U.S.

Still 'premature' to cancel trip

AUSTIN (AP) - It is "premature" for the Texas National Guard to cancel training excercises in Honduras until more is learned about reports of political unrest in the Central American country, a guard spokesman said.

The Texas Guard is scheduled to send about 450 troops to that Central American nation in April for two weeks of war games with U.S. Army and Honduran army troops.

In the Honduran capital of Tegucigalpa, President Roberto Suazo Cordova held emergency meetings Thursday with his Cabinet and the head of the armed forces, and asked Hondurans to remain calm through a conflict between the legislature and Supreme Court.

A legislative commission has been investigating reports of corruption in the judicial system, and on Wednesday submitted a report to the Congress saying it had found 14 cases of corruption on the part of five of the nine Supreme Court judges.

Maj. David Cottom, public affairs officer for the Texas National Guard, said another public affairs officer with the Guard was checking on reports from Honduras.

Ground west of Houston sinking

HOUSTON (AP) - Underground water pumping in fast-growing areas of Houston has caused the ground there to sink as much as one foot since 1978, studies show.

And if underground water continues to be pumped at the present rate, the ground south and west of downtown Houston could sink by another 10 feet in the next 35 years, J. C. Holzschuh, chief hydrologist for the Harris-Galveston Coastal Subsidence District, said Wednesday.

Studies by the district and the U.S. Geological Survey showed that subsidence has increased to a rate higher than in the past in western and southern Harris County.

"An additional 10 feet of subsidence could cause some inland flooding in these areas," he told the Houston Chronicle.

Subsidence rates have slowed in areas where it once was rapid, said the hydrologist.

The bowl-shaped subsidence area in Harris County once centered on the Houston Ship Channel. Land sinking there contributed to flooding of parts of the San Jacinto Battleground, of neighborhoods in Baytown and of roads near the Johnson Space Center.

Dealers charged in investigation

BEAUMONT, Texas (AP) - Two pesticide dealers and a rice growers' cooperative have been charged with selling farmers restricted pesticides, including one considered as harmful as DDT, officials say.

The charges, filed Thursday, are the first stemming from a federal investigation that began a year ago into illegal pesticide use throughout the rice growing region of Southeast Texas, Assistant U.S. Attorney Paul E. Naman said.

The American Rice Growers Cooperative Association-Anahuac Division allegedly sold Furadan 4F to farmers in April 1984 in violation of federal pesticide regulations, Naman told the Beaumont Enterprise.

The misdemeanor charge claims the co-op sold the compound, originally developed as a nerve gas, so rice farmers could kill birds feeding on their rice seed.

Dallas-based Hunt International company filed for protection under Resources Corp.

Trusts of Dallas billionaires Nelson Bunker Hunt and W. Herbert Hunt own Hunt International, which earlier disclosed it is in default on \$295 million in debts and is unlikely to repay the loans in full.

Great Western attorney Charles Gibb arged Thursday that the refineries had to be sold swiftly to save asset values and prevent damage to the economies of rural sugar-farming areas.

And under the agreement worked out, Great Western can now sell six refineries in Nebraska, Wyoming and Montana. It also owns operations icolorado and Kansas.

Four creditors at the hearing Thursday objected to the sale, including Golden West Commodities, which asked for another week to gather \$35 million to buy all of Great Western's 12 refineries.

But Great Western, once the nation's fourth-largest beet sugar processor, and New York-based Tate & Lyle won out.

Tate & Lyle, a subsidiary of London-based Tate & Lyle PLC, agreed to pay \$21.5 million for the refineries, \$31.5 million for sugar inventories, \$6.5 milion for sugar byproducts at the refineries and

\$750,000 for packaging equipment. Great Western has \$282.67 million in liabilities on assets of \$301.98 million, according to bankruptcy documents. The six refineries account for about 25 percent of Great Western's assets, Gibb said.

Hunt International has been trying to liquidate its ailing Great Western unit, which employs about 700 people, since December. The company was forced to shut down abruptly March 1 when its banks withdrew operating funds.

Great Western was not able to meet its final payroll, and banks bounced earlier payroll checks. The firm's three main banks are Bankers Trust of New York, First National Bank of Chicago and Manufacturers Hanover Trust of New York.

Nebraska, Wyoming and Montana sugar beet growers had aligned themselves with Tate and Lyle, which offered to buy another portion of the Great Western sugar operations last week.

Former mobster ran brothel from prison cell

CONROE, Texas (AP) - Grand jurors indicted a former New Jersey mobster on charges of organizing and running a Montgomery County house of prostitution from his cell in a Texas prison, authorities said.

Raymond Carl Freda, already sentenced to life in prison for an attempted arson conviction, was served with two indictments Thursday accusing him of engaging in organized criminal activities, sheriff Joe Corley said. Bond was set at \$150,000. Six other people, including Freda's wife, his brother-in-law and a former prison guard, also were named Wednesday in 11 sealed indictments, Corley said.

Freda, also known as Raymond G. Conti, was moved to Houston in the early 1970s under the federal Witness Protection Program after testifying about his ties to the late crime boss Carlo Gambino.


His exploits as an "enforcer" in the Gambino crime family were detailed in the book, "Marked to Die." In the book, he said killing was "the easiest thing in the world to get away with" and likened it to "going to work in the morning or slapping your wife in the mouth when she needs it."

At noon Thursday, the Montgomery County Crime Control Unit along with officers from the Harris County vice squad, the Trinity County sheriff's department and the **Texas Department of Public Safety** raided the facilty and two area homes.

Among the suspects arrested was Francisco Olivas, a 23-year-old former prison guard from Trinity alleged to be responsible for the dayto-day operation of Foxy Lady. Olivas was fired in December after prison officials found drugs in his dormitory room.

Freda's wife, Delores Conti, 41; and her brother, Tony Rubino, 35, both of Spring, also were arrested. Each was charged Wednesday with two counts of engaging in organized criminal activities and jailed on \$150,000 bond, Corley said.

Both are serving 10-year probated sentences for organized crime activities in Brazos County, Corley said.

Group may bid for control

NEW YORK (AP) - T. Boone Pickens Jr. disclosed Thursday that he is no longer just an investor in Unocal Corp., saying the partnership he heads may attempt to gain control of the international oil company.

Pickens, the chairman of Mesa Petroleum Co. of Amarillo, Texas, also said his group might try to restructure Unocal or force the sale of its assets. He also left open the possibility that the partnership, which owns about 14 percent of Unocal's stock, might take no further action

Following the broad announcement, Unocal stock rose \$1.871/2 a share and closed Thursday at \$49.50. It was the most active issue on the New York Stock Exchange for the second straight day, with more than 3.4 million shares changing hands.

Barry Lane, a spokesman at Unocal's headquarters in Los Angeles, declined comment.

Earlier this week, however, Unocal Chairman Fred Hartley questioned Pickens' goals and attacked corporate raiders in general.

Body being flown home

FRANKFURT, West Germany (AP) - A U.S. Air Force jet bearing the body of an American army major shot by a Soviet sentry in East Germany left for the United States today after a brief runway ceremony

The body of Army Maj. Arthur D. Nicholson Jr., 37, was brought in a flag-draped coffin from the Army morgue in Frankfurt to the Rhein Main Air Base and was met by a 30-man, U.S. Army-Europe color guard.

As a U.S. military band played "America the Beautiful," the coffin was carried slowly to the Air Force C-141 jet. The pallbearers paused on the runway to allow Nicholson's wife, Karyn, and daughter, Jenny, 8, to touch the coffin.

The coffin then was taken up the back ramp into the plane, followed by Nicholson's family and about a dozen members of the U.S., French and British military liaison missions based in Potsdam, East Germany. Nicholson was attached to the U.S. mission there.

Government imposes ban

JOHANNESBURG, South Africa (AP) - The white minority government today imposed a three-month ban on meetings by 29 anti-apartheid organizations in 18 areas after weeks of fierce black rioting that has left scores dead.

Minister of Law and Order Louis le Grange disclosed the ban, effective immediately until June 30, in the weekly government gazette of official announcements.

Apartheid is South Africa's system of racial segregation which denies voting and other rights to the country's black majority of 22 million. The whites number about 5 million.

The ban covers indoor meetings of the United Democratic Front, the nation's largest anti-apartheid group, and 28 other organizations. Outdoor political meetings have been banned since 1976. The districts are mainly in the eastern Cape Province, where police shot dead 19 black marchers last week.

"I've said all along the 55 mph speed limit has been very burden-some to Texas particularly. The difference between the 55 mph speed limit in New York State is relatively insignificant in (travel) time. When you go out in West Texas, the 55 mph speed limit is significant in the time to journey from one of those towns to the next."

He indicted as a habitual criminal, convicted of attempted arson at a Houston restaurant and received a life sentence in 1980.



Two other women identified as prostitutes were named in the indictments and remained at large late Thursday, Corley said.





Heightens Tulane investigation

Associated Press Writer NEW ORLEANS (AP) - The testimony of two Tulane basketball players before an Orleans Parish grand jury "amplified" his investigation of possible game fixing, says District Attorney Harry Connick.

But after the first day of the grand jury session Thursday, Connick said his investigators have not yet determined the scope of the gambling allegations.

"We don't have that yet," Connick said. "But it's naive not to conclude that somebody's betting on those games, and when you have gambling involved you have out-of-town folks involved. So that could become the case.'

Clyde Eads, 22, a starting senior from Tampa, Fla., and Jon Johnson, 22, a starting senior from Columbus, Ga., testified Thursday for about one hour each.

The Times-Picayune, The States-Item quoted sources as saying the two had been given immunity in exchange for their testimony.

Since Tuesday night, Connick's investigators have arrested three Tulane basetball players and two

students who are not team members. **Coach Ned Fowler and eight other** players were at the courthouse, but they did not testify. The eight teammates, under subpoena, were told to return next Thursday. Fowler's lawyer said the coach was told he will be rescheduled for a later appearance.

The only members of the team not at the courthouse Thursday were the three players booked on gambling law violations earlier this week.

Mark Olensky, 21, a senior from Fair Lawn, N.J., who is not a member of the team, surrendered Thursday and was booked on two counts of bribery of sports participants, Connick's office said.

Olensky also was booked on charges of conspiracy to bribe and conspiracy to distribute cocaine.

Green Wave star John Williams. 23, a 6-foot-10 all-conference center, was arrested Tuesday night at his Sorrento home. He has denied any wrongdoing.

On Wednesday, sophomore swingman David Dominique of New Iberia, La., and senior guard Bobby Thompson of New Orleans surrendered to officers.

Williams, Thompson and Domini-

que are accused of shaving points either winning by a lower margin or losing by a larger margin than the established "line" on the game.

Also arrested Tuesday was Gary Kranz, 21, of New Rochelle, N.Y., a Tulane student booked on cocaine dealing as well as gambling law violations. He was released on a \$10,000 surety bond.

All five charged in the investigation are free pending disposition of the charges.

The maximum penalty for violation of Louisiana's sports bribery law is five years in jail and a \$10,000 fine.

Connick said the investigation still centers on two Metro Conference games - Feb. 20 with Memphis State and Feb. 2 with Southern Mississippi in the Tulane arena.

Asked if the scandal could expand beyond Tulane, Connick said the National Collegiate Athletic Association had been alerted and was conducting its own investigation.

Neither Fowler nor his lawyer would comment on the reports.

"I'm going to stand by my players," Fowler told reporters in a brief news conference as he left the courthouse. "They're my guys."





Memphis State, Villanova

Teams not to be overlooked

By BRUCE LOWITT AP Sports Writer

LEXINGTON, Ky. (AP) - Memphis State and Villanova are rapidly becoming the Forgotten Two of the Final Four.

"Hey, there's two other teams here," Villanova Coach Rollie Massimino blurted out Thursday as most interest by the growing herd of media centered on Saturday's St. John's-Georgetown game.

That one is being talked about as the championship game before the real championship, as though the winner will - as if by divine right also win the national championship on Monday night.

The experts have said things like that before - for the past two years, in fact. They haven't always been right.

Two years ago in Albuquerque, N.M., the Houston-Louisville semifinal game was all but conceded to be for the title as well. North Carolina State-Georgia? Well, the

winner in that one would be sacrificed to the Cougars or the Cardinals two nights hence.

It didn't work out that way. N.C. State, on Lorenzo Charles' oftreplayed last-second dunk, stunned Houston 54-52.

One year ago in Seattle, Houston beat Virginia in the Saturday night semis and was projected as little more than fodder for Georgetown, which demolished Kentucky in the other semifinal.

It did work out that way. The Hoyas took apart the Cougars 84-75.

Now it's Villanova-Memphis State, given second-class status to the game between Coach Lou Carnesecca's Redmen and John Thompson's defending champion Hoyas.

Massimino's Wildcats, the only unranked team to survive the regionals, weren't even supposed to be here. And, with a 23-10 record, they've got two more losses than the three other Final Four entries combined.

Now the experts figure they won't get past the Tigers. But Massimino gave himself the momentary luxury Thursday of looking ahead to the championship game.

"We played Georgetown great twice," he said of the 52-50 and 57-50 losses. "We played St. John's great twice," losing 76-71 and 70-68. "We could beat both of them. ... Thompson and Looie, they're my buddies. I'm happy for them. Looie's my idol and John eventually will become one."

Massimino isn't the only coach who believes the Wildcats are being overlooked.

Syracuse finished third in the Big East Conference, tied with Villanova behind St. John's and Georgetown. And Coach Jim Boeheim of the Orangemen sees the Wildcats as sleepers - if they can win their semifinal.

"It'll be tough for Villanova to get by Memphis State," Boeheim said. "But I'd say Villanova has a better chance than St. John's to beat Georgetown because of their style. Villanova can play a slow tempo.'

The Wildcats can dictate a slowdown game because there's no shot clock in the tournament. It's almost certain there'll be one a year from now in Dallas.

The NCAA will meet next week to consider rules changes and the addition of a 45-second shot clock is expected to receive the necessary twothirds vote.

Edward Steitz, athletic director at Springfield College and longtime editor of the rules committee, told a news conference Thursday that "the likelihood of it failing is almost nil."

Steitz also said the NCAA will consider adopting a three-point field goal and will be trying to find ways to "clean up, you might say, the fouling at the end of the game and, at the same time, not take quite as long to play the last four or five minutes.'
