WILL BUILD A TOWN

Parmer County to Have a Hustling Town in Bovina.

Manager A. G. Boyce has recently sold 28,000 acres of land at \$2.50 per acre, cut up in small sections, the purchasers paying extra for windmills and all improvements.

Fencing was paid for at a rate of \$100 a mile, and windmill wells at \$600.

In conversation with the manager on Wednesday he informed us that he would now sell off in small parcels to suit purchasers, the land in the vicinity of Bovina, at which point a fine city is to be built up. "There will be no question about purchasers, as the land in that vicinity is the richest and most desirable soil in the Panhandle," remarked Manager Boyce to a reporter. Capt. A. S. Howren, of Georgetown, surveyor for the XIT, is already here and will enter the field at once, and in a month's time the land will be ready for occupancy. Thus are populous towns and cities built in this wonderful land of ours. They spring up

almost full grown, as if they were the work of the enchanter's magic wand. Where last month howled the lonely coyote, today stands the hustling town, pulsing with life and activity. And the world goes on.— Channing Courier.

In alighting from the train above the switch, which had by that time gained considerable headway, he struck a rock which threw him with considerable force to the ground, resulting in fracturing two ribs, besides bruising him considerably about the body. He was brought to his boarding place, the Hereford restaurant, where Dr. Tinsley reduced the fractured ribs and made him as comfortable as possible. It is thought that nothing serious will result from the accident, aside from laying him up for awhile.

This has been the custom of a number of the boys for some time past, notwithstanding the fact that there are strict laws prohibiting this practice and in spite of the repeated warnings given them by Station Agent Davis and other employes of the road, and the only wonder is that some one has not been injured heretofore. We understand that if a repetition of this dangerous practice is again indulged in the offender will be severely dealt with by the



SAN FRANCISCO has another case similar to the Durant murder. The victim is Nora Fuller, who was found dead in a deserted house. A man by the name of John Bennet, alias C. B. Hawkins, is the suspected murderer of the girl, but his whereabouts are unknown.

A FRESH geyser has developed at Yellowstone Park, whose eruptions are about six times greater in volume than the noted Constant geyser. The new geyser has been christened the "20th Century."

W. F. KELLEY of Silverton has announced himself a candidate for the office of district attorney. Mr. Kelley was one of the attorneys for the defense in the Thornton murder trial at this place last spring.

It is said that in Eelzen, Russia. the authorities have passed an ordinance requiring all husbands to be at home with their families by 11 o'clock at night, or pay a fine of \$2.50. This would be a good law in enlightened America.

WITH incorporation we can soon point with pride to the general appearance of the town as an object to prospectors who are desirous of a location for themselves and families. and it will have some weight, too.

. In the matter of the people living out side of the possible incorporated limits of Hereford signing a petition to the commissioners to order an election for incorporation, we believe that as residents of the county they have a perfect right, morally and legally, to sign such a petition, as most of them are interested in the welfare of Hereford and will be residents of the incorporated town of Hereford inside of the next twelve months. Unless they are assured of a clean, healthy town, they will remain on their nearby ranches and bring their children in for school advantages and have them return as soon as the school day is over.

We also contend that they should have a vote in the matter at the elec-

HEREFORD should incorporate at once. The town has outgrown the hamlet form, with its evils of filthy back alleys and other nuisances, and should take on city airs, with its attendant cleanliness. Without laws to compel them there are some people (a very few in Hereford, however) who had as soon live in filth as otherwise. If you have any respect for cleanliness you will sign a petition requesting the commissioners to order an election for or against incorporation and will then vote for the measure at the election.

WITHIN two months Hereford will commance the erection of a handsome brick college which will be an ornament to the town and be a great factor toward the developing of physical and mental character of the present and future inhabitants of the Panhandle. If you have not already invested in this great enterprise, do so at once.

THIRD ASSISTANT POSTMASTER GENERAL MADDEN has sent to Congress the memorandum of a provision which will be a boon to every business man in the country. The measure, if passed, will permit the mailing of third and fourth class mail matter at pound rates when mailed in quantities, thereby doing away with the necessity of affixing stamps to circulars and other advertising matter.



Grant and the Spy.

A correspondent to the Richmond, (Va.) Dispatch, who was a confederate soldier vouches for the following story:

During the siege of Petersburg there was in the Federal army a Colonel Hamilton, who appears to have been an engineer. Captain Hamilton, the Confederate, made his way through Grant's lines and obtained drawings of the Federal fortifications, and was on the eve of returning to his command, when he was captured, tried as a spy, and condemned to be shot. Colonel Inman says he was sitting in General Grant's tent, conversing with him on the night before the execution was to take place, that Colonel Hamilton,

the provost marshal, entered the tent and addressing the General said: "General Grant, I cannot shoot that spy."
