Hereford ISD to receive \$14.5 million in grant money for construction

Hereford Independent School District has been awarded \$14.5 million in grant money for classroom construction.

HISD is among 148 school districts named by the Texas Education Agency sharing the \$200 million set aside by lawmakers during the 1997 legislative session. House Bill 4 set aside the funds to provide money for the construction of new classrooms and other instructional facilities.

The HISD administration has been working since September to put the district in a position to quality for the funding.

Before filing its application, HISD had to submit preliminary plans and costs to the state. Part of the preliminary plans included the hiring of architect Joel Mills out of San Antonio. Mills has completed several studies, project plans and recommendations to the school board and the state.

"This grant will allow us to eliminate some portable buildings and accommodate some of the ADA (Americans with Disabilities Act) codes," Superintendent Jack Patton said.

The grant money will be used for a new vocational education/tech prep center, an improved fine arts center and additional physical education facilities at the High School; and a new 30-classroom wing at Hereford Junior High.

The funds for these projects will be made available starting in March. The school board and the staff will complete construction plans in the coming

'We're looking at possibly a two-year project, once the funds are made available to completion," Patton said.

Filing to begin in February for four seats on City Commission; election to be May 2

Filing will begin Feb. 16 for four seats on the Hereford City Commission. The filing will run through March 18.

Early voting will be April 15-28. On election day, all ballots will be cast at the Hereford Community Center, 100 Ave. C.

Voters will be asked to elect two at-large commissioners, as well as fill two single-member district spots.

The at-large seats now are held by Roger Eades and Carey Black; the single-member district seats are held by Eugene Condarco, Place 2, and Wayne Winget, Place 4.

Pope urges Cubans against fear, criticizes policy on abortion, closing of Catholic schools

HAVANA (AP) - "Be not afraid" was Pope John Paul II's message to Cubans on his first full day on the island, a day that began with criticism of government policy on abortion and the closing of Catholic schools and ended with an appeal to free some prisoners.

After a private meeting between the pope and Fidel Castro, the Vatican announced late Thursday that the government had agreed to consider freeing some prisoners who had asked the pontiff to present their cases to the Cuban

Earlier in the day, amid the lilting, romantic beat of maracas and drums, the pontiff celebrated Mass in the provincial city of Santa Clara, appealing for sexual morality and restoration of Catholic education.

"The family, the school and the church must form an educational community in which the children of Cuba can 'grow in humanity.' Do not be afraid; open your families and schools to the values of the Gospel of Jesus Christ, which are never a threat to any social project," the pope said.

The pope is scheduled today to say Mass in Camaguey, an old, eastern city of white colonial buildings and lush interior gardens where the pontiff is to talk about youth.

On Thursday, the Vatican announced the possible concession on freeing prisoners after the pope met privately with President Fidel Castro, an opportunity long awaited by John Paul to set down his vision for his church in Cuba.

Requests from Cuban prisoners asking John Paul to press for an act of clemency were put forward by the Vatican's secretary of state in separate talks during the pope-Castro meeting, said papal spokesman Joaquin Navarro-Valls.

Kaczynski pleads guilty to bring an end to Unabomber case, gets life in prison

SACRAMENTO, Calif. (AP) - The angry rantings of Theodore Kaczynski ended the deadly reign of the Unabomber. Word by venomous word, they also helped send him to prison for the rest of his life.

Facing evidence that included diary pages filled with his own damning statements and told he could not defend himself in court, Kaczynski brought an end to the nation's longest serial bombing case Thursday with a few

quiet words: "Guilty, your honor." Kaczynski pleaded guilty to 13 federal charges covering five bombings, including two deaths in Sacramento and one in New Jersey. The agreement resolves all federal charges against Kaczynski, who also admitted his role

in Unabomber attacks for which he had not been charged. The 55-year-old mathematics professor turned mountain hermit entered the last-minute plea on the day a jury was finally to be sworn in and opening

statements were to begin.

Had Kaczynski been convicted, the man diagnosed as a paranoid schizophrenic could have faced death by injection. The agreement calls for life in prison without parole when he is formally sentenced May 15.

TEXAS vs. TOBACCO

Judge OKs settlement, attorney fees

TEXARKANA, Texas (AP) - A federal judge has approved Texas' \$15.3 billion settlement with the tobacco industry, giving himself oversight of how the largest settlement in U.S. litigation history will be distributed.

"A brighter future for Texas and the health care of its poorest children has been sealed by the court's signature," Attorney General Dan Morales said after U.S. District Judge David Folsom signed the deal Thursday. Morales said Texans will see lower health and insurance costs, while

businesses will boost productivity because fewer workers will be out with Under the terms of the agreement announced last week, the \$1.2 billion first-year payout was earmarked for a variety of health-care services for

all Texans, children's health care, anti-smoking education and enforcement.

The rest of the money is to be paid out over the next 24 years. Folsom said he will handle any disputes over how the money is spent. The judge also said he would oversee payments made to private lawyers hired to represent Texas in its lawsuit, which sought to win compensation

for the expense of providing health care to smokers. Folsom said he thought the contracted fee of 15 percent, worth a total of \$2.3 billion, was reasonable. He instituted a \$100 million cap each year on the legal fee payments, and the money will be funded by arrangements

made in a pending national settlement or by the tobacco companies under the state's deal.

The state has questioned whether it should have to pay the attorneys 15 percent for a case that did not go to trial.

'If press reports are accurate and attorneys have been awarded \$2.3 billion in attorneys' fees, Gov. Bush believes that amount is clearly excessive and outrageous," said Karen Hughes, a spokeswoman for Gov. George W. Bush.

Florida, which reached an \$11 billion settlement with the tobacco industry in August, also has struggled with payments to 12 lawyers who assisted it in its case. On Thursday, a judge ordered that legal fees be decided by an independent, three-person panel.

Five of the lawyers object to the panel and are suing to keep an original deal in which they were entitled to receive a 25 percent contingency fee, which could amount to \$2.8 billion over 25 years.

In St. Paul, Minn., jury selection was continuing in Minnesota's lawsuit against the industry. The state and Blue Cross and Blue Shield of Minnesota are suing for \$1.75 billion in medical costs for treating smoking-related illnesses, alleging tobacco companies concealed the dangers of smoking

Clinton's behavior called 'stupid,' if true

WASHINGTON (AP) - As details of an alleged White House affair dribbled out, many Americans were giving President Clinton the benefit of the doubt but warned that there is only so much they can stomach.

"I believe his behavior was entirely inappropriate and stupid, if it's true," said Barbara Rhodie, 55, a film producer from Heathrow, Fla.

'If it's true," said Jacki Brune, 31, of Los Angeles, "I think he should be impeached."

The buzz in bars, the talk on TV and the chatter in cafes across the country Thursday turned to the topic of Monica Lewinsky, a 24-year-old former White House intern and employee. She is said to have told a friend in secretly taped conversations that she and the president had an affair. But she later signed an affidavit in the Paula Jones sexual harassment case denying the affair.

Whitewater prosecutor Kenneth Starr is investigating whether Clinton or presidential confidant Vernon Jordan urged Lewinsky to lie. Clinton has denied the affair and efforts to cover it up.

Polls immediately after the allegations became public suggested that a narrow majority of Americans were prepared to believe Clinton and Lewinsky had a sexual relationship. Still, most Americans said they didn't want Clinton out of office.

What has Americans most upset: The possibility that Clinton may have asked her to lie under oath. A quick ABC poll Wednesday night found that 53 percent of those surveyed said Clinton should resign if he had had an affair and told the woman to lie about it.

"Telling her to lie, that's what crosses the line,"

said Jamie Phace, 22, of Portland, Ore. Julie Roe, shopping at the Kirkwood Mall in Bismarck, N.D., said he should be left alone to do his job, unless he lied under oath.

'Then he has to be impeached," Roe, 65, said. "He has to pay the consequences just like anybody

Others were offended by Lewinsky's age and allegations that she had sex with Clinton in the White House.

"Her age bothers me. She was just 21, probably pretty naive," said Lynn Westerman, 51, of Little Rock, Ark. "If the allegations are proven, I think it would probably be honorable to resign.

Yet many voters seemed eager to excuse any presidential affairs.

For many Americans, it's old news. He was elected in 1992 amid allegations of extramarital affairs and 'they've decided to dismiss it," said Rod Strickland, a 38-year-old Detroit attorney.

A few voters wondered if Clinton is being set up. "I could say I've had an affair with Clinton and he tried to romance me and I'm sure Ken Starr would be happy with that," said Al Blum of Fort Lauderdale. Fla., lugging a duffle bag through the Charlotte, N.C.,

House to await Starr's findings before an inquiry

WASHINGTON (AP) - If Independent Counsel Kenneth Starr finds credible evidence that President Clinton tried to get a former White House intern to lie under oath, his findings could trigger a House impeachment inquiry - if the Watergate example is

The House is unlikely to do anything until Starr investigates the allegations. But key lawmakers said if an impeachment inquiry eventually begins, it likely would expand far beyond the perjury allegation that enabled Starr to expand his Whitewater investigation.

Legal experts said it will not be easy for Starr to prove that Clinton tried to get former intern Monica

Veterinarian stops screwworm infestation

SAN ANTONIO (AP) - A San Antonio veterinarian is being credited with preventing a reinfestation of screwworm flies, a pest that cost U.S. ranchers hundreds of millions of dollars and infected humans as well before

The threat of reinfestation has prompted federal authorities to consider tougher regulations on pets entering the United States, which currently has no domestic animal quarantine.

Federal officials say Dr. Sheryl Proctor, a veterinarian at the Ellison Drive Animal Hospital, discovered screwworm infestation last Nov. 21 in a basset hound.

Laboratory tests confirmed the infestation and federal health investigators were called in, said Dr. Dave Wilson, a senior staff entomologist with the U.S. Department of Agriculture's Animal and Plant Health Inspection Service

The dog's owners, a military family, brought the animal to the veterinarian

because it was limping, Proctor said. Man shoots 64 emus rather than let them starve

WEATHERFORD, Texas (AP) - An elderly man shot and killed 64 of his 76 emus because he could no longer afford to feed the flightless birds, a Parker County deputy says.

Parker County Chief Deputy Larry Fowler said the 76-year-old man who lives near Cool was in the process of shooting the emus Thursday when the deputy responded to a report of gunfire and found the dead birds.

The man, who was not identified, has not been charged, but officers are investigating the incident. Officers said the man said he decided to shoot the birds rather than let

them starve to death. He had killed all but 12 when the deputy arrived. Fowler urged other emu owners to find another way to solve their problem. TV reported found slain

TEMPLE, Texas (AP) - Television news reporter Kathryn Dettman had plans to start a new job next week at the CBS affiliate in Dallas. She never

The 36-year-old was found beaten to death in her Temple, Texas apartment Thursday, and police are questioning a neighbor they found covered in blood who had been calling her.

Dettman had just stepped out of the shower when she was attacked. Police found no signs of a break-in at her second-floor unit at the Wildwood Apartments, police spokesman Tony Hennes said.

Charges were not filed Thursday, as the man faced more interrogation and remained in custody, Hennes said. An autopsy was pending.

'According to some friends of Kathija, the young man ... had been calling her a lot. But she seemed unconcerned about it," Hennes said. Neighbors reported the man lived in the same complex as the victim. Mowbray deliberations continue

BROWNSVILLE, Texas (AP) - A jury deliberated nearly five hours without reaching a verdict in the murder retrial of a woman who spent nine years in prison for the 1987 death of her husband.

The eight-woman, four-man panel was told to return this morning to continue considering whether Susie Mowbray shot her husband to death or whether he killed himself.

If the jury cannot reach a verdict, prosecutors said they would re-evaluate the case before deciding whether to try Mrs. Mowbray a third time.

Deliberations began Thursday just moments after a dramatic courtroom outburst by Mrs. Mowbray, who broke into tears and screamed, "I didn't do it! I didn't do it! Please don't let them do this to me again!"

Collapsing onto the defense table, Mrs. Mowbray sobbed and quivered as she continued to proclaim her innocence. The jury stared at her, stone-faced. Texas Supreme Court rules against ex-partner

AUSTIN (AP) - A partner who was expelled from her law firm after blowing the whistle on another partner whom she suspected of overbilling has lost an argument in the Texas Supreme Court.

In a 6-2 ruling, the Supreme Court on Thursday upheld a decision by a lower court to overturn more than \$4 million in damages awarded to Colette Bohatch, who had been a partner in the Washington office of the Houston-based law firm Butler & Binion.

Ms. Bohatch contends she was told by the firm in 1990 to find another job after she reported that the managing partner of the office, John McDonald, was overbilling Pennzoil, the office's chief client.

Ms. Bohatch said McDonald was taking long lunches, shopping trips and practicing photography during office hours and billing Pennzoil for 11- and 12-hour work days when he would only put in three to four hours.

There was also no discussion of the controversial questions surround-ing bilingual education, despite publication of recent studies showing Hispanic students drop out of high school at more than twice the rate of white students.

The questions given to students selected to sit on a panel for the question-and-answer portion of the visit focused on several of the same issues that are part of President Clinton's 10-point call for improved education for the 21st century.

Regarding national education standards, Riley said it is appropriate for states and local school districts to set their own standards, but said the federal government should recommend standards based on tests given to students around the world.

Another question about federal aid to college students led Riley to discuss the \$1,500 Hope Scholarships, which provide tax credits to the families of college students, and other newly implemented tax credits geared toward vocational training programs.

Authorities can try to trace the statements' origin through the screen name that was used to write them, by subpoening the Internet service provider and finding out who has that screen name, Ziegler said.

Armed military patrol still needed

WASHINGTON (AP) - Congress should scrutinize a rumored Pentagon move to abandon the use of armed military patrols for anti-drug operations, says the author of House legislation that would authorize the deployment of up to 10,000 troops along the U.S.-Mexico border.

"Now is not the time to terminate one of the few successful initiatives we have had in stemming the flow of illegal drugs over the border," Rep. James Traficant, D-Ohio, wrote Thursday in requesting hearings of the House military personnel subcommittee. "Our country is being invaded by narco-terrorists and illegal aliens."

The Defense Department last year suspended the use of armed military personnel for border anti-drug reconnaissance after a West Texas teen-ager was fatally shot by a U.S. Marine patrolling the area near Redford, Texas. The moratorium remains in place pending completion

of a Pentagon policy review. Quoting an unnamed senior defense official, Scripps Howard News Service last week reported the decision had been made to recommend termination of the program to Defense Secretary William Cohen

The Pentagon has declined to officially confirm that report.

Last year, military patrols operating in support of border anti-drug missions were credited with the seizure of 11,813 kilos of cocaine, 144 kilos of heroin and 135,589 kilos of marijuana, said Maureen Bossch, a spokeswoman for Joint Task Force Six, the military anti-drug detail based out of Fort Bliss in El Paso,

For every \$1 spent on JTF Six, the military seizes \$50 in drugs, Defense Department spokeswoman Cheryl Irwin said Thursday.

In his letter Thursday to Rep. Steve Buyer, R-Ind., requesting hearings of Buyer's subcommittee, Traficant wrote: "We should not abandon a sound military strategy because of one accidental shooting.

In other District 1-4A boys action, Canyon Randall is at Dumas and Pampa is at Borger. Canyon has an open district date.



Elway, of course, headed the celebrated quarterback class of 1983, going as the top pick in the draft that year. By comparison, two other star players in Sunday's Super Bowl didn't have as lofty a draft status. Terrell Davis was surprised to even be drafted, and Brett Favre was taken behind two quarterback busts, Dan

And there are a whole lot more players who've taken the rags-to-riches route to Sunday's title game between the Green Bay Packers and Denver Broncos.

Davis, Denver's stellar running back, still can't believe that his roundabout career has taken him to the Super Bowl. In his hometown, no

"I'm probably one of the few players who knows what it feels like to not be a star player, a person who has been stepped on his entire life," Davis said Wednesday. "I really

never had that superstar status in high school or college. That's helped me get mentally prepared for what I'm taking on now."

A sixth-round draft pick in 1995, Davis is a star now. In just three NFL seasons, he's rushed for 4,377 yards. 

S.C. bishop plans to retired CHARLESTON, S.C. (AP) - The Most Rev. David B. Thompson. outh Carolina's top Roman Catholic

clergyman, will retire this spring.
Thompson, who has headed the
Diocese of Charleston for nine years, lans to retire May 29 on his 75th birthday, mandatory retirement age for all Catholic bishops.

Thompson made the announcement to the diocese's 131 priests

"I believe that my appointment as your bishop has been the work of the Holy Spirit," Thompson said. "And I believe the same thing about my retirement as your bishop."

Although he is asking to retire in

May, he may serve in an interim of six months or longer until a new bishop is appointed.

As bishop, Thompson, has taken strong stands for ecumenical understanding and against the death penalty. His opposition to flying the Confederate flag atop the Statehouse won him a national award last year. Thompson also steered the diocese through several sexual abuse scandals involving clergy and created tough church standards for reporting and preventing such misconduct.

He may be best remembered for the Synod of Charleston, a series of meetings that ended three years ago with the approval of an 82-page blueprint for the diocese's future. It contains guidelines covering everything from the language of liturgies to the role of women in the church.

Auction nets \$20,600 from church thefts

ORO VALLEY, Ariz. (AP) - A

police auction raised nearly \$20,000 for religious groups robbed of artifacts by a man posing as a priest. The auction in this Tucson suburb

drew 104 collectors, antiques dealers and onlookers. The items were among those valued at \$100,000 found in the Oro Valley home of Michael Dongarra when he was arrested in April 1996.

Dongarra, 51, was convicted on multiple theft and fraud charges and is awaiting sentencing.

IRS slaps lien on minister's home

CLEARWATER, Fla. (AP) - A tax lien of \$41,300 has been filed against Bernice V. Edwards, the convicted embezzler who owns a waterfront home with the Rev. Henry Lyons, embattled head of the National **Baptist Convention USA.**

The Internal Revenue Service lien was filed after a published report that Lyons planned to offer the house for sale. The house, appraised at \$700,000, is in the island town of Tierra Verde, across Boca Ciega Bay from St. Petersburg.

Preacher offers workers sanctuary

DES MOINES, Iowa (AP) - The Rev. Gil Dawes is in the limelight in Iowa on the issue of undocumented workers, but it's hardly the first time he has pushed his activist brand of Christianity.

"I look back and wonder, how come I ended up thinking this way? There doesn't seem to be a lot of us out there," he says. "What happened to me, I think, is that I'm left handed."

He's serious, sort of.

They didn't make allowances for lefties when Dawes, 64, went to school, so he made unusual adjustments. "The way they had you position the paper, I learned to write from the bottom of the paper to the top so I wouldn't smear," he says.

He has been turning things upside down ever since.

Last year, Dawes' United Methodist congregation in Des Moines defied the law and offered sanctuary to eight illegal aliens. All said they feared for their lives if forced to return to El Salvador.

None are currently at Trinity United Methodist: One returned to El Salvador and the others received favorable changes in immigration status. But Dawes is looking for more.

'Our next test is to have a Mexican who is in danger of deportation who has come here solely for economic reasons," he says. "Economic terrorism is the predominant form of terrorism in the world."

To those who say they cannot condone sanctuary because it breaks the law, Dawes responds, "They have the idea that if they disobey the government, they disobey God.

And he adds: "There is a place for borders, for people to organize their lives in distinctive ways. But I do not think that borders are made by God. When they are man-made lines drawn by blood, when they are drawn by injustice, they are not to be honored.'

Dawes first tackled the sanctuary issue more than a decade ago, as pastor of a church in Cedar Rapids. Before that, at a church in Camanche in the 1970s, he supported worker unions, even inviting communist activist Angela Davis to speak at the church. People were "hanging from the rafters," he recalls, and the late Charles Kuralt did a story there.

After seminary, Dawes earned a master's degree in counseling from Boston University. Then he headed into missionary training, during which he organized a bus load of missionaries to attend Martin Luther King's "I have a dream" speech. In the early 1960s, he left for Central and South

First, it was to Costa Rica for a year and then to Argentina for six more. There, he witnessed a military takeover and the start of the "dirty war," where political undesirables would simply disappear. Close to students and laborers, Dawes felt threatened.

In 1971, he was appointed pastor of St. Mark's United Methodist Church in Camanche, where he stayed for a decade, followed by another at Faith United Methodist Church in Cedar Rapids.

In 1991, he left Cedar Rapids to head PrairieFire, a rural advocacy group. Together with that part-time job, he is now pastor of both English- and Spanish-speaking congregations at Trinity.

A year ago, the church offered sanctuary to a 23-year-old Salvadoran who said his request for political asylum has been denied. Dawes calls the man's dilemma "a teaching moment about the meaning of Christianity and the nature of democracy and the shape of our foreign policy and racism."

Other immigrants such as the Irish have it easy, he says, because "they speak the right language and they're the right color." But some groups face hurd'es of racism. "We don't let those Haitians in. We don't let those brown-skinned Hispanics in."

Young Cubans proud of faith, not afraid to speak

CAMAGUEY, Cuba (AP) - One refuses to take part in Communist Party work brigades. Another says she regularly astounds her university classmates by openly criticizing Fidel Castro's government.

Both young Cuban women think their country is plagued by a moral crisis and a lost sense of community.

Are Liliana Acosta and Yailyn Avila outspoken dissidents? No, just devout Roman Catholics among 10 young Cubans helping Pope John Paul

II celebrate a Mass today in which the central theme is youth. Cuban youth, depressed by economic hardship and limited career opportunities, are spiritually rudderless and seek refuge in alcohol and sex, the women said in an interview in the garden courtyard of La Merced

After Thursday morning's rehearsal, the two were exuberant, anticipating their once-in-a-lifetime meeting with John Paul. Acosta was to present the Eucharist to John Paul, Avila a lector in the Profession of Faith.

But the women's enthusiasm ebbed when talk turned to the state of Cuba's

'We Catholics have direction, but other young people don't know where they're going. They have no hope," said Avila, 21, from nearby Las Tunas. Avila knows she may be hurting her career prospects by refusing to ioin the work brigades, which perform tasks like harvesting sugar. But the special education student refuses to conform.

'The way we're living now, it's not the right road," she said.

Acosta, a fifth-year medical student, shudders when she recalls treating a woman who had undergone six abortions.

The 22-year-old Camagueyan said her religion almost cost her a medical career when a teacher tried to deny her a post-secondary education nine years ago because she is a practicing Catholic.

Only 1 percent of the 300,000 people in her city, Cuba's third-largest, regularly attend Catholic services.



MERV GRIFFIN BEVERLY HILLS, Calif. (AP) -Merv Griffin thinks it's time people got out a little, so he opened a

nightclub. "I really think people are tired of sitting at home on their fannies," said the 72-year-old producer of "Jeopardy!" and "Wheel of Fortune."

Griffin's Coconut Club opened last weekend. It's his homage to the days when he sang with Freddie Martin's orchestra at the Coconut Grove.

"People want to go out and have a good time. And this isn't like a jazz club where you sit and don't participate. Here you dance, you eat, maybe have a drink or a smoke. It's an inexpensive night out - except for what you might have to pay the baby sitter," Griffin said.

TIMOTHY LEARY ESTATE BEVERLY HILLS, Calif. (AP) -Canceled checks and a Christmas card from Ringo Starr are among the earthly possessions of LSD guru Timothy Leary that will be auctioned by Christie's.

The ashes of Leary, who died of prostate cancer in 1996, were rocketed into space last April.

WASHINGTON (AP) - The attorney for Monica Lewinsky said today the former White House intern is a target of the Whitewater criminal investigation and prosecutors oppose any deal for immunity as they probe whether she had an affair with President Clinton and lied about it.

Attorney William Ginsburg also complained his client had been questioned in a hotel room for hours by FBI agents and prosecutors without an attorney

to represent her.

"She has been targeted. She is a target," he told The Associated Press.

A target, according to the manual used by federal prosecutors, is someone likely to be indicted.

Ginsburg said he is seeking a deal to gain immunity from prosecution for his client in exchange for her testimony. But Independent Counsel Kenneth Starr's investigators have rejected the idea.

"Their position is they are not going to give her immunity," he said. Prosecutors subpoensed Ms. Lewinsky to testify before the grand jury, sources said. Ginsburg declined comment on that, citing grand jury secrecy.

Despite pressure from prosecutors and the sudden media limelight, Ginsburg said of his client "at this point, she stands by her affidavit" filed earlier this month in the Paula Jones case in which she denied an affair with Clinton.

Prosecutors, moving quickly to subpoena key players and documents, are trying to determine if Ms. Lewinsky, Clinton and Clinton confidant Vernon Jordan conspired to cover up an alleged affair. Lying in a sworn

affidavit could be grounds for perjury charges.

The president and Jordan have both denied any converup and Clinton

has denied he had a sexual relationship with the young woman.

The prosecutors have tape recordings suggesting that Ms. Lewinsky, concerned she was about to be questioned in the Jones sexual harassment case against the president, talked to Clinton in December and was hooked up with Jordan to find a lawyer and a new job, lawyers familiar with the

The White House was sharply divided over when Clinton should respond to questions raised in the Lewinsky matter. Some political advisers hoped he would hold a news conference today. But the president decided otherwise, siding with aides and attorneys who sought a cautious approach more mindful

Clinton would like to address the issue before Tuesday night's State of the Union address, presidential spokesman Mike McCurry said. "But whether we can or not we don't know. We've got to assemble every answer to every question that you are all going to pounce on very quickly to ask," he said.

The president was meeting with his Cabinet to discuss Tuesday's speech. McCurry said Clinton probably would speak to them about the accusations.

Ginsburg said Ms. Lewinsky has been "squeezed" by prosecutors and they "managed to detain her" for eight hours of questioning without an

In an earlier interview with ABC, Ginsburg confirmed that Ms. Lewinsky was prepared to plead the Fifth Amendment - which protects against self-incrimination - and refuse to testify today if questioned in the case. That's "fairly accurate," Ginsburg said.

Ms. Lewinsky was spared by a federal judge from questioning by Jones' attorneys as Starr sought Ms. Lewinsky's cooperation for his investigation into whether there was any attempt by Clinton and Jordan to influence Ms. Lewinsky's testimony in the Jones federal lawsuit.

Jones' attorneys, relegated to a sideshow in this week's developments. called a news conference this morning to dispute speculation they were working in tandem with Starr. "I think it is safe to say there's no communication between our office and Mr. Starr's office," said Donovan Campbell. He said he welcomed the delay in Ms. Lewinsky's deposition to "allow the victim to collect her thoughts."

Ms. Lewinsky is "devastated, concerned, upset, and fearful," Ginsburg said. "She does not know what the future holds."

The crisis which has entangled Clinton began when a friend of Ms. Lewinsky provided Starr with about 20 hours of audio tapes in which she is heard describing a sexual relationship with Clinton and discussions on hushing it up.

Taxpayers, there's relief

NEW YORK (AP) - Simply because they have never heard of a particular government form, many thousands of taxpayers will pay costly civil penalties to the Internal Revenue Service this year.

It is difficult to determine the precise number of such taxpayers, but in 1996 the Internal Revenue Service assessed 13.1 million taxpayers a total of \$1.2 billion in civil penalties for failure to pay taxes.

Many of these people could have avoided the penalties. Had they known about IRS Form 1127, they would have recognized that the IRS may allow taxpayers to delay payment by up to six months during which interest, but not penalties, are assessed.

The form is so little known that some IRS employees are unaware of its existence, and the agency does little to publicize it. Moreover, it is not readily available.

Instead, most people caught in a financial bind use IRS Form 4868, which allows for an automatic four-month extension for filing. However, in using this form both taxes and civil penalties are assessed on any tax owed in

The payment extension, as distinguished from the filing extension, is not granted automatically. Taxpayers must show that unforeseen circumstances beyond their control, such as medical bills, made it impossible for them to pay by April 15.

In each instance, however, one or the other form must be filed by the April 15 deadline. And if Form 1127 is used, the tax return itself must be

Tax litigation consultant Dan Pilla, who teaches tax professionals the ins and outs of the tax law and who has written nine books on the tax system, has done his best to inform the public about Form 1127, but it is still little

Pilla, whose offices are in the St. Paul suburb of White Bear Lake, Minn., says he's had a difficult time learning why the form is so little publicized, since inevitably there are many thousands of taxpayers who might benefit from its use.

The only explanation ever offered by the IRS, he says, is that it would create confusion, a somewhat ironic response in view of 17,000 pages of

tax rules and regulations that often confuse the IRS itself.

The two forms, Forms 1127 and Form 4868, are not the only means by which pressured taxpayers can delay the inevitable. Using IRS Form

by which pressured taxpayers can delay the inevitable. Using IRS Form 9465, a filer who owes taxes but cannot pay the full amount immediately can request an installment agreement.

In worst-case situations, there exists such a thing as tax amnesty, although this aspect of the tax law also is little known.

Using IRS Form 656, accompanied by IRS Form 433A, a taxpayer may submit an offer in compromise, conceding that the full amount is owed but pleading and proving that the total is unaffordable, and suggesting an amount that is financially feasible.

Proving such a case is not easy, but the results can be dramatic and relieve the taxpayer of mounting penalty, interest and compounding of debt that the taxpayer of mounting penalty, interest and compounding of debt that

could only worsen matters. The average settlement as of last November was 13 cents on the dollar. Pilla, a researcher who has delved into the most obscure alleyways of the IRS code, has made taxes his life's work: writing books and articles,

appearing on TV and radio programs, conducting seminars and training Much of the information used here is contained in his Tax Amnesty Forms Kit, which includes the book "Tax Amnesty."

Lewinsky to lie and involved Washington attorney Vernon Jordon in the effort.

If he meets those obstacles, the criminal charge likely would be subornation of perjury, which carries a maximum penalty of five years in prison and a \$2,000 fine. Subornation is a suggestion that someone commit perjury

"Perjury is hard to prove, and subornation adds another layer, making it even harder," said James Cole, an attorney who investigated House Speaker Newt Gingrich for the House ethics committee.

Philip Heymann, former deputy attorney general and now a Harvard University law professor, said, "The very difficult burden for Ken Starr would be to prove that Vernon Jordan urged her to commit perjury, and it would be even harder to prove the president requested Jordan to do that."

Joseph diGenova, a former independent counsel, said perjury investigations are difficult because "It's usually tough to find someone to talk about it." One GOP staff source, speaking only on condition of anonymity, said House Judiciary Committee Chairman Henry Hyde, R-Ill,, would not launch

an inquiry without broad support of House members.

"It can't be a vendetta," the staffer said. "You have to have Democrats of the same mind. Starr must move swiftly and make his report. Either this is the greatest political self-immolation of the 20th century or one of the greatest smears of the 20th century. Starr has to move swiftly to determine which one it is. Until he does, the House is in no place to move."

The Judiciary Committee also lacks an investigative staff to handle an impeachment inquiry, and it would be a major undertaking to hire one. Rep. Gerald Solomon, R-N.Y., chairman of the House Rules Committee, said if an impeachment inquiry begins, it could range beyond Starr's

'Consequently, if these most recent allegations are shown to be credible, they will be part of the Rules Committee deliberations into the wide-ranging

questions about illegal activities on the part of the president and his Cabinet, including prior allegations of selling influence to the White House, economic espionage and violations of national security," Solomon said. In his 1976 memoirs, Watergate special prosecutor Leon Jaworski wrote

that he had "grave doubts" that the Supreme Court would permit an indictment against a sitting president, and deferred to the House impeachment investigation of Richard Nixon.

The proper constitutional process, it seemed to me, would be for the (Judiciary Committee) to proceed first with an impeachment inquiry,"



Clinton administration steps up pressure

on Israel, Palestinians on peace process
WASHINGTON (AP) - The Clinton administration is stepping up its
role in the stymied Mideast peace process, telling Israel and the Palestinians we need some results soon.

The next move probably will be talks in Europe between Prime Minister Benjamin Netanyahu and Palestinian leader Yasser Arafat brokered by Secretary of State Madeleine Albright. She insisted again Thursday on a sizable and credible Israeli pullback on the West Bank

Declaring that remained her position, Albright confirmed President Clinton had decided on a strategy of urging a phased Israeli troop withdrawal timed to Palestinian actions against terrorism.

With Clinton making proposals and Albright likely to lead an Arafat-Netanyahu bargaining session, the administration has begun to shape the outline of a settlement - insisting, all the while, the hard decisions were up to the two leaders.

Terrorists are waging a relentless war against Israelis," Albright said, echoing Netanyahu's complaint on this issue while disagreeing with him about a pullback. He has offered to withdraw from less than 10 percent more of the West Bank.

Arafat, for his part, demanded 60 percent more of the West Bank - he told reporters that was what agreements with Israel required - and said he had given Clinton a letter to show the Palestine National Council had nullified calls for Israel's destruction.

"So far as we're concerned that was put to rest," he said.

Group launches appeal to save tigers
GLAND, Switzerland (AP) - With the Chinese Year of the Tiger beginning this month, the World Wide Fund for Nature launched a \$1 million appeal Thursday to help save the big cat from extinction.

'The situation for tigers is becoming increasingly precarious," spokesman Jean-Pierre d'Huart said. The number of tigers in the world has declined by 95 percent during

the last 100 years, the group said in a report. The main threats to tigers are habitat destruction, poaching and the illegal trade in tiger parts for use in traditional Chinese medicine. Three species of tigers, the Bali, Caspian and Javan, are already extinct

and the South China species risks the same fate with only 20 or 30 left

There are between 5,000 and 7,000 tigers left in the wild, mainly in national parks and protected areas. About half the world's tigers live in

Formula suggested for Baby Bells, long-distance

WASHINGTON (AP) - In return for speedier regulatory action, regional Bell telephone companies would be allowed to provide local and long-distance service through separate companies in which they would have a limited financial stake, a long-distance company proposed Thursday.

LCI International Inc., the nation's sixth-largest long-distance company, offered the plan to the Federal Communications Commission. The FCC is considering how to help the Baby Bells enter the long-distance business as well as spur local phone competition.

LCI's "fast-track" proposal would not lower the regulatory bar for the Bells to provide long-distance service to local phone customers. They would still have to comply with all provisions of a 1996 telecommunications law governing long-distance entry.

Instead, the proposal would "greatly simplify the factual examination" regulators must go through when reviewing Bell companies' requests to provide long-distance, Anne Bingaman, LCI's senior vice president insisted.

But BellSouth spokesman Bill McCloskey said LCI's proposal "builds new regulatory hurdles" for Bell entry into long-distance and would delay more competition to that market. Other Bell representatives didn't like

went well and represented a "radical departure" from previous adversarial contract talks at Greyhound. "That's the reason we reached a fair agreement early," Cushing-murray

said. Greyhound Lines is the only nationwide provider of bus transportation.

IMF: Asian bailouts don't cost taxpayers
WASHINGTON (AP) - The International Monetary Fund is defer
its multibillion-dollar rescue packages for three Asian economies and ins

they will not cost U.S. taxpayers.

Stanley Fischer, the IMF deputy managing director, said that without IMF action, there would have been more bankruptcies, unemployment and a deeper recession that could have spread to global financial markets.

He said Thursday that the IMF's first order of business was to restore confidence in the currencies of Thailand, Indonesia and South Korea, which were targets of IMF aid totaling \$120 billion.

Replying to critics in Congress that say these bailouts come from texpayers' pockets and constitute corporate welfare because international banks get the funds, Fischer said the IMF "does not carry out its operations at texpayers' expense."

"On the contrary, it operates like a credit union" with subscriptions, called quotas, that earn market-rate interest when they are used in IMF lending programs.

Researcher asks test plots of hemp

MONTPELIER, Vt. (AP) - The best way to find out whether it makes
sense to grow industrial hemp - the plant from which the drug marijuana
can be derived - is to plant a few test plots, a University of Vermont economist

Dr. Jane Kolodinsky, an associate professor of economics, told the state House and Senate Agriculture committees there is not enough information about the potential market for U.S.-grown hemp to predict whether farmers could make money growing it in Vermont.

But its success as a niche product in Europe indicates it is worth a try,

'It seems that there are several definitely positive things about" growing industrial hemp, Kolodinsky said after a meeting of the two comm "Unless you try something, perhaps on a small scale, you can argue about

it for years and perhaps never get anywhere," she said.

Several Vermont lawmakers have been pushing to legalize hemp as a farm crop. Gov. Howard Dean, citing the drug associations, has sworn to veto any such bill that passes the Legislature. The movement to grow hemp has scattered support in several other state legislatures.

AIDS cases jump among older Americans

ATLANTA (AP) - New AIDS cases rose more than twice as fast among those over 50 than among younger adults between 1991 and 1996, suggesting that older people aren't protecting themselves against the disease.

The Centers for Disease Control and Prevention said 6,400 AIDS cases

were diagnosed in the United States among people at least 50 years old in 1996, a 22 percent increase from 1991. Cases for the 13-to-49 age group rose 9 percent in the same period, to

The CDC said most older adults who got AIDS in the early days of the epidemic probably contracted it from a tainted blood transfusion. Now,

more are being infected by unprotected sex and by injecting drugs. "These are older adults who are engaging in some risky behaviors because they don't perceive themselves to be at risk," Dr. Kimberly Holding of

the CDC said Thursday. Among older women, the number of new AIDS cases linked to unprotected sex more than doubled between 1991 and 1996 - from 340 to 700. In older men, that increase was almost as sharp, from 360 to 700.

Doctor says false AIDS rumors hurt reputation

NASHVILLE, Tenn. (AP) - Dr. Susan Johnson started hearing the rumors in October, before patients began calling her obstetrics-gynecology practice asking to transfer to another doctor.

They had heard Johnson had AIDS and didn't want her treating them. Her practice faltered as the rumor spread.

"It's devastating for any human being to have a lie told about you," she said Thursday.

Johnson and her husband, William Whitehurst Jr., have filed a \$5 million lawsuit against the people they claim started the rumor: two other doctors in Martin, a city of 10,000 in northwestern Tennessee.

Johnson claims Drs. Susan Lowry and Anna Hopla "were motivated to do harm" to her because she refused to take on obstetrical patients of Lowry, who was pregnant and a patient of Johnson's at the time. Lowry and Hopla were in practice together at Martin Medical Center.

The doctors became angry and retaliated by spreading the "false, scurrilous and slanderous rumor" that Johnson had AIDS, according to the lawsuit filed Jan. 14. Johnson, the doctors allegedly claimed, would write a letter to each of her patients informing them of her condition

Repair shops balk at switches for air bags

WASHINGTON (AP) - Drivers who want on-off switches installed for their air bags are having a hard time finding dealers or repair shops to do the job, an American Automobile Association survey indicates.

In the group's informal survey of 700 new car dealerships and other repair shops in 29 states, only 16 percent said they would install the cutoff switches for motorists with the required authorization papers from the

Sixty-two percent of the shops said they would not install the switches. The remaining 22 percent said they are waiting for additional information from legal advisors or vehicle manufacturers.

"I tried at least 15 dealerships in the area and not one would do it. I called everybody," Mary Gustafson, 54, said in a telephone interview from Minneapolis. "I have this permission letter, but what good does it do me? I'm so disgusted."

Gustafson, who wants a driver-side switch, got an authorization letter because she is 4-feet-10 and cannot sit far enough away from the air bag
