Stopgap needed so government won't shut down

WASHINGTON (AP) - Republican leaders say they agree with President Clinton on the need to prevent a massive government shutdown as Congress and the administration inch toward a collision over budget-cutting strategies.

"We don't want any stoppage," House Speaker Newt Gingrich said after a White House meeting with Clinton on Tuesday. "We don't want to lay off government employees. We don't want people to be in a position where they're being harmed."

"What we did agree to do was to work hard to try to avoid the so-called train wreck," of a government shutdown, Sen. Thad Cochran, R-Miss., said today. "We've got to tone down the rhetoric and get about the business of making this government work," Cochran said on the "Fox Morning News."

"I think there was agreement that we are not going to let the government shut down. We're not going to let the federal government default," Sen. John Breaux, D-La., said on the

same program. "I think we all agreed we're going to do whatever is necessary" to get a stopgap spending bill to keep the government operating after the end of the month.

"If there's any way we can work together in a mature, adult manner and get this thing done right," Gingrich, R-Ga., said, "I think we're going to cooperate fully." However, he vowed not to compromise on the GOP's determination to balance the budget within seven years.

White House press secretary Mike McCurry characterized the meeting as "a very candid and very sobering conversation about the work that lies ahead for the Congress."

The crunch comes Sept. 30 when the government's appropriations run out. Congress has not sent Clinton any of the regular 13 appropriation bills for the fiscal year beginning Oct. 1. The administration has threatened a presidential veto of eight of the measures working their way through the House and Senate.

School trustees split meetings

Hereford Independent School District trustees, wanting to speed up their meetings and make their deliberations more efficient, agreed Tuesday to split their meetings into two parts.

Formal action on the policy change is expected at the regular Sept. 26 board meeting, after which time trustees will meet twice each month.

After a lunch of pizza and salad, trustees agreed to hold the first meeting each month on the second Monday, traveling to a different campus each time.

That meeting will be devoted to non-voting items.

They will hear a presentation from the school and will deal with information and discussion items.

Two weeks later, on the fourth Tuesday of the month, trustees will meet in the HISD board room, 601 N. 25 Mile Avenue, to take consider minutes and financial matters, hear reports from the teacher groups and high school student council, and to

vote on any action items.

The new system will take effect in October, with the first campus meeting set for Oct. 9. The meeting location will be determined later.

Trustees also hope holding a meeting in the community will allow more people to attend meetings who otherwise would not.

Currently, board members may present an item for information at one meeting, then decide informally to carry it over for discussion the next month, at which time it can be moved to the action agenda a month later.

In the new configuration, items can be acted on in as short a time as two weeks -- with discussion the first meeting of the month and a vote the second meeting.

Board president Jim Marsh said he hopes the change will make it possible for votes to be taken on action items without having to rehash the entire discussion, thus speeding up the process.

All board meetings, both those on campuses and in the board room, will continue to be open to the public.

Officer names DARE Bear for child injured in springtime traffic accident

On the afternoon of May 14, Sheryl Garcia watched in horror as her son, Rocky Hilliard, was struck by a pickup as he crossed the street from the ice cream truck.

On Tuesday, that horror was replaced with pride as Mrs. Garcia and her husband, Jesse Garcia, watched as Rocky was formally honored by Hereford police DARE Officer Carol Keyes as the namesake of her stuffed DARE Bear.

At the time of the accident, Mrs. Garcia was panic-stricken as her son lay in the street, his leg, collarbone and skull fractured and blood pouring from an open wound on his head.

She stayed with him through a week in intensive care and six weeks of traction at home.

Tuesday, she watched as he did his work in the Aikman Elementary School second-grade class of Kathie Kerr, a normal kid almost completely healed of his injuries.

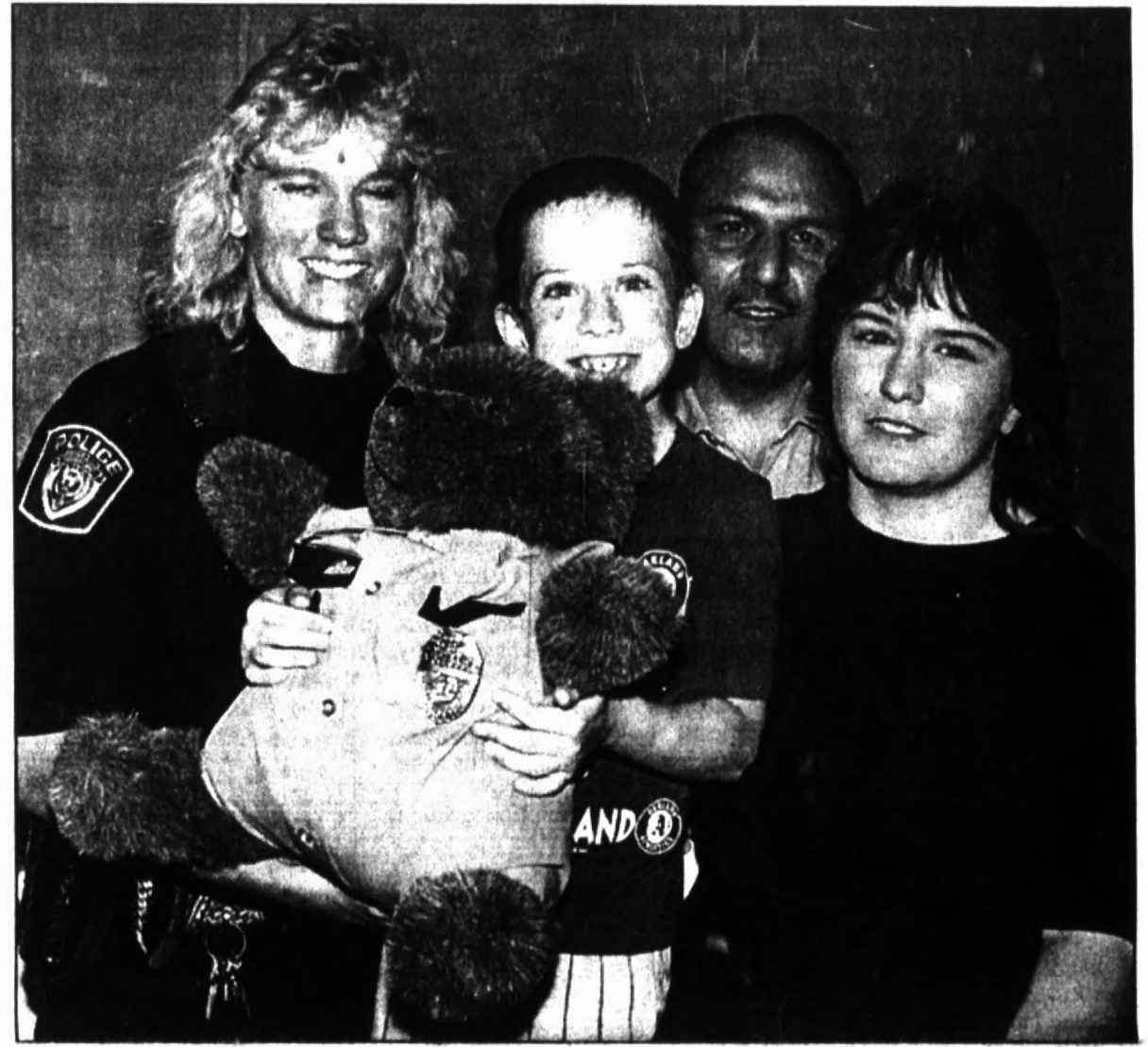
As a first-time DARE Officer, Mrs. Keyes had to find a name for her bear, which attends classes with her and helps teach children the dangers of drug abuse.

When a class of students at Walcott School suggested the name Rocky, Mrs. Keyes said, she was reminded of the courage of Rocky Hilliard.

The accident had special meaning for Mrs. Keyes other than just knowing about the circumstances of his accident.

As a patrol officer from the time she came here in May 1994 until taking over as DARE Officer

American Legion declares local man to be Firefighter of the Year for 1995

Longtime Hereford firefighter Paul Hamilton arrived at Tuesday's regular fire drill expecting to help train new firemen on procedures for moving through smoke-filled rooms.

What he was not prepared for was to be presented with the first of several plaques from the American

Legion honoring him as the top firefighter in the United States.

Hamilton's wife, Dee, and a delegation from American Legion Post No. 192 surprised Hamilton with a plaque during the Tuesday night volunteer fire department meeting.

Jess Robinson, commander of the post, announced to the assembled firefighters that Hamilton, who is currently assistant chief of the department, has been named American Legion National 1995 Firefighter of the Year.

Robinson presented Hamilton with a plaque honoring him as American Legion District 18 Firefighter of the Year, noting that the American Legion national convention is currently being held in Indianapolis, Ind., and his plaque from that meeting will be forwarded to Hereford at a later date.

Robinson said the local post nominated Hamilton in October 1994, "because of his dedication to the fire department and his hard work."

Hamilton also was cited for his efforts during a fire in December

1993 at the home of Buddy and Alva Lee Peeler.

Hamilton is credited with rescuing the couple's granddaughter from the burning home, saving her life.

The District 18 plaque recognizes him for "outstanding service to the community."

"He's not afraid to risk his life if he thinks he has a chance," Robinson said. "Not all firemen would do that, I would doubt."

"We're proud to have an individual such as Paul to represent us," Robinson told the firefighters.

Hamilton's nomination as district firefighter of the year was approved in April, when he was chosen as top fireman among the 26 counties of the Texas Panhandle.

His nomination was then forwarded to the regional level, where one top firefighter was selected from among several American Legion districts.

At the regional level, he came out on top and was nominated to be state Firefighter of the Year.

After being named top fireman in Texas, Hamilton's name was sent on

for consideration of the national honor.

Robinson said Hamilton will be flown by the American Legion to Austin at a later date to be honored at the state level.

Hamilton, a native Hereford resident, joined the fire department in October 1973, shortly after returning to town following a stint in the U.S. Marine Corps.

The 43-year-old Hamilton has held a variety of offices during his 22 years in the department, including assistant chief and captain several times each.

He is a 1970 graduate of Hereford High School and works for WT Services.

On receiving his plaque, an obviously stunned Hamilton expressed his thoughts on the awards.

"It should be 'The Hereford Volunteer Fire Department,'" on the plaque. "I'm not worth 10 cents without them," he said, gesturing to his colleagues. "We appreciate what the Legion does for Hereford and Deaf Smith County."

Economy rises slightly in August

WASHINGTON (AP) - Consumer prices edged up a tiny 0.1 percent in August as a sharp decline in airline ticket prices and the biggest drop in gasoline costs in more than four years helped keep inflation well in check.

The small increase in the Labor Department's Consumer Price Index released today marked the third straight month of price moderation after a price spurt last winter raised concerns that inflation might be worsening.

Since June, prices have been edging up by modest amounts including a 0.2 percent increase last month. So far this year, inflation is rising at an annual rate of just 2.8 percent, little changed from the 2.7 percent increase turning in during 1994.

The good news on consumer prices followed a report Tuesday that prices paid by wholesalers actually fell by 0.1 percent last month.

That report spurred a big rally on Wall Street that pushed stocks to a record close as investors believed that the benign inflation news will give the Federal Reserve room to cut interest rates further. Bond prices gained further strength today immediately after the CPI report was released.

"This is more evidence that the Fed's soft landing has done exactly what it was supposed to do, which was reign in inflationary pressures," said Robert Dederick, economic consultant for Northern Trust Co. in Chicago.

The economy, under the impact of

a string of Fed rate increases in 1994, slowed dramatically this spring with the gross domestic product expanding at an annual rate of just 1.1 percent, the slowest rate in more than three years. Economists believe recent signs show the economy is rebounding to growth of around 2.5 percent for the second half of this year.

"The Federal Reserve has pulled off the hat trick. It has given us slower growth that capped inflation while avoiding a recession," Dederick said.

For August, energy prices fell by 0.8 percent. This decline was led by a 2.9 percent drop in gasoline pump prices, the biggest one-month decrease since March 1991.

Airline fares also took a big drop for the month, declining 3.5 percent.

SARAJEVO, Bosnia-Herzegovina - Despite two weeks of intensive NATO airstrikes against rebel Serb targets, the campaign is showing no sign of forcing a Serb pullback of heavy weapons from around Sarajevo.

WASHINGTON - Republican leaders seem agreed with President Clinton on the need for a stopgap spending bill to prevent a massive government shutdown as Congress and the administration inch toward a collision over budget-cutting strategies.

last month, Mrs. Keyes got the call that Sunday.

She was in the police station when the incident was called in, and she quickly raced to the scene. It was, she noted, the first accident she had worked since coming here that involved a child.

When paramedics straightened his fractured femur, the officer said, "I screamed for him."

Mrs. Garcia said Mrs. Keyes and paramedic Kenneth Cook hold a special place in her heart for the efforts on behalf of her son.

Cook, she said, "was just great, and he's come to see Rocky several times since. Him and Carol -- they're Rocky's heroes."

As for Mrs. Keyes, she said, the short, freckle-faced Rocky inspired her with his "courage, bravery and I don't know what -- a lot of heart."

Other children wanted to name the bear something else, Mrs. Keyes said.

"I started telling them (Monday) about this one (Rocky). Those kids

who really had their hearts set on the name they picked (were) 100 percent for naming it Rocky" after hearing the story of Hilliard's accident and recovery.

Mrs. Keyes said she alerted Mrs. Garcia to her decision Tuesday morning.

"I had to call and bawl to my mother about it," Mrs. Garcia said. "I thought it was great."

Now, Rocky's name -- and story -- will continue to be told.

Mrs. Keyes carries the bear with her as she teaches sixth-grade students the DARE anti-drug curriculum and as she meets informally with other students in kindergarten through fifth grades.

"He's come back 100 percent, which we never expected," his mother said as Rocky worked at his desk, fidgeting like a normal kid.

"He still may have epilepsy" because of the head injury, Mrs. Garcia said, but that won't be known for many years.

NASA looking for satellite solution

Experiments stalled by failure of Wake Shield to respond

SPACE CENTER, Houston (AP) - A troubled research satellite trailing space shuttle Endeavour ran into yet more problems today, failing to respond properly when it got the signal to resume electronics experiments.

Ground controllers beamed up commands early today for the \$25 million Wake Shield Facility to resume growth of ultra-thin, ultra-pure semiconductor films.

The experiment stalled soon thereafter, when satellite instruments failed to distribute atomic arsenic, the principal material out of which the film was to have been manufactured, on a tiny template.

Controllers scrambled to understand the latest problem as precious experiment time passed.

"This is more or less a make-or-break effort for the Wake Shield project," said NASA spokesman Rob Navias, adding that a command-relay problem or a power problem was suspected.

The dish-shaped Wake Shield is designed to produce the semiconductor materials only one-100th the thickness of a human hair by exposing prepared surfaces to molecular beams of arsenic and other chemical compounds.

Physicists had hoped the craft, using the pure vacuum in its wake, would manufacture seven semiconductor films of unprecedented quality. Such material could ultimately lead to faster computers.

When experiments were halted Tuesday, three semiconductor wafers had been produced. Ground controllers had planned to produce two more today and the final two early Thursday, but the latest problem threatened to prevent the creation of any more films.

On Tuesday, the 12-foot steel disk was shut down by controllers after it overheated and began flying at the wrong angle. NASA said today that the 4,350-pound dish actually flipped once before it was steadied by automatic on-board controls.

Ground controllers turned off

nearly all Wake Shield instruments to cool the spacecraft. Project director Alex Ignatiev said the increased temperature caused the tilting and was his biggest worry.

By early today, 20 hours after the shutdown, the craft had sufficiently cooled and was commanded to resume experiments. That's when the new problem developed.

The satellite has also suffered intermittent interruptions of data communications with ground controllers in Houston.

The satellite was originally scheduled to be recaptured by shuttle astronauts today, but NASA postponed the retrieval until Thursday to give scientists an extra day of work. Landing is set for next Monday.

The Wake Shield was the second satellite dispatched by Endeavour's crew. The first, an \$8 million Spartan solar-research satellite, also had technical problems that forced it to be shut down and made Sunday's retrieval by the shuttle crew more difficult.

And the Wake Shield's first trip into space, aboard shuttle Discovery in February 1994, had its troubles. The disc was not released for a free flight because of wiring and sensor problems. It was suspended in space on the end of the shuttle's mechanical arm instead, and the wafers it grew ended up being tainted by shuttle exhaust.

Also today, astronaut James Voss and Michael Gernhardt checked out their spacesuits for Saturday's planned spacewalk to practice techniques and equipment for construction of an international space station.

Voss and Gernhardt were told to replace their spacesuit batteries, which drive life-support systems in the suits, with on-board spares.

The suits have been aboard Endeavour since July, before the flight was delayed more than a month by booster and power generator troubles, and flight managers wanted to be sure they had fully charged batteries.

Computer chips are target in three heists

DALLAS (AP) - Face-down and with his hands tied behind his back, a frightened Chris Lee could hear three bandits repeatedly entering the warehouse of a computer manufacturer where he works.

There's gold in the Silicon Prairie, thieves have discovered at high-tech companies like Lee's. Almost \$100,000 in computer chips were taken in the latest of three heists in far North Dallas suburbs over the past 10 months, authorities said Tuesday.

Lee's car also was taken in the Sept. 1 robbery at Computrend Systems Inc. in Richardson, along with some 30 to 40 microprocessor chips and about 220 to 230 memory chips.

But unlike a December robbery at Cyrix Corp. in Richardson and another in July at Benchmark Microelectronics in the neighboring suburb of Carrollton, the bandits at Computrend were unmasked.

"At Cyrix, they had covered their faces and blindfolded the employees," Lee said. "But at the robbery here, three guys came in without masks, saying they wanted to rob us. They didn't even wear gloves."

Lee, 33, and the Computrend manager, 52-year-old Delwin Peterson, were alone in the building after 6 p.m. on a Friday when the bandits entered an unlocked door, Richardson police Sgt. Ray Pennington said.

Federal authorities are investigating, and police in Richardson and Carrollton have compared details of the three heists, all pulled off after normal business hours or on weekends. Each involved suspects described as Asian. None of the cases has been solved.

In the Carrollton robbery, between two and five masked men ordered 10 Benchmark employees into a back room. There, the workers' hands and feet were bound as hundreds of thousands of dollars in computer parts were stolen.

The possibility of Asian gang involvement "is one of the areas the investigators are looking into," Carrollton police Sgt. Jack Adams said.

At Cyrix, six or eight men and two women tied up four lab technicians and hauled off 2,786 chips, initially valued at more than \$500,000. Pennington said the estimated loss was later revised to \$359,360.

Defendant denies guilt in stockbroker death

LUBBOCK, Texas (AP) - Under a street light before dawn on an April morning, newspaper carrier Randy Lawson inched down his passenger window and took three bullets to the shoulder.

A neighbor who ventured outside in his bathrobe heard the honks for help. Lawson's car circled wildly in reverse; it bashed a mailbox and stopped.

The neighbor peered through shattered windows and saw the 39-year-old driver slumped against the passenger door. Within the hour, Lawson died.

The 1994 murder of stockbroker Randy Lawson - a church deacon and volunteer baseball coach who threw newspapers seven days a week - eroded the sense of security in upper-middle class Lubbock when allegations arose that the two black defendants had been looking for someone white to kill.

Now, no black jurors sit on the panel that will decide the guilt or innocence of 21-year-old Ryan Keith Moody, the accused triggerman.

"I only hear people say it ain't looking right," said city councilman T.J. Patterson, who represents Moody's predominantly black East Lubbock neighborhood. "This is from the common, Joe Blow citizen."

Prosecutors rested their case against Moody on Tuesday after showcasing tattoos, rap music, gang bravado and a rifle fished from a local lake.

The defense also closed after Moody took the stand and denied shooting Lawson. Jurors will deliberate today.

It was Moody's weapon, according to testimony, that was used to gun down Lawson on April 9, 1994. No eyewitnesses have emerged.

But an FBI affidavit quotes a statement by Moody that Lubbock police wanted "to hang this on a black man."

Since testimony began Sept. 6, the trial has attracted a standing-room-only crowd that segregates itself each day. Lawson's friends, mostly white, gather on one side. Moody's supporters, black and Hispanic, group across the aisle.

One woman outside the courtroom said the spectators were attracted by the allegations of race hatred in this city where 65 percent of the population is white, 24 percent is Hispanic and 9 percent is black.

She wouldn't give her name. What she wanted to convey was the image of Moody as softhearted and unprejudiced.

"If it was racial, he wouldn't have

Spanish friends," said the 23-year-old woman, who is Hispanic and knows Moody from Estacado High School in Lubbock.

The FBI affidavit quotes one witness who told investigators this: "He went to the white part of town and shot the first white person he saw. That he was mad at the white race. ... The kid had lived in Dallas before and had been fired from a couple of jobs by white bosses."

Jurors heard in opening statements that the case stumped police until a fisherman's net snagged a rifle about one month after the murder.

Investigators traced the gun to Gerald Wayne Young Jr. of Dallas, who had reported it stolen and then changed his story, testifying he sold it to Moody for \$250 in early '94. Ballistics tests pegged it as the murder weapon.

Moody and another black man, Kenneth Polk, 23, were indicted Jan. 25. Polk hasn't gone to trial yet. But prosecutors say the rifle was fired from his purple Chevrolet Caprice.

As Moody sits with his Dallas attorney Gene Gaines, who also is black, the trial twists in some bizarre ways.

"Prosecutors brought out a boom box and played the rap song 'Drive Bye Homicide.' Copies of that tape

turned up in Moody's car, according to testimony.

Moody was made to remove his shirt and show the jury four tattoos, including the "187 PROOF" tattoo that allegedly signifies murderer status among gang members.

"Shut up. You're talking too much," a friend testified, quoting what he heard Moody tell Polk when talk of the murder came up three days later.

If convicted of first-degree murder, Moody faces punishment of five to 99 years in prison and a \$10,000 fine.

DEAR ANN LANDERS: I am enclosing an article I read in my local newspaper. I hope you can explain it to me. I'm totally stumped. Here it is:

"A North Hollywood man faces misdemeanor charges accusing him of beating and choking his girlfriend, then strangling her pet rabbit as she watched in horror.

"Raphael Diaz Rodriguez, 24, was charged this week with battery in a dating relationship, punishable by up to one year in jail and a \$1,000 fine, and cruelty to animals, which carries a maximum penalty of a year in jail and a \$20,000 fine."

Tell me, Ann, did the writer make a mistake? A \$1,000 fine for battering a human being and a \$20,000 fine for cruelty to animals? Is this how little a human life is worth? I find this incomprehensible and outrageous. What do you make of it? --Mystified in Simi Valley, Calif.

DEAR SIMI VALLEY: I agree with you. It IS outrageous, but there are going to be some changes soon. Bet on it.

Donna Shalala, secretary of Health and Human Services, and Attorney General Janet Reno recently formed the Violence Against Women Advisory Council. I was honored to have been asked to join this blue-ribbon group which is composed of 40 leaders in law enforcement, public health, victims' rights, social services, the business community, religious organizations, higher education and other fields.

You can be sure this advisory council is not going to be just another government "committee." This group of no-nonsense men and women is determined to help the attorney general and the HHS secretary implement solutions that will most certainly reduce violence against women.

DEAR ANN LANDERS: You asked for letters from people who changed their minds about suicide or had attempted suicide and failed. I hope you will find room for one more.

Ten years ago, everything hit me from all sides. I became depressed and suicidal and started to plan my own death. I attempted to kill myself in March, but a motel attendant saved me.

I came out of the hospital still determined to end my life. I began saving prescription pills. When I went to church in search of answers, I would look around to see if there was a way I might hang myself from the ceiling. In June, I headed for a small town where I thought I would not be found and took 300 prescription pills with me.

A friend traced me to the motel. Three other friends flew up and talked me into going to the hospital. I walked into the hospital with the 300 prescription pills, determined to kill myself there.

While seated in the lobby with other patients, I picked up a Reader's Digest and opened it without looking at the index. Here is the unbelievable part, Ann. The article I saw was entitled "Before You Kill Yourself." It gave several reasons to choose life over suicide.

I called a nurse and handed her all the pills I had hidden in my boot toes and luggage. You should have seen her face.

God, friends and that article in Reader's Digest saved me. I know you can't print all of this, but please shorten my letter and find space for it in your column. My reason for writing is to help others. P.S. I am doing just fine now. -- Been There and Back

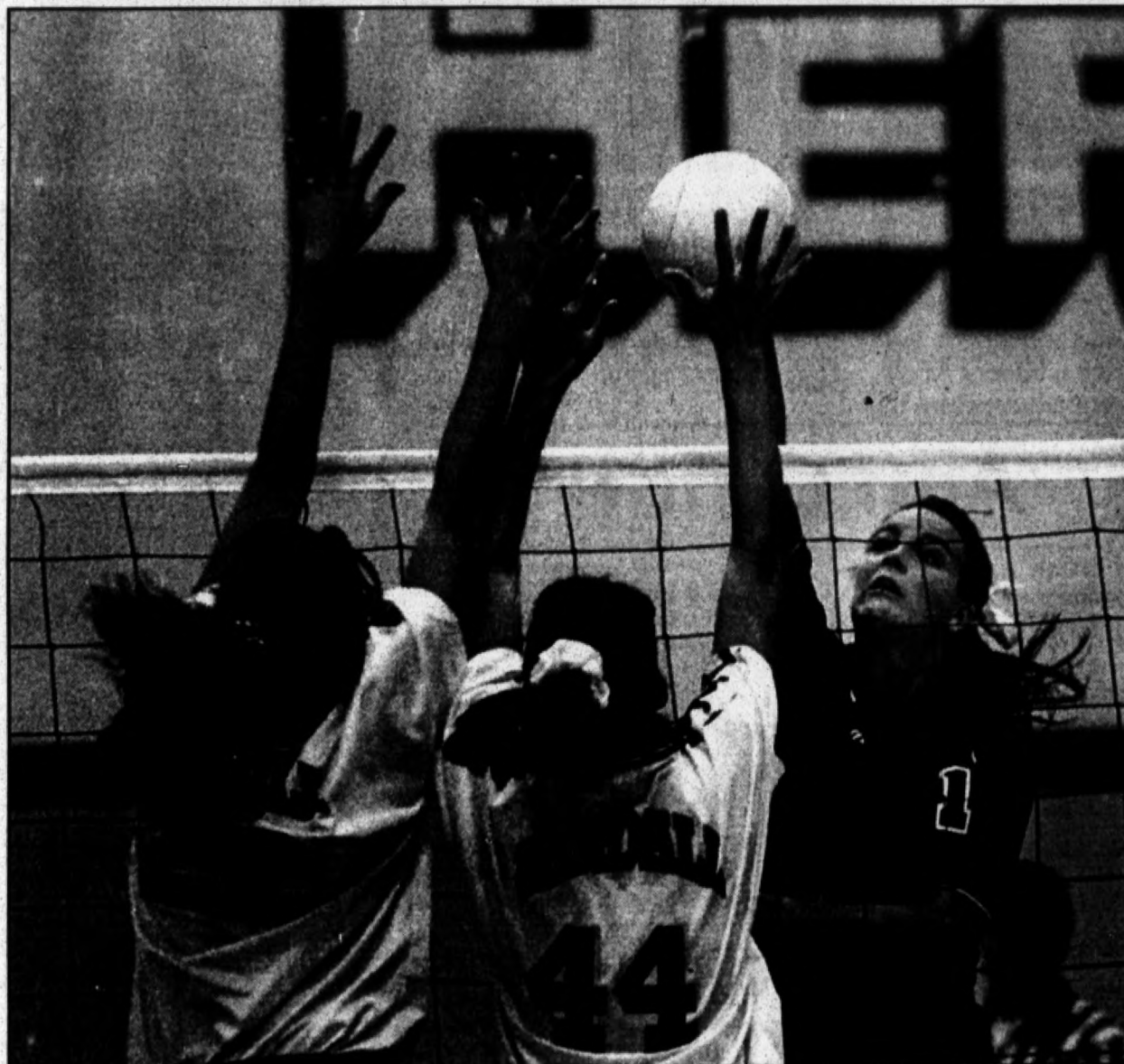

Cowboys go on without Deion

IRVING, Texas (AP) - The Dallas Cowboys can get to work this week without being worried about another Deion Sanders circus.

The flashbulbs have quit popping and Deion Sanders' jewelry has quit glittering. All the Deion speculation has subsided.

Coach Barry Switzer is glad. He is worried about a third week letdown because his Cowboys had one last year.

Detroit sprang a 20-17 overtime ambush and Switzer is wary of playing the Minnesota Vikings in a dome on Sunday night.

"It's a noisy place," said Switzer, who took Oklahoma there 10 years ago for a game against Minnesota.

Switzer said the Cowboys will try to get the crowd out of the game early.

"We ran against the New York

Giants and took the crowd out of the game," Switzer said. "It's funny how if you have your running game going everything works. We'll have to run against the Vikings."

Dallas has recent experience playing in the Metrodome. They beat the Vikings 37-20 there in December 1993. Dallas holds an 11-7 series advantage.

Now that Deion Sanders has signed and returned to the baseball diamond the Cowboys plan a week free of distractions.

The team could have some more offensive line help in Valley Ranch. Derek Kennard, who decided he didn't want to play in training camp, may be back.

The Cowboys still own his rights and Switzer said "Derek could really help our depth. I was told he would be in this week. We need him and we're committed to keeping him on the team."

Switzer said there's still little hope linebacker Darrin Smith will end his holdout.

"I keep hoping he will come in but we're playing well at linebacker without him," Switzer said. "Godfrey Myles had nine tackles against Denver."

The Cowboys have offered Smith \$425,000 and he said he won't play for less than \$750,000.

Switzer said even without Smith and cornerback Kevin Smith, who tore an Achilles tendon, the Cowboys may be further along than they were at this time last year.

"Troy (Aikman) lost a lot of weight and is quicker and faster," Switzer said. "He was up to 235 pounds and looked like a linebacker last year. Michael Irvin has dropped down to 202 pounds and can run a 4.49 in the 40, his fastest time. Those are great indicators of how hard everyone has been working."

Notre Dame's Holtz has surgery

SOUTH BEND, Ind. (AP) - If interim Notre Dame coach Bob Davie has his way, the only sign that coach Lou Holtz is gone will be the absence of his golf cart whipping around the practice field.

"We went out and practiced ... just as if Lou Holtz was at practice," Davie said. "We are going to continue to do that. Nothing is going to change. It will be business as usual Saturday against Vanderbilt."

Holtz underwent 4-1/2 hours of surgery Tuesday at the Mayo Clinic to remove pressure on his spinal cord. A bone growth that apparently developed over time has compressed Holtz's spinal cord, causing weakness in his hand and leg muscles, said Dr. James Moriarity, a university physician.

Holtz will be out at least three weeks, leaving defensive coordinator Davie as the interim coach. The No. 24 Irish play Vanderbilt at home Saturday, before taking on three Top 25 teams: No. 15 Texas (Sept. 23), No. 10 Ohio State (Sept. 30) and No. 18 Washington (Oct. 7).

"We're not as concerned with Vanderbilt as we are concerned with just getting our football team ready to play," Davie said Tuesday. "We are at a very positive point. Obviously

there is a distraction. We're without our leader right now.

"But as I said last night, one of the things that being at Notre Dame, playing at Notre Dame, coaching at Notre Dame, but more importantly in being associated with Lou Holtz, you are put in a position where you understand how to handle adversity," he said.

Giving the players a sense of stability is foremost on Davie's mind, especially since the team has so many freshmen. Offensive coordinator Dave Roberts will call plays from the field rather than the press box, but Davie said that should be the only noticeable change on the sidelines.

Davie will coach the defense as usual. He will use a headset to stay in contact with the other coaches, and said he'll consult them before making any changes that affect the entire team.

There won't be any fiery speeches before Saturday's game, Davie said. In the past, Holtz has fired the team up with talks Thursday and Friday, then used the time before the game to run through what the team needed to do to win.

There is no reason to change that, Davie said.

"We're not going to win this game on emotion, we're going to win this game on execution and by following

the plan that Lou Holtz has already set forth for this football team," Davie said. "You don't want to be on an emotional rollercoaster. So I'm going to do everything I can, and these coaches are going to do everything they can, to just temper emotions."

But Davie also said he is not foolish enough to think his players will forget about Holtz. The seniors plan to hold a players-only meeting later this week, and Davie said he thinks that will be good for the team.

"Let's be honest and let's face it ... this is a unique situation and this is Lou Holtz's football team," Davie said.

While Davie said he is flattered Holtz and the university thought enough of him to pick him as interim coach, he is not going to make a big deal out of his new title. He hasn't called other coaches to ask their advice, and he doesn't plan to.

Holtz will be back sooner than everyone thinks, Davie said.

"I am just going to do everything I can so that when Lou Holtz comes back, we are going to have this in as good a situation as it is when he left," he said.

The 1993 season was the 60th in the National Football League for the Detroit Lions.

Yankees gain ground on front-running Red Sox

The Boston Red Sox still have a 10-1/2-game lead with 18 games to play. They were unofficially awarded the AL East title quite awhile ago, with the rest of the season a mere formality.

But these are the Red Sox, the franchise that has crushed its faithful with some of baseball's most infamous collapses. Could the "Curse of Babe Ruth" really exist?

The Baltimore Orioles beat the visiting Red Sox 6-5 Tuesday night, their season-high fifth straight loss. The New York Yankees, the team in second place in the division, won its sixth straight, and Boston's magic number to clinch again remained at eight.

"I don't think there's a sense of

urgency, like things are slipping away from us," said Boston first baseman Mo Vaughn who had two homers Tuesday night. "All we need is one win and we'll be fine."

Seven homers in the last two games - Mike Greenwell also homered Tuesday - haven't been able to get a win. None of the starters have stepped up in the role of streak stopper. There's a low grumble starting to be heard around Boston.

"You've got a bunch of winners on this ballclub," said Vaughn, who has 37 homers and four multihomer games this season. "Because we've been used to winning, it's really disheartening."

In other AL games Tuesday night it was New York 9, Cleveland 2; Detroit 5, Milwaukee 1; Texas 6,

Toronto 5; Seattle 14, Minnesota 3; California 3, Chicago 1; and Kansas City 3, Oakland 1.

The Orioles had two outs and nobody on in the seventh when pinch-hitter Harold Baines doubled off Joseph Hudson (0-1), who took his first major league loss. Mark Smith followed with a bloop single to center that made it 6-5.

"It seems like they've been scoring all their runs on homers, but we're coming up with the clutch hits," Smith said. "It's nice that we could keep up with them without hitting homers."

Rangers 6, Blue Jays 5
Toronto first baseman John Olerud had a tough eighth inning as a line drive bounced off his glove for a

double, and he also made a throwing error as Texas scored three runs.

Trailing 4-3, the Rangers had two on when Ivan Rodriguez lined a ball over first that appeared to be slicing foul. The ball skipped off Olerud's glove and down the right-field line, allowing the tying run to score. One out later, pinch-hitter Rusty Greer hit a sharp grounder toward first with the infield in. Olerud dived and stopped it, but his throw home sailed to the backstop and two runs scored, one on the error.

Olerud homered earlier, his eighth this year and first at SkyDome since Aug. 7, 1994.

Yankees 9, Indians 2
New York won its sixth straight

and 12th of 14 on Ruben Sierra's tie-breaking sacrifice fly in the seventh and a six-run ninth.

Cleveland committed a season-high five errors, two in the ninth, and lost its second straight after winning 14 consecutive games at home. The Indians are 1-6 against the Yankees at Jacobs Field since the park opened last year.

Paul O'Neill had a two-run homer, his 20th, in the ninth and Wade Boggs added a two-run single.

Scott Kamieniecki (5-5) allowed two runs and five hits in 6 1-3 innings.

Tigers 5, Brewers 1
At Detroit, Chris Gomez drove in four runs, three on a bases-loaded double in the second, and Jose Lima allowed three hits in six innings as the Tigers won their fourth straight.

Lima (2-7) gave up one run and struck out three. John Doherty pitched two perfect innings for his fifth save.

Mark Loretta of Milwaukee hit his first major league homer.

Colorado's Vinny Castilla could have watched his former team clinch at least a tie for its fourth straight division title.

Instead, he took it upon himself to help his current team get closer to winning its first.

Castilla went 4-for-5, drove in three runs and hit his 31st home run Tuesday night as the Rockies delayed the Atlanta Braves' victory party with their season-high sixth straight victory, 12-2.

The win kept host Colorado a game ahead of Los Angeles in the NL West, and left Atlanta needing a win or a Philadelphia loss to clinch a tie for the NL East.

Castilla, drafted from the Braves in the 1992 expansion draft, had his fifth career four-hit game and the fourth this season.

"It was satisfying, but not just because it happened against the Braves," he said. "It meant a lot because we are in a pennant race, and we have to beat the Braves to stay ahead."

In other NL games, Florida edged Cincinnati 5-4, Los Angeles stopped Chicago 7-1, Houston beat New York 8-6, St. Louis defeated San Francisco 10-4, Philadelphia beat Montreal 8-2 and San Diego beat Pittsburgh 5-1.

Castilla was 19-for-84 in 12 games against his former team.

"You knew it wouldn't last," Atlanta manager Bobby Cox said. "He's too good a hitter."

Lance Painter (2-0), who had lost his only two career decisions against Atlanta, won his first start of the season. He allowed two solo homers among his nine hits in five innings. Kevin Ritz pitched four perfect innings for his second save.

"That's what baseball is all about," Colorado manager Don Baylor said. "You go several games where you can't buy a hit against a particular team and then you go off and have a good game like Castilla and Painter had."

NBA players vote for union; end of lockout could be next

NEW YORK (AP) - Following an overwhelming victory for pro-union forces, the next step is for NBA player representatives to vote on a deal that would ensure six years of labor peace.

"I'm confident that if the players do their part, I will deliver the owners to do their part," NBA commissioner David Stern said Tuesday after players rejected an effort to decertify their union.

If the deal is approved, training camps would open as scheduled on Oct. 6 and the season would begin on time on Nov. 3. Owners also would lift the lockout that began July 1 - blocking all individual player contracts.

"The players want to play basketball," said Buck Williams of the Portland Trail Blazers, the president of the NBA union. "We believe we got a fair agreement."

Among the 421 eligible voters, 226 (53 percent) voted to keep the union and 134 voted to decertify. The pro-union forces, supported by Stern, said the vote was tantamount to a referendum on the labor agreement.

"I would hope the player reps look at that and ratify the agreement," union head Simon Gourdin said after the votes were counted at the National Labor Relations Board.

Daniel Silverman, the NLRB's New York regional director, said the results will not be official until Sept. 19. The losing side may file objections to the way the vote was conducted. The NLRB would then take four to six weeks to determine whether the objections are valid.

"Of course, I'm disappointed by the vote," said Jeffrey Kessler, the

lawyer for players seeking to decertify the union. "I still believe this is a terrible vote for the players and they will regret it for a long time."

Kessler's group, which includes Michael Jordan and Patrick Ewing, will decide whether this week whether to challenge the election. The one-sided vote may cause the group to give up the fight, which began June 21.

"A lot of the players got intimidated by the threat of the owners that the season was going to end," Kessler said. "The strategy the NBA carried out was effective."

Stern denied the NBA had coerced players to support the union.

"This is a perfectly legal lockout," he said. "We did nothing that is wrong."

The dissidents think players could get a better deal by dissolving the union and fighting the NBA in court. The group filed an antitrust suit in

Minneapolis on June 28, but appellate courts have ruled players can't proceed with antitrust cases if they are unionized.

While baseball, the NFL and the NHL have been interrupted by strikes and lockouts over the past 25 years, the NBA did not have a job action until this summer.

Players who voted against decertification said they were concerned the NBA could turn down the same path as baseball, which experienced a 20 percent attendance drop following the 7-1/2-month strike.

"People came up to me and said, 'Don't do what baseball did,'" said Charles Smith of the New York Knicks, the union's vice president. "We want to make sure the NBA starts. That played a part of it."

Players voted Aug. 30 and Sept. 7, but the ballots weren't counted until Tuesday.

Bookshop guide aids purchasers, irritates dealers

British second-hand shop handbook caters to buyers looking for used volumes

EDITOR'S NOTE - He's a navigator in the vast ocean of secondhand books and an unrelenting critic of their purveyors. Even if you're not looking for an old book, Drif Field's guide to Britain's secondhand bookshops is an entertaining read. Many dealers would like to see him horsewhipped.

LONDON (AP) - Drif Field reached into his bag and pulled out an old book.

"It's about lightning," he said. "Did you imagine there was a book on lightning? Do you know that you have more chance of being struck by lightning than winning the national lottery?"

To a waiter hovering close by in a restaurant garden, Field remarked: "Can you arrange for us to be struck by lightning? It would be a fitting end to this meal."

In the curious and anarchic trade of dealing in millions of mostly forgotten books, Field is the man to find a book when others cannot, or can't be bothered, or don't know how.

The books he seeks are not the kind for which collectors and dealers pay thousands of dollars at auction, but secondhand books which can be impossible to find when you don't know where to look.

"There are really only two types of book: the ones you've got and the ones you haven't," Field says.

"There is no such thing as a rare book or a common book. If you don't believe me, ask your nearest book dealer for a copy of the world's second-best-selling novel of all time, 'Gone with the Wind,' and see if he has it."

(The Guinness Book of Records says Jacqueline Susann's 1966 novel 'Valley of the Dolls' edged out Margaret Mitchell's 1936 'Gone With the Wind' as the all-time best

seller. Both sold more than 28 million copies.)

Addicts of secondhand bookshops regard Field as a benefactor of mankind. The latest edition of his "Drif's Guide to the Secondhand Bookshops of Britain" is a Golconda of information and opinions on 920 shops, including a list headed, "Well worth avoiding."

Field goes to often remote corners of the kingdom to see these shops, as the cover testifies: "The only guide that's been there."

Dealers admire or detest Field because his guide, first issued in 1984, describes what their shops are like and the range, condition and prices of their books.

His scabrous comments on the dimmer shops have excited demands for apologies, banishment from shops and book fairs and threats of horsewhipping and lawyers. Some examples of his style:

"Looks like a modernist fish tank, with mock grottoes."

"A grunge special, the book shop as occupation for somebody who cannot think of anything better to do and then does not want to put any effort into doing it properly. I like the owner's wife."

"I tried to get into this shop and the gentleman told me I was not the sort of customer he wanted."

Among his singular, character-defining acronyms are: AWYW, meaning the proprietor "asks what you want." Field says what he wants in a bookshop is to be left alone.

ETGOW is "easy to get on with," KUTI is "keeping up the image," NEB "not enough books," NSOC "not strong on condition," WEBCOC "was expecting a better class of customer," and WYLAH, "watches you like a hawk."

"A Samuel Beckett Special" is his descriptive terminology for, "A secondhand book shop where it is not

always possible to tell what is going on ..."

Why are these shops so often run by the weird and woolly?

"People who read are introverts and the people who deal are selected from them," Field says. "They believe they are doing it right and they alone know how to do it."

He recalls a dealer named Guy the Spy: "He wore an ill-fitting wig and built a Berlin Wall of books across the door so you couldn't get into the shop. His customers had to take up athletics to leap inside."

Editions of Drif's Guide have contained revelatory essays on aspects of the trade which dealers want to keep secret, such as what they actually pay for books and "ringing" auctions to prevent the public buying.

The 1995-1997 edition savages the national and trade press for ignoring a book Drif wrote last year on a court case involving the mysterious purchase of a famous secondhand book business in London by some fabulously rich Americans.

It was mysterious because there are no big bucks in secondhand book dealing. Field is convinced his book was ignored because the press was terrified of being sued if it discussed the case.

Field sent out 126 review copies which didn't produce a single review. "I am now claiming the world record for copies sent out with no reviews obtained," Field says.

Field is 45, a stocky, pugnacious Londoner. He wears smart, bright clothes and a hat always. He changed from book dealing to book finding because it was more interesting to find the books that people wanted instead of trying to sell the books he had.

As for his curious name, "There is a place in Yorkshire called Driffield," he said, and wouldn't be pressed further.

He says he makes a comfortable living searching out old books for

customers who are prepared to pay surprising amounts of money.

"I charge \$117 an hour while looking and the price for the book may be up to \$300 or more," he says. "I will pay what I need to pay to get a book and if I pay \$800 for it I will charge \$1,200. I look for one book for one customer at a time so my charges depend on the work I put in."

Who on earth is prepared to pay such prices?

"Nutters," Field says.

"They are not surprised by what

I charge. They don't visit bookshops and don't know how much books cost. They believe that having a certain book will change their lives. I don't work for collectors, dealers or journalists."

He once burned a paperback book around the edges and mailed it to a well-known London journalist who wouldn't pay his price for finding it.

"I heard it threw him into a state of collapse," Field says.

"I've burned books before. There are too many books. It's sad. There

are more writers than readers. I went to a reading the other day and there were 12 writers present and three members of the public."

He never inquires why a book is wanted, even if it's a book on suicide.

"The stranger it is the more I enjoy it," he says. "I've had to find books on bed-wetting and any book with photographs of naked midgets."

"The pleasure is in the hunt and most people don't have my perseverance. I get all the pleasure and others pay me for it."

Food is more than necessity to most Americans these days

SAN ANGELO, Texas - It's no wonder so many of us are a little plump these days. Food has become so much more than just a necessity for us Americans. It's become more of a hobby or pastime.

When we go to northern New Mexico and southern Colorado - my husband's and my "Heaven on Earth" - not only do we consume lungfuls of fresh, crisp air, but also plenty of good food. I'm always scanning the menus for anything with green chilies as a key ingredient.

I've learned that a little green chili goes a long way in flavoring a dish, and that green chilies are a hot item in the Rockies. That could have something to do with the fact that peppers are a major crop in New Mexico.

On our last excursion, I had a green chili burger, complete with guacamole and fresh salsa served on a bun with a grilled meat patty and Swiss cheese. It was delicious, but messy to eat.

Green chilies go well with scrambled eggs, in soups and stews, in appetizers and in all sorts of Mexican and New Mexican dishes.

Apparently, I'm not alone in this pursuit of the pepper. According to a report from the Agriculture Department, the use of chili peppers has doubled since 1980 from about 3.3 pounds per capita annually on a fresh-picked basis to an average of 5.7 pounds now.

Chili is green before it turns red. The green chili is harvested from late July until October, is roasted and peeled, and is primarily used in sauces, relishes and dips. Red chili is harvested before the first frost, from mid-September into the early part of October. It is dried for later use and often crushed into powder. The heat in the pepper is determined by the variety, not the color.

Green chilies, obviously my favorite, like other peppers, are a good source of Vitamin C and provide Vitamin A and some calcium.

They are low in calories and can add zing to otherwise boring foods.

Fresh chilies are frequently roasted, peeled, seeded and deveined before being added to a dish. To roast, heat a griddle until very hot. Place chilies on the griddle and roast, turning until the skin puckers and chars on all sides. Place roasted chilies in a bag, and close and sweat for 4 or 5 minutes. To leave longer could cause the trapped steam to overcook them. Peel the chilies under a stream of cold water, discarding the skin. If the chilies are to be cut or chopped, remove the stem, slit the chilies lengthwise, and remove seeds and veins. If they are to be stuffed, leave the stem intact, but slit down the side and remove seeds and veins. Rinse and dry peppers with towel or paper towel.

You may want to wear a pair of rubber gloves, and remember to never touch your face or eyes while working with chilies.

When purchasing green chilies, select firm peppers and use within three days. Soft or wilted peppers are more difficult to peel.

You may be aware that this year's crop has suffered a bit at the hands of Mother Nature. Supplies are a bit tighter this year, but chilies are still available.

FRESH SALSA

3 cups seeded and chopped fresh tomatoes
1/2 cup sliced green onions with tops
1/2 cup chopped bell pepper
2 or 3 tablespoons lime juice
2 tablespoons fresh cilantro, snipped
1 tablespoon finely chopped jalapeno
1 teaspoon finely chopped garlic
1/2 teaspoon salt
Mix all ingredients and chill in refrigerator 2 to 3 hours. Salsa goes well with chips, tortilla dishes and on grilled chicken or hamburger.

CHILI BURGER

Fresh salsa
1-1/2 pounds of ground beef

1 (4-ounce) can chopped green chilies, drained

1/2 cup diced Monterey Jack cheese

1/2 teaspoon black pepper

1/4 teaspoon salt

Prepare salsa and refrigerate. Mix remaining ingredients and shape into 6 patties, each about 1/2-inch thick. Grill patties on outside grill or broil in oven until desired doneness. Serve with salsa on bun.

CHILI CHICKEN SPREAD

1 (3-ounce) package fat-free cream cheese, softened
1 cup (4 ounces) grated Cheddar cheese
1 (6-3/4-ounce) can chunk chicken, drained, or 1 cup cooked chunk chicken
1 (4-ounce) can diced green chilies
1 (4-ounce) can sliced black olives, drained
Combine all ingredients and mix well. Serve cold as sandwich spread or with crackers or tortilla chips as appetizer. Also tasty served warm. Microwave on 50-percent power until cheeses melted, and stir to blend.

I have, somewhere, a recipe for John Wayne Quiche, which was a prize-winning entry in a Concho Cookery Contest. It is a party favorite. The following is similar.

GREEN CHILI CASSEROLE

3 (4-ounce) cans whole green chilies, peeled
1 teaspoon salt
6 eggs, beaten
1/2 pound Cheddar cheese, grated
1/4 cup milk
Slit chili pods lengthwise and line greased 9x9x2-inch casserole, covering sides as well as bottom. Salt lightly. Mix eggs, cheese and milk, and pour over chilies. Bake at 350 degrees 30 minutes or until casserole set. Serve in squares on crackers or as main dish.

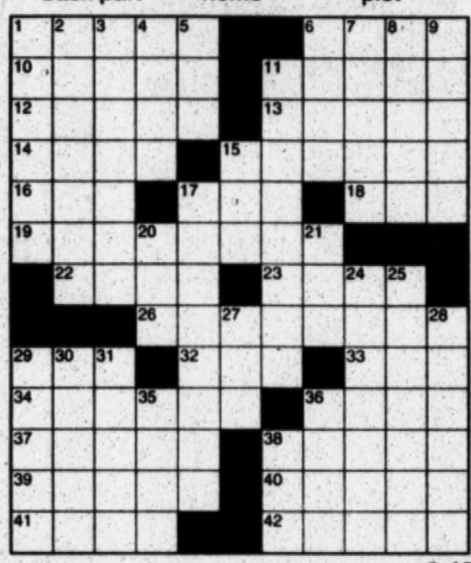

Paging industry upset with new state law overhauling telecommunications statutes

AUSTIN (AP) - The burgeoning digital paging industry didn't know what hit it when the overhaul of the state's telecommunications laws was signed into law. It does now.

The law includes a \$150 million fund to help schools and hospitals purchase advanced hardware needed to utilize modernized phone services envisioned by the new law.

Half of the fund is to come from assessments from revenues derived from traditional local and long-distance carriers. Cellular phone and paging firms will foot the other half of the bill.

The paging industry, which has no trade association nor a full-time lobbyist, didn't realize it fell under the law until after Gov. George W. Bush signed it, according to the Texas Journal in today's editions of The Wall Street Journal.

"I don't think the Legislature really understood what they were doing here," said Mark Stachiw, senior counsel for Dallas-based AirTouch Paging.

Industry officials warn that if the levies' effects aren't softened somehow, companies will go out of business. They also envision higher charges to hundreds of thousands of Texans who carry beepers and pagers.

While lauding the honorable goals of the fund, portable telecommunications manufacturers contend they are being asked to pay too large a share for the fund.

The law requires equal involvement between the wire-based and wireless industries. But the \$420

million in reported earnings by cellular, paging and other wireless services pales in comparison to the \$8.2 billion made by wired telecommunications.

The assessment means a 1 percent speed bump for wire-based companies but an 18 percent hill for wireless companies to climb, based on the revenue figures. The state has yet to determine how it will determine assessments.

The fund was established because lawmakers thought schools and hospitals could ill afford costly equipment to plug into high-capacity telephone networks.

Some of the biggest cellular companies are part of the biggest local phone carriers in the state - SBC Communications Inc. and GTE Corp. - so they're not complaining too loudly.

Stachiw estimates that at least 500,000 and possibly more pagers are active in Texas. Makers of those units have contacted Rep. Curtis Seidlits, D-Sherman, one of the bill's sponsors, to air their concerns. The lawmaker admits the law might need an adjustment.

"We probably should have looked at it on a more proportional basis," Seidlits said. "It was just something we didn't think of at the time."

The Legislature doesn't return until January 1997. They've also met with officials in

the state comptroller's office, who will determine the payment rules. One of the decisions will be whether to allow companies to bill users specifically for the assessment. The state should flesh out the rules by mid-October, the Journal reported.

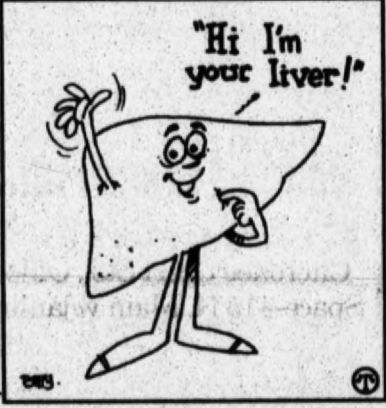

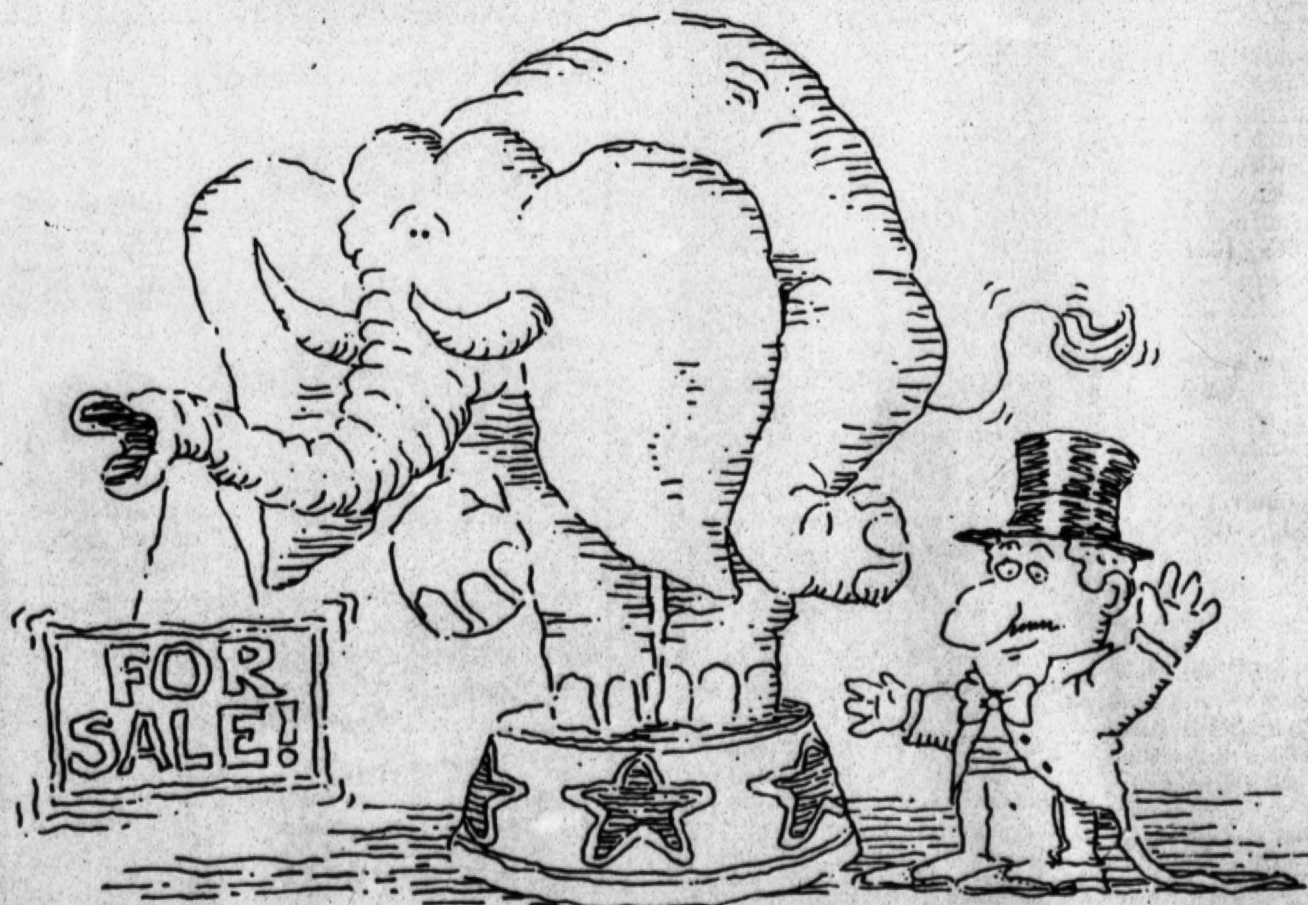

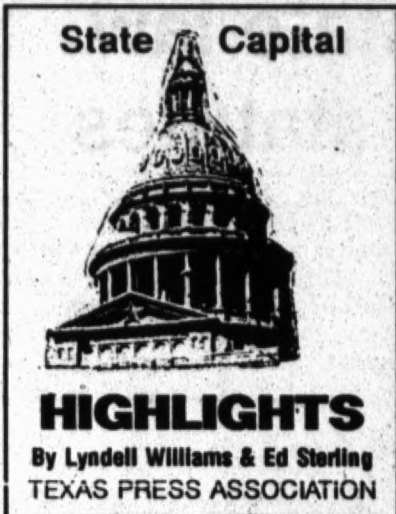

AUSTIN — Comptroller John Sharp and Land Commissioner Garry Mauro — both Democrats — said over the Labor Day weekend that their paths will be “up or out” in 1998, the *Houston Chronicle* reported.

Sharp was re-elected as comptroller in 1994. Though his name has surfaced as a possible candidate for governor or lieutenant governor, he shrugged off questions about a future campaign for statewide office. Thinking about running in 1998 is “like asking a lady who’s just had triplets whether she wants to go on a second honeymoon,” he said.

Mauro, who has served as land commissioner since 1982, said he would not seek re-election to the same office. He said he would stick with plans to run President Clinton’s 1996 re-election campaign in Texas.

Both Sharp — a real estate broker and goat raiser by trade — and Mauro indicated an interest in returning to the private sector.

On the other hand, fellow Democrat, Attorney General Dan Morales said he assumes he will seek a third term.

Republican Agriculture Commissioner Rick Perry also said he has plans for re-election and indicated an interest in filling the seat of U.S. Sen. Phil Gramm, if Gramm is elected president.

“Any high school football coach who doesn’t aspire to be the

coach of the national championship football team, there’s something wrong with them,” Perry told the *Chronicle*.

Gov. George W. Bush, answering questions about his plans, said, “There’s nothing right now that would convince me not to seek re-election,” but stressed that he has no plans to seek national office.

Deadbeat Law Prompts Calls
Attorney General Morales says a new law allowing for the suspension of driver’s, professional and recreational licenses of parents delinquent on child support already has made a difference.

Even before the law took effect on Sept. 1, Morales said parents concerned about the measure bombarded a special license suspension phone bank with calls. In one week after the phone bank became operational on Aug. 24, more than 5,000 calls were received, and parents committed to pay more than \$382,000, Morales said.

In late August, Morales announced his office was sending out notices about the new law to 50,000 deadbeat parents.

Morales said he believes the license suspension law will prompt an additional \$20 million in support payments annually, in addition to almost \$500 million already collected through wage-withholding. About \$1 billion in outstanding child support is owed in Texas.

Panel to Study Phone Law
Lt. Gov. Bob Bullock has assigned an interim Senate committee to study the new law deregulating local telephone service.

Bullock asked the Senate Economic Development Committee to determine if consumers are getting more choices and lower rates in local phone service as a result of recent telecommunications reform legislation passed by the Legislature.

“We need to monitor the impact to make sure the law is fair to all potential telephone service providers and that consumers are benefiting from the increased competition,” said Sen. David Sibley,

R-Waco, committee chairman.

Bullock also wants Sibley’s committee to look into the possibility of medical savings accounts, and study tax abatements and other financial incentives for businesses.

Juvenile Drinking Targeted
Meanwhile, Bullock told Senators to get to work on proposals to keep underage drinkers from behind the wheel.

According to Bullock, Texas has a major problem with inexperienced drivers who become inexperienced drinkers.

“No other issue the Texas Senate will address in 1997 is more important than curbing juvenile drinking and driving,” Bullock said in appointing a special committee to study the problem. “Too many young lives have been lost and too many others jeopardized to ignore the problem.”

According to the Texas Department of Public Safety, 136 drunken drivers under the age of 21 were involved in fatal wrecks last year.

CMP Article Clarified
We erred in a late August column, in which we reported Land Commissioner Garry Mauro said a coastal management plan by Railroad Commissioner Barry Williamson “strips” Mauro’s office of certain oversight duties.

Ron Calhoun, a spokesman for Mauro, said Williamson’s plan doesn’t strip the General Land Office of anything, but some proposals made by the Coastal Coordination Council, which is made up of representatives from several state agencies, would “severely interfere” with the goals of the state’s Coastal Management Program (CMP).

Mauro contends that rules proposed by Williamson go beyond the express changes required when lawmakers amended the CMP during the last legislative session, and would weaken the CMP to such an extent that it would not qualify under the federal Coastal Zone Management Act of 1972.

The public comment period on the new rules closed Aug. 31, and on Oct. 5 the council will vote on the new rules, Calhoun said.

Defense claims Ito going too far if financial help provided juror

LOS ANGELES (AP) — To help jurors cope with the rigors of sequestration, O.J. Simpson’s judge has done everything from treating them to a performance by Jay Leno to allowing one juror to attend an out of state funeral.

But this time, the defense claims, Superior Court Judge Lance Ito went too far.

The defense on Tuesday called for the ouster of a juror after Ito told her the county might be able to compensate her for money she is losing on a vacant rental property. Court papers referred to a juror losing \$1,500 a month in rental income.

Ito took no action on the defense request. He pointed out that he had tried to help jurors whenever possible, but he made clear he had yet to give this particular juror any financial assistance.

The defense also urged Ito to loosen his tough sequestration order and let jurors go home at night.

Prosecutor Marcia Clark called the motion a “transparent” ploy to expose jurors to community outrage over the racist statements of Detective Mark Fuhrman.

The judge seemed to agree, calling the issue “a no-brainer,” but he took it under consideration.

Today, prosecutors hope to put on some of their most compelling evidence: a new DNA test showing the genetic markers of Simpson and victim Ronald Goldman in a blood mixture in Simpson’s Ford Bronco.

On Tuesday, a prosecution glove expert provided additional testimony linking Simpson to a pair of bloody gloves collected after the June 12, 1994, slayings of Goldman and Simpson’s ex-wife Nicole Brown Simpson.

Richard Rubin, a former executive of Aris Isotoner, looked at photos and videos of Simpson working at football games and identified the gloves on Simpson’s hands as Aris Lights, the same type of gloves found near the bodies of Goldman and Ms. Simpson, and on Simpson’s estate.

“How certain are you of that?” asked Deputy District Attorney Christopher Darden.

“I’m 100 percent certain,” he said.

Rubin said Aris Lights are a model that is “quite rare.”

Prosecutors recalled Rubin to the stand to recover from the disastrous demonstration in which Simpson struggled to squeeze his hands into the evidence gloves.

While the glove testimony took up most of the court time, attention once again focused on the troubles of jurors, who look tired and distracted

after spending eight months in a hotel — four months more than they were told to expect.

Ito has said repeatedly that the jurors, sequestered since Jan. 11, are “not happy campers” and are demanding a quick end to the trial.

Jury problems hampered the trial during the first six months, and just two of the original 12 alternates are left. But since June 5, no juror has been dismissed.

Clark said she has cut back her rebuttal case and plans to rest Friday, barring more defense motions and appeals. She said the response to jury fatigue should be to “shut this case down, end this trial.”

Media reports identified the panelist the defense wants removed as a white woman in her early 60s, a retired gas company worker who is believed to favor the prosecution. She is among the most active note takers on the jury and, despite the apparent hardship, one of the few jurors who still smiles in court.

The woman was an alternate panelist until March 17. She said during jury selection that she was the lone holdout in another murder case and managed to get other jurors to change their minds, although she didn’t disclose the verdict.

She is one of two white women on the jury; the other is in her early 20s. The panel also includes eight black women, a black man and a Hispanic man.

Defense lawyer Robert Shapiro told Ito that the juror should be dismissed because Ito’s conciliatory words to her in chambers had elevated her to “a special condition” and might lead other jurors to think they are entitled to payments as well. He said the judge overstepped his bounds.

Ito suggested that a member of the public might come forward and bail the woman out, eliminating the controversy.

“Who knows,” he said. “Maybe it will go away.”

A Chicago radio station that carries gavel-to-gavel coverage of the trial called Ito’s chambers late Tuesday offering to begin a fund-raising drive for the panelist. Drew Hayes, operations director for WLS-AM and WLS-FM, said he has yet to receive a reply from the court.

Meanwhile, lawyers for a man serving 13 years in prison for kidnapping and assault sought to reopen his case Tuesday, alleging Fuhrman coerced witnesses against him.

A motion filed on behalf of Howard McCowan was the first seeking to overturn a conviction involving

Fuhrman since tapes of the now-retired detective uttering racial slurs and boasting of police misconduct were played at the Simpson trial.

Also Tuesday, a TV executive said Simpson’s lawyers have subpoenaed a taped interview in an attempt to locate an unidentified ex-police officer who said he heard Fuhrman make racist remarks.
