County begins budget process

Deaf Smith county commissioners heard budget requests from several county departments Monday in a budget workshop for the 1990-91 fiscal year.

The county's new fiscal year will begin Oct. 1.

Sheriff Joe Brown requested an additional \$55,000 for his department, and a \$56,000 request for vehicles because the department needs four more vehicles. Brown told the commission that a smaller increase will be adequate if the department uses his Bronco instead of buying another vehicle, and commissioners agreed that would be a good idea.

The County Extension Service requested a \$17,000 increase to buy a new pickup. The pickup now being used has 112,000 miles, a rear back panel is torn up, the tires are worn out, the front end is getting bad, and the engine is not good.

Commissioners decided that the county could fix the engine, tires, front

end, and body for about \$2,500.

Another increase questioned by the commission was a \$12,000 increase in Deaf Smith County Library's budget to purchase and install the hardware for another public access terminal. The terminal would be connected to the card catalog. The old card catalog is still in place but is not updated.

The library's computer system is part of a network throughout the Panhandle and is purchased from the Harrington Foundation. A representative from the Harrington Foundation will explain the system to the commission on May 14.

The commission is considering terminating the computer programming service provided by Hart Graphics. About six months has passed and Hart Graphics has not yet provided a computer program to the county.

The county is a little over six months into this year's budget. On April 30, the commission will hold another budget workshop to work on the 1990-1991 budget and discuss the general fund.

Clyde charges dropped

State District Judge Marvin Marshall of Plainview has dismissed charges of sexual assault against local attorney David Clyde.

Clyde is a former assistant district attorney for the 222nd Judicial District.

District Attorney Danny Hill, of Amarillo, special prosecutor for the case, asked that the charges be dismissed because the complaining witness no longer lives in Texas and is unable to travel.

District Judge David Wesley Gulley and District Attorney Roland Saul recused themselves from the case because of their association with Clyde while he was serving as assistant district attorney. Judge Marshall was appointed to the case April 10.

Clyde was indicted for sexual assault by the 222nd District Court grand jury on March 31, 1989. The attack noted in the indictment allegedly occurred on Nov. 22, 1988 in a Hereford residence.

Clyde had resigned his post as assistant district attorney more than a month prior to the Nov. 22 indictment. His resignation was offered after he was charged with Class C misdemeanor assault by Randall County authorities in connection with a separate incident.

Discovery lifts off

CAPE CANAVERAL, Fla. (AP) - Discovery blasted off today on the long-delayed launch of the \$1.5 billion Hubble Space Telescope, an astronomical marvel that will enable man to peer deeper into the universe than ever before.

The shuttle roared through a thin bank of clouds on a 700-foot column of flame at 8:34 a.m. EDT, carrying five astronauts and NASA's most complex and costliest payload.

"Liftoff of shuttle Discovery, our window on the universe," said NASA launch commentator George Diller.

The launch was delayed three minutes with 31 seconds to go on the countdown clock when an indicator showed a fuel valve closed instead of open. The problem was quickly corrected.

At two minutes, six seconds into the flight, Discovery's two solid-fuel rockets burned out and dropped into the Atlantic Ocean. The spacecraft continued upward on the thrust of its three main liquid-fuel engines.

At 8 1/2 minutes into the flight, Discovery reached an elliptical orbit of 374 miles at its highest point. By firing thrusters, the astronauts were to nudge the shuttle six miles higher to a final orbit of 380 miles, where the telescope would be safely above Earth's obscuring atmosphere. That was the highest a shuttle could reach with such a heavy payload.

The previous record orbit for a shuttle was 309 miles, by Challenger in 1984 when it deployed a science satellite.

Hubble has been waiting to take its place in space since 1983, delayed by technical problems and the 1986 Challenger accident.

Discovery's first launch attempt two weeks ago was scrubbed four minutes before liftoff because of a faulty hydraulic power unit on the shuttle.

Columbia, which journeys into space next month with the Astro observatory, sat on a launch pad 1.6 miles from Discovery's pad.

Lawmakers want schools to stay open

AUSTIN (AP) - Lawmakers and lawyers are maneuvering to make sure schools stay open even if the Legislature doesn't meet a May 1 court deadline for reforming the public education finance system.

The Texas Supreme Court - which last year found unconstitutional disparities in funding available to property-rich and property-poor school districts - said state aid to schools should stop May 1 unless the finance system is overhauled.

But on Monday, Attorney General Jim Mattox said he'll go to court to force schools to keep operating through the end of the school year, even if lawmakers and Gov. Bill Clements don't meet the deadline.

In another effort to forestall the possibility of school closings, the House Appropriations Committee endorsed a bill to give schools their nearly \$500 million May payment at the end of this month.

The measure - backed by Clements, Lt. Gov. Bill Hobby and Speaker Gib Lewis - goes to the full House for consideration.

Schools currently aren't scheduled to get their May state payment until the 25th of the month. Mattox noted in a letter to State District Judge Scott McCown.

"Because this office is concerned about the continued provision of education to the school children of this state, and because no serious economic disruption will occur within the school districts until the end of May, we will seek from the court temporary injunctive relief... against any school district in this state that attempts to suspend school operations prior to the normal end of the school year," Mattox said.

Oat bran ice cream, and more, is in the near future

BOSTON (AP) - Impossible as it sounds, a food scientist says he's invented just what the world's been waiting for: Ice cream that's good for you.

Not only does this stuff contain almost no fat, it might actually lower the body's cholesterol level instead of raising it.

The secret ingredient is a fluffy white powder made from that darling of the food conscious, oat bran. Its principal inventor, George E. Inglett of the U.S. Department of Agriculture's research labs in Peoria, Ill., calls it Oatrim.

If his predictions are correct, in two or three years it will be an ingredient in all sorts of otherwise high-fat foods, including mayonnaise, cheese spreads, salad dressings and margarine.

"It has a double whammy," Inglett said. "It will replace animal fat, such as cream, in desserts. And it acts in the body to lower blood cholesterol."

To be successful, Oatrim will have to compete against other fat substitutes that have been under development longer, and it will have to overcome doubts that have arisen about the powers of oat bran to lower cholesterol.

The first of the substitutes, called Simplesse, was approved by the Food and Drug Administration last month. It is made from egg whites and milk protein. Others, made by Kraft and Procter & Gamble, are also under consideration by the FDA.

Whether oat bran actually lowers blood cholesterol was called into question by a study conducted last year at Brigham and Women's Hospital in Boston. Doctors concluded that cholesterol levels fall when people eat lots of oat bran - but only because they are too full to eat high-fat foods that raise cholesterol.

Oatrim is produced when enzymes are used to remove water-soluble fiber from oat bran or oat flour. When mixed with water, it takes on the consistency of cream cheese but has almost no taste.

Inglett unveiled his product Monday at a meeting of the American Chemical Society. He handed out samples of English muffins covered with an Oatrim cheese substitute. It was sweet and bland with a mild taste of cheddar cheese.

While he did not show off Oatrim ice cream, he said that in taste surveys people rate it between ice milk and ice cream. When whipped up by a soft-serve machine, tasters describe it as "delicious, excellent, wonderful and marvelous," he said.

In one respect, it is clearly different. Four ounces of fancy premium ice cream contain about 300 calories, 22 grams of fat and 85 milligrams of cholesterol. Oatrim ice cream has 135 calories, virtually no fat and four milligrams of cholesterol.

Mrs. Allen promotes more donors

Barbara Allen was the featured speaker at Tuesday morning's Pilot Club International meeting. Barbara, a liver transplant recipient, told the group about her transplantation experiences.

April 22-29 is Organ Donor Tissue Awareness Week. The Pilot Club International became a sustaining member of the American Council on Transplantation in 1984.

Mrs. Allen received her liver transplant October 7, 1989 at Baylor University Medical Center in Dallas. She suffers from a rare condition known as primary biliary cirrhosis, which causes her own immune system to attack her liver.

Despite the gravity of receiving a liver transplant, Barbara Allen approached the topic with levity.

She explained the major incision made for the transplantation is called the Mercedes-Benz incision, because it is shaped like an upside-down Mercedes-Benz sign. "It also costs, too," Barbara said. "My husband, Bill, likes to remind me that we could buy two Mercedes-Benz for the cost of the surgery."

Getting her new liver has given Barbara a new lease on life, despite frequent checkups and seven types of medication she takes to prevent rejection.

Many people in the Panhandle have received major transplants. Justin White, who lives in Dimmitt, needs a liver transplant.

Mrs. Allen's advice to Pilot Club members was to take care of themselves and push until they got an answer if they suspected a medical problem. Consideration of organ donation is a possibility if the condition is life-threatening, although organ donation is not for everyone.

She urged persons considering becoming organ donors to discuss the issue with their families. If just one family member does not want one to become an organ donor, it will not happen.

Mrs. Allen asked Pilot Club members to consider organ donation. Organ transplant donor cards are available from Pilot Club and Lions Club members in Hereford.

WASHINGTON - President Bush is ready to announce a set of measured economic penalties against the Soviet Union in response to the Kremlin's crackdown in Lithuania, administration officials say.

The suggestion has been made that "Due to the highly competitive nature of economic development, it is a traditional strategy to keep the identities of target industries secret." The implication here is that there is something sinister about respecting the confidentiality that an individual prospect may require in the initial

negotiations. I have been involved in several such negotiations through out chamber of commerce and how there could possibly be any conflict of interest because of any such negotiations being made by a board that is funded by public funds is beyond me. There always comes a time in such negotiations before any commitments are made that many people in the community are made aware of the pending deal.

Not everyone in our community is going to agree with any industry that is brought in. There were folks, good folks, who thought that Holly Sugar Corp. would not be good for this area. I have been to several industrial development seminars in the past few years and one of the many things I was taught was that, if requested, confidentiality must be granted up to a point.

The voters of Hereford have a very simple decision to make; either they want a well-financed professional long-term effort to give our community an opportunity to compete for future growth and prosperity, or they don't. As a city commissioner, a past

chairman of the Industrial Development committee of the chamber of commerce and as volunteer, part-time director of the Hereford Area Economic Development Council, I wholeheartedly recommend Proposition One to the voters.

In the economic development arena in the 1990s, volunteers and the possibility of donations, grants and endowments will not get the job done.

In the past, when you bought a bag of potato chips, you got a bag of potato chips. Now you get a huge bag of air with a handful of chips at the bottom.

Wake up, Mr. and Mrs. John Q. Public. You're being taken left and right—R.W., Hubbard, Neb.

DEAR HUB: You have a point, but alert shoppers don't get fooled. There are any number of truth-in-packaging regulations designed to protect the consumer against getting gyped.

Government regulations make it mandatory that the weight of the contents be printed on the outside of the box or can. The wise shopper cannot be hoodwinked by clever packaging. These days anyone who can read can get a fair shake.

DEAR ANN LANDERS: Recently our small office advertised for part-time help. After interviewing 34 applicants, it became clear to me why a lot of people are out of work.

The position involved clerical work, and we also wanted someone who

could deal with the public. The ad mentioned that some experience was required and requested applicants to send resumes and references.

Several people phoned and babbled about past employment, bragging about what a great job they had done for so-and-so. They said they'd send A-1 references, but none arrived. A few applicants sent Xerox copies that were unreadable and semiliterate letters written in pencil or notebook paper or legal pads. A former teacher's letter of application had four misspelled words. A high schooler came in, wearing jeans, sporting a punk hairdo and chewing bubble gum.

We finally hired a woman with no experience except homemaking. "But

I can learn," she said. She turned out to be terrific.

Please, Ann, tell job applicants to prepare a resume. Books from the public library will tell you exactly how. Wear clean, neat, attractive clothes. Focus on what you can do for the business, not what the business can do for you. -- I Live in Boston

DEAR BOSTON: And now may I add a word? People who strike out repeatedly on interviews should go back to some of the places where they failed and ask the person with whom they spoke why they weren't hired and how to make a better presentation. If they are sure to improve their chances.


Brandon Knutson added three more runs with a two-for-three day at the plate while Tory Peet drove in two runs with a double and a triple.

Carter finally broke loose Monday night, driving in a career-high seven runs and hitting his first National League grand slam as the Padres routed the San Francisco Giants 13-3.

Carter came to San Diego in December in a trade that sent prize rookie Sandy Alomar Jr. and two others to Cleveland. But Carter, who averaged 31 home runs and 108 RBIs for the Indians the last four years, did little in his first 12 games for the Padres, batting just .213 with one home run and six RBIs.

But against the Giants, Carter stood tallest of all. He hit his fifth career slam in the first inning, added a two-run single in the fourth and an RBI double in the sixth. He went 3-for-4 and left in the seventh to rest.

"I watched a film of myself. I hadn't been swinging the bat with any kind of authority. Basically, I was just a one-dimensional hitter," Carter said. "I told myself today, 'Look for your pitch. Look for your area. And try to drive the ball.'"







Social Security

This year's celebration of Older Americans Month will honor the achievements of the older Americans Act and the many positive changes it has made in the lives of the Nation's elderly. Tim Talbot, Social Security district manager in Amarillo said today.

The theme chosen for the month is "Celebrate America's Coming of Age. The Older Americans Act 1965-1990. Silver Anniversary -- 25 Years of Achievement." Events during the month will center around this theme.

Virtually every elderly American has benefited in some way as a result of passage of the Act. People have received home delivered meals, homemaker and home aide services, health screenings, employment assistance and many other services through funds provided by the Act.

For 50 years, Social Security has provided its beneficiaries with a monthly retirement income to help them after they leave the work force.
