

Dalhart scored first after taking a bad pass and scoring two on a foul followed by a field goal, then another two free throw points to lead 6-2.


From there, the score widened, and at the end of the first, it was a 13-3 ball game for the Dalhart Wolverines.





January 20. This month's allocation also includes yearly and fourth quarter filers.

Muleshoe shows a 'whopping' 17.71 percent increase over receipts for last year. Their current payment for this period was \$30,839.95, up from the \$25,750.03 for the same period a year ago. This brings current total payments to date to \$43,217.23, as compared to the \$36,714.81 shown a year ago.

In Cochran County, Morton shows a 27.81 percent increase in tax receipts for the year. Last year, Morton had received \$9,155.76 at this time, and this year's figure is \$11,701.76. Their current payment was \$7,468.33, up from the \$6,368.-90 of a year ago.

Littlefield shows payments for this pay period of \$36,193.23, up slightly from the \$35,949.69 of a year ago. Their payments to date are running 2.64 percent behind payments of a year ago. Last year, for the second month, Littlefield had received a total of \$51,097.40, and this year's total payment is shown to be \$49,-747.22.

In Parmer County to the north, Friona has a decrease of 14.64 percent in tax receipts to date this year. Last year at this time, their total payments were \$19,779.07, down to \$16,883.57 at the same time this year. Their current payment was \$11,574.75, down from the \$14,672.48 of a year ago.

The largest allocation this month, \$22.1 million, went to Houston, an increase of 10.47 percent. Dallas received the second-largest check, \$14.7 million, an increase of 1.4 percent. San Antonio's check totaled \$7.9 million, a decrease of two percent.

Bullock also sent checks totaling \$59.6 million to the state's six metropolitan transit authorities, an increase of four percent over February 1987 MTA payments. Houston's MT-A received the largest check, \$24.7 million, while Dallas collected \$22.8 million, the second-largest MTA allocation.
