

Muleshoe woman files 'personal injury' suit

A Muleshoe woman has filed a suit against her former employer, the Muleshoe Area Hospital District, claiming personal injury while she worked there.

A lawsuit was filed in the 287th judicial district court in Bailey County on June 27 by Mary Sutton, a former hospital employee. Sutton currently lives in Parmer County.

In the lawsuit, Sutton alleges that while she was an employee at the hospital, she was struck in the face by one of the patients in the nursing home on or about June 26, 1992. As a result of the blow to the face, she alleges that it caused fractures and resulted in damage to her right eye.

As a result of the injury, Sutton claims it has caused her incurred medical expenses, pain and suffering in both the present and past, and states she will continue to have medical expenses, pain and suffering in the future, which

she says will add up to an amount in excess of the minimum jurisdictional limits of the said court.

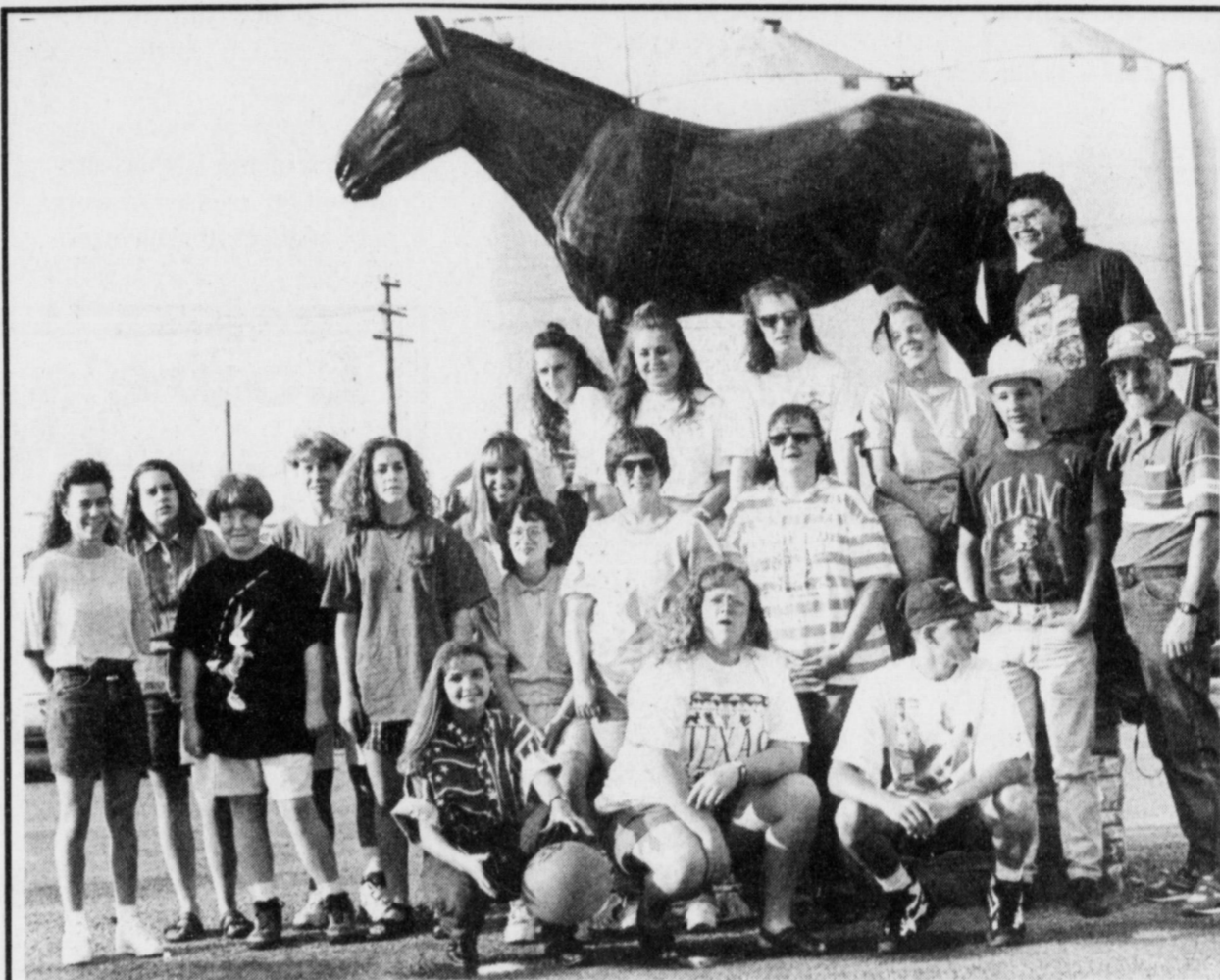
The hospital was served with a notice of the filing of the suit on Tuesday, July 5 and has about 20 days to file a written response. Hospital administrator Richard Murphy was out of

town this week and could not be reached for comment.

Sutton is being represented by Muleshoe attorney Linda Elder.

The suit further states that Sutton complied with all requirements by the defendant to five notice of injury, as stated by the defendant's personnel policy.

Sutton is requesting that she be awarded attorney fees, for alleged damage she has sustained, and all costs for such further relief as proper.

Gauna selected All-State shortstop

BRYAN—Muleshoe High School junior shortstop Jimmy Gauna has been named to the Texas Sports Writers Association Class 3A All-State baseball team.

Gauna, the only underclassman named to the team, hit .529 for the Mules and head coach Ted Leps.

Also the All-District 2-3A shortstop, Gauna was the only South Plains player named to the team.

Gauna, who stole 27 bases in 28 attempts, helped the Mules to an 18-8 record and a runner-up spot in District 2-3A. Muleshoe made the playoffs for the second time in three seasons, losing to Sanford-Fritch in the bi-district round.

Orange Grove's Ricky Sandate and West's Scott Podsednik were named co-players of the year. Sandate led his team to the 3A state title, pitching a no-hitter in the title game. He was 10-1 on the year with three saves and had five career no-hitters.

Podsednik hit .529 with 10 doubles, eight triples, five homers and had 24 runs batted in as

Jennyslippers raise more than half of funds needed

The Jennyslippers raised approximately \$1,200 for the fireworks display which was held at the City Park last Monday. An estimated 2,000 people viewed the display, including several people who were in town attending class reunions.

PUSH cyclists to ride into Muleshoe on Monday

Sixty six-members of Pi Kappa Phi Fraternity, representing colleges and universities nationwide, are expected to ride into Muleshoe on Monday, July 11 as part of the Journey of Hope, a project of PUSH America.

They are cycling across the United States this summer, and will be making a stop in Muleshoe. They are on a na-

tional awareness campaign for Americans with disabilities.

They are expected to arrive in Muleshoe on Monday, July 11. The Jennyslippers, who will host them, will not know the exact time they are expected to arrive until the night before. The time they will arrive will depend on the weather, but they are expected to arrive at about 1 p.m.

The PUSH cyclists are expected to come to Muleshoe from Elida, N.M., and stay overnight here. The Jennyslippers will feed them supper and breakfast at Methodist Church.

The PUSH cyclists will also perform at puppet show at the Muleshoe Municipal Swimming Pool at about 3 or 3:30 p.m.

The college students are participating in the "Journey of Hope" in an effort to raise funds and awareness for those with disabilities. The trip began in San Francisco on June 13 and will finish 3,500 miles and 61 days later in Washington, D.C.

of the Jennyslippers, said that people with special disabilities are encouraged to come and visit with the cyclists.

The Journey of Hope is a project of PUSH America, the national outreach project of Pi Kappa Phi Fraternity. Headquartered in Charlotte, N.C.

PUSH America, a non-profit organization, serves people with disabilities nationwide. Through the work of 145 Phi Kappa Phi chapters at colleges and universities, PUSH America serves the

disabled by donating and building adaptive equipment, through educational programs and by promoting volunteerism on college campuses.

The members of the Journey of Hope team will cycle an average of 75 miles per day. After each day's ride, the team

members will join forces with local allied organizations to provide educational programs or participate in awareness events in the communities they visit.

"We want to change the

perception that people with disabilities are a burden. They're people, just like you and me," said team member Chad Perce, a recent graduate from the University of North Florida.

The Journey of Hope will reach 21 states in 61 days. After cycling the first week together, the team divides in two. From there, half is trekking a northern route to Washington, D.C., the other is taking a southern path.

Early Childhood program accredited

PORTALES — Eastern New Mexico University's Early Childhood Education (ECE) licensure for ages birth to third grade has been approved by the State Board of Education's Professional Standards Commission. Eastern becomes the first institution in the state to meet new licensure requirements for ECE (birth--third grade).

The approval means that graduates of the ENMU program will be licensed to work in public schools that have pro-

grams for infants and young children.

Many schools now have programs in which teenage mothers and fathers can bring their young children to school. The licensure gives teachers special training for these young age groups which goes beyond basic day care.

Eastern's program provides special training in three age groups: birth to two years old, three to five, and six to eight.

"Some methods of teaching in the traditional kindergarten

through eighth grade certification are inappropriate for younger children," says Ms. Wilson.

Eastern's program requires 55 semester hours in general education, 41 hours in professional ECE, 10 hours of student teaching, and six hours of observations, lab experiences, and/or field experiences.

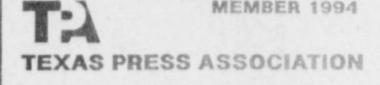

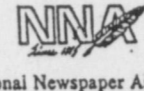

Ruling is victory to Texas rural landowners

WACO—The Supreme Court decision in the Oregon case called Dolan versus Tigard is being celebrated as a victory by landowners in rural Texas, according to the president of the state's largest farm organization.

"This case shows there really is a fifth amendment and it is not some kind of constitutional quirk to be ignored while private property rights are trampled," said Bob Stallman,

president of the Texas Farm Bureau.

The takings clause of the fifth amendment states that government may not take private property for public use without compensation. In this and other recent decisions, the court seems to have expanded the definition of "taking" to include the diminished value of property due to government mandates and regulations.

In the case, Florence and

John Dolan, a mother and son with a plumbing supply store in Tigard, Ore., decided to expand their store. The necessary building permits were conditional, requiring the Dolans to give up a trip of their land as a "greenway" and bicycle path. The strip in question amounted to 10 per cent of the Dolan's property.

The court ruled that such action constituted a "taking" under the fifth amendment, and

that the Dolans were entitled to compensation.

"This is an important decision for farmers, ranchers and landowners across the nation," Stallman said. "It will force governments at all levels to look more closely before taking a person's property without compensation."

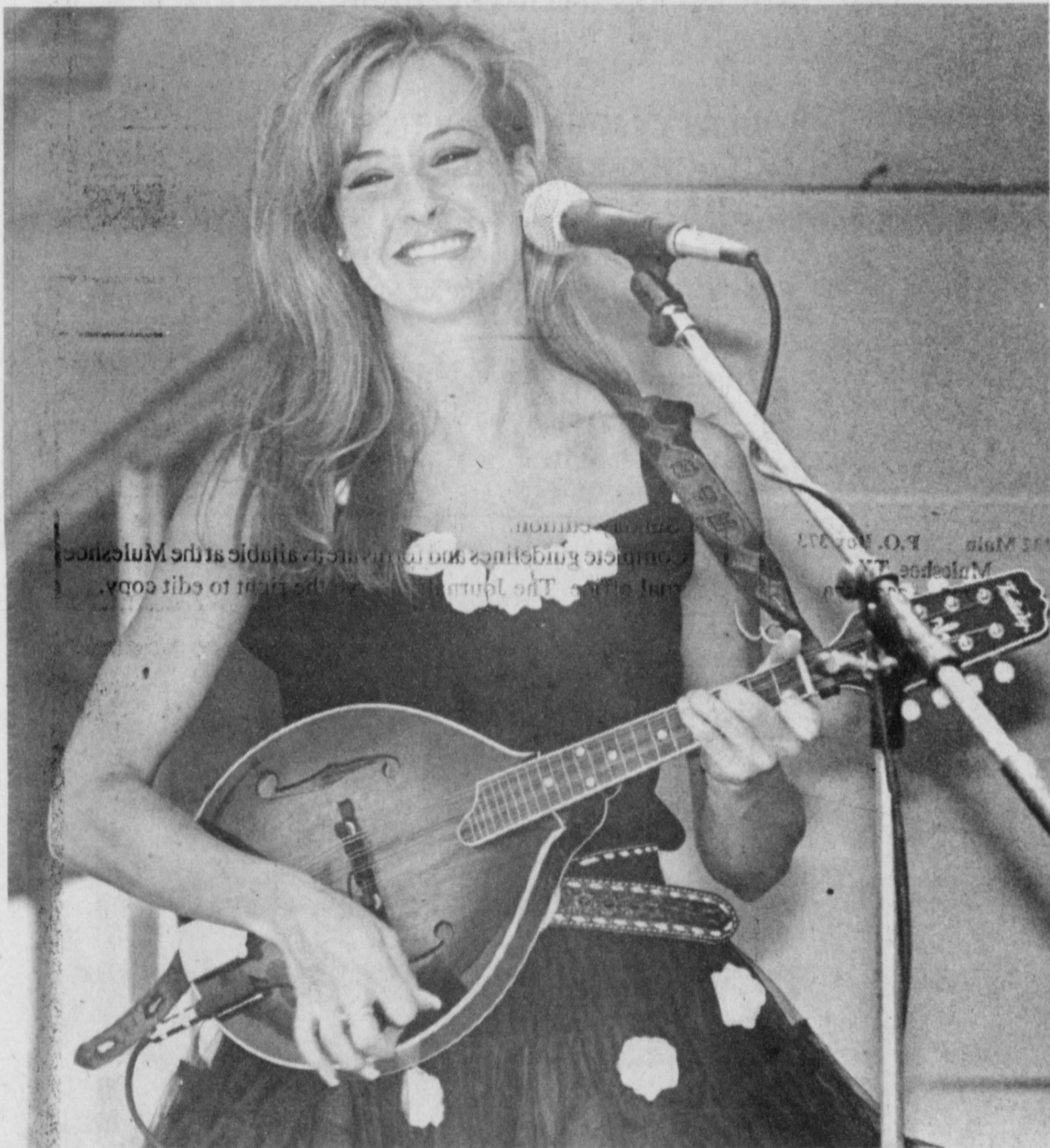

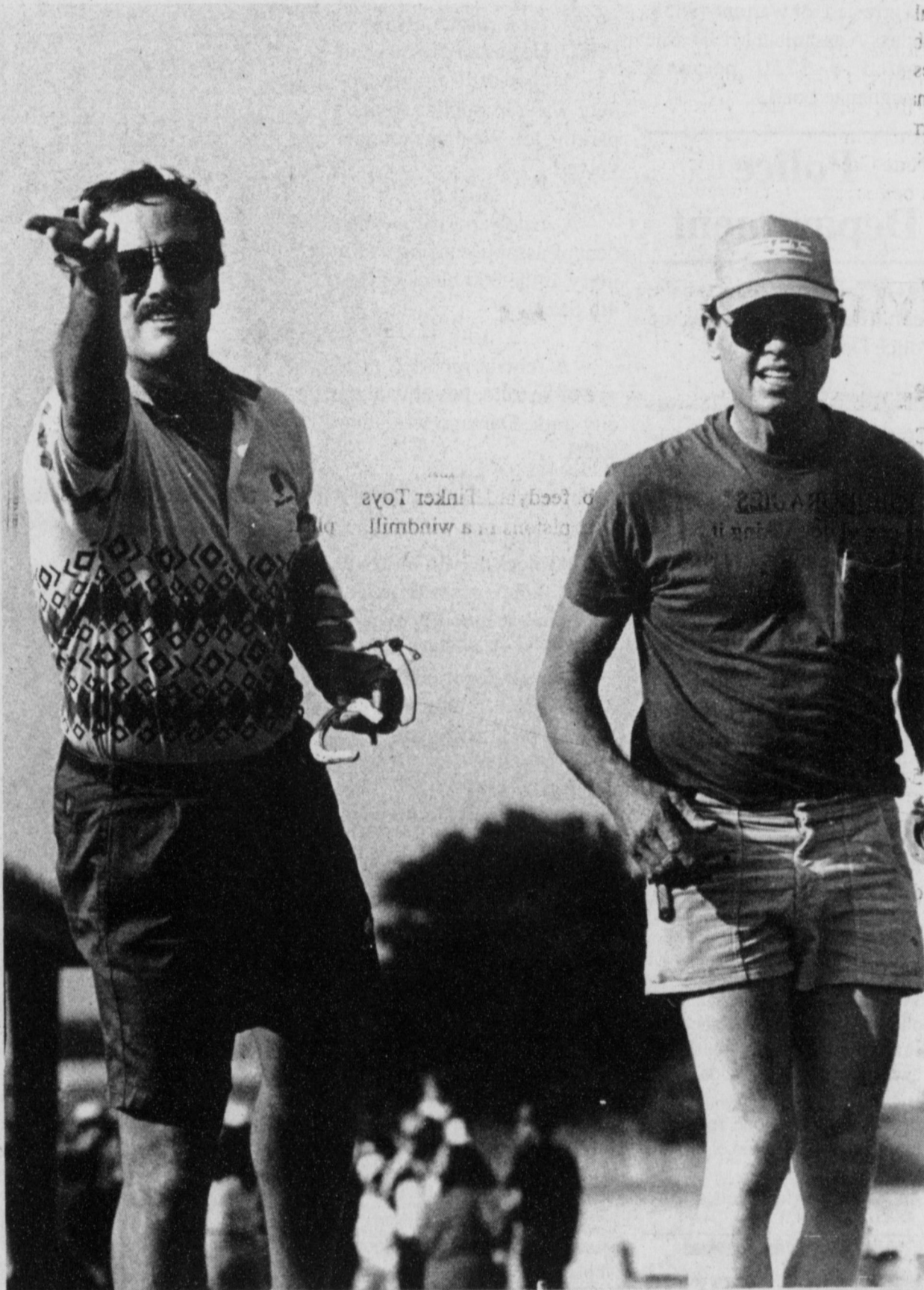
