W is "a rule of conduct established by authority," while equity is synonymous with justice, honesty and fairness. Not all law is founded upon justice, honesty and fairness; but back of law may often be found public sentiment, moulding and shaping the course of

the legislator. And public sentiment is as fickle as when in the days of Christ the multitude with one breath cried "Hail, King of the Jews!" and with another, "Crucify Him!"

The pharisaical observance of the letter of the law does not always denote the best class of citizenship; but, on the other hand, not infrequently brands one as a most contemptible hypocrite.

The pot-bellied old post-nuptial proselyte who leaves his trusting wife at home alone and wends his way disgracefully down the crooked avenues of certain society and spends a night of carousing and debauchery. that leaves on his whirling brain an illusion of beer bottles, fair female forms and striped stockings, may occupy his pew with a duly dignified countenance on the following Sunday morning, and be respected as a lawabiding citizen; but he has a soul so steeped in sin that the good dominie could never reach him with the defacating influences of the Holy Spirit though he preached till all hell rang with shouts of praise to God.

The merchant who forecloses a \$100 mortgage on a \$25 value, may be acting within his lawful limitations, and be recognized as a shrewd business man; but he has a soul. so small that a million of them in the mouth of a musquito would have as much room as a tadpole in Tartarus.

The lawyer who sells his services to the highest bidder, regardless of principle, dilly-dallies over technicalities to defeat the spirit of the law, and turns criminals loose upon the public or swindles honest men, may rever be impeached before the county bar; but he'll wear chains when he appears before the bar of God.

The doctor who charges you a dollar for a prescription of salt and water, and when you're dead turns your widow out of doors for his fees, may do it legally and think he's going straight to heaven when he dies; but he's a damphool, and his view of the jasper walls will be treonly diminished by distance.

The church-member who drinks

Peruna in the cellar and shouts prohibition on the housetop, may be a stickler for the law and occupy an amen corner in the church; but he's a putrescent excrescence on the posterior regions of indecency, a suppurating sore on society, and if his rotten old carcase were hung on the back gates of perdition the black beaked vultures of demnition would turn away in disgust.

The gossiping old hag who covertly stabs you with the venom of her scandalous tongue, may be a leader in church and social circles and occupy an exalted position in the Ladies' Aid Society, the Christian Endeavor and the Epworth League; but the English language is inadequate to express the deep moral turpitude of such a hell-cat. She is the slimiest and filthiest of all the serpentine brood of perdition, and should a respectable buzzard perchance to cross the relics of such a loathsome, mass of degradation it would pause to consult the dignity of its bill before befouling it with

such garbage.

The woman who marries a man under the sacred obligation to obey, serve, love, honor and keep him, in sickness and in health, and seeks the first opportunity for a divorce on the ground of "incompatibility," may make loud professions of her sanctity, and become a leader in the church choir; but she's a whited sepulchre that stinks to hell. and she'll never hear the euterpean notes of the celestial choir on the other shore. The man who does the same thing may be a financial pillar of his church; but he's not to be classed among humans-rather a monotype of monstrosities, damed by a buzzard and sired by polecat, whose offspring has never been deodorized.

The girl who lures a man, with all the arts and wiles known to such feminine demi-devils, into the commission of some folly or infamy, and then sues him for breach of promise, may be sustained in the courts; but if I were to canvass the chorography of perdition I could find no spot so vile as her own heart.

Pseudo-prosecutors and contrefait Christians may drive every saloon out of America and put every bartender in the penitentiary; but unless their lives and practices are squared

to the plummet of God's law, it will be of little avail to them in the final reckoning of the deeds done in the flesh. This one act alone will never raise them high enough heavenward to see the lining of a cloud.

O tempora! O mores! O rats! I'm neither a law-breaker nor the son of a law-breaker. But we see daily the imperial ægis of Equity. with her motto of "Justice. Honesty and Fairness." prostituted to the base ends of Law, in the hands of men whose respect for either is based solely upon their relative importance to their own selfish pur-

Consistency seems to be a rare jewel in the crowns of such men. Methinks the Saviour himself was meditating on this truth when he rebuked his hypocritical hearers for straining at a gnat and swallowing a camel. Inconsistency is an offspring of narrow-mindedness, and narrow-mindedness, or ignorance, if you please, is one the greatest curses of humanity.

It's just such cases of intellectual contractibility that furnish examples of one man shooting another over a two-bit account, or a nanny cat, or a female specimen of the mangy mongrel tribe. And it's just such minikin cusses that ought to be taken to the plains, tied to a bunch of bear grass and all the posterior parts of their pants worn threadbare with a strap of cow hide.

#### Judge W. B. Plemons.

On Wednesday of last week a man died in Amarillo whose memory will ever remain sacred in the hearts of Panhandle people—not because of the external paraphernalia of greatness or goodness with which he may have been endowed, but solely for those riches of soul and mind that

had proved him to be-a man

The silver cord was loosed and the golden bowl was broken, and the Reaper took from earth the soul of —a Man.

Judge Plemons, during his lifetime, held positions of trust and honor. He was one of the pioneer plainsmen, and has done more for the Panhandle than any other one man living. He stood high in the esteem of his fellow-men, and his it was to command the respect—aye, veneration—of all. But higher than all these, he was a Man.

A typical southern gentleman of the old school, he was admired for all those concomitant qualities of sterling wealth of mind and grace of action. But he was loved because he was just a Man.

He was an honored member of several fraternal orders, and was closely associated with that class of citizenship which represents the highest type of the material worth and platonic value of this world. But if Judge Plemons could be recalled from the dead today he would claim no higher title than that of a Man, and no higher honor than that which accompanies it.

Greater than these could no man bestow.

He fulfilled as near as in his power the demand of his God and his country in that one compound, Man. But he possessed those attributes of character that entitled him most preeminently to the claim.

He subscribed to no creed, and he pinioned his soul to the narrow confines of no dogma. But he loved his fellow-man with an unselfish love, as broad as the universe, as deep as space and as lasting as eternity.

He was a friend to the stranger, he fed the hungry, clothed the naked and gave drink to the thirsty.

Has creed or dogma done more?
"Forasmuch as ye did it to one
of the least of these, ye it to me."


